



Letter from Poor Law Commissioners informing the Board of Guardians, with reference to the arrangement they have proposed for the division of the Union into Dispensary Districts, that the Commissioners have given instructions for the preparation of all orders under seal for the declaration of their approval of those Dispensary Districts according to the scheme originally proposed by the Board of Guardians; and if in working the measure it should appear that any of the Districts are inconveniently arranged the Commissioners will take the necessary steps for their rearrangement.

and stating that they have addressed the several Medical Practitioners named by Guardians on 14th inst, last as being in possession of Dispensaries and have requested to be informed - whether they desire to be appointed Medical Officers of the respective Districts in pursuance of sec 14 of the Act.

In reference to the sealed order declaring the division of the Union into Dispensary Districts,

The Board on referring the Medical arrangement to the Medical Officers find that it would be more convenient to those appointed to the 1 & 2 Districts by changing - Tanghboy to the 2 District and Castlefreuch to the 1. The Board would be glad to adopt this arrangement should it be effected without causing delay; but they consider it of the highest importance that no time should be lost in carrying out the provisions of the Medical Charities Act.

Forwrding

Adverting to that part of the Commissioners' order with respect to the Dispensary Houses -

The Board find that in two of the Districts suitable accommodation exists; but that in No. 2 it will be necessary to make provision for the purpose. The Board therefore appoint Lord Clabreck, Mr. Filgate and Mr. John Carr to make the necessary arrangements, subject to the approval of the Board, in the Village of Lurgan which they consider the most convenient situation for the dispensary of that District.


