Letter from Commissioners forwarding a copy of a Resolution passed by the Board of Guardians of Ballinasloe Union, at their meeting on the 2^d instant respecting the payment of the debt due by Mr. Bellew Guardians for the maintenance of Paupers belonging to the latter Union in the Ballinasloe Work House; and requesting the observations of the Guardians thereon.

With reference to the debt owing to the Ballinasloe Union, it has been intimated to the Chairman, that the Treasurer will advance a sum of £1500, on the security of the Rates, upon an application, sanctioned by the Commissioners, being made to him by the Board.

As the Board is aware that the interest upon this loan cannot legally be charged upon the Rates, it is proposed to offer this sum to the Ballinasloe Board, who may be able to induce their creditors to accept it, minus the interest which will be due upon it, in the discharge of their several claims.

In requesting the Commissioners to sanction this arrangement the Board beg to observe that this method of compounding for their just debts is by no means satisfactory to them and they regret that the state of the law alluded to, leaves them no other alternative, except that of the imposition of a new Rate, the collection of which would at this season, over the greater part of this Union be impossible - It is hoped that the remaining balance due to Ballinasloe, may be paid out of the Rates, now in process of collection.


