The Board conceive this report most unsatisfactory. The Commissioners Architect ought to have been competent to direct what kind of Pump would have been efficient for the supply of the House; and it is a very great hardship on the Union that because he had directed an useless machine they should now be put to the additional expense of procuring a proper pump after the establishment has been by this neglect put to extreme inconvenience for the want of it.


