Minutes of prodeedings of above mentioned Local Authority at its monthly meeting of October 2nd. 1962.

ATTENDANCE. The Chairmen, Commissioner O'Brien presided. Other Members present were Commissioners O'Connor, Stapleton, Campbell, Coghlan and Burke, together with the Assistant Manager and Engineer.

The Minutes of the last monthly meeting were read and signed. Arising out of the minutes:-

a) The Assistant Manager, referring to the Board's recommendatuor that all of the Town Planning area of Tuam be included in the order prohibiting Temporary Dwellings, explained that this was not possible as it would not be upheld in court and that the areas to which the order would validly apply would have to be carefully defined areas of restricted extent. It was then agreed to recommend the following

a) All of the main road to Athenry from Tuam as far as the premises of Messrs. Gills Ballygluinin.

b) All of the main Road to Galway for a distance of three miles from Tuam.

c) All of the Mallymoat Rd. i.e, of the road linking Bishop St and Dublin Rd. and comprising a circuit from the Square Tuam to the Square of about three miles.

d) The Gardenfield Roaf from the point where it branches from the Ballygaddy Rd to Gardenfield Village, including the section of thi Road through the former Kirwan Estate and the section skirting the Kirwan Estate and the road linking the latter section with Tullinadaly  $Rd_{\overline{z}}^{1}$ 

b) With regard to an application from Messrs. James J. Farragher & Co. Ltd., Building Contractors, Tuam, for permission to connect a house being erected for a Mr. Hughes at Athenry Rd. with the Commissioners sewerage and water mains there, the Manager stated this should be allowed without charge as it would be best to arrange to have the County Council take over the mains there.

c) With regard to the Children's Home the Manager stated it would be best to have parties seeking the use of thes put in direct contact with the County Council as the Council can now sell or lease this premises. The Council had agreed, at their last meeting to advertise it.

d) Parking in the Square.

As members complained of chaos intthe Square for want of parking regulations, the Chairman volunteered to discuss the problem wuth the Gardai Superintendant.

CORRESPONDENCE. A letter from James Martin, Athenry Road, requesting repairs was referred to the Engineer. Also referred to the Engineer was a sketch map from Martin Mannion, 48, Athenry Rd. which he had forwarded in support of an application for permission to erect a shed there.

The appended motion from the Carrickmacross Urban District Council was agreed with.

A letter from the Co. Engineer stating that a report from Mr. Ed. R. Ryan, Consulting Engineer, Galway on the treatment and filtration of Tuam Water supply was shortly expected was read and a letter from the Gardai Supr. on the parking of vehicles in the Market Square and Vicar St.

MARKET AND TRANSPORT BYE LAWS. As no communication further to the meeting with representatives of the Tuam Livestock Mart had been received, the Asst. Manager stated it would be necessary to take action against the Mart if that body failed to take a further initiative in the matter of Tolls due to the Commissioners. It was decided that the Town Clerk write the Mart Manager requesting that the final decision on the payment of Tolls be communicated within one month.

PLANTING OF SHRUBS ON RIVER MARGINS AT SHOP ST. It was agreed to leave this to private effort.

MISSION STALLS IN CAR PARK. Commissioner O'Brien stated that the Gardai Superintendant had informed him that he would prosecute parties who had erected Mission Stalls at the Car Park at Bishop Bt. and Commissioner Coghlan reminded the Board that on a previous occasion on which an itinerant trader had erected a stall there the Superintendant had given the Board an assurance that in future such would not be permitted.

The Board decided against a proposal of Commissioner O'Connor that signs should be erected indicating the position of the Post Office.

Commissioner O'Brien referred to a motion which had been before the Association of Municipal Authorities of Ireland that Local Authorities should qualify for reconstruction and major repairs Grants as in the case of private landlords and the Assistant Manager stated that in the last Housing Act, provision was made for grants to occupiers and tenants as distinct from landlords. It was decided that the matter be placed on the Agenda for discussion at the next meeting.

HOUSING. Commissioner Campbell referred to the project to erect an additional ten houses in Tuam which had been deferred for some years, holding that this should now be proceeded with, as the vacant houses in Gilmartin Rd. had been tenented and Commissioner Stapleton to the making available of sites in the Palace Grounds for parties who wished to erect their own houses. In view of the snall number of of applicants for houses on the waiting list the Asst. Manager did not feel the erection of further houses by Local Authorities was warr warranted. It was agreed that the Clerk should write the Co.Council conveying a recommendation of the Board that the Council should advertise for applicants wishing to procure sites in the Palace

CLINIC. Commissionet Campbell adverted to the necessity to speed up the erection of the new clinic for which the Co.Council had purcha purchased a site. He also referred to the decision to discontinue the use of rent books in the collection of rents.

FESTIVAL OF TUAM. It was decided that the Board should not march in the parade to be held in connection with the Festival and that they should be invited to the saluting base. Also on the proposal of Commissioner Coghlan, seconded by Commissioner Burke it was unanimously resolved that the sum of £20 be expended on decoration (lighting) of the town for the Festival.

This concluded the business of the meeting.

Minutes of proceedings of above Local Authority at its wonthly \* meeting of Tuesday November, 6th, 1962.

ATTENDANCE. The Chairman Commissioner O'Brien presided. Other members present were Commissioners O'Connor, Stapleton, Browne, Campbell, Burke, Coghlan and Heskin together with the Assistant Co. Manager.

The minutes of the last monthly meeting were read and signed.

Arising out of the minutes, the Assistant Manager, in reply in reply to a query by Commissioner Campbell, stated that the construction of extra houses would not be justified, in view of the small number in the housing waiting list, but, that an advertisement we was appearing in the current weeks local papers inviting applications for sites in the Palace. Also arising out of the minutes. The Chairman stated he had discussed parking in the Square with the Garda Superintendant, who informed him that the whole matter of parking was undergoing consideration at the moment.

Because of representations by Mrs. Trayers, 49, Gilmartin Rd, to have repairs to her house effected, the town Steward , was directed to take a man to this house and have the matter carefully examined and remedied.

A letter from Miss K. Morley requesting the use of the Theatre Room of the Town Hall for a concert in aid of the polio fund was read and it was agreed the room should be let at the appropriate charge for the purpose.

The Clerk read a letter from Mr. J.F. Cahill, Westport inviting delegates from the Board to a meeting of Western Local Authorities at the Co. Buildings Galway on November 29th to discuss rates equalisation. It was confirmed that the following delegates should attend, Commissioners O'Brien, Burke, and Heskin,

A complaint from Mr. P. Kelly St. Endas Avenue on the condition of his range was referred to the Engineer.

A letter from the Livestock Mart stating that the Mart Committee had not yet decided on a reply to the Board on the matter of the payment of tolls was read. The Clerk was directed to write the Committee again requesting an immediate decision and reply.

A letter from Mr. Burke, 11 Tobberjarlath Rd. was referred to the Engineer.

A letter from the Town Steward representing the necessity of erecting pens in the Fair Green was considered. It was. proposed by Commissioner Coghlan, seconded by Commissioner Brownen and agreed that a sub-Committee of the Board, comprised of the Chairman and Commissioner Browne, Campbell and Coghlan should visit the Green and report on the proposal.

Commissioner Campbell adverted to the fact that the Green space in front of St. Josephs Park was being extremely used on Fair days for the sale of stock. The Clerk was directed to write the Co. Secretary on the matter of fencing it off. The necessity for this had already in the past been represented to the Co. Council.

Commissioner Browne referred to the necessity of having toilet facilities in the Fair Green and the Assistant Manager stated that the Co, Council had decided to provide twenty toilets throughout the County. It would take sometime before these were erected. Tuam had a good chance of getting such facilities in the Fair Green.

Copies of an Abstract from the 1982 Housing Act were distributed amongst the Members present and its provisions explained by the Assistant Manager, who confirmed that Local Authorities would not be entitled to Grants for major repeirs and improvements in their houses, but that tenants of such houses would. Regulations by the Minister had, however yet to be made.

CIVIL DEFENCE. In connection with Civil Defence the Assistant Manager stated that Tuam was very backward, especially in regard to the Warden service. There was only one District Warden in Tuam and in this respect the Town was the worst in the County and in two counties adjoining. He outlined the history and necessity for civil fefence and referred to the very short period of training necessary for Wardership. All members of the Board, the Clerk and the Town Steward volunteered for service as Wardens and it was agreed that the Civil Defence Officer would contact the Chairman with a view to organising the Service.

LETTING OF HOUSES. The letting of four vacant houses was discussed It was unanimously recommended that House No. 8 McHale Terrace, be let to Mr. Patrick Hussey, Dublin Road, and that Mr. D.J. Murphy be transferred from No. 13 to No. 14 Newtown Morris. Members of the Board felt that Mr. Patrick Heneghan, Barrack St. should be given No. 6, St. Endas Avenue, but, as, at earlier meetings it had been arranged to give Mr. Connaughton of 20, Gilmartin Rd a transfer to St. Endas Avenue, it was agreed to give this latter tenant the St. Endas Avenue vacancy - No. 6.

The transfer of Mr. Joseph O'Reilly from No. 30 to No. 26 Gilmartin Rd. was agreed upon as well as the granting of No. 30, Gilmartin Rd. to Mr. Byrne and of No. 20. Gilmartin Rd rendered vacant by the transfer of Mr. Connaughton to Mr. Patrick Gaynor. It was also decided that Mr. Frank O'Reilly be transferred from 44 Tobberjarlath Road, to No. 13, Newtown Morris and recommended that No. 44 Tobberjarlath Rd. be given to Mr. Patrick Heneghan.

Thès concluded the business of the meeting.

The Clerk read a letter from the Dept. of Industry & Commerce, in reply to representations made to have the firm of Messrs. John Bruton & Co. re-opened. Letter appended hereto.

A letter from Councillor Patk. A Patten also appended was read.

As Messrs. Fossetts had applied for the use of the fairgreen for a circus exhibition for May 5th, 1963, the Clerk requested the Board to state if he might let the Green for the purpose and it was agreed that the green might be so let on the usual conditions.

The Clerk requested the Board to state whether it considered Thos. Kerman, of 61 Gilmartin Rd., a suitable tenant to whom to lease No. 61 its Tenant Purchase Scheme, in view of the fact that complaints had recently been made by other residents in connection with the behaviour of the Kerman family. This was seconded by Commiss-ioner O'Connor and agreed; Commissioner Browne requesting Board members who were also on the Livestock Mart Committee to use their good offices to effect a settlement

DATE OF ESTIMATES MEETING:

This was fixed for Monday, January 21st. 1963.

LETTER FROM MRS. O'BRIEN. (appended) This was read by the Clerk and it was agreed that the matters raised be left to the Assistant Manager and Clerk to deal with.

Commissioner O'Brien moved that the tolls on Hawkers be raised from 10/- to fl. and Commissioner Burke complained that tolls were taken from Hawkers who had erected standings in the centre of the Market Square, thus giving them a right to erect such standings there to the obstruction of normal traffic. It was directed that tolls be no longer accepted from parties so using the centre of the Square and that the Gardai be requested to remove them.

# Agreement for the letting of the Town Hall. It was directed that this be brought up at the next meeting.

# DERELICT SITE AT CORNER OF THE GALWAY & WEIR ROADS.

Commissioner Burke asked the Engineer if any steps were being taken by the Co. Council to clear this site, In reply the Engineer stated that he thought the owner might make an offer of the land to the Co. Council who might then accept it.

Commissioners Heskin & O'Connor requested that extra lights be erected in Ballygaddy Rd., and Bishop St., and on discussion it was decided that a general survey of the town lighting be made by a subcommittee comprising of : Commissioners, O'Connor, Burke, Heskin and Campbell, and that the report of the sub-committee be given to the Boards Engineer.

Commissioner Burke complained of the level crossing at Galway Road being a bottle-neck and it was agreed the matter be referred to the Co. Council and thatCouncillor Patten be requested to use his good offices in the Council to have the matter remedied.

ATTENDANCE. The Chairman, Commissioner O'Brien, presided. Other members present were Commissioners O'Connor, Campbell, Browne, Heskin, Coghlan, Burke and Stapleton together with the assistant County Manager.

MINUTES. The minutes of the last monthly meeting were read and signed.

Arising out of the minutes:-

(1) Commissioner Coghlan inquired if any response had been had to the Board's request that the provision of ten new houses in Tuam which had been deferred some years ago, be now again reopened. 

Manager to representations made by the Board to have the Architectural Work on the new clinic, on the proposed ten new houses in the Palace and on lay out plans for private site development in the Palace expedited was placed before the meeting. Members expressed dissatisfaction with the terms of the reply and on discussion it was unanimously decided to request Mr. O'Flynn to receive a deputation to concist of the Chairman Vice-Chairman and Town Clerk and of a member of the swimming Pool Committee and of Councillors Patten, Killilea and Burke should these let latter agree to act; the Clerk to arrange with Mr. O'Flynn the time and day on which such a deputation would be received. In addition to the matters on which representations had been made, the deputation would be required also to take up the delay in the provision of a swimming. pool, the prohibition of four parties from building in Messrs. Mc Namaras field. Ballygaddy Road. and the long delay which had been imposed on the owner of a local factory in extending his premises.

A reply from Bord Failte Eireann on points in the report of the adjud Adjudicators of the Tidy Towns Competition queried by the Commissioners was then read. Arising from this the Town Clerk was instructed to obtain quotations for Street Name Plates.

It was decided to defer consideration of a reply from the Dept. of Local Government on the matter of Market Bye Laws to the next meeting when the Clerk was instructed to have all relevant correspondence available.

It was unanimously decided that the vacant house in Gilmartin Road formerly tenanted by Mrs. Bridget Trayers should be given to Mrs. Lydon of St. Patrick's Terrace.

The folloeing resolution proposed by Commissioner Campbell and seconded by Commissioner Stapleton was unanimously adopted

"That Labourers employed by the Tuam Town Commissioners have their wages increased by onepenny per hour with retrospective effect to 1st. July 1963"

The Clerk was directed to request the good offices of the Gardai in keeping stock on the streets during the October Fairs on the move.

Votes of sympathy to the relatives of the late John Joseph Egan, formerly of Ballygaddy Rd. and of the late John Byrne, Esq. formerly of Galway Rd. were unanimously adopted all members remaining standing. This concluded the business of the meeting.

ATTENDANCE. The Chairman Commissioner Burke, Presided. Other members present were Commissioners O'Connor, Coghlan, Purcell, Campbell, Staple O'Brien and Heskin together with the assistant County Manager.

The Minutes of the last monthly meeting were read and signed.

Arising from the minutes, Commissioner Coghlan inquired as to the podition of the proposed deputation to the Co. Manager and the Clerk in reply informed the Board that he had been in touch with the County Manager who had not that he was prepared to receive a deputation but, who had written on the matter of the twelve additional houses for the Palace grounds. This letter was then read to the Board. Members commented adversely on its terms adverting to the Minister's public statement deploring slackness of Local Authorities in providing housing accomodation. The assistant Co. Manager stated that approx. fifty applications for houses were held and were at present under investigation and that on the result of this investigation the need for houses in Tuam would be determined and that if warranted a certific of heed would then be issued. Such a certificate was essential before the erection of any additional houses could be undertaken. The investigation might take a further two weeks. Commissioner O'Brien complained that twenty five newly married couples had to leave Tuam since the prior Christmas for want of accomodation and Commissioner Stapleton that, in the past when one hundred and thirty houses had been erected they had been occupied within three months. In reply to Commissioner O'Brien the assistant Manager stated that if urbanised Tuam would supply its own houses and that there was no limit borrowing powers for housing construction.

# SITES IN THE PALACE FOR PRIVATE HOUSES.

The Assistant Manager stated the present position of this matter was that the Architect and Col Engineer had agreed in general as to lay out plans and that the Architect was at present being given details of the sewerage system in the locality. It was expected that I would very soon supply detailed lay out plans and estimated costs.

A letter from Miss K. Morley, Academy of Elocution, High Street, Tuam applying for the use of the Town Hall Theatre for presentation of a play on the nights of December 12th and 13th was race, As this necessitated discussing the Theatre Room from the view point of fire hazards the Assistant Manager requested that the meeting should go into Committee. The Board fully endorsed the Assistant Manager's standpoint in this matter and the Clerk was directed to write Miss Morley stating the hall would not be available.

It was directed that letters from Mrs. Ml. Higgins and Mrs. Kitty Condon, Gilmartin Road, requesting bepairs be passed to the Engineer. Repairs to the Houses of Mrs. Carroll 2, Tobberjarlath Rd. Guard Quinn and Mrs Harte 18, Tobberjarlath Rd were also discussed.
