intes:

Commissioner Finnegan, on behalf of Tuam Development Committee presented a cheque for £1,000.00 to the Chairman. This is a contribution to the Urban Village Renewal Scheme for 1096. The Chairman thanked Commissioner Finnegan and the Tuam Development Committee.

hristmas lights: The Members expressed concern at an item in a local Paper saying the Town Commissioners were holding back the privision of Christmas lights in Tuam. The Members stated that Tuam Chamber of Commerce had approached the Commissioners in 1994 and an allocation of £2,000.00 for provision of new lights for 1995 was provided for in the Estimates. This was thought to be a once off contribution. A further contribution of £2,000.00 was provided in the Estimate for 1996. During the Estimate Meeting for 1997 a letter from Tuam Chamber of Commerce was read requesting an increase in the contribution. The matter was discussed and an extra £500.00 was provided in the estimate for 1997 as a contribution towards the annual costs of the Tuam Chamber of Commerce. The Town Commissioners also contribute £300.00 per annum for cost of electricity.

The Minutes of the Istimates Meeting were adopted on the proposal of Commissioner Burke seconded by Commissioner Biggins.

ourt House:

The Assistant County Manager told the Meeting that an Architect has been appointed to inspect the structural condition of the Building. A decision will be made when his report is received. It was proposed by Commissioner Burke, seconded by Commissioner Reilly and agreed that a new Court House be constructed in Tuam, and the existing Court House be demolished.

ink Road:

Replying to the Members regarding the inner relief road the Town Engineer said it was originally proposed to site the Pedestrian Crossing between St. Patrick's School and the Vocational School. Before making a final decision on the location it was hoped to have the agreement of Bus Eireann, Galway Co. Go. and the School Managements. He said he would again talk to all concerned and endeavour to resolve the problem. It is hoped to have funding early in the new year for the necessary works. The Commissioners urged all concerned to have the matter resolved in the interest of the safety of the School Children. Letters from Mr. C. Greaney, Acting Principal, St. Patrick's School and an Garda Siochana were read.

Roads:

Replying to Commissioner O'Grady the Engineer said repairs would be carried out at Ballygaddy Road before Christmas. Replying to Commissioner Mongan he said damage to the road at Parkmore was the responsibility of the Contractor. Repairs would be carried out.

Abbey Trinity:

Replying to Commissioner Reilly the Engineer stated that a Traffic/ Pedestrian survey had been carried out. Abbey Trinity road does not meet the requirements for the provision of a Pedestrian Crossing. He said it was expected the new link road would be open in May. It was agreed that a new survey be carried out at Abbey Trinity road when the new link road is opened.

Tuam Stadium:

The Town Engineer presented his report. The Assistant County Manager said he would be coming to the January meeting with a proposal to dispose of .4 of an acre of ground to the Tuam Stadium Committee.

sulation:

The Town Engineer told the Meeting that the cost of the materials for insulation was £108.00 per house. The Assistant County Manager stated that the cost of the materials would be borne by the Commissioners. The Rent Collector to inform Tenants of the scheme.

Award of the Year: Commissioner Biggins told the Meeting that the referee's (who wished to remain anonymous) had now selected a winner of the Town Commissioners "Award of the Year" - Sr. Lorota Slattery. A presentation will take place on Wednesday 11th December at 9 p.m. in Credit Union House, Hermitage, Tuam.

The Minutes of the Meeting held on 29th October, 1996 were adopted on the proposal of Commissioner Reilly seconded by Commissioner Burke.

Business:

The Assistant County Manager informed the Members that he and the Chairman had met with the Lion's Club. An inspection of the Town Hall has been arranged for Monday 11th December, 1996 at 11 a.m.

putation:

Commissioners Biggins, O'Grady and Reilly met with Mr. Brendan Howlin, Minister for the Environment. They impressed upon the Minister the need for Urban Renewal for Tuam. They also outlined the situation if the Town Board should be downgraded. They stressed that the "Lacey Report" did not do justice to towns west of the Shannon. The Minister promised to look at the Town Commissioners submission and write to the Board. Commissioner Biggins was thanked for arranging the Deputation.

It was proposed by Commissioner Burke and seconded by Commissioner Reilly that the Court House in Tuam be demolished and a new one built.

k Road:

Replying to the Members the Town Engineer said that Pedestrian crossing similar to the one on Bishop Street will be provided. Regarding lights all underground services are in place. A detailed estimate has been submitted to Galway County Council and it is hoped funding will be available in 1997. It was decided to ask the

Gardai to put a Patrol there in the short term.

Flooding:

The Town Engineer told the Meeting that work at Ballygaddy Road will be carried out before Christmass. He said the situation at Galway Road had been resolved.

Footpaths:

Replying to Commissioner O'Grady the Engineer said that the E.S.B. and Telecom had work to complete before the footpath at Galway Road could be resurfaced. It was hoped the work would be completed before Christmas.

Minutes of Estimates Meeting held on Tuesday 29th October, '96

The Prayer was recited.

The Manager introduced the Estimate of Expenses for 1997 which had been circulated to each Member and advertised. He said total expenditure for 1997 is estimated at £54,790, while receipts are estimated at £23,700. Provision has been made for £5,000 expenditure on Town Hall renovations and £500 as a contribution towards Tuam Tidy Towns Committee. Provision for the A. M. has been reduced in accordance with the revised arrangements approved by the Minister for the Environment. A sum of £2,000 as a contribution to Tuam Chamber of Commerce for the provision of Christmass Lights has been provided. The Estimate prepared will require a rate in the £ of 154.25 pence for 1997 as compared with 137.55 pence in 1996.

The Commissioners examined the various items of expenditure and receipts proposed by the Manager in the draft estimate. During the course of the discussion Commissioner Finnegan confirmed that Tuam Development Committee would contribute £1,000 for Urban Village Renewal for 1997. It was also agreed that £1,000 of Members expenses for 1996 be allocated for Urban Village Renewal for 1997.

It was proposed by Commissioner Burke that £1,000 from Members expenses be allocated towards the provision of a machine to clean the streets of Tuam. The Manager advised against this. The Chairman urged Commissioner Burke and Commissioner Finnegan to take this matter up at Council level. The Manager told the Members an application to refurbish the Town Hall had been made to FAS. The estimated cost of materials for this is £92,000. He proposed starting a fund with a £5,000 allocation for 1997. It was proposed by Commissioner Burke and seconded by Commissioner Reilly that the Manager meet with the Lion's Club and report back to the next meeting.

It was proposed by Commissioner Reilly and seconded by Commissioner Joyce that an amount of £500 extra be included in repairs in order to provide attic insulation in houses not yet refurbished-rebuilt. It was proposed by Commissioner Burke and seconded by Commissioner Biggins that £500 extra be included in the contribution to Tuam Chamber of Commerce for the provision of Christmass lights. This resulted in the demand on Galway County Council being increased from £31,090 to £32,090. The rate in the £ consequently would increase from 154.25 as set out in the

estimates to 159.2 pence.

It was then proposed by Commissioner O'Grady seconded by Commissioner Biggins and resolved that the Estimate of Expenses as amended be adopted by the Commissioners and that the net amount of £32,090 in the said estimate as amended be demanded from Galway County Council in respect of the year ending 31st December, 1997 and that the form of Demand be signed by the Chairman and the Town Clerk.

TO THE CHAIRMAN AND EACH MEMBER OF TUAM TOWN COMMISSIONERS/

I attach hereto Estimate of Expenses for 1997 for Tuam Town Commissioners which will be considered at Estimates Meeting, to be held in the Town Hall, Tuam at 8.00 p.m. on Tuesday 29th October, 1996. Total expenditure for 1997 is estimated at £54,790, while receipts are estimated at £23,700. I have provided for £5,000 expenditure on the Town Hall renovations and £500.00 as a contribution towards Tuam Tidy Towns Committee. The provision for the AMAI has been reduced in accordance with the revised arrangements approved by the Minister for the Environment. Regarding Meeting with Mr. John Joyce and Mr. Martin Duckly of Tuam Lions Club it was decided that a meeting be arranged with the Town Engineer.

Replying to the Chairman the Town Engineer said that flooding at Abbey Trinity/Galway Road was being persued. He said it was hoped to carry out emergency work at Athenry Road in the next few weeks, and flooding at Ballygaddy Road will be resolved in the near future.

It was proposed by Commissioner Burke, seconded by Commissioner Biggins and agreed that the Town Commissioners write to Galway County Council and request that the link road be called "Bobby Burke Road".

Regarding a pedestrian crossing at Abbey Trinity Commissioner Reilly told the Meeting He and the Chairman had met with Insp. Broderick. The Gardai are in favour of the pedestrian crossing. The Town Engineer stated that a survey would be carried out before the next Meeting.

The Minutes of the September Meeting were adopted on the proposal of Commissioner Biggins, seconded by Commissioner O'Grady.

Manager's Business:

It was agreed to hold the Meeting to consider the Estimate of Expenses for 1997 on Tuesday 29th October, 1996 and to bring the November Meeting forward by one week to that date.

The Chairman welcomed a deputation from Tuam Chamber of Commerce. Mr. Jarlath Canney, on behalf of the deputation, told the Meeting that additional financial assistance for the Christmas festive lighting was needed. He presented a breakdown of the costs involved. He said the most equitable way of collecting the funds is to charge same against the rates. He said the Chamber of Commerce are happy to administer the scheme. He asked the Commissioners to consider the matter at the Estimates Meeting.

It was proposed by the Chairman, seconded by Commissioner Finnegan and agreed to invite a Person from FAS to a future meeting of the Board.

They received several complaints regarding the wall around the car park. They had to have a number of Gardai directing traffic. It is not possible to have personnel there at all times during rush hours. The job of the Gardai is Law endorcement and the law will be vigorously enforced from now on.

Letters from Presentation College, Concanon & Meagher, Solicitors on behalf of Supervalue supermarket and the Chairman of the Tuam and district Vintners Association were read. During the discussion the Members welcomed Inspector Broderick's assurance that the parking laws will be vigorously enforced. The Town Engineer confirmed that there was a piece of private property between the car park and the Mall. He was asked to re-examine it to see if any arrangements could be worked out.

Dublin Road

Commissioner Lane and other members stressed the need for a **Pedestrian Crossing:** pedestrian crossing and the need to undertake any preparatory works as soon as possible.

The Town Engineer agreed to have this examined.

Following discussion it was agreed that Mr. Kavanagh would discuss the proposed wording with Dr. T. Claffey.

Correspondence:

The following items from a letter from Parkmore Residents Association were discussed.:

Transfer of Keys of houses - Mr. Kavanagh stated this was not allowed and proceedings are instituted against any unauthorised tenants.

Dump Charges - There is a big gap between the £1 charge for cars and £10 for a van and the Commissioners asked that this be examined.

Erection of signs prohibiting horses and caravans.

Name of Estate - There appears to be two names for the estate and this should be corrected.

Gully at entrance to estate - Have flooding checked.

Vtos Scheme:

Commissioner Burke referred to a cutting from the Tuam Herald and urged that the Commissioners strongly support a Vtos Scheme for Tuam and that a letter be written to the Department of Education. This was agreed.

Letter from O.P.W. in relation to drainage of river Nanny was noted.

Letter from Private Secretary to Minister for Environment regarding deputation was noted.

Letter from Association of Municipal Authorities of Ireland in relation to closure of E.S.B. shops was noted.

Motion from Leixlip Town Commissioners was noted.

Letter from Patrick McMyler, Foxrock, Dublin who is doing research into the life of a James J. Corbett was read. It was agreed the Town Clerk would give whatever assistance possible

Notice of Motion:

- 1. Commissioner Burke proposed the motion and stressed the need for something to be done to slow traffic in the interest of safety. The motion was seconded by Commissioner Reilly and supported by other members. The possibility of a roundabout was also mentioned. The Town Engineer said that the traffic calming schemes mentioned by the Commissioners were on National Routes.
- 2. Mr. Kavanagh stated that motion was out of order as it proposed to reject a decision lawfully made by Galway County Council at its statutory Estimates Meeting. He said the motion would undermine the authority of the County Council to do its work and would have serious implications for the good relationship that existed between the two bodies. Commissioner Reilly said his complaint was that a number of houses were not connected to the sewerage scheme. There was a general discussion on charges including a proposal that there should be uniform charges throughout the country.
- 3. This motion about the replacement of footpaths was proposed by Commissioner Reilly who said that he had got complaints from residents and the cutback on the workforce seemed to be the cause of the problem.
- 4. Flooding at Dublin Road Mr. Kavanagh stated that this motion was out of order but could be put in order by substituting the words "County Council" for Town Engineer. The Town Engineer said that he hoped to rectify this problem early in 1996.

Referendum Posters:

Commissioner O'Grady mentioned that many referendum Posters were still in position and asked that those responsible have them removed.

The meeting then ended.
