Minutes of Monthly Meeting held on Tuesday, 3rd October, 1995

The prayer was recited.

The Chairman and members wished Mr. Declan Nelson a speedy recovery.

Supply:

Tuam Water The Chairman and members discussed the serious shortage of a water supply in Tuam in recent weeks. They complimented the Council staff on doing everything possible to alleviate the situation and notifying the public. They said that even when the new Tuam Regional Water Supply Scheme comes into operation, it might not benefit the town because of the faulty pipework system. This would be a ludicrous situation. Mr. Kavanagh agreed that the water shortage had been a serious one. The main cause was the drought which had affected many schemes but the old pipe network was a contributory factor resulting in loss of water through leakage. He said the Council had constantly monitored the situation and were in touch with the Health Board and only took water from the Clare River as a last resort. He said that a new pipe distribution system for the town had been planned as Stage Two of the Regional Scheme but the Council was now pressing the Department to bring that forward into Stage 1. The estimated cost was £350,000. On the proposition of Commissioner Browne-Lane, it was agreed to seek a deputation to the Minister to have the distribution system approved as quickly as possible. On proposition of Commissioner Burke, it was agreed to support Roscommon County Council's application for a sewerage scheme for Ballyhaunis which would improve the quality of the water of the Dalgan River which in turn flows into the Clare River.

Minutes:

On the proposition of Commissioner Burke, seconded by Commissioner Reilly, the minutes of meeting held on 5th September, 1995 were approved and signed by the Chairman.

Matters Arising: Town Hall:

The Chairman referred to the application of Tuam Theatre Guild for use of the old Library Room. Mr. Kavanagh advised that the Commissioners should not allow any group use any part of the Town Hall unless it was in good order, and appropriate rent paid and a leasing agreement entered into enabling the tenancy to be terminated at short notice. The Town Engineer stated that the Library Room was not in a safe condition and needed to be re-wired and heating provided. Following discussions it was agreed that the Town Engineer would meet representatives of the Theatre Guild and Christmas Craft Fair and show them the condition of the Library Room. The Commissioners asked that the Exhibition Room in the Library be considered as an alternative for the Craft Fair.

On the suggestion of Commissioner Biggins, it was agreed that the Assistant County Manager might meet Ms. Emer Colleran and Ms. Anna McHugh of the National Heritage Council, as an alternative to asking them to attend a Board Meeting.

Level Crossing:

Replying to Commission Kelly, the Town Engineer said that the road works at the level crossing would be started as soon as work on the Inner Relief Road was finished.

Toilets:

The Assistant County Manager said that the County Council was aware of the need and the Commissioner's desire for replacement toilets. The 'members asked that the Shambles Car Park be cleaned up and that the derelict site there be investigated with a view to incorporating it into the car park.

Urban Renewal: Commissioner Burke complimented the Council on the work being done and asked if walls would be provided at the River and alternative lights which would light the arches of the bridge. The Town Engineer confirmed that new walls would be provided and new lighting was also being considered.

Gilmartin Road:

The Commissioners asked that the Council's further plans for remedial works on houses on Gilmartin Road and also No. 56, be put on the Agenda for the next meeting.

Nuclear Testing:



SUBMISSION ON LOCAL GOVERNMENT RE-ORGANISATION

TUAM TOWN COMMISSIONERS - MAY 1995

- The functions and the staff of Town Government to be strengthened, particularly in existing large towns with Town Commissions, so that Town Government is given a meaningful role in the administration of local services and is responsive to the needs of the local community.
- The existing system has led to frustration among locally elected members of Town Commissions on the basis that the public perceive the Commission to be inactive and worthless while the reality is that the Commissioners have no effective statutory powers. The principle of subsidiarity should apply to Town Commissioners and services should be devolved to Town Councils which can adequately be performed by them.
- Town Councils should have responsibilities for the administration of housing, local roads, the distribution system of water supplies and sewerage, the provision and maintenance of footpaths, public lighting and green areas.
- Town Councils should have a consultative role with other statutory agencies (including representation on local committees for the delivery of health services, social services, education, industrial development and tourism promotion).
- The administrative area of the Town Council should be co-terminus with the franchise base, ie. all persons voting in the local elections in the town should have a voice on the Local Council and adequate financial resources should be made available to administer the Local Council including once-off starting funding together with annual disbursements thereafter from local sources (ie. proportion of the town rate, service charges, etc.).
- Formal linkages would be established with County Councils and Regional Authorities in the administration of local services, ie. the County Council would provide the headworks treatment plant etc., for sanitary services schemes with the distribution system being administered by the Town Council.
