

The Manager intorduced the Estimate of Expenses for 1995 which had been circulated to each Member and advertised. He said total expenditure proposed is £44,560 compared with £38,370 for 1994. Total receipts are estimated at £17,038 compared with £18,420. On the expenditure side he had allowed £3,600 for Members Expenses, £2,000 for Christmass lighting and £1,300 for a new Documents safe. The Estimate prepared will require a rate in the £ of 135.9 pence as against 99.74 pence for 1994.

The Commissioners examined the various items of expenditure and receipts proposed by the Manager in the draft estimate. APPROACH ROADS: The Residents requested that the approach roads leading out as far as the Golf Club to be repaired and improved.

CEMETERY:

The residents stated while this was the Towns concern, they expressed problems with the Caretaking of the Cemetery.

GLASS AVENUE:

Council laid pipes a few years ago on Glass Avenue. They removed the grass margin and replaced it with stones. These stones are quite dangerous, and the residents would like to have same replaced with grass. The wall leading up to Glass Avenue is in a dangerous state and likely to fall down.

LIGHTING:

The residents requested that public lighting be provided for the two houses near the Golf Club, and a light to be provided at the Cemetery.

The Commissioners thanked the Deputation and agreed to discuss the matters raised.

The Deputation then left.

DISCUSSION OF POINTS RAISED BY DEPUTATION

- 1. FOOTPATHS: Mr. O. Higgins, Town Engineer, stated that a number of footpaths needed repair. Footpaths on National Primary Roads where there is a large number of pedestrians using same were getting priority. Due to lack of money, it is not feasible to provide footpaths for the two houses near the Golf Club.
- DUMP: Mr. O. Higgins, stated that small quantities of belly grass are being dumped in the Town. He has been informed that same is harmless. The Commissioners are asking the County Council to make other alternative arrangements, e.g. why can't it be dumped closer to the source. It was stressed that this is one of the most important things to happen to Tuam and should be treated with the upmost speed and urgency. Mr. Kavanagh was in contact with Mr. B. Callagy for his assistance in drafting a Plan. The Chamber of Commerce could make submissions. It is hoped to have a Draft Plan available for the next meeting.

It was agreed that a letter be written to Minister Stagg thanking him for his assistance and advice.

The Manager presented a map of areas of Tuam, selected by the Planning Dept., Galway County Council, which it considered would qualify for Urban Renewal as per the guidelines set down by the Dept. Mr. Comer listed the areas: Area 1: This area is bounded by Foster Place on the north side, Shop Street on the east side, Chapel Lane on the west side and High Street on the south side. It has an area of approx. 2.5 acres (1.20 hectares). The area fronting Shop Street and Foster Place and (1.20 hectares). It causes severe traffic congestion in the town of Tuam and it would be of great advantage both to the town and to the farmers and those who use the mart, to relocate it to a more suitable site in the environs of Tuam where the road network would be more suitable to service same. This area could then be re-developed for commercial/residential use if designation were granted. which would be more suitable and would use the existing infrastructure rather than greenfield sites in the environs.

The primary purpose of the scheme is to promote the redevelopment and upgrading of run-down urban areas. The term "urban decay" would embrace all types of dereliction, run-down buildings, low grade uses, poor environmental conditions etc.

In general, areas located in or close to the centre of a city/town are considered most suitable for designation.

Designation is restricted both in terms of area and time. It is important that designation is not wasted by applying it to areas that will not be redeveloped.

The historic and architectural character of urban areas should be preserved hand in hand with new development. The potential of the scheme to promote the enhancement, and where appropriate, the bringing into everyday economic use of buildings of architectural or historic interest should be considered in selecting designated areas.

One of the primary aims of the urban renewal scheme is to encourage people to live in the centre areas of towns and cities. There is a strong focus in the taxation incentives of residential development expecially on refurbishment/conversion of existing buildings for residential purposes.

You should note that in addition to residential development, incentives are also available for commercial development (excluding office except where ancillary to other commercial development) and industrial development.

PROPOSED DESIGNATED AREAS FOR TUAM TOWN

Tuam town is located in the north of County Galway about 20 miles from Galway city. It is the largest town in this half of the county and vies with Ballinasloe to be the second largest town in the county. It is a scheduled town as designated by the 1963 Planning Act.

Taking into account the boundary extension for electoral purposes, the population of the town is estimated at over 5,500 persons. The Galway/Mayo Regional Study of 1983 projected a future population of Tuam and its environs of 8,300 persons in the year 2004 assuming an annual increase of 1.35% per annum.

Tuam town is centred in a large area of good agricultural lands and draws its support from this hinterland. It is a very important regional centre with large educational institutions in the town. Tuam flourished in the 60's, 70's and early 80's until the Sugar Factory in the town was forced to close in 1986 due to the economy at the time and following this, the Coca Cola plant and Ix Ltd closed so that there was a large increase in unemployment and the economy of the town suffered as a result. The growth of Galway city and the proximity of Tuam was also a factor in the decline of Tuam. That was a low point in the town of Tuam and since the beginning of the 90's many new local industries have grown with the aid of the County Development Team and the I.D.A. For the last few years the Bishops Conference has also added a new impetus to the town and is backed by the local Chamber of Commerce and the Town Commissioners.

A new sewage treatment plant costing over £8 million pounds has been installed in the town and a new Regional Water Scheme has been designed and tenders received.

Tuam is a very old town, parts of it dating back to the 12th century. The streets are narrow and little development has taken place in the town centre since the foundation of the town. In the 70's and 80's most new developments took place on the perimeter of the town so that there was a decline in the centre of the town where residential use also declined, a trend that occurred in many other towns.

Tuam then is ripe for the introduction of an urban renewal scheme which will promote redevelopment of decayed areas and encourage residential use in the town centre by refurbishing existing buildings as well as appropriate commercial and industrial development.

The following is a list of areas that should be designated for urban renewal in Tuam. It should be noted that all the following areas are located in an archaeological zone as designated by the S.M.R. Report prepared by the O.P.W. and U.C.G. and adopted in the Galway County Development Plan.

AREA NO. 1

This area is bounded by Foster Place on the north side, Shop Street on the east side, Chapel Lane on the west side and High Street on the south side. It has an area of approximately 2.5 acres (1.20 hectares). The area fronting Shop Street and Foster Place and High Street has a mixture of commercial developments with little first floor residential use. The Mill Museum, a heritage building, is located towards the centre of the Riverside Walk. It is an objective of the Town Plan to consider the preservation of this Mill. The remaining area is made up of back yards and sheds and is in an advanced stage of decay. In the Tuam Plan which was adopted in 1992, this area is zoned commercial. This commercial zoning permits residential development in certain cases. Some refurbishment of commercial/residential use has already been carried out on premises in Shop Street which is one of the main shopping streets in the town. The designation would further encourage such development.

AREA NO. 2

This area is bounded by Chapel Lane, the Telecom Eireann site and the Riverside Walk. It has an area of 0.22 acres (0.089 hectares) and is adjacent to Area No. 1. It consists mostly of derelict sheds. It is zoned commercial in the Town Plan.

AREA NO. 3

This area is bounded by High Street/Galway Road on the south side, Chapel Lane on the east side and the public car park and supermarket property on the north side. It has an area of 1.6 acres (0.647 hectares). This area is zoned for commercial use. The area fronting Galway Road/High Street comprises a mixture of commercial developments and again with little residential development. The area at the rear i.e. fronting the car park is made up of unattractive rear views and is made up of back yards, sheds, etc. There is obvious development potential in this area which would be enhanced by designation status.

AREA NO. 4

This area is bounded by the carpark on the south side, the Palace Grounds Road on the east side, the Palace Grounds on the north side and a supermarket property on the west side. It has an area of 0.7 acres (0.78 hectares). This is made up of a plot of ground on which the Presentation Convent had a boarding school. This building has a facade and arch and it is an objective of the Town Plan to secure their preservation. Permission was granted a number of years ago to convert this building to a supermarket with an office development overhead. Presently, it lies empty and is slowly deteriorating. This could be redeveloped as a commercial/technology based/residential property with apartments on the upperfloors. Designation would be a very strong promotional aid for this purpose.

AREA NO. 5

This area is bounded on the east side by Shop Street, on the south side by Bishop Street/The Square, on the north side by the River Nanny and on the east side by a car park, Palace Grounds and a supermarket. This block has an area of 3.5 acres (1.416 hectares). Replying to Commissioner Malion the Manager said everything was going along normally.

Town Hall:

The Manager informed that everything was going ahead as agreed. A letter from Tuam Theatre Guild was read. He also informed that a report requested was to be sent to the National Heritage Council.

Urban Renewal:

Replying to the Chairperson the Manager said plans were going ahead.

The Square:

The Chairperson welcomed Mr. Frank Gilmore, Design Dept, Galway County Council to the meeting. She explained the difficulties concerning the Square - large trucks and buses having difficulty getting round the Square, reduction of parking spaces, lack of Pedestrian crossings, trucks which had traditionally unloaded on the Square now unloading on Bishop street and causing obstructions. Commissioner Halion said High Street was the main entrance to the Town and should revert back to two-way traffic. Commissioner Burke said the complaints listed had been going on since the inception of the new Square. He also said traffic from Dublin road to High Street or Bishop street was prevented from moving at the same time. He said traffic should be permitted to stream both ways. He also said that if traffic from Tullinadaly road could turn right at Foster place it would make a difference. Commissioner O'Mara agreed with this and said at present all traffic has to go round a small island in the Square. Commissioner Kelly said the number of delivery trucks had multiplied in recent years and when one parked it delivered to a number of premises. Commissioner O'Grady suggested that part of the pavement outside the Town Hall be removed and let traffic slip onto High street also part of the pavement outside Square Deal. Commissioner Biggins agreed with this and said traffic

from Shop street to Bishop street could also slip away. Commissioner Stapleton said the design of the Square was excellent but traffic going to High street shouldn't have to queue behind traffic going to Bishop street. A reduction of the paved areas would solve this problem. He said the Square is Pedestrian friendly. He also said he would like to see the Dublin road to Vicar Street/Galway Road bypass completed immediately. He said the Taoiseach's comments the previous week were favourable and the onus was now on Galway County Council to finish the bypass also the Dunmore road to Milltown road link. He also said rumble strips were badly needed on Dublin road.

Replying Mr. Gilmore said People had asked for a roundabout at the Square He would look at the central island with a view to reducing it. He said he had observed the Square area for 1½ hours the previous week. On one occasion two articulated trucks had passed with difficulty. On another occasion a bus couldn't get round because of a parked car. He said there was a need for definite control on parking and suggested that "I hour" parking be strictly enforced. He said he wouldn't be some on Pedestrian crossings at the Square because traffic moves so slow. The chains are there to guide the Pedestrians. Regarding pedestrian crossings in other areas he said he favoured Pelican crossings. A survey was to be carried out on Dublin road. He said rumble strips were still experimental but could be installed if they were legalised. He said he would look at the items mentioned.

The Chairperson thanked Mr. Gilmore for attending the Meeting.
Replying to the Members the Town Engineer said some restoration work would be carried out at Vicar Street. He would recommend that Foster Place revert to two way traffic. He will be meeting with the new Superintendent shortly.

The Minutes of the April Meeting were adopted on the proposal of Commissioner Biggins seconded by Commissioner Flaherty.

The Minutes of the special Meeting were adopted on the proposal of Commissioner Burke seconded by Commissioner Flaherty.

ager's Business: The Acting Assistant County Manager told the Members that there should be agreement between the Town Commissioners and Galway County Council regarding the refurbishment work at Gilmartin Road.

It was proposed by Commissioner Burke, seconded by Commissioner O'Grady and agreed that Tuam Town Commissioners enter into an agreement with Galway County Council under "section 59" of the Local Government Act 1955 in relation to the remedial work scheme at Gilmartin Road, Tuam.

Replying to Commissioner Kelly the Manager said the 1993/94 scheme was in progress. Under the 1994/95 scheme it was proposed to demolish and rebuild eight houses. He also informed the Board that house No. 15 Gilmartin Road has come back into the ownership of the Town Commissioners. Refurbishment work has started at No. 75 Gilmartin Road. The Manager undertook to examine some spare ground at the back of Nos. 15 and 16 Gilmartin Road.
