The Prayer was recited.

The Chairman proposed a vote of sympathy to the Wife and Family of Richie Burke R.I.P. The Chairman and Members spoke of the shock of hearing of his death. As Overseer in the Tuam Engineering Area he was most helpful and co-operative and his death is a sad loss to Tuam. One minutes silence was observed as a mark of respect.

Minutes: Replying to the Members re: Public toilets the Assistant County Manager said that a report from the Architect on the future of the Court House has been received. The erection of a new Court House at Abbey Trinity with Public toilets is being considered by Galway County Council. The Members called on Galway County Council to erect temporary accomodation and the Town Engineer was requested to submit a report for the next meeting of the Board.

Playground equipment: Replying to Commissioner Mongan re: the St. Enda's Ave playground the Town Engineer said he would examine the situation. Replying to Commissioner Reilly re: the Palace Ground the Assistant County Manager said Galway County Council were proceeding as quickly as possible with the replacement of playground equipment.

Dump: The Members criticised the increase in cost of entry to the dump. They said if People cannot afford to use the dump there will be indiscriminate dumping and the resulting damage to the environment will mean greater cost to the County Council. They asked the Manager to consider some incentives eg: 'One free Saturday every few weeks' 'Free bags' 'If you buy four tickets get one free'. The Assistant County Manager stated that the charges at landfill sites were related to the cost of running the site. He said a directive from the E. U. prevents Local Authorities from subsidising the charges. Costs will increase further. There are new very very stringent safeguards for the Environment. Licencing for land fill sites will come in in 1998. It will cost millions of pounds to bring existing sites up to standard and develop new sites. The site in Tuam will be closed. The County Council were complimented on the clean-up on Sunday night/ Monday morning following the Football Match.

Urban  
Renewal:

The Assistant County Manager told the Meeting that an extensive Study of the impact of Urban Renewal Schemes in Economic, Social and Architectural terms has been completed at National Level. The new criteria to qualify for inclusion will be published before the next list of Towns is made known.

Commissioner Burke asked that a hole at the rear of Houses at Athenry road be fenced off.

Commissioner Joyce asked that the Dog Warden be requested to monitor the Palace Grounds as a Lady had been attacked by dogs there during the week. She also asked that dumping at Curragh Park be investigated.

The Chairman asked that the park at Newtownmorris be looked at re: rubbish.

Replying to Commissioner Burke the Assistant County Manager said the Control of Horses Act is now in place. A sub-committee in the County Council are studying same with a view to implementing the Legislation.

The Minutes of the May Meeting were adopted on the proposal of Commissioner O'Grady seconded by Commissioner Reilly.

Business:

The Assistant County Manager told the Members that work on the Town Hall has commenced. Demolition of the chimney and extension is proceeding also the waterproofing of the Clock Tower. The stage and balcony are to be demolished and a safe access to the Clock to be installed.

Commissioner Reilly said no animals should be allowed in the cemetery and immediate steps should be taken to rid the cemetery of wandering dogs. Regarding the hole in the field the sewerage problem seems to be solved but Residents are being denied access to the rear of their homes. The Town Engineer said the hole had been dug for drainage purposes and would be filled.

It was agreed to write to the Dog Warden.

At the outset of the meeting the Chairman advised the Members that the Special Meeting had been called to discuss proposals for the refurbishment/renovation to Tuam Town Hall.

Mr. Oliver Higgins presented a report to the Members, detailing the current position.

Phase 1 of the refurbishment works on Tuam Town Hall commenced in October 1992. Total expenditure amounted to £24,500. Grant of £6,000 received from an overall allocation of £35,000 from National Heritage Council. The work included the replacement of the leaded cupola over the Clock Tower, replacement of the roof on the Clock Tower, cleaning and pointing of stone work, repairs to roof, leaded valleys, flashings and gutters, and replacement of windows on ground floor.

The Engineer recommended that Phase 2 of the work would commence immediately with the aid of the Conservation Grant of £10,000 under the Urban and Village Renewal Scheme, Conservation Grants. The grant of £10,000 must be matched by a local contribution from the Town Commissioners amounting to £10,000. The work was to commence immediately as it was a requirement of the Scheme that all requests for payment must be received in the D.O.E. not later than the 20th November, 1997. The proposed works to consist of the following:

1. Clock Tower  
Remove internal brick leaf and reline with new inner leaf.  
Provide safe access to the Clock.
2. Demolish and remove old chimney at the rear of building.
3. Demolish and remove first floor extension at rear of building.
4. Repair leaks to roof and replace roof timbers where necessary.
5. Repair gutters and downpipes to prevent ingress of rainwater.

The Town Engineer pointed out that the bulk of the work was labour intensive and will be carried out by direct labour under the supervision of the Town Engineer. Work needed to be underway as soon as possible.

On the proposal of Commissioner Reilly, seconded by Commissioner O'Grady the Members unanimously agreed to the programme of works as detailed by the Town Engineer at an overall cost of £20,000. The Members also agreed that funds amounting to £10,000 be made available from the Commissioners own resources.

The Assistant County Manager stated that a detailed work programme and cost budget would be prepared which he would present to the Commissioners as soon as it was available. The work would be closely monitored to ensure value for money and that expenditure would be kept within the limits stated.

The Assistant County Manager also advised the Members that he hoped that Phase 3 of the refurbishment programme would get under way as soon as possible after the current phase was completed. This Scheme would be undertaken by FAS and he would pursue the question of the payment of the balance of the grant from the National Heritage Council to part-fund this expenditure. Phase 3 would essentially consist of internal works to the building including the provision of new staircases, provision of heating system, re-wiring, repairs to internal plaster work and redecoration.

Commissioner Reilly was wished a speedy recovery from illness.

The Chairman and Members paid tribute to Mr. Oliver Higgins, Town Engineer who is leaving. They said Mr. Higgins had been a tremendous friend to Tuam and his leaving is a major disaster. All present thanked Mr. Higgins for his contribution to the town over the past six years.

Mr. Higgins thanked the Members.

Minutes:

Replying to Commissioner Biggins the Town Engineer said a Pedestrian crossing will be erected on the town side of the relief road/Dublin road junction. Replying to Commissioner Burke he said a safety barrier would be erected at the junction outside Dr. Cunningham's house.

Toilets:

Commissioner Burke told the Meeting he hoped there would be a decision before the next meeting.

"Feile"

Commissioner Biggins proposed that the Commissioners investigate the possibility of holding a "Feile" in Tuam. Commissioner Burke agreed and said the Saw Doctors concert held a few year ago was still talked about. The Assistant County Manager stated the Town Commissioners could support such a venture, but could not get involved in directly organising such an event.

It was decided to invite local organisations to discuss the matter.

Palace Grounds

Replying to Commissioner Finnegan re: playground equipment the Town Engineer said prices are awaited. He expects the work to be in hand before the end of the month. Replying to Commissioner Browne-Lane the Assistant County Manager said the Dog Warden would be requested to inspect the play area.

The Town Engineer informed the Meeting that Galway County Council had approved the appointment of a gardener for Tuam.

Urban/Village  
renewal:

Replying to Commissioner Burke re: the extension of the Urban/Village Renewal Scheme to Abbey Trinity/Trinity Court the Town Engineer stated that the work at present being carried out under the scheme is from the bridge on the N17 to the bridge at Shop Street together with the upgrading of the Abbey Trinity car park. It was decided to write to Farragher & Co. and ask that they facilitate the upgrading of the area at Trinity Court. The Assistant County Manager told the Meeting there had been a substantial increase in the Urban/Village renewal grant for 1997. He said the grant for Tuam is £22,700. Galway County Council will provide £11,350 and a corresponding £11,350 will be required locally. It was proposed by Commissioner Finnegan, seconded by Commissioner Browne-Lane and agreed that Tuam Town Commissioners increase their contribution to the Urban/Village Renewal Scheme from £5,000 to £11,350 for 1997.

Christmas  
lights:

The Chairman welcomed a deputation from Tuam Chamber of Commerce - Mr. E. O'Driscoll, Mr. P. Lane and Mr. T. Joyce. Mr. O'Driscoll told the Meeting that lights are part of the Christmas spirit and project a good image of the town. He said the Chamber of Commerce administer the scheme but £2,500.00 is not sufficient. He said insurance alone last year cost £1,020.00. As rates are collected from business people this is the most fair way of collecting the cost of the lights. They envisage the cost to be £5,000.00 next year. He thanked the Members for meeting with the Deputation.

The Chairman and Members expressed concern at including such an amount on the rates. There had been a 25% increase in the contribution for 1997. Commissioner Lane said she had been approached by a trader who suggested running a draw and involving the wider community. Commissioner Burke noted the high cost of insurance and if there was any way it could be incorporated into the Town Commissioners insurance. The Assistant County Manager was asked to consult with I. P. B.

Town Hall:

The Assistant County Manager confirmed that £10,000 had been allocated towards the cost of refurbishing the Town Hall. - The money is to be spent by 30th September, 1997.

The Town Engineer presented drawings of the proposed layout of the refurbished interior of the Building. He said the existing stairs on the left of the entrance hall was not safe. He proposed installing a new stairs in the hall (drawing 3) and locating toilets where the old stairs is removed. He proposed that the dressing rooms on the first floor be demolished. He said the Arch on the old stage should be retained (drawing 4).

Replying to Commissioner Browne-Lane he said a lift could be accommodated at the left of the entrance door. Replying to the Chairman regarding the clock tower he said work on the inside of the clock tower should be carried out as a matter of urgency.

It was proposed, seconded and agreed that work be carried out on the Clock tower and the dressing rooms on the first floor be demolished.

I wish to inform you that the Department of the Environment has notified Galway County Council of its grants allocation for 1997 under the above scheme.


The 1997 Grant for towns is £68,000. This level of grant is significantly higher than anticipated. It is proposed to divide the £68,000 between the three towns of Ballinasloe (£22,600), Loughrea (£22,700) and Tuam (£22,700).

As a consequence of this increased grant, the level of matching funds will also have to be increased. Therefore, the contributions required from each Town Authority are set-out below:-

<b>Ballinasloe U.D.C. contribution</b>	<b>£22,600</b>
<b>Tuam Town Commissioners contribution</b>	<b>£11,350</b>
<b>Loughrea Town Commissioners contribution</b>	<b>£11,350</b>

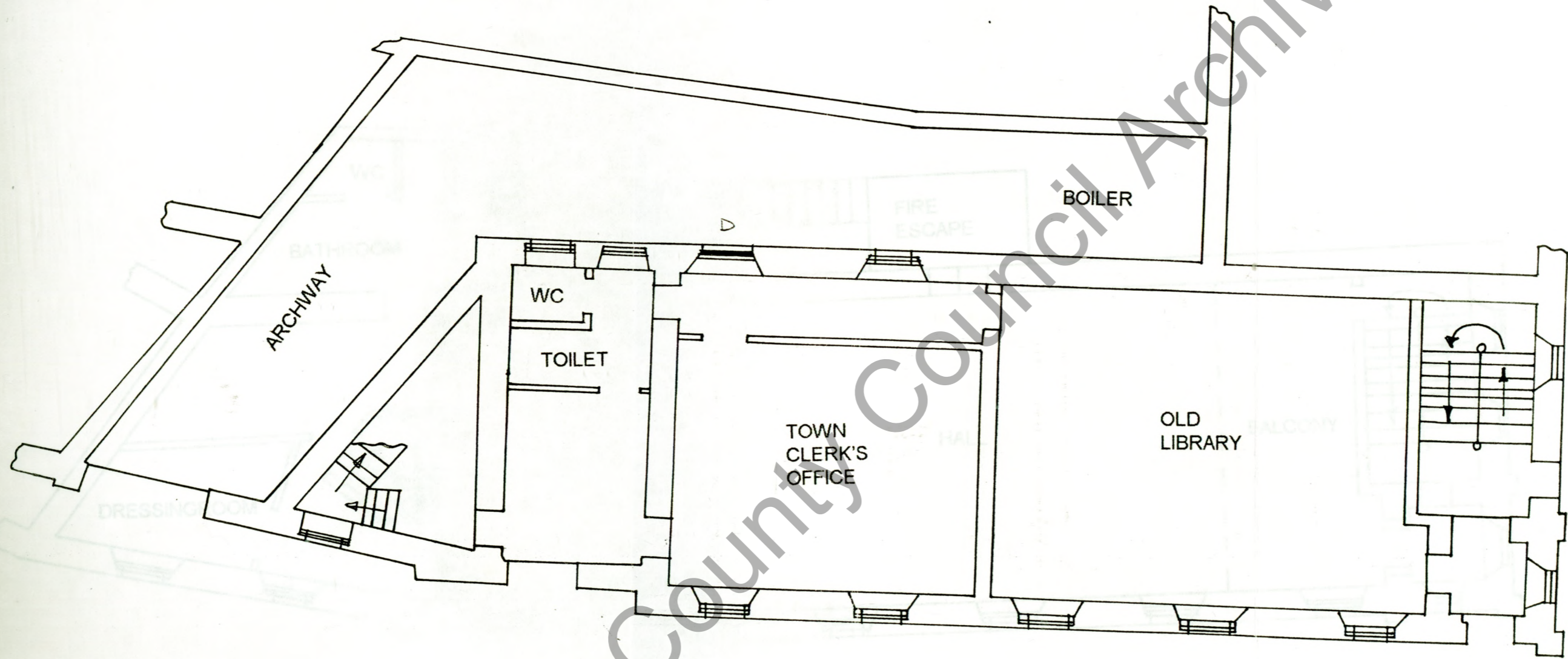
Plans will be prepared for additional works to be undertaken with the increased funding and these will be submitted to the Department of the Environment.

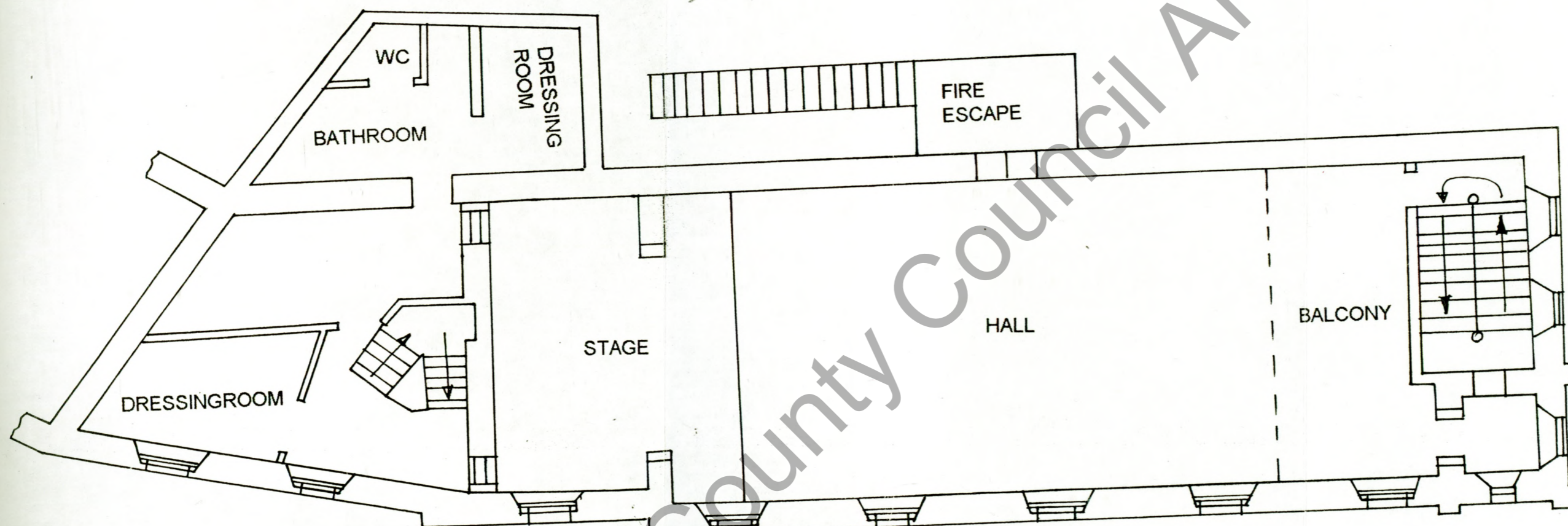

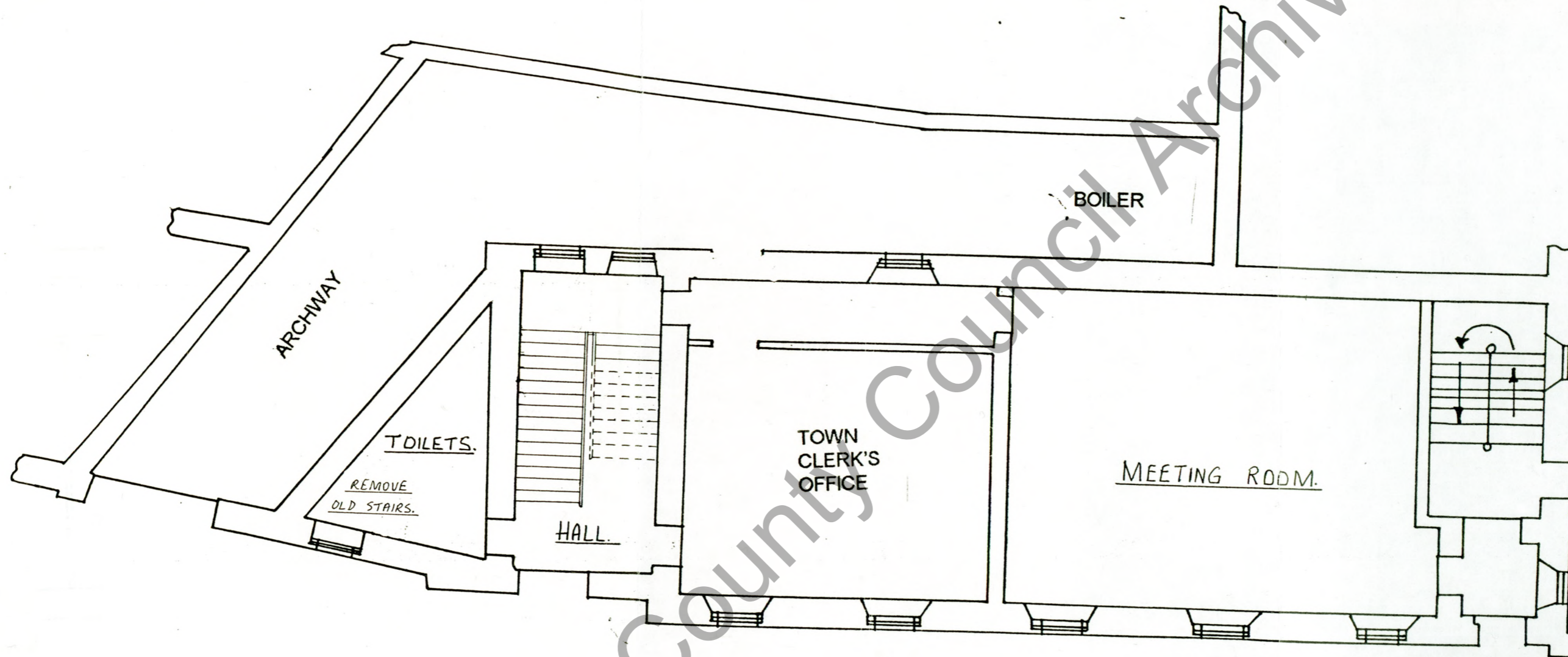
GROUND FLOOR PLAN

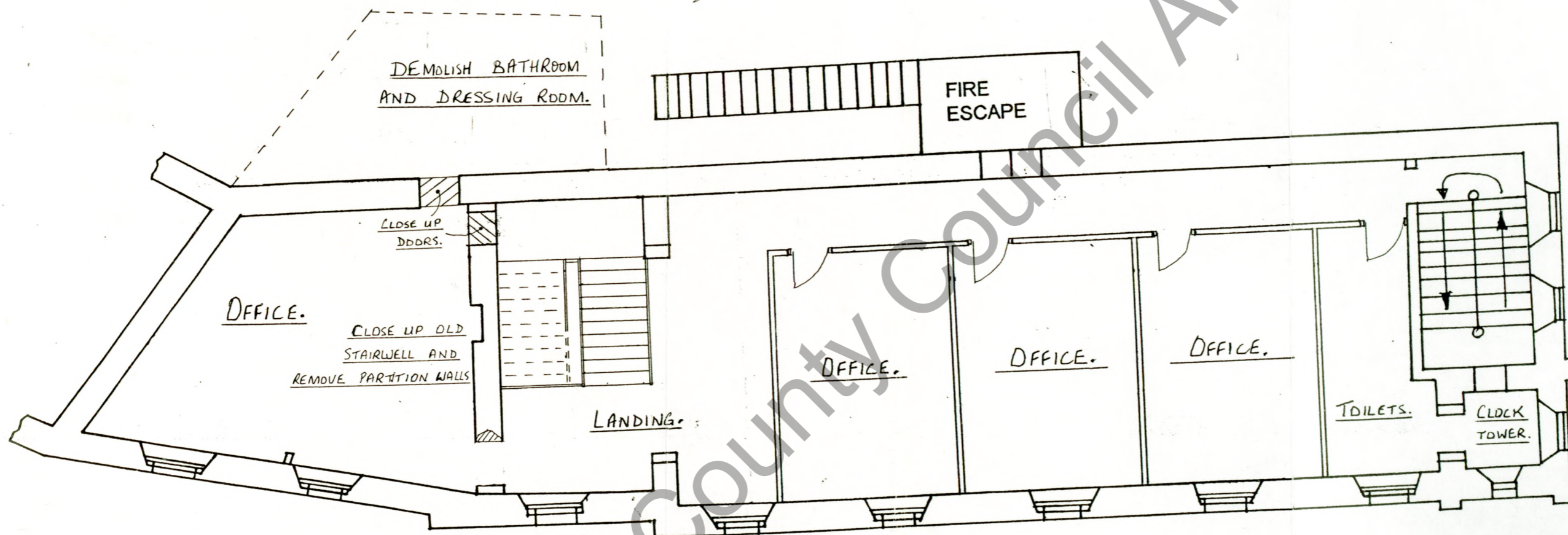
FIRST FLOOR PLAN

Commissioner Burke said the work done by the County Council under the Urban/Village Renewal Scheme was excellent but the Trinity Court side of the river was unsightly and dangerous. He proposed that the Urban/Village Renewal Scheme be extended. He proposed that Galway County Council be requested to extend the Urban/Village Renewal Scheme a further 100m. Commissioner Reilly seconded the proposal. It was proposed by Commissioner Finnegan, seconded by Commissioner Joyce and agreed that the Clerk write to the O. P. W. as stated also that they look at the river at Bishop Street and the Curragh with a view to carrying out maintenance work.
- (3) Commissioner Reilly spoke on his motion re: street lighting. He said Galway Road lost one light following an accident and it needs to be replaced. He also said that where the Town Boundaries were extended lighting should also be extended. The Town Engineer stated that the Public Light programme for 1997 has been passed and none of the areas mentioned were included. He said the light at Galway Road is being processed under an Insurance Claim. He said there was no existing E.S.B. network near ballymote. The Assistant County Manager said Galway County Council would be making a case to the National Roads Authority regarding lighting in Tuam. It was agreed to write to the N. R.
