The Minister for Housing and Urban Renewal Mr. Robert Molloy T.D. on the 17th February, 1999 decided to approve the Integrated Area Plan for Tuam and to designate for Urban Renewal certain sub-areas within the I.A.P area recommended by the Expert Advisory Panel. (see attached maps).

A Schedule is set out here under of the decision regarding each of the sub-areas within the Tuam I.A.P and the incentives recommended. With effect from the 1st March, 1999 the Minister for Finance will apply the residential tax incentives only (and as set out in the Schedule attached for Tuam). These residential incentives will apply for a three year period expiring on 28th February, 2002.

As far as commercial incentives under the new scheme are concerned the position remains that it is not possible to proceed with the application of such incentives at present because the E.U. Commission has not as yet given its approval to the application of these incentives. Once the decision of the E.U. Commission is forthcoming a further circular will issue outlining the terms on which incentives for commercial development can be applied for the purposes of the new scheme.

A Chara,

I wish to refer to my previous reports of the 28th January, 1998 and 5th May, 1998 in connection with the above. Since 1995 approximately £80,000 has been spent on the conservation and refurbishment of the Town Hall.

To date the grants which have been made available towards the project are as follows;

- a) £10,000 under the Urban Conservation Measure of OPLURD
- b) £13,760 from the Heritage Council

A further £6,240 will be claimed from the Heritage Council within the next couple of weeks. Total grants will then have amounted to £30,000 with a net outlay to date for the Commissioners of £50,000.

Galway County Council under its Millennium Scheme approved an allocation of £100,000 for the Town Hall Project. There will also be further monies totalling £15,000 available from the Heritage Council. Together with the recently approved FAS Scheme this will enable major works to be carried out to the Town Hall over the next year to year and a half.

The proposal is based on moving the Town Clerks Office and the proposed Council Chamber to the first floor area. In order to maintain the integrity of this area the Architect suggests that any partitions should be mobile. This proposal will also involve the installation of a lift.

The ground floor area would then be available for use by other agencies. One suggestion is to make it available as a one stop shop. I would propose making a submission to the Department of the Environment and Local Government for funding under this heading. If this submission is not successful alternative uses can be considered.

Subject to the approval of the Commissioners the Council will proceed on this basis. When overall costings have been put together I will revert to the Commissioners to finalise funding arrangements.

The FÁS Scheme is scheduled to commence work in June. In the meantime I have asked the Housing Section of the Council to quote for the completion of the ceiling/wall/insulation/plastering etc on the first floor. Subject to a satisfactory quotation we will continue with this work over the next few months.

Further to our meeting on Friday 22nd January 1999, I now enclose a sketch proposal on the basis of our agreed accommodation schedule at that meeting.

At ground floor level I have simply indicated the rooms as they function at the present that is as a town clerks office and old library. The area where the original staircase was, I have indicated as storage but it could form a small office.

At first floor level we have provided, as you requested, a Council Chamber, which is subdivided by a mobile partition and this subdivision allows for an office in the area adjoining the lift lobby. We have also provided a kitchen, new male toilets and new female toilets, all off the lobby where the original staircase existed. During the course of our discussions we talked about the cost of a lift installation and I suggested that it would probably be in the region of £60,000.00 I know you are anxious to try and put an overall costing on the project and this is not easy in view of the potential of the FAS scheme. However, I am sure that if a proposal can be agreed in principal then this detail can be discussed and resolved.

Our sketch proposal is based on the survey drawings you supplied and obviously it will be necessary to check these out before we can commit final drawings to paper. But again this can proceed when you have agreement from the Councillors on the project in principle. I hope this information meets with your present requirements and I await your further instruction.



They thanked the local organisations who arranged Flags and the Fireworks. They thanked Roaches, Glynns, D. Marley, O'Neills, St. Jarlaths Credit Union, Tuam Brass Band, The Saw Doctors, Rita Flaherty, Bus Eireann, The Gardai Siochana, The Press and TV crews. They thanked the Galway Football Board, Commissioner Kelly and in particular the Manager and Players for their memorable performances. All present joined in congratulating the Galway Football Team.

Minutes:

The Minutes of the September Meeting were adopted on the proposal of Commissioner Burke seconded by Commissioner Browne-Lane.

Matters arising from Minutes:

Bye-Laws:

The Assistant County Manager told the Meeting that publication of the draft Bye-Laws had been delayed. It was agreed that Supt Fennell be invited to the next meeting of the Board i.e. on 27th October, 1998.

Waste:

The Assistant County Manager confirmed that the Landfill site at Tuam had closed. A temporary transfer/recycling facility is available there at the moment. Following points raised by the Members at a special meeting the County Council are examining ways of collecting unusual/big items. This collection may be carried out two or three times per year and would be advertised. There will be Public consultation before a decision is taken on the location of a permanent Transfer Station. Galway County Council are recruiting Environmental Officers and seminars will be held. He advised the Public to avail of the private collectors to the maximum extent possible.

Gilmartin Road:

The Assistant County Manager informed the Members that the contracts for the refurbishments works at Gilmartin Road will be signed shortly. Replying to Commissioner Biggins he said there were 150 households on the waiting list for housing. Replying to Commissioner Kelly he confirmed that an Architect had been appointed regarding site at Weir Road. The Plans will be advised to the Town Commissioners in due course. He expect work to commence in mid 1999.

Parkmore:

Regarding site at Parkmore the Assistant County Manager stated that it was proposed to have private sites and voluntary housing plus a GAA and soccer pitch which would be available to the People of the estate. Commissioner Burke asked that an area near the river be included in the proposed plans.
