





Minutes of Monthly Meeting held on Monday 3rd December, 2007

The Prayer was recited.

The Minutes of monthly meeting held on Monday 5th November, 2007 were adopted on the proposal of Councillor Reilly seconded by the Councillor O'Donnell-Brady.

Matters arising from Minutes:

Replying to Councillor McHugh regarding parking at Liam Mellows Street Mr. Gilmore said the Draft Traffic Management Plan had not been advertised yet. There would be public consultation and suggestions are invited.

Councillor Browne-Lane asked if an area for parking of trucks would be considered by the County Council. Letter dated 21st November, 2007 from Valeo Vision Systems, logstrup Ireland Ltd. and Transitions Optical Ltd. and letter dated 29th November, 2007 from Pulse Electronics Ltd. regarding trucks parked overnight and over weekends on Dunmore Road between Parkvew Drive and Industrial Estates and between the Pulse building and College Green on the Dunmore Road were read. Mr. Gilmore said he would ask the Town Engineer to contact the Gardai.

Replying to Councillor O'Donnell-Brady, who said funding had been made available to provide street lighting at Dunmore Road, Mr. Gilmore said there were delays of up to twelve months with the E.S.B. Replying to Councillors Warren and McHugh he asked them to compile a list of areas where they are concerned that lighting is sub-standard. Councillor Warren welcomed the installation of ramps at the Lane. Councillor Flanagan asked if similar ramps could be installed on the road to the Park.

Councillor Reilly complimented the Town Engineer regarding meetings with the Taxi People and recommendations sent to the Roads Department, Galway County Council. The Deputy Mayor and Members thanked Mr. Gilmore for the recently held Forum on Drugs. They said the Forum was very informative, the speakers were excellent and there was a full house. Mr. Gilmore said he had spoken to Supt. Keane and tentative arrangements were made for another talk on home security and personal safety.

Manager's Business:

Mr. Gilmore told the Members that Section 183 notice, adopted at meeting held on 8th October, 2007 and amended had been referred to the legal advisors. In relation to granting of lease to Scouting Ireland – Tuam it may not be legal and may hold up Scouting Ireland. It was proposed by Councillor Kelly, seconded by Councillor Flanagan and agreed that original notice, as circulated to the Members, be adopted.

Email dated 26th November, 2007 from Tuam Chamber of Commerce – noted. Email dated 21st November, 2007 re: Ireland's first All Ireland Ecotourism conference-January 2008 – noted.

Grove Hospital:

Mr. Gilmore told the Members the procurement process initiated by the Health Service Executive is on track.

Tuam By-pass:

The Deputy Mayor welcomed Minister Kitt and Deputy Connaughton to the meeting. Deputy Connaughton stated that the original cost of the By-pass was estimated at E12M to E14M, it will be E20M. E4.5M of the initial E5M allocated has gone to land owners. The roundabouts at Ballygaddy Road and Weir Road have been taken out. Is the By-pass a stand alone project or linked with the Atlantic Corridor and the N17? Should the By-pass be removed from 'Transport 21'? Some months ago Mr. Barry, C.E.O., National Roads Authority said the Tuam By-pass was in competition with every road of its size in Ireland. It is vitally important that the By-pass be constructed as soon as possible. Minister Kitt said it would not be a good idea to remove the By-pass from 'Transport 21'. The By-pass, theN17 and Tuam/Claremorris road should be done in an integrated way. The Grade separation proposed for Ballygaddy Road will not affect traffic coming into town. It is hoped further funding will be made available when the estimates are published next week. Replying to Councillor Flanagan he said he would be attending a Capital Programme meeting in the morning.

The Members agreed the By-pass should remain in 'Transport 21'. Unless funding is made available by the Government the By-pass will not progress, they urged the Oireachtas members to ensure funding is provided for the construction of the Tuam By-pass.

Mr. Gilmore stated that the grade separation proposed for Ballygaddy Road is a positive, a better access and exit from the By-pass and is to be welcomed from a safety point of view.

Tuam has Hub status and the Government is now putting a greater emphasis on hub status. Galway County Council recognize the importance of Hub Status. Tuam will have first class links with the outside world, vital ingredients for the development of Tuam as a Hub town.

Councillor Browne-Land said Tuam hasn't seen any significant sign of Hub status. People are stuck in traffic on the N17 for hours each day. Tuam is choked and business is affected.

Regarding Hub status Mr. Gilmore stated that a meeting of County and City Managers who have Hub/gateway towns under their control has been convened by the Department of the Environment, Heritage and Local Government. There are lots of positives for Tuam, major programmes planned are - Water/Sewerage, the By-pass, N17/Atlantic gateway, Rail corridor and the Hospital. Tender documents for the water/sewerage programme have gone to the Department, start date is April. Ducting for Broadband will be included. Galway County Council will support all efforts to ensure Tuam gets Development.

The Deputy Mayor said next week was crucial and he hoped serious funding would be made available. He thanked Minister Kitt and Deputy Connaughton for attending the meeting and appealed to them to continue to press for the construction of the By-pass.

I. D. A. Ms. Maura Saddington:

The Deputy Mayor, the Members, Minister Kitt and Deputy Connaughton welcomed Ms. Maura Saddington, Area Director, West-Midwest Region, I. D. A. to the Meeting. Ms. Saddington told the Members the I.D.A. markets each town and region and each are competing with the other. She said the I.D.A.'s only business is to attract overseas business to Ireland and having advance factories built is a marketing tool. Overseas companies are looking to locate in Ireland and Europe. Replying to Councillor O'Grady she said the I.D.A. has a rolling list of building projects and comfirmed that a new 25,000 sq. ft. building on the Business Park, Dunmore Road, Tuam had gone to tender. She said it is up to the Government to develop target locations. The I. D. A. is constrained by E. U. regulations. Being so close to Galway is an asset for Tuam and when the By-pass and services are in place the town will be more attractive, - marketing is vital. Replying to Councillor McHugh she said it is up to local Councils to lobby to get Broadband which is crucial, some companies just want a site but in a very competitive environment it is easier to market a site with a high quality building. Replying to Councillor Reilly she said there had not been an enquiry from a 'major player' in the recent past however a query is being dealt with at the moment. Mrs. Saddington apologized for a misunderstanding which arose a few weeks ago in relation to an employee of the I.D.A. Following further discussion the Deputy Mayor thanked Mrs. Saddington for attending the meeting.

<u>A.O.B</u>.:

C.C.T.V.: Replying to the Members Mr. Gilmore said installation of poles etc. was due to commence this week.

Cemetery: Councillor Kelly said she had received complaints regarding the state of footpaths etc. in the older section of the cemetery.

Markets: Councillor McHugh complimented the People involved in the recent very successful market days.

The Shambles: Replying to Councillor McHugh Mr. Gilmore said an Architect had been appointed and plans will be brought before the Board, however work will not commence until the water/sewerage scheme is complete.

Courthouse: The Deputy Mayor stated that the negotiators were close to reaching a deal.

The Mall: Replying to Councillor Flanagan Mr. Gilmore said it will be some weeks before the road from the Mall is opened.

Councillor Warren asked that a house at Parkmore and a house at Athenry Road be visited by the Litter Warden.

Councillor Flanagan asked if it was possible to have the clock chimes ring in the new year.

Councillor Browne-Lane was wished a very happy special Birthday.

The Mayor welcomed Mr. Bonar and Mr. O'Riordian to the meeting and introduced them to the Members. He expressed the concern of the Board at the lack of an Ambulance base in the town.

Mr. Bonar said he was responsible for the Ambulance Service for the Western Region. An ambulance base for Tuam was approved in November 2006, was tied in to the Tuam Health Campus and couldn't progress separately. His department want to proceed independently with the Ambulance base and internal discussions are currently taking place with four options being considered: 1. remain as part of the Health Campus, 2, proceed independently from the Health Campus, 3, move to an independent site or 4, buy an existing building and convert. It is hoped to have a decision on this in February 2008, submit a planning application and go to tender in July 2008. Construction should be completed by September, 2009. Recruitment and training of Staff will begin in January 2008 and be completed in July 2009. Replying to the Members he said the Grove had been inspected and rejected on health and safety issues. Following further discussion the Members expressed their concerns at the lack of an Ambulance base in the town and paid tribute to Tuam Order of Malta. The Deputy Mayor thanked Mr. Bonar and Mr. O'Riordan, Deputy Kitt and the Members of the Order of Malta for attending the meeting.

<u>A.O.B.:</u>

Fire Brigade: Councillor Reilly complimented Mr. Gilmore on his speedy acquisition of a site for the Tuam Fire Brigade. Mr. Gilmore pointed out that the site had been purchased by Mr. Jim Cullen, Director of Services.

It was proposed, seconded and agreed to hold a civic reception for the Galway minors on the on the night of the Person/Group of the Year awards.

The Prayer was recited.

Budget of Expenses:

Mr. Gilmore introduced the Draft Budget of Expenses for the year 2008, which had been circulated to each Member and advertised. He proposed an increase in the rate of 4.1%. He said total expenditure for 2008 is estimated at E216,400.00 while receipts are estimated at E88,677.00.

He said he had included an amount of E20,000.00 for C.C.T.V. also increased the allocation for Town Enhancement and Urban Village Renewal as it was planned to carry out work in the Shambles car park and around the center of the town.

The Councillors examined the various items of expenditure and receipts proposed in the Budget of Expenses. Councillor O'Donnell-Brady proposed to increase the amount for "contribution to the Arts" to E1,750.00 and reduce "miscellaneous and other expenses" by E750.00. This was agreed to. Replying to Councillor Browne-Lane who said the condition of the Town Hall had deteriorated in the past year and was in need of painting Mr. Gilmore said funds would be made available for painting etc. Replying to Councillor McHugh who raised the issue of central heating in Town Council houses Mr. Gilmore said a programme was being looked at.

It was proposed by the Mayor, seconded by Councillor Warren and agreed that the rate in the Euro of E3.55 be adopted. It was proposed by Councillor Warren, seconded by Councillor O'Donnell-Brady and agreed that the draft Budget of Expenses, be adopted by the Councillors, that the net amount of E99,559-44. be demanded from Galway County Council in respect of year ending 31st December, 2008 and that the Form of Demand be signed by the Mayor and the Town Clerk.

This concluded the Meeting.



Grove Hospital:

They were informed the present cutbacks would not affect Capital Expenditure. The process is going according to plan, the builders could be on the site by late 2008 or early 2009. Mr. Gilmore stated that the matter was brought before the Town Council originally to provoke discussion. The skate board rink had been re-allocated to the Dublin Road area. He presented plans of the proposed two five-a-side multi-use pitches to be located on the site of the present coach park. The site would be managed and supervised by Aura and would add to the viability of the Swimming Pool and Gym. The matter had been discussed at the Tuam Electoral Area Committee meeting earlier that day and he had been requested by the Committee to bring the proposal before the Town Board as a matter of courtesy prior to a decision being made.

Councillor Reilly said the pitches would be fenced and floodlit and would facilitate Tennis, 5 a-side soccer, 6 a-side hockey and summer camps. He said a group of young People had collected approximately 600 signatures in support of the facility and these had been passed to Galway County Council. He presented copies of the signatures. Following further discussion and a vote (6 Members in favour of the motion) it was proposed by Councillor O'Grady and seconded by Councillor Browne-Lane that the motion be adopted.

Mr. Gilmore said he would convey their decision to the Tuam Electoral Area Committee.



Matters arising from Minutes:

Replying to Councillor Warren the Town Engineer said road works at Vicar Street would be completed the next day.

Replying to Councillor Reilly the Town Engineer said a new sensor was being fitted on the public toilet the next day.

Councillor O'Grady told the members that a report in a Galway based newspaper that Tuam Town Council had refused E600,000-00 for a skateboard park and two soccer pitches was totally untrue. All Members stated they welcomed expenditure of E600,000-00 on Youth facilities in the town, but not in the Palace Grounds. Mr. Gilmore stated that Mr. Kevin Kelly, Director of Services had presented plans and outlined proposals for the skate-park and two five-a-side all weather soccer pitches at Town Council Meeting held on 16th May, 2007. He informed the Council at that meeting that the funding cannot be transferred to another site. Mr. Gilmore said if the present proposals do not go ahead this money will be lost to Tuam. The matter is on the agenda for the Tuam electoral Area Meeting on Tuesday 2nd October, 2007. It was proposed by Councillor O'Reilly and seconded by the Mayor that Public consultation be initiated.

The Mayor stated that the Chain of Office had been discussed at a special meeting of the Board held on 17th September, 2007. It was agreed that a new "face" to include the town crest and "Tuam Town Council" be provided and the old "face" together with the excess links be put on display in the Town Hall. It was proposed by Councillor O'Grady, seconded by Councillor Kelly and agreed to refurbish the Chain of Office as outlined by the Mayor.

Manager's Business

Regarding CCTV Mr. Gilmore told the Members that planning approval under Part 8 of the Planning & Development Regulations had not yet been granted by Galway County Council nevertheless it is hoped CCTV will be up and running before the end of the year.

Councillor Warren stated that the Staff and Board of Management of the School are up in arms regarding the proposed development, the loss of the tennis courts and the proposed road. Councillor Reilly said locations were being sought for the amalgamation of the schools, different sites were being looked at and he felt there would be a breakthrough shortly regarding the amalgamation process. Councillor Flanagan said this development would affect the safety of students but if a site for amalgamation was identified there would be no objection. Councillor McHugh asked if an assessment of the impact of the Development on traffic in the town had been carried out. Sincere thanks for allowing us to speak to the meeting tonight.

The reason for requesting this deputation is to emphasize the urgency of the matter of the lease. (Section 183)

In 2004 we got approval of $\notin 110.000$, based on the letter dated the 15^{th} of January, from our solicitor O' Donoghue & Co. (see letter attached), but without the completed and signed lease no moneys could be released to us. The committee failed to acquire a signed lease and change of personnel in our unit resulted in the matter being put on the long finger.

Late 2006, a big interest in restoring the unit to its former size developed. The committee decided to reactivate the plans for refurbishing the hall.

The closing date for the draw down and completion of the grant was April 2007.

Despite the delay we have been able to appease the Dormant Account Committee; they have kindly extended the deadline for us. We don't know how long more they will give us, and they are at a stage that they are demanding a lease now. We are currently at risk of loosing the grant.

We have all other requirements met and a lot of time, work and money has gone into this already.

We are appealing to you to give this matter your **urgent** attention.

The Minutes of Annual meeting held on Monday 25th June, 2007 were adopted on the proposal of Councillor Reilly seconded by Councillor O'Donnell-Brady. The Minutes of monthly meeting held on Monday 25th June, 2007 were adopted on

the proposal of Councillor Warren seconded by Councillor Reilly.

The Minutes of Special meeting held on Monday 9th July, 2007 were adopted on the proposal of Councillor O'Grady seconded by the Mayor.

The Minutes of Special meeting held on Wednesday 18th July, 2007 were adopted on the proposal Councillor Reilly seconded by Councillor Warren.

The Mayor welcomed Deputy Kitt, Deputy Treacy and Deputy Connaughton to the Meeting, he also Welcomed Councillor Canney, Mayor of the County and Ms. Martina Maloney, County Manager. The Mayor proposed that discussion on CCTV be deferred to the JPC meeting which followed the ordinary meeting, also his Notice of Motion regarding the Chain of Office be deferred to the next meeting because of the long agenda.

Mayor Canney thanked the Members for inviting him to the meeting. He said he was well aware of the issues in Tuam and intended to work with the Town Council, Galway County Council and the Tuam Electoral Area Committee to find solutions. He said he was disappointed at vandalism at the new civic office site at High Street. E5m will be invested in this community facility which will also include a new branch Library. The fire station will be re-located to a new site. He said he would be meeting with the N.R.A. on Friday 7th September and intended to highlight the importance of the Tuam by-pass. He would also raise the terrible condition of the N17 through Tuam and he hoped to get answers from the N.R.A regarding funding. He said the opening of the railway corridor would be kept high on the agenda. The investment of E28m on major upgrading of water and waste water facilities, starting in February 2008, is welcomed and innovative planning should minimize disruption in the town. The Tuam Arts Festival has a positive impact on the town. 'Energise Tuam' held a very successful market day in August and another one is planned for September.

Ms. Martina Maloney, County Manager said she was glad to be in Tuam and felt positive for the future of the town, located on the Atlantic corridor and a Hub town. She said if everyone works together Tuam will fulfil the obligations set for it, the Mayor of the County had touched on the issues. She said there would be major population growth in Tuam in the next few years and plenty of land has been rezoned for development. She was anxious for Tuam to see further regeneration and the new library and civic centre was a welcome development. She said the by-pass was high on the priority list in the Roads Department, Galway County Council. In the area of Broadband she said Galway County Council will do all it can to ensure infrastructure is in place. She complimented the People on the RAPID programme. She said she looked forward to working with the Town Council over the years.

Deputy Kitt told the Members he supported the issues raised. He welcomed the County Manager and the County Mayor. In relation to the "Grove" he said he was in constant touch with the H.S.E. Regarding "expressions of interest" three to six developers have been mentioned. He hopes there will be an announcement soon - funding has been provided by the Government. Regarding the By-pass he said it was very frustrating it was taking so long, when the County Council meet the N.R.A. on the 7th September it is hoped to get a commitment. The inner relief road is also important and he hoped to see a quick decision in the amalgamation of the Schools. He said he is in constant touch with Minister O'Cuiv regarding the rail link and it is hoped to meet the target for Tuam – 2011. Regarding Broadband Tuam is well behind and it is hoped to make progress on that. He complimented the local RAPID committee. He supported the water/waste water upgrading and the different projects in the Town.

Deputy Treacy said he was delighted to attend the meeting. He welcomed the County Manager and said he looked forward to working with her in the future. Regarding the "Grove" he said he was pleased to be part of the Deputation that met with the H.S.E., who were unable to indicate a firm timescale for the development. Tuam wants its hospital as soon as possible. Regarding the Court House he said the O.P.W. advertised for a site in Tuam in August. Regarding the rail corridor he said it was a tribute to Minister Brennan that the project is back on track. Minister O'Cuiv is driving this at Cabinet level and he is totally committed to the project. He said two new amalgamated schools should open together. He said Broadband was disappointing in Tuam, the Government is committed to Broadband and he would continue to make representation on behalf of Tuam. He said he would continue to work on behalf of Tuam.

Matters arising from Minutes:

Mr. Gilmore told the Members he wanted to clarify that the contract for the water and sewerage scheme will include ducting for Broadband and Gas. The contract will include a provisional item for the construction of Broadband and Gas ducts - the intention is the need to re-excavate Tuam streets for services will be minimized.

Councillor O'Grady asked that a copy of the plans for the new civic offices be made available. Replying to Councilor O'Grady Mr. Gilmore said a full range of Council services would be available in Tuam. Councillor O'Grady said the last farmers market was held in Tuam last week, in future all traders will have to have a licence.

Councillor Reilly congratulated Old Tuam Society and Lavally Community on the unveiling of the WW2 Memorial.

Replying to Councillor McHugh Mr. Gilmore said a copy of the Traffic Management Plan would be circulated to the members as soon as possible.

The Mayor welcomed Mrs. Teresa Kelly and Inspector Aiden Foley to the meeting.

The Minutes of the inaugural meeting held on 23rd October, 2006 were adopted on the proposal of Councillor O'Donnell-Brady seconded by Councillor McHugh.

Matters arising from Minutes:

Supt. Keane stated that the Garda Commissioner had approved the Communitybased CCTV Scheme for Tuam and letter of approval was on its way to the County Manager.

Presentation by Supt. Seamus Keane:

Supt. Keane stated that An Garda Siochana has always sought to police with the good will of the People. The good will enjoyed by An Garda Siochana has in no small measure contributed to the success of An Garda Siochana. He said An Garda Siochana are committed to Community Policing, Ireland continues to evolve socially and economically, the Community policed today is very different from the community which he first policed. In some respects Community Policing is going back to basics. It is recognised as an advance that we now have Gardai on bicycles, this was normal years ago. An Garda Siochana is very much of the People with the Men and Women of the Force recruited from the thirty two counties, urban and rural and indeed now from the wider ethnic community.

He said the objectives of Community Policing are to provide a holistic policing service which addresses the needs of the Community, to develop even closer relationships with each of the communities served and to establish partnerships with the public and other agencies.

The four cornerstones of Community Policing could be described as collaboration, co-operation, commitment and involvement in the community. Collaboration and co-operation involves working with interested parties to eliminate or reduce a particular problem for example Public Order, working with publicans and off licences to combat Underage Drinking. Visiting schools to talk on issues of Road Safety, Bullying etc., supporting local initiative such as CCTV for Tuam, working with the business community by use of crime prevention services to reduce the risk of crime, juvenile liaison service to divert young people from the criminal justice system, working with the housing authority. Working with the Joint Policing Committees, Establishing youth diversion programmes such as the scheme currently being established in Tuam. Seeking to maintain or review Neighbourhood Watch Schemes and Community Alert Schemes, to develop closer links with members of the various ethnic communities, listen to the community and recognize their policing needs by fully engaging with bodies such as JPC, Resident Groups, Travellers Groups and Business Groups. In a time when people seem to have less time to give to peighbourhood watch schemes and community alert schemes these

time to give to neighbourhood watch schemes and community alert schemes these schemes become more difficult to maintain or establish. An Garda Sciohana need the co-operation and assistance of the Community.

Replying to the Councillor Browne-Lane regarding drug use among young people Supt. Keane said it would be naive to think this matter does not need attention. He said the Gardai now have a drugs unit in Tuam and two members recently spent time training with the Drugs Unit in Galway. He said the Gardai had drawn up a plan to deal with drugs and other issues. This plan will be presented at a future JPC meeting. Deputy Connaughton stated that a recent survey which he had conducted revealed that 80% of People were of the opinion that there were a lot of drugs in East Galway and 50% of People were of the opinion that there were a lot of drugs in their area. Councillor O'Grady said it would be helpful if An Garda Siochana addressed Parents and Leaders of the community on drugs. He said drugs frighten people and he suggested holding an open Forum on drugs, in conjunction with other organizations in the town - on a question and answer basis. Councillor Kelly suggested holding meetings area by area in the town as this would also enable people to get to know their neighbours. She also said it was important to involve young people, who could be encouraged to set up workshops themselves with the held of an adult co-ordinator. David Collins, Community Development Officer said a lot of organizations in the town had people dealing with the issue of drugs. Pat O'Hora, RAPID agreed with this. He said it was difficult to get community representatives to speak for their community and said RAPID may have a function in co-ordinating and liaising with the different organizations.

Mr. Gilmore stated that Adults and Parents also need education on drugs. He realized it was difficult to get people involved as the Town Council had placed an advert in the newspapers, prior to this meeting, requesting questions from members of the public but there was no response. The Town Council would host an open forum on drugs, this would help to bring the various organizations together. He said he was open to ideas and would prepare a draft.

Ms. Ann Mallaghan, RAPID Co-ordinator who was unable to attend the meeting sent the following, which was circulated to the Members:

Tenders have been sought and received for the provision of the proposed Community CCTV System for Tuam Town. As this programme is being funded by two government Departments (Department of Justice and Department of Community, Rural and Gaeltacht Affairs) and managed by POBAL on their behalf,

copies of tenders received and quotation for any associated works are to be assessed by POBAL who will approve a recommendation for award of tender. A report has been prepared for POBAL on the tenders received and a quotation for outstanding civil works and provision of electricity supply to the sites is being completed. An application for planning under Section 4 is presently being prepared based on confirmation of the exact sites of the poles and it is hoped to advertise this in next week's papers. An application was made to the Garda Commissioner for authorization for the Local Authority to operate the proposed CCTV system prior to Christmas, and a reply to this is expected from the Garda Commissioner shortly. This in turn must also be submitted to the office of POBAL prior to their giving an approval to proceed.

No licence for the broadcasting frequency of the proposed CCTV system is deemed to be necessary.

It is anticipated that should all these steps be completed as planned, that the CCTV system for Tuam Town should be installed during June or July 2007.

The Mayor proposed a vote of sympathy with An Garda Siochana and Limerick County Council on the death of a Garda and a Fire Officer at the scene of an accident over the weekend.

Grove Hospital: Letters dated 13th June and 18th June, 2007 from Mr. Alex Maclean, A/General Manager, Galway Primary, Community & Continuing Care, Health Service Executive were read. The Members expressed disappointment with the letters. The Mayor told the Members he had personally written to Ms. Priya Prendergast requesting that she meet with the Town Council. <u>C.C.T.V.</u> The Members expressed outrage at the damage done at Tuam Swimming Pool. Replying to Councillor Flanagan Mr. Gilmore said there would be no difficulty in introducing by-laws. He said he would look at options and come back to the Board.

Joint Policing Committee:

It was proposed by the Mayor seconded by Councillor Reilly and agreed to call a meeting of the Joint Policing Committee.

Traffic Management Plan:

The Town Engineer introduced the draft Traffic Management Plan. The Members discussed the various proposals in the plan. It was agreed that a copy of the draft plan be circulated to the Members. All submissions to be sent to the Town Engineer. The Mayor and Manager thanked Mr. John Leahy, Executive Engineer and Mr. Peter Gavin, Town Engineer for their work in preparing the Traffic Management Plan.

<u>A. O. B.</u>

It was proposed by the Mayor seconded by Councillor Reilly and agreed to invite Councillor Canney, Mayor of County Galway to the next meeting of the Board.

Business Improvement Districts Scheme:

A copy of Commencement of Business Improvement Districts Legislation and Making of Ratepayer Plebiscite Regulations had been circulated to the Members. Mr. Gilmore explained: A Business Improvement District Scheme is an organisationa dn financing mechanism, through which the business community can develop and implement projects, services or works in defined areas to improve those areas for the betterment of the local environment. Before a BID Scheme can proceed it requires the holding of a ratepayer plebiscite, the support of a majority of ratepayers and the approval of the rating authority. A BID Scheme is financed by contributions from the ratepayers in the area.
