Minutes of Monthly Meeting held on Monday 14th June, 2010

Present:

Mayor: Councillor Flanagan

The Prayer was recited.

The minutes of monthly meeting held on Monday, 10th May, 2010 were adopted on the proposal of Councillor Reilly seconded by Councillor Kitt.

It was agreed to hold the Joint Policing Committee on Monday 5th July, 2010 in the Town Hall at 7 p.m., prior to the ordinary meeting.

Matters arising from the Minutes:

Replying to Councillor Warren regarding a clean-up at Gilmartin Road Mr. Leahy said a clean-up will be carried out in the next few weeks. What is happening in this area is unacceptable. In a follow-on to the clean up he said Officials and Wardens will visit houses for proof of disposal of waste.

Replying to Councillor Kelly regarding the Tuam Leisure Centre Councillor Flanagan said she would contact the County Manager.

Councillor Kelly thanked the Town Manager for the provision of footpaths at Weir Road. She said she hoped the lights would also be attended to.

Regarding the Old Library Building at Shop Street it was agreed to invite Mr. Pat O'Hora, RAPID to the next meeting. The Town Clerk informed the members that Ms. Ann Mallaghan, RAPID Co-ordinator would be unable to attend the meeting.

Replying to Councillor Bane regarding the Tuam Water and Main Drainage Scheme Mr. Gilmore said Coffey's have a contract with Galway County Council. He could not give them an instruction to attend a meeting of the Town Council but he would get updates on progress at intervals. Replying to Councillor Ward he said the Resident Engineer would be available. It was proposed by Councillor Reilly seconded by the Mayor and agreed to invite the Resident Engineer to a meeting. Councillor Loftus asked if Dublin Road could revert to two-way traffic for the duration of the Scheme.

Replying to Councillor Kitt regarding traffic calming at Demesne Mr. Leahy said new footpaths will be constructed in the area in the Autumn and installation of ramps will be considered then.

Replying to Councillor Warren regarding house repairs at a house in Tirboy Mr. Gilmore said repairs would be carried out.

Manager's Business:

Mr. Gilmore told the Members he had no further news regarding the Court House.

Regarding the Ambulance Base he said Galway County Council requested further information regarding planning and this is awaited.

Correspondence:

The following letters were read, noted and agreed:

Letter dated 14th May, 2010 from Castleblayney Town Council – read. Letter dated 14th May, 2010 from Monaghan Town Council -read. Letters dated 26th May, 2010 from Deputy Paul Connaughton – read. Letter from Association of Municipal Authorities of Ireland regarding "Democratic Local Government" – to be circulated to the Members.

Tuam Stadium:

Councillor Reilly said he would try and contact the Manager of the Galway Football Board.

Notices of Motion:

(1) Councillor Ward spoke on his motion proposing a preservation order for the Palace Park. Replying Mr. Gilmore stated that the Park is zoned an amenity in the County Development Plan.

(2) Councillor Ward spoke on his motion proposing that the Town Council be acknowledged as part of the governing body of the Palace Park. Mr. Gilmore stated that Galway County Council is the owner of the park. The park wouldn't be the subject of a protection order but would be a matter for Galway County Council as a planning authority. The Tuam Area Committee is the forum to discuss this matter. The Mayor may sit on the Tuam Area Committee and may speak and vote on any matter. Joint meetings of the Electoral Area Committee and the Town Council are held on a regular basis. The Manager said he would arrange a meeting.

The revised edition of the Tuam Area Plan is due to be presented to the Tuam Electoral Area Committee shortly and a presentation can be arranged for the Town Council.

A. O. B.:

Replying to Councillor Kitt regarding the swings at the park Mr. Leahy said they would be re-instated this week.

Replying to Councillor Bane regarding trees Mr. Leahy said funding is limited but he would look. Regarding a "yellow box" at the Ballygaddy Road/Milltown Road junction he said he would investigate following completion of the Tuam Water and Main Drainage Scheme. Regarding Liam Mellows Street he said everybody is entitled to park on a public road. Replying to Councillor Ward Mr. Gilmore said the problems being experienced on match days could be resolved by discussions between the Residents and the Stadium Committee.

It was proposed by Councillor Reilly seconded by Councillor Kelly and agreed that a FAS Scheme be sought for the cemetery in an effort to keep the grass cut and the cemetery maintained.

The Mayor stated that she would like to hold a clinic in the town hall one evening per month. This was agreed to.

It was proposed by Councillor Loftus seconded by Councillor Reilly and agreed that a Civic Reception be accorded to the Special Olympic's winners.

The Mayor welcomed everyone to the meeting and thanked them for attending.

Addressing the meeting Mr. Colman O Raghallaigh, Spokesman, West on Track said West on Track was launched seven years ago and thanked the community of Tuam for their support. Phase 1, Ennis to Galway, of the western rail track was opened on 29th March, 2010. This has been an outstanding success with a high rate of traveler participation. A commitment is now required from Government to begin phase 2, Athenry to Tuam.

Addressing the meeting Fr. Micheal McGreil, Secretary, Western Intercounty Railway Committee said the Western Intercounty Railway Committee was set up 31 years ago to lobby Government to press for the opening of the line from Sligo to Kilclooney. The aims of the committee are to restore the railway network, in the short-term Athenry to Tuam, medium-term Tuam to Claremorris, long-term Claremorris to Sligo and eventually to Derry. He paid tribute to Deputy Seamus Brennan, R.I.P. who instructed C. I. E. to carry out a feasibility study on the project and saved the tracks.

Councillor Michael McGreal, Chairperson, Western Intercounty Railway Committee said a commitment was made in 2006 to have railway line opened in Tuam in 2011. He thanked Deputy Kitt and Deputy Treacy for their support and complimented the Mayor on calling the meeting.

All present welcomed the recent opening of Phase I (Ennis to Galway) of the Western Rail corridor and noted that it is proving itself to be most successful. They reiterated the need to progress Phase II (Athenry to Tuam). They said this would be even more successful and the line could be upgraded at very little cost.

It was noted that the Minister for Transport Deputy Noel Dempsey, T. D. has been requested to meet a deputation regarding progressing Phase II (Athenry to Tuam) of the Western Rail Corridor. It was noted that Tuam Station will be 150 years in operation on 27th September, 2010. It was also noted that Tuam will be celebrating 150 year of Local Government in 2013.

It was agreed to write to Mr. Noel Dempsey, Minister for Transport, Mr. Richard Fearn, C. E. O., Iarnrod Eireann, Dr. John J. Lynch, Chairman, C. I. E. Group, Mr. Brian Lenihan, Minister for Finance and Mr. Eamon O'Cuiv, Minister for Social Protection.

The Prayer was recited.

The minutes of monthly meeting held on Monday, 12th April, 2010 were adopted on the proposal of Councillor Warren seconded by Councillor Kitt.

Matters arising from the Minutes:

It was proposed by the Mayor, seconded by Councillor Kitt and agreed to hold the meeting regarding the Western Rail Corridor on Monday 24th May, 2010 at 7.30 p.m. in the Town Hall. It was proposed by Councillor Flanagan, seconded by Councillor Loftus and agreed to invite Mr. Noel Dempsey, T. D., Minister for Transport to the meeting.

Regarding the Tuam Leisure Centre Councillor Flanagan told the Members that she had been informed by Ms. M. Maloney, County Manager that Galway County Council had met with the Operators of the Leisure Centre.

Replying to the Members regarding the Gilmartin Road area Mr. Gilmore said all houses owned by Tuam Town Council and Galway County Council have been boarded up. Action will be taken regarding other abandoned houses. A Clean-up of the area will be organized very quickly. The co-operation of the Residents and the Public is required. Replying to Councillor Warren regarding the installation of a C.C.T.V. camera he said this would be considered. Discussions are taking place with the Department of the Environment regarding a remedial scheme for the area. The Members welcomed the boarding –up of empty houses.

Replying to Councillor Warren regarding vacant houses at Parkmore Estate Mr. Gilmore said a contractor has been appointed to refurbish these. Replying to Councillor Kelly regarding a recently erected picnic bench at the entrance to Parkmore Estate and the ensuing litter problems he said this would be investigated. The Mayor stated that the area is due to be cleaned in the morning.

Replying to Councillor Flanagan regarding the Old Library Building at Shop Street Mr. Gilmore advised that the interested parties submit proposals to Galway County Council.

It was proposed by the Mayor, seconded by Councillor Kelly and agreed to write to the Transition Year Students, Presentation College and compliment them on the reenhancement project at Bishop Street.

Replying to Councillor Cunniffe regarding 'trial trenching' Mr. Gilmore said work is being carried out at night in order to disrupt traffic as little as possible. Replying to Councillor Bane he said the Engineer in charge of the Tuam Water and Main Drainage Scheme would attend meetings of the Board occasionally.

Regarding Tuam Stadium the Mayor told the Members that the Manager of the Galway Football Board will come to a meeting of the Town Council.

It was proposed by Councillor Flanagan, seconded by the Mayor and agreed to invite Ms. Ann Mallaghan, RAPID Co-ordinator to a meeting.

Regarding the **Court House** Mr. Gilmore told the Members the Courts Service hope to be gone from the Town Hall in June.

Councillor Kitt asked if ramps could be installed at Demesne Cottages. He also asked if something could be done about wandering dogs in the park.

Replying to Councillor Warren regarding ramps at the Dublin Road Estate Mr. Leahy said he would investigate. He also agreed to check regarding lighting at Athenry Road and Tubberjarlath Road.

Councillor Loftus asked if something could be done to stem the flow of people leaving Tuam to shop in other towns. She proposed that the Board invite Mr. John Stapleton, President, Tuam Chamber of Commerce to a meeting. The proposal was seconded by the Mayor. Replying to the Members Mr. Gilmore said Galway County Council had granted planning permission for several developments in Tuam but have been frustrated by An Board Planala, An Board Planala can overrule the County Council. Galway County Council had offered land to a developer in an effort to try and stimulate the Tirboy Area but the developer has now dropped his plans. He welcomed the recent granting of planning permission to Mr. O'Toole. Regarding the proposed development at Milltown Road the Mayor stated that An Board Planala had extended the decision making date to the end of May.

13. —(1) A local authority may by resolution adopt this Part in respect of the whole or a specified part of its administrative area and may by resolution rescind such adoption.
(2) For the purpose of this section the administrative area of the council of a county shall not include any borough, urban district or town.
(3) A resolution shall not have effect unless not less than one month's notice of the intention to propose it has been given in writing to every member of the local authority and has been published by advertisement in at least two newspapers circulating in the area to which the proposal relates.
(4) A local authority on passing a resolution shall cause notice of the fact to be published in at least two newspapers circulating in the area to which the resolution relates and shall as soon as may be send a copy of the resolution to the Minister.

In reply to your letter dated 31st March last, I enclose an extract from part 3 of the Gaming and Lottery Act 1956. Where this part has been adopted, applications can be made to the District Court for the issue of a licence permitting Gaming at an amusement hall or funfair. Where the Act has not been adopted, or where, as appears to be the case in Tuam it had been adopted but was subsequently rescinded, Part 3 then does not apply, and no application can be made therefore for a Licence under the Act.

The correct response to their letter would be that the Councils Records show that The Town Council (then the Commissioners) resolved to rescind part 3 of the Gaming and Lottery Act 1956.

As a matter of interest I located on my file the minutes of a County Council meeting on the 23rd February 1957. During that meeting the Council did adopt Part 3 of the Gaming and Lottery Act 1956 in respect of County Galway excluding the towns of Loughrea and Tuam. It appears from the minutes attached to your letter that the town of Tuam adopted Part 3 of the Act in 1959.

The Prayer was recited.

The minutes of monthly meeting held on Monday, 1st March, 2010 were adopted on the proposal of Councillor Kelly seconded by Councillor Ward.

The Mayor proposed a vote of sympathy with the Polish People on the death of President Lech Kaczynski and the 96 other victims of the plane crash in Russia. A book of condolences was opened and same will be available to sign at the Area Office, High Street during office hours. A vote of sympathy was also passed with the Families of Margaret Morley, St. Enda's Ave and John Lardner, Bodane. 1 minutes silence was observed as a mark of respect to the deceased. The Mayor welcomed Mr. Enda Gallagher, Town Engineer to the meeting and introduced him to the Members.

Matters arising from the Minutes:

Councillor Warren thanked the Mr. Leahy for the work carried out on the trees and footpaths at Athenry Road.

Replying to Councillor Warren regarding the Tuam Water and Main Drainage Scheme Mr. Leahy stated that 'Trial Trenching' would begin at High Street next week. Councillor Flanagan stated that she attended the information evening in the Town Hall on 25th March and the starting date seems to be late May or early June. Replying to Councillor Bane Mr. Gilmore said the Water and Main Drainage Scheme is a large complex contract, the delay in starting while regrettable, is totally outside the control of Galway County Council. Replying to Councillor Cunniffe he said the Traffic Management Plan is a matter for the contractors, when available Galway County Council will advertise for road closure, every effort will be made to accommodate Business People and keep disruption to a minimum.

Replying to Councillor Kitt regarding the Weir Road Mr. Leahy said some repairs had been carried out this week. Work on the Water and Main Drainage Scheme would be starting at the Weir Road in June. Replying to Councillor Kelly regarding lights and footpaths Mr. Gilmore said lights and footpaths will be done as part of the road restoration programme.

Regarding the Western Rail Corridor Councillor Kitt told the Members he had attended the opening of the Ennis to Galway Line. He had spoken to the Minister for Transport and impressed upon him the concerns of the Town Council and the need to extend the Line to Tuam. The Mayor stated that he also attended the opening and spoke to the Minister. Regarding a deputation to the Minister for Transport it was proposed by Councillor Kelly, seconded by Councillor Ward and agreed to write to Councillor Tom McHugh, Mayor of the County and Chairman of the Deputation Organising Committee. It was proposed by the Mayor, seconded by Councillor Kitt and agreed to invite Colm O'Raghallaig, Fr. McGrael, Elected Representatives and others involved in the W.R.C. to a meeting of the Board.

Regarding the Tuam Leisure Centre Councillor Flanagan stated that the Public meeting had been held in the Town Hall on 8th March, 2010, Minutes attached. An Action Committee was formed, consisting of Public Representatives and Members of the Public. The Action Committee met with Ms. Martina Maloney, County Manager and Mr. Kevin Kelly, Director of Services on the 8th April, 2010.

Replying to Councillor Flanagan regarding the chains at the square Mr. Leahy said he would have information for the next meeting.

Regarding Urban District Status Councillor Flanagan told the Members that the Association of Municipal Authorities of Ireland is carrying out a study of other Countries and other projects. A report will be issued.

Replying to Councillor Bane regarding Pedestrian Crossing at the Railway Kitchen and Councillor Flanagan regarding Pedestrian Crossing at Galway Road the Town Engineer said this would be considered when the Water and main Drainage Scheme is completed. Replying to Councillor Warren who asked if a "Lollypop Person" could be provided at school times Mr. Leahy said the school warden service is operated by the schools.

Replying to Councillor Kitt regarding the swings for toddlers at the Palace Grounds the Town Engineer said faults had been discovered and they would be repaired or replaced.

Replying to the Members regarding the Courts Service Mr. Gilmore said latest information is that the Courts Service will move out of the Town Hall on 1st May, 2010. Regarding the Ambulance Base he said this is still at the planning permission stage.

It was proposed by the Mayor, seconded by Councillor Kitt and agreed that a civic reception be accorded to Mr. Charles Lynch, Galway Enterprise Board on his retirement.

Manager's Business:

The Manager welcomed Mr. Enda Gallagher as Town Engineer. Replying to the Members he said the Library would be moving to the new building shortly. Mr. Gilmore informed the Members that work is still underway assessing the tenders for the M17 which should be awarded in October, 2010. He said E20M will be spent on land acquisition this year.

Letter dated 3rd March, 2010 from South Tipperary County Council – read. Letter dated 25th March, 2010 from Sr. Patricia Fahy, Secretary, Fairtrade Action Committee. It was agreed to advertise and invite applications from organizations in the town who wish to be considered for funding under the "contribution to the arts" scheme. Letters dated 23rd and 26th March, 2010 from Mr. Michael P. Kitt, T. D. – read. Letter dated 23rd March, 2010 from Mr. Noel Treacy, T. D. – read. Letter dated 25th March, 2010 from Mr. Paul Connaughton, T. D. – read. Letter dated 12th April, 2010 from Mr. Tommy Gavin, Irish United Nations Veterns Association – to be discussed later. Notice of Seminar for Councillors – Patrick Punch Hotel, Limerick on 28th & 29th May, 2010.

Transition Year Class from Presentation College:

The Mayor welcomed Stephanie Higgins and Andrea Burke from the Transition Year Class, Presentation College, Tuam. The girls outlined their plans to clean up Bishop Street, planting of flowers, painting of murals and a sculpture of a donkey to be erected at the bridge adjacent to the entrance to Parkview Drive. Replying to the girls regarding a contribution from the Town Council the Mayor stated that they should apply to an advertisement inviting applications from groups/organisations in the town for funding which will be in the Tuam Herald shortly.

A. O. B.:

Replying to Councillor Warren and other Members regarding illegal dumping at Gilmartin Road Mr. Gilmore said Galway County Council is dealing with the matter – the Environmental Unit visited the area, Section 7 notices have been issued. If necessary covert filming will be used to catch those responsible. The co-operation of the People of Gilmartin Road in reporting People who are dumping rubbish in the area is vital, if the information is provided Galway County Council will act. Vacant houses will be boarded up. Clearing of the area will have to be done mechanically. He had met with officials from the Department of the Environment regarding funding for the refurbishment of the Gilmartin Road area. Replying to Councillor Kelly regarding an unoccupied house at Galway Road he said the Community Wardens should be contacted.

Councillor Bane raised the issue of the status of Tuam Stadium. He asked if the Town Council could help the Stadium Committee to secure more matches for Tuam. It was proposed by the Mayor, seconded by Councillor Flanagan and agreed to write to the Manager of the Galway Football Board.

The Mayor, Manager and Members paid tribute to Councillor Ward who, for health concerns, is retiring having spent eleven years as a Town Councillor and been Mayor on two occasions. They thanked Councillor Ward for his contribution to Tuam and wished him and his family all the best going forward.

Access to Tuam swimming pool by the public

- Opening hours are not suiting the public.
- During the public hours of 8pm-10pm, classes are being held (aqua aerobics). Shallow end of the pool is not accessible.
- During the public hours of 4pm-7pm, swimming lessons are taking place. Access only to the deep end of the pool.
- Children are unable to access the swimming pool and therefore cannot practise swimming lengths. This is the basic requirement for becoming a member of Tuam Swimming Club.
- Due to the new public hours, Tuam as a town is losing out on business as people from the hinterland are unable to avail to the facility.
- Foreign students who are attending school in Tuam that used to swim daily are now unable to use the pool as the hours do not suit them; also, the previous operators had a three monthly subscription available to them.
- The Special Olympics Committee hire the pool for training on a Saturday morning for one hour. All volunteers must be Garda vetted, however, during this hour the public have access as advertised.

Health and safety

- When cleaning is taking place, cables are visible going through the showers.
- The public expressed their concern over the way the pool is being cleaned. Dirty water is being hosed from one area to another.
- People who have used the pool in the mornings commented on the changing areas and water having not been cleaned, plasters and chewing gum stuck to the floor.
- Those with special needs are unable to use the pool as the hoists are not working.

General complaints from the public

- Swimming lessons for children are now overcrowded and very little individual attention • been given. Times slots are now shorter and it is like a conveyor belt with children rushing in and out of the pool.
- Showers are not working at times.
- No keys for over 200 of the lockers.

- No proper complaints procedure active. There has been no follow up to complaints already • made by the public to Kingfisher directly.
- A number of people have had to leave the pool as the water was either too hot or too cold.
- Swimming pool has been closed on a number of occasions due to the temperature of the • water.

It was proposed that an action committee would be formed consisting of members of the public and public representatives. This committee would seek a meeting with the Manager of Galway County Council as a matter of urgency.



The Den currently opens on a Tuesday evening from 4pm to 6pm for 1st to 3rd years and on Thursday's from 6pm to 8pm. It caters for the interests of young people through the provision of a 'hang out' space, internet access, various games and activities such as PS2 and the Wii, Pool table and fuzz ball table. Young people are more than welcome to avail of these services at these times.

In relation to Halloween, we are writing to ask if the Tuam Town Council have ever considered the organising of a Tuam Halloween Bonfire. This we believe would be held in a centralised location which would be controlled and managed by qualified members of the council, fire brigade and Gardai with support from other concerned parents and volunteers. This would be a wonderful way for the community to come together and celebrate this occasion whilst also putting out a positive proactive image of Tuam and its Council. In hosting such an event it would deter activity taking place within estates which can often cause concern, particularly to the elderly, animals and some families in our community, and also can create damage to public areas.

Iniatitives like this have being organised in Galway City and other communities and proven to be a wonderful success. In conjunction with the event being held in the Old Junior School by Youth Work Ireland Galway Tuam we believe this would really make Tuam the place to be this Halloween! We are more than willing to get involved in organsiing this event and look forward to your response!

Dear Frank,

I refer to the above and previous correspondence including my letter to the elected Members of Tuam Town Council and the County Council's Electoral Area Committee on 9th December 2009.

I set out in that letter the overall position, the issues raised and the resultant changes to the operation of the facility.

While the original tender proposal ensured more overall opening hours per week than previously in place (an increase of 5½ hours per week) and reduced access fees for both pay-as-you-go and membership visitors, other areas were the subject of some discussion. Examples of reduced prices include adult swim, child swim, family swim and the cost of membership. The operators Kingfisher in response to issues raised reduced the fee for school's access, moved the public hours as requested (from 2.00 - 4.00pm to 3.00 - 5.00pm to 4.00 - 6.00pm), provided public access to the gym and included a swim and gym combined access fee.

Following these changes the main issue raised was the timing of the pay as you go session in the evening with some suggesting that the period from 4.00 - 6.00pm was too early. Following the raising of the matter with Kingfisher they agreed to extend the afternoon session from 4.00 - 6.00pm to 4.00 - 7.00pm thereby giving an extra hour each day and it was understood that this would be considered reasonable. It should be borne in mind that when the nighttime public access session from 8.00 - 10.00pm is taken into account 5 hours public access are provided between 4.00pm and 10.00pm each weekday.

The public access on a pay as you go basis in the swimming pool is now 7 hours per day Monday to Friday and 5 hours per day on a Saturday and Sunday giving a total of 45 hours per week. The timing of these hours were agreed in order to give a range of attendance options between morning, afternoon and evening.

It should be noted that the public can also use the pool at other times not included above while not being a member such as during the periods dedicated exclusively for swimming lessons and aquafit sessions in which the public can participate without being a member. There have always been membership options available in Tuam Leisure Centre so membership is not new and extensive participation at the facility is available without being a member.

I can confirm that the revised arrangements including the additional hour from 6.00 - 7.00 pm have been incorporated into the revised timetable for the centre and are now in place.

Following the last meeting with a deputation from Tuam Town Council it was necessary to await the recent County Council meeting before making any further adjustments as the swimming pool was an item on the Council Agenda and it was necessary to ensure that all matters raised would be considered before making further adjustments and communicating these to the Members.

I understand that there are currently 1,400 children receiving lessons each week at the facility with strong pay as you go usage, keen interest in membership and good attendance at classes.

I trust that the above will be useful in clarifying the position to the Members of Tuam Town Council at their next meeting.

The Prayer was recited.

The minutes of monthly meeting held on Thursday 11th January, 2010 were adopted on the proposal of Councillor Kitt seconded by the Mayor.

The Mayor wished Councillor Loftus and Councillor Ward a speedy recovery.

Matters arising from the Minutes:

Replying to the Mayor regarding parking at Old Road Mr. Leahy said feedback from the Community Wardens is the present arrangement is working and householders are happy. The Wardens will continue to monitor.

The Members welcomed the signing of the contract for the Tuam Water and Main Drainage Scheme on Friday 29th January, 2010. Councillor Kelly raised the issue of potholes especially at Milltown Road and Tullinadaly Road. The Town Engineer told the Members that work on potholes was ongoing, heavy traffic volume areas are being prioritized, some bad spots had been dealt with last Saturday. A section of Milltown Road beside the garage will be fully re-constructed this week and a section of Dublin Road beside the supermarket will be fully re-constructed next week. He said the Weir Road will be dug up for the Water and Drainage Scheme.

Replying to Councillor Flanagan regarding footpaths at Weir Road Mr. Gilmore said he would see what can be done. Replying to Councillor Kelly regarding lights at Weir Road he said he would investigate. Replying to Councillor Warren regarding consultation with business people he said Galway County Council had given a commitment on publicity and this will be honoured. There will be a lot of disruption but this is a massive investment in the future of Tuam. E38.9m has been announced for the Gort to Tuam Road, the contract to be signed in October, 2010 and 600,000 for the Tuam to Claremorris Road. He said these projects are very valuable to Tuam and the West. The Mayor said he was delighted to be present for the signing of the contract, he thanked everyone involved and welcomed the provision of this vital infrastructure for Tuam.

Replying to Councillor Kitt the Town Engineer said double yellow lines had been installed at Tullinadaly Road.

Manager's Business:

Mr. Gilmore told the Members that the Courts Service expect to move out of the Town Hall in April or May.

Regarding the Ambulance Base Mr. Gilmore said a planning application has been lodged with Galway County Council.

Tuam Person of the Year

Councillor Flanagan told the Members that the sub-committee had decided on a form of Application Form. The People of the Year Awards will be advertised and application forms will be available from the Town Hall, the Library, Eason's and Quinn's Shop.

Tuam Leisure Centre:

Letter dated 15th January, 2010 from Kingfisher Club was read. Mr. Gilmore told the Members that a meeting was arranged between the Town Council, Kingfisher and Mr. Kevin Kelly, Director of Services. Letter dated 27th January, 2010 from Councillor Michael Connolly was also read. The Mayor agreed to contact Mr. Kevin Kelly, Director of Services in the morning.

Urban District Council Status:

Mr. Gilmore told the Members he had looked at the Legislation but could find no process to change the status of a town from Town Council to the equivalent of former Urban District Council. He was of the opinion that any change of status of a town would have to be by Ministerial Order.

Councillor Flanagan told the Members she had raised the issue with the Association of Municipal Authorities of Ireland and it would be on the agenda for an executive meeting in April. It was agreed to keep the matter on the agenda.



The Mayor welcomed the substantial fines for littering handed down at Tuam Court the previous week. Replying to the Mayor regarding a 'clean-up' at Gilmartin Road Mr. Gilmore said there was not a great deal of progress, a Residents Association may be about to be set up. The Prayer was recited.

The Minutes of the meeting held on 6th April, 2009 were adopted on the proposal of Councillor Ward seconded by Councillor Warren.

The Mayor welcomed the new Members of the Joint Policing Committee to the meeting.

Matters arising from Minutes:

Replying to Councillor Warren Mr. Leahy, S.E.E said maintenance of the traffic lights was carried out regularly.

<u>C.C.T.V.:</u>

Regarding C.C.T.V. Mr. Leahy stated that the electrical work has been carried out for the installation of the camera at Duffy's chemist. Replying to Members who suggested that a monitor should be available in the Gardai station Supt. Skehill said monitoring of C.C.T.V. would not be an efficient use of Garda time. The Gardai have access to the monitor in the Town Hall.

Mr. Gilmore stated that there were sensitivities regarding data protection concerning access to the C.C.T.V. system. The operation of C.C.T.V. is governed by strict guidelines laid down by the Data protection Commission. He said he would bring a copy of the regulations to the next meeting. The Town Clerk is the official data controller.

Hooliganism:

Following discussion regarding hooliganism in Tuam some weeks ago The Mayor and Members complimented Supt. Skehill and the Gardai on their handling of matters. Replying Supt. Skehill said further charges will be brought following these incidents. The last few weeks have been incident free and the Gardai will remain pro-active.

Traffic Management:

Replying to Councillor Kitt regarding problems with the traffic lights at the Weir Road junction Mr. Leahy said the present lights on the N17 are not linked, ducting for "intelligent lights" will be installed during the Tuam Water Distribution and Main Drainage Scheme.

Replying to the Mayor who asked if a Garda presence could be provided at the traffic lights especially on Friday evenings when traffic is at its worst Supt. Skehill said this would be a waste of Garda time but she would consider it as a short-term solution.

Tuam Town Water Distribution and Main Drain Scheme:

Mr. Gilmore informed the meeting that the contract for the Tuam Town Water Distribution and Main Drain Scheme was expected to be signed in approximately two weeks. He said Galway County Council will be in contact with Supt. Skehill regarding Traffic Management in the town.

<u>A. O. B.:</u>

Replying to Deputy Connaughton who raised the issue of knife crime Supt. Skehill said while knife crime has become prevalent she wanted to stress that knives were not an issue in recent incidents in the Tuam Area. She said it is an offence to carry a knife and there are serious penalties for anyone convicted of being in possession of an offensive weapon.

This concluded the meeting.
