The meeting was called to agree an agenda for Public Meeting to be held on Monday 12th October, 2009.

The Mayor welcomed Mr. Eugene Carthy, Mr. Raymond Quirke and Mr. Paul Flaherty, Coca Cola Workers to the meeting. Mr. Carthy told the meeting that they had attended a meeting at the Labour Court on Friday 18th September, 2009. The Workers were represented by Mr. Gerry McConnell and Mr. John Dunne, Union Reps and the Company was represented by IBEC. Recommendations from the meeting, which are binding on the Employees, will be issued later this week. It is expected that Coca Cola will also issue a statement.

It was proposed by Councillor Warren, seconded by the Mayor and agreed to write to the Tainiste and Minister for Enterprise, Trade and Employment.

It was proposed by Councillor Bane, seconded by the Mayor and agreed to hold another meeting following the issuing of the Statement by the Labour Court.

The Mayor welcomed Mr. Eugene Carthy, Deputy Shop Steward and Mr. Raymond Quirke, Coca Cola to the meeting. He apologized to the workers of Coca Cola for being unable to join them on the picket line because of illness. He thanked the Deputy Mayor for deputizing for him, fellow Councillors and the Town Clerk for calling the meeting at short notice.

Mr. Carthy told the meeting that 27 people out of a workforce of 29 had been given their P45, RP50 and cheque representing statutory redundancy payments that week. They had been written to on the 8th September, 2009 and asked to inform the Company if they wished to avail of an enhanced redundancy package. The Workers felt they were being bullied and contacted the L. R. C. He said Management refused to talk to the workers and read letter dated 14th September, 2009 from Coca Cola.

The Mayor and Members said they fully supported the Coca Cola Workers and called on the People of Tuam to support them. They complimented a number of Business People who they said were boycotting coca cola products.

It was proposed, seconded and agreed that the following statement be issued on behalf of the Town Council:

"A shocked Town Council called an emergency meeting last night, 16th September, 2009, after twenty seven Employees of Coca Cola received their P45s without notice or negotiation.

Tuam Town Council calls on Coca Cola to rescind their decision and engage in meaningful dialogue with the Workers.

Tuam Town Council will continue to support the Workers until such time as a favourable conclusion is reached".

It was agreed to discuss the matter further at a special meeting to be held on Monday 21st September, 2009.

Matters arising from the Minutes:

Replying to the Councillor Ward regarding Remedial Works Scheme for Gilmartin Road/St Enda's Ave/Tirboy area Mr. Gilmore said a scheme is being prepared and will be presented to the Town Council.

Manager's Business:

Mr. Gilmore told the Members that Galway County Council expect to sign the contract for the Tuam Town Water Distribution and Main Drainage Scheme in early October, work will begin shortly afterwards. Replying to Councillor Warren he said the contractor will produce a traffic management plan when the contract is signed. Replying to Councillor Bane Mr. Leahy, S. E. E. said ducting for the traffic lights will be included. The Members welcomed the start of the scheme and thanked the Manager, Engineer and all involved.

Mr. Gilmore informed the Members that there had been a reduction in the Annual Expenses of Members of Borough and Town Councils, from E1,100-00 p.a. to E1,018-00 p.a.

Nomination to County Development Board:

Letter dated 12th August, 2009 from Mr. Shane O'hEithir, Galway County Development Board was read. It was proposed by Councillor Kitt, seconded by Councillor Ward and agreed that Councillor Loftus represent Tuam Town Council on the Galway County Development Board.

Grove Hospital:

Replying to the Members Mr. Gilmore said there were no new developments regarding the Health Campus. It was agreed this would be raised at the Public Meeting in October.

Court House:

Replying to the Members Mr. Gilmore said the Courts Service have responded to an offer to use the Grove Hospital but need to continue to use the Town Hall for the immediate future. Replying to Councillor Loftus he said he would raise the matter of an office in Tuam to accept fines etc. The Members support the retention of the Courts in Tuam.

Tuam Town Trail:

Letter dated 7th September, 2009 from Ms. Eimear Dolan, Community, Enterprise & Economic Development Unit, Galway County Council was read. The Members welcomed the on-going work of the Tuam Town Trail.

Tuam Hub Fund Application:

The Deputy Mayor welcomed Mr. Brian Barrett, Community, Enterprise & Economic Development Unit, Galway County Council to the meeting. Mr. Barrett told the Members that submissions were invited to a new fund - BMW Region, NSS Gateways and Hubs European Regional Development Grants Scheme in July 2009 - Up to E1.4 million is on offer to each hub on a 60% funding rate (programme size E2.3 million). The closing date for submissions was 20th August, 2009. Matching funds cannot come from borrowings or reducing the capital balances of the Local Authorities (compliance with Dept. of Finance circular 12/2/'08). Submissions must strategically fit with the operational programme of the BMW, the NSS, Regional Planning guidelines and local development plans and strategies for a Hub town. The programme is to be fully completed by the end of 2010. He outlined the approach to the scheme, review of strategies, additional priority, constraints, connecting Tuam concept and objective of submission. He outlined projects identified under a series of themes, connecting community buildings, connecting community through developing the public realm and connecting technology. He said a submission was made, subject to the endorsement of Tuam Town Council and Galway County Council. A decision by the BMW Regional Assembly will be made by the end of September, 2009, a consultation process with stakeholders to agree final implementation - October to December 2009, implementation October 2009 onwards with completion by December, 2009. Replying to Councillor Kelly he said the community gym will be located at Bhru Bhride, a house at Parkmore Estate has been identified as a Community house. Replying to Councillor Loftus Mr. Gilmore said a plan to upgrade the Shambles had been presented to a previous Town Council, the final details were not agreed but the work cannot commence until the Tuam Town Water Distribution and Main Drainage Scheme is completed. Proposals to develop the Shambles will be brought back before the Town Council. Replying to the Members Mr. Gilmore said E750,000-00 earmarked for broadband ducting and cabling represents half the cost of providing Broadband ducting. The Members welcomed the scheme. The application was approved on the proposal of Councillor Kelly seconded by Councillor Ward.

Taxi Rank:

Letter dated 10th July, 2009 from Mr. Gerry Mullins, Shop Street was read. Councillor Loftus pleaded that something be done in relation to the present taxi rank both in Shop

Street and High Street - reducing the space available to taxi's in both streets. Replying to the Members Mr. Leahy, Senior Executive Engineer stated that the statutory process had been gone through in relation to the provision of the taxi rank. There will have to be consensus between the Traders and the Taxi people and in view of the imminent start of the Tuam Town Water Distribution and Main Drainage Scheme it would be make no sense to revisit this now. It is the attention of Galway County Council to do a comprehensive Traffic Management Plan for Tuam and this will be brought before the Town Council in due course. Mr. Gilmore suggested that the Traders and Taxi people come up with a scheme.

Gas Connection:

Mr. Gilmore informed the Members that ducting for Gas was included in the Tender Documents for the Water Distribution and Drainage Scheme. Final agreement will be between Galway County Council and An Bord Gais.

Public Meeting:

The Town Clerk informed the Members that a room had been booked at the Ard-Ri Hotel for Public Meeting to be held on Monday 12th October, 2009 at 7 p.m. It was agreed to hold a special meeting on Monday 21st September, 2009 to draw up agenda.

A. O. B.:

It was agreed to hold the next J. P. C. meeting on Monday 5th October, 2009.



The Prayer was recited.

The Minutes of the meeting held on 13th October, 2008 were adopted on the proposal of Councillor Kelly seconded by Councillor Flanagan.

The Mayor welcomed everyone to the Meeting. He particularly welcomed Inspector Michael O'Dwyer to his first meeting of the Joint Policing Committee. As this was the last meeting of the present Town Council Board he thanked everyone for their work, help and contribution to the success of the J. P. C.

Matters arising from Minutes/C.C.T.V:

Superintendent Skehill told the meeting that Gardai needed more training in the use of the CCTV. She said she had met with Mr. Gavin, Town Engineer and Duffy's Pharmacy had been identified as the best location for the extra camera. The camera will be set facing across the Square and down Vicar Street. She said static cameras are more useful. Mr. Gilmore told the meeting that funding is available for the extra camera. He didn't know if the camera was ordered but agreed to pursue the matter. He also said the camera on the Town Hall rotates at present but can be adjusted to a fixed position if that is the better option.

Replying to Councillor Browne-Lane regarding CCTV and extra lights in the Palace Grounds Mr. Gilmore said there was a delay in the installation of Public Lighting but he was hopeful the lights would be installed as soon as possible.

Replying to Deputy Connaughton Superintendent Skehill said CCTV is not monitored constantly but the Gardai can check at anytime and it is of benefit. There is a heightened awareness of CCTV.

Replying to Deputy Kitt Mr. Gilmore said CCTV comes under the Data Protection Commissioner, the footage is available to the Gardai at all times.

Traffic Congestion on N17/Traffic Lights not synchronised:

The Mayor asked if some thing could be done regarding the continuing problems being experienced by motorists on the N17 especially on Thursday and Friday evenings when traffic is backed-up for miles out the Galway Road. Superintendent Skehill said this was not a Garda problem, the sequencing of the lights is at fault. The Weir Road junction also causes problems.

Mr. Gilmore said funding is available to synchronize the lights, however the traffic lights were installed at different times by different suppliers and this could be a problem. He said synchronization will not eliminate the problems because of the capacity of traffic going through the town – the cure is the Bypass. He agreed to investigate regarding synchronization of the lights and inform the Members.

Garda presence at Dublin Road at School times:

Councillor Browne-Lane told the meeting, that as stated at the ordinary meeting she had serious concerns regarding traffic congestion and safety problems on Dublin Road at school times, she felt there should be more help from the Gardai and the Community Wardens in patrolling the area at school times. Mr. Gilmore said he would ask the Roads and Transportation Committee/Road Safety Team to investigate regarding providing School Wardens and a designated drop of place.

Councillor Ward asked that a pedestrian crossing be installed at Vicar Street urgently.

Garda presence/foot patrol in the town centre at night especially at weekends

Superintendent Skehill told the Members that assaults, between January and March this year, were down by 75% compared to last year and public order offences were down by 14%. "Operation Curb", targeting young people driving dangerously or using souped-up vehicles, had resulted in 28 vehicles being seized from young people in the same period. These vehicles will only be returned to the owners on condition that they be made compliant with the legal requirements and payment of a fine of E125.00.

Replying to Deputy Connaughton regarding "Neighbours from hell" Mr. Gilmore said Galway County Council deal with anti-social behaviour as quickly as possible but very often a tenant is punished because of the conduct of a relative/family member. Superintend Skehill said in one case a second anti-social behaviour order had to be served before the tenant/family moved out.

This concluded the meeting.

Annual Expenses of Members of Borough and Town Councils

I am directed by the Minister for the Environment, Heritage & Local Government to refer to circular EL 03/09 of 11th March 2009 which inter alia, informed of the Government's decision to reduce travel and subsistence rates and of its application to the annual expenses allowance of county and city councillors. Arising from this, the annual expenses allowances of the elected members of borough and town councils have been revised downwards to €3,054, €2,036 and €1,018 for the respective groupings of urban authorities as set out in the table under and may be paid from a date not earlier than 12th June 2009 as the local authority may decide.

In addition, to reflect retrospective increases of rates arising from circulars EL 11/09 and EL 12/09, revised allowances may also be paid in respect of the dates specified in the table (i.e.1 July 2007 to 30 June 2008 and 1 July 2008 to 11 June 2009) respectively as the local authority may decide.

Overall Development Approach:

The importance town of Tuam is warmly welcomed back to the TidyTowns competition. Thank you for the completed application form, the very useful map, copies of examples of your meeting minutes, documentation in connection with your submission to PEIS Funding, with examples of the splendid press coverage your spring clean-up secured. We were very impressed with the extensive photographic analysis of the difficulties and opportunities that abound in this most interesting town. It can sometime be almost overwhelming when TidyTowns committees initially survey the range the range of tasks that face them. It is always beneficial to identify the items for priority action. In each case this exercise should incorporate the name of the lead agency with which you plan to tackle the task. To be effective please insure that you insert a start date and a completion date for each project. This has the effect of preventing your three year plan from becoming merely a "wish list" without any real consideration of the resources and agencies involved in their completion. It is very apparent based on the enormous success of your clean-up day that there is a reservoir of good well to be tapped both at community, club and commercial level in addition to the local authorities. The street signage is very good and the one way traffic system is working well. The Square is colourful and vibrant and the little mill project is a significant success.

The Built Environment:

The large and well presented shopping centre is impressive while the regional offices of Galway County Council are a fine building, well presented. St. Mary's Cathedral is imposing and would be improve if the splendid iron gates were wire brushed and repainted. The river bridge is most attractive at the start of Shop Street while the Roman Catholic Cathedral, in Bishops Street was very well presented. The Town Hall is a fine building and we enjoyed the fine stone frontage of O'Toole's. Gilligan's Restaurant certainly caught the eye and the fine traditional shop front of Connaughton was a delight. The ruins of Temple Jarlath (1319) and the grounds were very well presented. The Garda Station looked well but we were disappointed to note the flag

poles but no flags flying unlike the Credit Union which was enhanced by the flags flying there. The flying of flags is one of the least expensive enhancements one can recommend, bringing colour and movement to the scene in an instance. Lynch Antiques in Forster's Place caught the eye as did Geraghty's Clothes Shop in Bishops Street. Schools generally and the National school in particular were well presented.

Landscaping:

This aspect has received considerable attention and to good effect. The amenity area with the yellow pump on the N17 approach was attractive while the Fairgreen Heights communal grassed areas were a delight. The raised flower bed at the sports field was a pleasant cameo. Don't overlook the opportunities and value of small incidental flowerbeds and planting which can add greatly to an overall colourful vista. The sculpture in Market Square and the Ann-Marie McHuge Memorial Garden are a delight. We were impressed by the grounds of the Irish Wheelchair Association which were splendid. The communal grassed area at Newtown Morris was an example as to how well thing can be. The Palace Grounds Park still has additional potential while the landscaping on the Dublin Road approach, when fully mature, will add greatly to this approach. The ambitious landscaping on the Galway approach road is to be applauded. The communal garden and grassed area in Parkmore Housing Estate augmented by suitable tree planting is commended.

Wildlife and Natural Amenities:

The selection of suitable native, berry bearing plants in landscaped areas is an important element in the creation of the essential food chain if wildlife and especially bird life are to be attracted. The creation of a bird life enhancement programme over a number of years helps to establish opportunities and identify suitable locations. Discuss the options with a local bird life enthusiast or contact the Wildlife Officer at the Office of Public Works. The river bio-diversity project being undertaken by the Anglers Club commencing at Shop Street at the very centre of the town is a wonderful project and we look forward to its progress over time.

Litter Control:

Litter management generally on the day of adjudication was of a high order apart from Milltown Road, which both attractive and effective. Again congratulations on the great success of your national spring clean-up and securing such a high level of involvement by the school. The dividing of responsibility among little for the securing such a high level of involvement by the school. respect of each street is an excellent development and should lead in time to a competition which might be sponsored by commercial interests or the local authority. Securing an anti-graffiti and a gum removal device would clearly be of additional benefit. already tacked.

Waste Minimisation:

This category is as much about securing a change of mind set as it is dealing appropriately with waste material. The concept of reducing usage to start with, reusing where viable and recycling wherever possible is now widely excepted as being both a mark of good citizenship and economic good sense. Secure the involvement of the Environmental Department of Galway County Council in addition to the support that is available from agencies with which they will put you in touch. Plan to stage an information evenings on the value to individual households of composting waste and other methods on reducing dependence on expensive landfill.

Tidiness:

Many aspect, impacting on the overall vista, fall to be considered under this "catch all" heading. There was an amount of weeds between the road and pavement in many location especially on some streets. Where weeds are killed by chemical means it is important that the residue be sweep up and removed for best effect. The fine Fairgreen communal grassed area is diminished by the number of capping stones which were missing from this area. The Pay & Display sign at the Cathedral needs attention as it is quite worn. A number of signs need simply to be washed for best effect noticeably the Tourist Office sign at the bridge among many others. The damaged and derelict cars in the garage on the Sligo approach on the N7 should be screened in some manner or ideally removed. The potentially very pleasant old pump in St. Joseph's would benefit from washing at least but ideally painted.

Residential Areas:

The decision to have a inter-residential area competition is to be applauded as this has proved most beneficial in other centres. The estate off the N17 was very well presented but some weeds were noted at the base of front facing walls, Hillcrest private house was a delight while the communal grassed areas in St. Joseph's Park were very well presented. Waterslade Downs looked very well as did the Oak's House Estate with a number of splendid individual gardens. The new pavement at Belair Drive add considerable to the overall

vista, while Hilltop Close was an excellently presented area.

Roads, Streets and Back Areas:

The N17 directional sign is somewhat obscured by nearby trees and may need to be repositioned. The speed limit signs are fine but their poles require to be wire brushed and repainted. On Ballygaddy Road additional planting would be beneficial while the road surface was somewhat below par both here and also at Belair Drive. Broadly roads were well swept and attractively presented.

General Impression:

The Trial Route

The trail will start and finish in Market Square area and include an orientation map to highlight all the stops on the trail. The route will follow the current town trail which is included in the Tuam 'Architectural' Walking Tour and is also available in an audio version on www.galwayeast.com/wayfinding and on www.galway.ie. It has been designed to provide a 1 hour route and facilitating the visitor to undertake a 'circular' route of the town.

Trail Signage

Signage for the trail will be installed in next month and will include orientation panel to provide a map of the overall route. At each stop there will be an interpretative panel providing images and details on the site. All signs will be bi-lingual English and Irish. The route will include directional posts with finger signs indicating the stop that you have passed and the next stop on the route.

Funding for the signage is provided by Failte Ireland and Galway County Council are funding graphic design and printing of the panels and all installation. Tuam is selected as one of 19 'Historical Town Trails' and the style of signage was provided by Failte Ireland who demanded it be the same as all other towns. It consists of cast iron signage in a dark green colour.

The layout of the information boards however, will reflect the style of the current panels which are considered to be 'best practice' of all the Historical Towns.

Assistance in preparing the information for the 'orientation' and interpretative' panels has been provided by Galway East Tourism (Neil Campbell) in consultation with local groups an in particular Dr. Tony Claffey. All final panels will be agreed with Council Conservation Officer Mairin Doddy and Heritage Officer Marie Mannion.

Promotion of the Trail

The trail is currently promoted by Galway East Tourism, Galway County Council and Failte Ireland as part of six town trails in the County. It is profiled on a number of web-sites to date and once the signage is in place (by early October) Tuam will be included on the www.discoverireland.com site and promoted as an historical town nationally and internationally, alongside Waterford, Kilkenny, Loughrea etc. The ongoing promotion of Tuam Town Centre and the Trail is a significant benefit of this Signage Scheme.

Installation of the Signs

The signs are being installed by Council Staff. Eamon Coyle is assigned Engineer in Tuam Regional Office. Final locations of signs are considered in terms of safety and conservation and access/owners. Draft trail has been presented to Town Council previously and outline provided to Tuam Chamber of Commerce.

The minutes of ordinary meeting held on Monday 15th June, 2009 were adopted on the proposal of Councillor Kelly seconded by Councillor Ward.

Matters arising from the Minutes:

Replying to Councillor Kelly regarding the entrance to Rivercrest Housing Estate Mr. Leahy, SEE said this estate had not been taken in charge by Galway County Council. He intended to meet with the Developer and request that yellow box/lines be put in position at the entrance. He said the Community Wardens would monitor the situation. Replying to Councillor Kelly regarding parking at Old Road Mr. Leahy said Old Road was included in the new Traffic Management Plan, implementation of which is being delayed because of the Water Distribution and Drainage Scheme. The Members asked if bollards could be placed on one side of the road to deter parking. Replying to Councillor Kelly regarding the old scout hall Mr. Gilmore said the old hall is leased to the Boy Scouts.

Replying to the Mayor regarding the Remedial Works Scheme for Gilmartin Road/St Enda's Ave/Tirboy area Mr. Gilmore said the submission had not been sent to the Department yet.

Replying to Councillor Cunniffe Mr. Gilmore said the Town Council will be invited to nominate representatives to the Galway County Council Special Policy Committees when these committees are being formed. 

Manager's Business:

Mr. Gilmore told the Members Tuam Town Council is a Statutory Representative Body and by virtue of its history is a housing authority. An annual Budget of Expenses is prepared each year, a copy of the Budget of Expenses for 2009 will be circulated to the new Members. He said the Joint Policing Committee had been established under the Garda Siochana Act 2005, each Town Council now has its own Joint Policing Committee. The members of the J. P. C. consist of the members of the Town council and Officials, Oireachtas Members, Members of An Garda Siochana and Community Representatives. He said the Town Council are entitled to be represented on the Special Policy Committees of Galway County Council which will be before the Annual Meeting of Galway County Council to be held on Friday, 19th June, 2009.

Mr. Gilmore told the Members that Galway County Council had received approval from the Department of the Environment, Heritage and Local Government to borrow funding to progress the Tuam Town Water Distribution and Main Drainage Scheme. A full reconstruction of the streets in the town will follow the completion of the Scheme. Replying to the Members, who said a major International Computer Company was considering locating in Tuam but the lack of Broadband would be an issue, he said no decision had been made regarding the inclusion of ducting for broadband but a more urgent case will be made to the Minister now that the Water Distribution and Drainage Scheme has been approved. Galway County Council lodged a submission for broadband with the Department of Communications, Energy and Natural Resources on behalf of Tuam three or four year ago. Mr. Gilmore said the E27m Tuam Town Water Distribution and Main Drainage Scheme will be a major investment in the town. Work should start early in 2010 and take approximately two years to complete. There will be major disruption in the town. Galway County Council will initiate a PR Campaign, a Liaison Person and a helpline will be provided. People will be kept informed. Mr. Gilmore told the Members that Galway County Council had a recreation fund for Tuam. He said the Water Distribution and Drainage Scheme had delayed renovation of the Shambles and the Town Trails/Walks. The Town Council have also been putting cash aside to co-fund these projects. He said he would bring proposals to a future meeting of the Board. He also said there would be more positive news for Tuam in the next few months.

Tuam Tidy Towns:

Letter dated 15th June, 2009 from Ms. Sarah Roarty, chairperson, Tuam Tidy towns Committee was read. The Members welcomed Tuam coming 20th out of 60 in a recent survey and paid tribute to the Tidy towns Committee and the people who took part in the recent "Clean-up" which took place in several areas of the town. It was agreed to circulate the letter from the Tidy Town committee to the Members.

Ambulance Base:

Replying to the Mayor Mr. Gilmore said he would endeavour to get information for the next meeting of the Board.

Agenda for next meeting:

Councillor Bane asked that the Court House be included on the agenda for the next meeting also field adjacent to Tuam Stadium known as Brown's Field.

It was proposed by Councillor Flanagan, seconded by Councillor Warren and agreed that a Civic Reception be accorded to Sr. Angela from Straubing when she visits Tuam in mid August.
