Mayor Kitt welcomed Derek Cassidy, Tuam Voluntary Force Mr. Cassidy addressed the meeting, he thanked the local representatives for their support and involvement in the campaign to retain all services at Toghermore House. He thanked Minister Reilly for his commitment to funding, the H.S.E. for their decision not to close the Residential units, the local and national media, Dr. Hennelly for her stance in the matter and the residents of Toghermore House and their families. He stated that there is an urgent need to get written clarification from Minister Kathleen Lynch and the H.S.E. in relation to securing the long-term future of Toghermore House. He expressed disappointment at the decision to abolish Town Councils.

Mayor Kitt informed the meeting that due to a prior engagement Cllr. Cannon was unable to attend this meeting and sent his apologies. He was informed by Deputy Cannon that this funding is a reprieve only and when the fire safety issues are addressed the future of Toghermore House can be focused on.

Deputy Connaughton informed the meeting that Public Representatives will continue to keep pressure on until the necessary works are completed. He stated that there is a need to know where the funds for works are coming from and to ensure that no other proposed Developments fro Tuam are affected.

Deputy Kitt stated that the decision has provided a less pressurised environment for debate about the future of Toghermore House. He is confident that the improvements will be carried out and he hopes that the development of further facilities at the site will happen also.

Deputy Keaveney cautiously welcomed the decision stating that further clarification is needed. He was concerned about the long term future of the facility as the H.S.E. have plans to build a 40 bed unit at U.C.H.G and staff from Toghermore may be transferred there. He thanked all concerned in the campaign.

Cllr. Reilly welcomed the decision and thanked the T.D.'s and Councillors and asked for their continued support to provide more facilities at Toghermore.

The members also cautiously welcomed the decision and stated that T.D.'s needed to keep pressure on to retain the facilities at Toghermore House.

Cllr. O'Hora read 4 main points from a statement issued by Minister Kathleen Lynch.

- 1- The decision to close a unit is a matter for the Minister for Health .
- 2- Other services at Toghermore House must continue to operate as normal.
- 3- Fire Safety issues cannot be used again as a reason to close the Residential unit.
- 4- There is strong commitment to progress the "Vision for Change" and the Minister is committed to developing services for the Mental Health Sector.

Ambulance Base:

In reply to Mayor Kitt, Deputy Connaughton stated that he had no up to date information but will be pushing for the best service for the facility, but other areas will not lose out on services because of this.

Deputy Kitt understood that there is 11 staff outlined in the Service Plan for the facility and at present the issue seem to relate to staffing.

Deputy Keaveney stated that discussions are taking place and the service plan should be available shortly and he strongly recommended that a delegation from Tuam Town Council meet the Area Manager, P.O' Riordain.

Cllr. O'Grady stated that there has been no deviation from what Mr. O 'Riordain said at the September meeting of Tuam Town Council but the Council needs to keep in contact with him.

Jobs Industry in Tuam:

Deputy Connaughton stated that Tuam needs to decide what type of industry is suitable for the Town and Councillors and T.D.'s should keep in touch with the I.D.A.

Deputy Keaveney stated that the last Budget has provided for 10,000 new positions nationally for S.O.L.A.S.

Deputy Kitt stated that the Absence of Leader Funding is an issue for Tuam.

Cllr. Flanagan stated that a sub-committee should be set up to work with the Chamber of Commerce in providing a package which could be taken to I.D.A.

Cllr. Flanagan proposed the setting up a sub-committee.

Cllr. Kelly seconded the proposal and it was agreed by the members that a sub committee be set up.

Cllr. O'Hora stated that when he and other members met Catherine Blewitt, I.D.A., she stated that the opinions of existing successful Business people in Tuam should be sought in relation to providing industry / jobs.

Cllr. O'Hora proposed that Business people from Tuam should be included on the sub-committee set up with the members of Tuam Town Council and the Chamber of Commerce.

Cllr. Reilly seconded the proposal.

Grove Site:

Deputy Keaveney stated that 20 sites were announced nationally for Primary Care Centres and one of these is planned for Tuam. He doesn't know what model will be used.

Deputy Connaughton and Deputy Kitt are also hopeful that Tuam will have a Primary Care Centre.

Mayor Kitt thanked the T.D's for attending the meeting .

Any Other Business:

Cllr. Reilly proposed that Mayor Kitt contact Ballinasloe and Loughrea Town Councils with regard to making a joint submission in relation to the proposed Abolition of Town Councils. Mayor Kitt seconded the proposal.

Mayor Kitt has contacted the Mercy Sisters and they will come back with a suitable date for the planned Civic Reception.

Cllr Reilly stated that tenants should be sought for the Town Council owned site at The Fairgreen as otherwise the Army may demolish the site .

The meeting concluded .

The Prayer was recited.

Mayor Kitt welcomed the Delegates from Tuam Chamber of commerce, the members and all present.

Cllr. Bane who had requested that the delegation be invited to attend stated that it was important that the Tuam Chamber of Commerce and Tuam Town Council work together for the benefit of the Town . The main topic of concern raised by the Delegation and members was the difficulties experienced by the business community in paying Rates . Town Manager, Mr. Gilmore, stated that the payment of rates is a statutory obligation but where difficulties in paying rates arises the rate payer should contact the Finance Department, Galway County Council early on and their situation will be looked at sympathetically and it may be possible to work out a timeframe for payment more suitable for the individual rate payer. As Rates are adopted by the County Councillors, the Town Council and Chamber of Commerce should make their views known to the Local Area Councillors. Rates collected in the town are generally spent in the Town.

Delegate Kevin Farrell expressed frustration at having to pay Water Charges and bind charges as well as rates. Ronan Glynn would like to see clarity as to how the Rates collected are spent and would like to see a portion of the Rates collected in Tuam Town ringfenced for particular works in the Town.

Cllr. Reilly and the other members complimented the Chamber of Commerce on an excellent evening at switching on of Christmas Lights Ceremony on 1st December, 2012.

Adoption of Minutes:

Cllr.Kelly proposed the adoption of the minutes of the Tuam Town Council meeting of held on 5th November 2012. Cllr.Reilly seconded the proposal.

Matters arising from minutes:

Mayor Kitt thanked Cllr. T.Reilly and Cllr.O'Grady and the members of the Chamber of Commerce who attended the meeting with Catherine Blewitt and also Cllr. S.A. Flanagan & Cllr. I. Kelly who met the Minister initially.

Cllr.Reilly requested that following on from previous discussions that the Town Council write to Bord Gais for an update on provision of gas in the Town.

Following on from decision made at November meeting Cllr. Reilly requested that the four Galway East T.D's be invited to a special meeting to discuss the staffing and provision of a 24 hour / 7 day week service at Tuam Ambulance Base.

Cllr. O'Grady stated that what Mr. O'Riordan had promised has been provided and the provision of an extended service seemed to be dependent on Finance being available. It was agreed by the members that the Area T.D'S be invited in to discuss this matter.

Cllr. Ward asked if the figures for rates for Tuam Town were available . Mr. Gilmore stated that the figure for Rates levied is €1.15 million but the figure for rates collected will not be available until year end.

Mr. Gallagher replied that there is no funding available for anything other than routine maintenance at present, there may be improvements carried out next summer.

Cllr. Reilly asked if repairs could be carried out to Abbeytrinity Estate as the estate was used for parking of machinery during the Big Dig. Mr. Gallagher stated that he will refer back to Coffeys to check the CCTV.

2013 Budget Meeting 3rd December 2012 Tuam Town Council

Mr. Gilmore presented the Budget for 2013.

Cllr. Ward queried the increase in allocation from €13,500 to €46,500 for CCTV. Mr. Gallagher stated that the CCTV system needs a total re-vamp as the quality of recordings is very poor and it is intended that the project will go to tender in 2013.

In reply to Cllr. Reilly on the cost factor involved Mr. Gilmore stated that it was 5 years since the present system was put in place and technology has advanced a lot since.

Cllr. O'Hora queried if the existing stock is being upgraded or replaced. Mr. Gallagher replied that not all cameras will be replaced at one time. The upgrading of all cameras will take 2-3 years . It would be intended that the consul would be replaced first and the Gardai will advise on the priority in which the individual cameras should be upgraded. New cameras will also be provided at key locations where there are no cameras at present. A discussion took place regarding the location of CCTV recording equipment after the Abolition of Town Councils in 2014.

Cllr. Reilly proposed that the Manager would contact the Gardai with a view to discussing the installation of this equipment in the Garda station. Mayor Kitt seconded the proposal

Cllr. Ward proposed the Adoption of the Budget for 2013. Cllr. Loftus seconded the proposal. Cllr. Reilly proposed rate in the euro which will remain at 3.66 in 2013. Cllr. Kelly seconded the proposal.

Cllr. Reilly proposed that photographs of all past Town Clerks be displayed in the Town Hall alongside photographs of members. Cllr. Loftus seconded the proposal.

Bord Gais:





Overall Development Approach:

Welcome to TidyTowns 2012. Thank you for your comprehensive entry form, the splendid Tuam town map, details of the 'Promote St. Mary's Wildlife' photographs and your three year programme. We particularly welcomed the time line you have sent as part of your three year plan. We admired the many examples where the kerb stones are painted in bright yellow and white. We noted the major work in progress on Frank Stockwell Road and especially along Purcell Road. There are many agreeable and pleasant shop fronts on Shop Street. We admired the many signs 'Welcome to Tuam' and also the sign indicating your twining statue - Strauging (Germany). The Market Square was a very attractive, busy and bustling area. Sadly there are a number of closed down businesses throughout the town and one hopes that future developments will find a beneficial, present day use for these. We admired the use of "weathered" boulders for landscaping in locations, for example at the Purcell/Stockwell Road roundabout. The Presentation Convent with its backdrop of mature trees was a very arresting vista. The Town Hall in the Market Square is an imposing building which is being well presented. The town is served with very extensive parking facilities near the church while on street parking in other locations is not well facilitated.

While the format of your planner is appropriate for use during the current year a somewhat different format is required to appropriately identify your plans over the next three years. You are urged to give some time this winter to the preparation of a five or even three year programme of activities. This should set out your objectives, your priorities and identify those agencies with whom you will engage to achieve them. Be sure to add a time line to each – start and finish dates - so that a realistic and workable set of proposals emerge. Such a plan is useful in securing community engagement, agency support and also helps in sponsorship and necessary fundraising.

The Built Environment:

The splendid cathedral of the 'The Assumption' is an imposing structure as is the nearby St. Jarlath's College. The impact of the cathedral is necessarily diminished by the extent of car parking in the front. What a wonderful plaza that space would make. The adjacent former archbishop's palace is an imposing structure. The sculptural installation of the large wheel is an interesting addition to the streetscape at this point. The Ard Ri Hotel looked most attractive and it was well presented as was the Connaught Arms. The Black Rose restaurant is housed in a most significant building. The Irish Wheelchair building was bright and well painted and located in excellently presented gardens. On a different scale, Geraghty's of Bishop Street looked well as did O'Tooles. Concanon and Meagher Solicitors are housed in an imposing new building. The Grove Medical Centre was neat and well presented while Paul O'Grady and Company caught the eye. O'Tooles Supervalu Supermarket was very well presented, bright and well painted. The Gaelscoil larfhlatha was admired as was the Tuam Bookshop. Sadly a number of shops and commercial stores have closed down but these are being presented and maintained to the optimum degree possible in the circumstances.

Landscaping:

The Tuam Star Sports Ground was very well presented. The Celtic Park, with work in progress still on its front wall but the club grounds generally were well presented. Some incidental areas like the splendid display at the start of the Frank Stockwell Road were admired and the 'Little Mill' Road by the river was a gem. The small scale garden at the commencement of the Milltown Road is a delightful development which could be replicated elsewhere. Tuam Leisure Centre was colourful and the grounds well presented. We admired the information panel on the wall of the ancient burial grounds of the parish with links as far back as 1360AD. The practice, ongoing, of cutting back the grass to the inside edge of kerbs is applauded. The large public park on Ballygaddy Road was admired. The plans for the 'Sensory Garden' at St. Mary's Cathedral will be watched with interest and you are wished success with your proposed 'Heritage and Wildlife Walk'. As a general principle if this can be kept away from busy traffic it will probably prove of greater interest. Have you considered the installation of a 'Slí na Sláinte'?

Wildlife and Natural Amenities:

The plans you have in mind for St. Mary's Cathedral 'Sensory Garden' clearly will take considerable energy and time to reach conclusion. The River Nanny which is the current focus of your activities in association with the local angling club, clearly would benefit from the proposed major clean up. We would be glad to learn of the progress in this regard. Drawing attention to the bio-diversity by issuing the leaflets to the primary school and encouraging them to investigate nature by going on observational fieldtrips is an initiative to be applauded. It is important that there is a follow-up to this to ascertain what the results were or indeed the level of activity engendered.

Litter Control:

We admired many 'Keep Tuam Tidy' signs throughout the centre and other notices urging use of the litter bins provided. Litter was still in evidence towards the centre of the town and on Frank Stockwell Road. By contrast Milltown Road was completely clear of litter and a joy to admire.

Tidiness:

For a town of its size Tuam is mercifully free from major black spots, albeit the large work in progress on Purcell Road seems to have stopped. The disused railway and the frontage of the livestock mart would benefit from additional attention. Minor items also intrude. The tattered flags at Highway Services Ltd. needs to be replaced. The large broken plastic and electric sign on the gable end of Computex Repair Centre should be removed. Fly posting seems to be very much reduced. Traffic volumes and flows, although still heavy, are of a more manageable nature. The weeds and grass on pavements are less of a difficulty than previous years but still leaves room for additional improvement.

Waste Minimisation:

Your efforts with the Chambers of Commerce and with the school to draw attention to these issues are commendable. Have you considered staging an information evening at which waste minimisation concepts can be explored by the community at large? We admired the Bring Bank at the Leisure Centre and the inclusion of a Clothes Bank also. Your plans to introduce a 'Green Sticker' for local businesses who achieve a high rate of waste minimisation are an excellent way to increase public awareness of this growing need.

Residential Areas:

Barnadern Estate is a mature, well presented area where the individual gardens and the communal grassed areas have been well presented. Sadly, as elsewhere, there is an extent of weeds outside the kerbs which detracts from the overall presentation. Hilltop Close and Black Acres are excellent developments while The Meadows are again a well presented housing estate. Meadow Grove is excellent but again marred somewhat by the weeds outside the kerbs. Tober Jarlath Road which was tree lined featured many delightful houses. Individual houses on the Dublin Road and elsewhere all contributed to a pleasant overall vista.

Roads, Streets and Back Areas:

Milltown Road was very neat, recently swept and was devoid of litter. The road surface in some locations gave rise to concern notably on the Ballygaddy Road. Seemingly it has been dug or disturbed on a number of occasions and the surface has not been adequately made good following these excavations.

The road surface at the central parking area is considerably below par with some almost frightening pot holes to negotiate. Kerbs and hedgerows on approach roads are very well presented and many of the approach roads feature excellent individual gardens.

TUAM TOWN COUNCIL Minutes of meeting held on 3rd September, 2012

The Prayer was recited.

The Mayor welcomed everyone present.

Adoption of Minutes

Cllr. Reilly proposed the minutes of Tuam Town Council Annual General meeting held on 25th June 2012. Cllr. Kelly seconded the proposal.

Cllr. Reilly proposed the minutes of July meeting of Tuam Town Council held on 25th June 2012. Cllr. Kelly seconded the proposal.

Cllr. Kelly proposed the minutes of the special meeting of the Town Council held on 20th August 2012 to discuss the Proposed Extinguishment of Right of way .Cllr. Reilly seconded the proposal.

Extinguishment of Right of Way:

Cllr. O'Hora raised a point of order stating that the incoming delegation expected that the County Councillors representing the Electoral Area would be present and that a civicly inclusive discussion could take place with Councillors and officials present.

Mayor Kitt explained that he had endeavoured to organise a meeting with Council officials and County Council members. The feedback from County Councillors was that the meeting would be pointless unless Mr. Jim Cullen, D.O.S. could attend and Mr. Cullen was not available.

Representatives of "Restore the Palace, Preserve our Right of Way" expressed dissatisfaction that area councillors were not present at the meeting and subsequently left the meeting .

Mayor Kitt expressed his disappointment at the walk-out but pointed out that the item was placed on the agenda for discussion at the monthly meeting and it was intended that a further meeting would be held with Councillors and officials present.

Mr. Gilmore, Town Manager informed the members that following a decision by Councillors at a County Council meeting an agreement was made with Mr. Joe O'Toole regarding a land swap and in return for the land Mr. O'Toole would construct a new Roadway. The section 183 disposing of the land was voted on by County Councillors in May, 2011.

Presently there are two separate issues being dealt with separately by sections within Galway County Council.

- (1) Issues in relation to planning
- (2) Extinguishment of Right of Way

The Planning section are dealing with Planning issues and have sent a warning letter to the Developer informing him that the Development which has taken place appears to be in contravention of planning permission granted.

The extinguishment of Right of Way is dealt with by the Roads and Transportation Department. Submissions will be accepted in relation to the extinguishment of Right of Way until 17th September 2012. Submissions will be considered and the final decision will be made by County Councillors as the extinguishment of Right of Way is a Reserved function. The Manager pointed out that the Town Council have no statutory powers in this matter.

Before the end of the meeting a letter was handed in from the "Restore the Palace Preserve our Right of Way" Committee requesting a meeting with the Area County Councillors before September 17th.

Mr. Gilmore stated that if the group wish to bring a delegation to the Electoral Area meeting, they should contact the Chairperson, Mr. Michael Connolly. Three persons from the group speak at the meeting for 15 minutes and then leave. The Mayor of Tuam Town Council will also be invited to attend.

Cllr. Kelly proposed that Tuam Town Council meet the Area County Councillors separately . Cllr. Bane seconded the proposal. Mayor Kitt agreed to contact the Councillors and arrange a meeting for Thursday, 6th September, 2012 if possible.

Arts Grants:

An application for funding was received from Tuam Traditional Festival Committee for funding under the recently advertised Arts Grants Scheme. Mayor Kitt proposed that €500 be provided. Cllr. Reilly seconded the proposal. Cllr. O'Grady proposed that a copy of accounts be submitted by Grant recipients. Cllr. Reilly seconded the proposal.

Bunting:

The provision of street bunting was raised by Cllr. Reilly and Cllr. Bane. Mr. Gilmore informed the members that the cost of putting up the bunting would cost €600.

Following discussion it was agreed that the Mayor would contact the Chamber of Commerce and seek assistance with the provision of buntings and flags.

JPC Meeting:

It was agreed that the Acting Town Clerk would contact the Superintendant to arrange a J.P.C meeting.

Ambulance Base:

The Mayor welcomed Mr.Paudie O'Riordain, Area Operations Manager, H.S.E West. Mr O'Riordain informed the members that the new ambulance base is expected to be in operation by the end of October and will be staffed by existing staff from Galway base. To provide a 24 hour / 7 day week service, 11 staff members would be required and a Business Case will be put forward next year for staffing.

<u>Tuam Main Drainage:</u>

Mr. Sean Whelan, Senior Resident Engineer, Galway County Council informed the members that due to problems with connections to the Palace Fields, a new sewer pipe will have to be laid through the Palace Grounds. He assured members the park will be fully reinstated after completion of works. Resurfacing works will also take place from market square to Egans garage Dunmore road over the next few weeks. Cllr. Flanagan queried why these works could not be carried out during school holidays. Mr. Whelan explained that after pipelaying, time must be allowed for settlement before resurfacing can take place.

Managers Business:

Mr. Gilmore informed members that contract documents are being prepared for improvement works in the Shambles. Part 8 has already been done. In reply to Cllr. O'Hora Mr. Gilmore stated that a market place could be accomodated.

Other Business:

It was proposed by Mayor Kitt and seconded by Cllr. Kelly that Cllr. Reilly and Cllr. Flanagan attend the A.M.A.I Conference in Ballinasloe on 13th 14th and 15th September.

In reply to Cllr. Ward's query relating to the motion from Mayo County Council read at the July meeting,

"that the members resolve to call on the Government to introduce the necessary legislation and or constitutional change to prohibit the receipt of a second state, semi-state or E.U. pension by any one individual and that no state , semi state or E.U pensioner be employed by the State , or semi state body while in receipt of State or semi – state pension."

Mr. Gilmore stated that the Acting Town Clerk would write to Mayo County Council supporting the motion.

Mayor Kitt informed the members that following on from Cllr .Flanagan's meeting with the Minister, Ms Bluett from the IDA will be visiting Tuam shortly to carry out an audit with regard to potential job creation in Tuam Town.

The meeting concluded.
