

# TUAM TOWN COUNCIL OF 12<sup>TH</sup> MAY, 2014

Attendance: Cllrs: Officials: Mayor I. Kelly L. Bane, S.A. Flanagan, E. Kitt, T. Reilly, M. Ward, P.O'Grady, P. O'Hora Mr. L. Gavin, Acting Director of Services Mr. E. Molloy, Senior Engineer Mr. J. Leahy, Senior Executive Engineer Ms. M. Dunne, Acting Town Clerk

Mayor Kelly welcomed everyone to the final meeting of Tuam Town Council. Cllr. Reilly on behalf of Pieta House Committee thanked all who took part in the "Darkness to Light" walk. Mayor Kelly and the Councillors all the Councillors complimented all who took part.

Cllr. Reilly requested an update on Brownes Field and also in relation to the contribution to Tuam Tidy Towns Committee and Tuam Trad Festival Committee.

#### Matters arising from the minutes:

Mr. Gavin stated that the Council are in the process of trying to identify ownership and he would appreciate an input from anyone who may have information which would speed up the process. Cllr. Bane proposed that the Town Council would write to the Municipal District Council requesting that they follow up on the Brownes Field Project. Mayor Kelly seconded the proposal. Mayor Kelly confirmed that contributions were allocated to Tuam Trad Festival and Tuam Tidy Towns at the April meeting the Town Council.

Cllr. O'Hora requested an update on the position relating to the FCA Hall. Mr. Gavin stated that an inspection was carried out and there are some works to be done. This will also be carried on to Municipal District Council.

#### Adoption of Minutes:

Cllr. T. Reilly proposed the adoption of the April minutes of Tuam Town Council. Cllr. M. Ward seconded the proposal.

#### Tuam Community Council:

Mayor Kelly proposed that a date be set for the first meeting to Tuam Community Council and requested all members interested to attend. The date was set for Monday, the 9<sup>th</sup> June, 2014. Cllr. Reilly seconded the proposal.

Cllr. Reilly asked if the Town hall would be available for the meetings. Mr. Gavin stated that it would not be available for the first meeting but the Committee may write to the Municipal District Council for permission to use the Town Hall.

#### Application for Funding for Tuam Sugarbeat Festival and Tuam Community Games Committee:

Mr. Gavin stated that €500 will be allocated by Tuam Town Council to the Sugarbeat Festival Committee and €500 will also be allocated to Tuam Community Games Committee.

#### <u>A.O.B</u>

Mayor Kelly asked if there were plans for the safe keeping of the Mayoral chain and stated that her late Father Miko Kelly R.I.P was the first Mayor of Tuam and she was the the last mayor and the Kelly Family would like to sponsor a secure cabinet to display the chain if Galway County Council were agreeable to this.

Mayor Kelly proposed that the Mayoral chain would be retained in Tuam preferably Tuam Library where it could be on public display .

Cllr Flanagan seconded the proposal

In reply to Cllr. Reilly in relation to photographs in display in the Town Hall, Mr. Gavin stated that the assets of Tuam Town Council would transfer to Galway County Council and the Council would be mindful of the history of these photographs.

The Councillors individually spoke of their time spent on Tuam Town Council and referred to the huge loss the Town Council will be to the people of Tuam Town .

They thanked all Councillors and officials past and present for their contribution.

Mr Gavin Director of Services thanked the Mayor, all past and present Town Councillors, and Town Clerks. He stated that history will show the huge effort and time put into the town and this work will continue into the future with the Municipal District Council. He stated that the town is well placed with infrastructure i.e Roads, water, gas, for the future.

Mayor Kelly welcomed all present especially the members of the 2004 and 1999 boards ,retired Town Clerk Angela Holian and all Engineers , Council Staff, and members of the press. Town Council -Final Meeting.

As we conclude the May meeting the last ever meeting of Tuam Town Council I would like to welcome you all here this evening on this very historic occasion. I would like to especially welcome the members of the 2004 & 1999 boards, retired. Town Clerk Angela Holian & our previous Director of Services Mr Frank Gilmore all engineers and council staff, members of the Press, Ladies & Gentlemen .Tonight is a very sad night for the town of Tuam as our town loses its town board after 401 years. At this point I would like to thank and remember all past commissioners & councillors both living and deceased who have served this town so well over the years. You will be glad to hear I'm not going to recount the events of the last 401 years but I am going to go back to 2002.

In 2002 Tuam Town Commissioners became Tuam Town Council (in accordance with the Local Government Act of 2001) & the Chairperson of the day, Miko Kelly ,my late father, became the first Mayor of Tuam. I'm sure at the time he never would have believed that 12 years later his daughter would become the Last Mayor of Tuam.

I am now going to read the minutes of that meeting from March 5<sup>th</sup> 2002.

People including ourselves would be of the opinion that as town councillors we had very little real power however we did have

a forum for highlighting issues , and had a direct line to the town engineer and Director of Services from Galway Co Council The fact too that our meetings were covered by the local press kept the people of the town informed of what was happening at our meetings.

The town council gave financial support to a lot of local community groups like Tuam Trad festival, Old Tuam Society, Tuam Tidy Towns & Tuam Chamber of Commerce .The Town Council supported all cultural, historical ,sporting , charitable, religious and economic efforts in the town over the years.

The loss of Tuam People of the Year awards is another civic event that has come to an end this was a very simple acknowledgement of local volunteers doing tremendous work in the community.

The role of Mayor is another loss for the town as the Mayor represented the people of Tuam at so many events and ceremonies and promoted the town in a positive way. In my year as Mayor I met so many wonderful people and groups doing fantastic work for the town these people are invaluable & make an outstanding contribution to this community.

As the last Mayor of Tuam I would like to thank each and everyone of those people and I am very confident that despite losing its town council Tuam will continue to maintain its community spirit its love of culture, sport, the arts and most of all its fantastic people who make this town such a special place to live. Finally, I would also like to thank my fellow councillors, my Deputy Mayor Cllr. Larry Bane, all the council officials especially Mary Dunne, members of the press, and I would like to wish our two sitting councillors Cllr Larry Bane & Cllr. Eamonn Kitt all the very best in the upcoming election.

#### April Meeting of Tuam Town Council held on 7<sup>th</sup> April, 2014

Ms. Mary Dunne, Acting Town Clerk

Mayor Kelly welcomed Mr. John Joyce who made a presentation on behalf of Pieta House in relation to the "Darkness to Light 5 km walk/run planned for the morning of the 10<sup>th</sup> May, 2014. He informed the meeting that the official opening of Pieta House takes place on 9<sup>th</sup> April, 2014 and he invited the members to attend.

Mayor Kelly thanked John Joyce and wished the Committee well with the "Darkness to Light" Walk. The Acting Town Manager, Liam Gavin and the Council members individually complemented the group on the great work they do. Cllr. T. Reilly stated that he is proud to be involved with Pieta House.

Mayor Kelly welcomed Mr. Shane Donnellan and Mr. John Sheridan, the event organisers with Sugarbeat Tuam Music Festival to the meeting. The festival is planned for August 23<sup>rd</sup>, 2014 (details attached). They asked the Town Councillors and the media for local support. They were also seeking a financial contribution of €1,500. The Mayor and members congratulated John and Shane and informed them that they will examine the financial situation and let them know if funds are available.

Mayor Kelly welcomed Mr.Mick Concannon and Ms.Fiona Cormican from Cluid Housing Association. The representatives were invited by Cllr. Martin Ward and they provided outline plans for a regeneration programme at Gilmartin Road. The programme would involve demolishing some houses, retaining others, and developing some of the long gardens at the rear of the houses into an open area.

Cllr. Ward stated that he was amazed at the transformation in a similar programme carried out by Cluid in Longford. A figure of €88,000 per unit was provided as an estimate for the regeneration programme. The members welcomed the presentation and would like Galway County Council to look favourably on the project. (Copy of presentation is attatched )

#### Matters Arising from the Minutes:

Cllr. Reilly requested an update on the provision of Public Lighting on the N17. Town Engineer, Mr. Langan advised that this is one of the projects included in the Walking/Cycling strategy. Footpaths and Public Lighting will be provided from the town to Brogans Garage, Galway Road, Tuam.

Cllr. O'Grady asked if there was any progress on the designation of an area in the Shambles for a monthly farmers market.

Mr. Gavin stated that there is a National Issue with Markets and the Department of Environment is due to issue guidelines, the designation of the Tuam Market will be addressed when the guidelines are received.

Cllr. O'Hora asked if there was any progress in relation to leasing of the F.C.A. Hall. Mr. Langan stated that the building has not been inspected yet and it needs to be checked by an Electrician. Mayor Kelly requested that an inspection would be carried out prior to the next Town Council meeting.

Mr. Gavin advised that the Building cannot be leased until it is advertised for lease and submissions invited from all interested parties.

Cllr. O'Grady asked if there were any plans for the use of the Town Hall after the Abolition of the Town Council.

Mr. Gavin stated that all buildings, assets and liabilities of the Town Council would transfer to Galway County Council and the Municipal District Councils would be involved in the decision on the future use of the Town Hall.

#### **Brownes Field**

Mr. Liam Gavin, Acting Town Manager updated the members on the position in relation to Brownes Field. He stated that Galway County Council, the G.A.A. and the residents are in agreement with the plans for Brownes field. However, the problem is Galway County Council have not yet established the ownership of the property and it would be unwise to progress with plans until the title to the property is established.

O'Hora was concerned that if there was no budget available that the meetings may become a talking shop and advised that a slightly different model could be looked at where proposals from the meeting could be brought foward to Council level by the members of the Municipal District Council who would be attending the meetings.

Cllr. Reilly requested that this item be placed on the Agenda for the May meeting.

#### Adoption of the minutes

The adoption minutes of the March meeting of Tuam Town Council was proposed by Cllr. Reilly and seconded by Cllr. Kitt.

#### <u>Applications for funding from Tuam Tidy Towns and also Tuam</u> <u>Traditional Festival .</u>

In response to applications for funding received it was agreed by the members that a contribution of  $\notin$ 800 would be granted to Tuam Tidy Towns and a contribution of  $\notin$ 700 would be granted to Tuam Trad Festival .

It was agreed that requests for contributions received from Tuam Community Games committee and Sugarbeet Festival Committee would be discussed at the May meeting of Tuam Town Council.

#### A.O.B

Cllr. Kitt enquired if traffic calming measures could be provided at Woodfield Estate, Galway Road, Tuam .He also requested that the Community Wardens be vigilant and impose fines where necessary for offences relating to dogs litter in public places particularly the Palace grounds. Town Engineer Mr. Langan stated that the wardens patrol the Palace grounds on a regular basis and there is a decrease in the incidents recently.

Cllr. Bane raised the matter of repair of Public Lighting at Lissadyra and enquired if repairs could be carried out where an application to take the Estate in charge has been submitted. Mr Gavin replied that repairs cannot be carried out by Galway County Council unless the Estate is actually taken in charge by Galway County Council.

Cllr Kitt stated that he had been approached by residents of Cuirt na Cora Estate on the Weir Road requesting that a sign would be erected at the entrance to the estate .

Mr . Langan stated that he will check with the Planning Department as there may be a Bond to cover cost of the signage .

Cllr. O'Hora stated that he uses the Tuam Civic Amenity site regularly and has noticed a decline in the number of customers using the site and suspects that this is contributing to the huge amount of illegal dumping in Tuam and environs . He requested current information relating to useage of the site .

Mr Gavin stated that he will request this information from the Environnment Section of Galway County Council .

Cllr Reilly suggested that questionnaires would be sent out to the public requesting details relating to how they dipose of their waste .

Mayor Kelly requested that this item would be included for discussion on the agenda for the May meeting .

#### Matters Arising from the Minutes

Cllr. Reilly requested an update on public lighting on the N.17.

Cllr. Kitt requested an update on Brownes field.

Mr. Langan replied that the Consultants are looking at a proposal for public lighting and footpaths from the Town to Brogans Garage as it would be pointless in constructing footpaths and providing lighting past this point as there are plans for a roundabout at this location later . In relation to Brownes field Mayor Kelly stated that she had a discussion with the Committee recently and they are willing to proceed with developments themselves due to the delay. Cllr. Reilly stated that both parties are in total agreement but are awaiting the finalising of the lease. Cllr O'Grady referred to the Planning permission which is about to issue in the vicinity.

Mr. Langan informed the members that a section 183 must be prepared by the Town Council and the terms and conditions of the lease need to be thrashed out. A discussion took place and Cllr. Bane proposed that a meeting be set up to discuss the matter and attempt to move it forward for Friday 7<sup>th</sup> March for the three Councillors who sit on the Stadium Committee, the G.A.A, the residents Committee, and Mr. Langan Town Engineer. Cllr. Kitt seconded the proposal.

In relation to the FCA Hall, Mayor Kelly stated that the building needs to be inspected to establish the state of the building before a leasing arrangement can be considered.

## January meeting of Tuam Town Council held on 6<sup>th</sup> January 2014.

Mayor Kelly welcomed everyone back after Christmas and wished everyone a happy new year. She welcomed Mr. Liam Gavin Acting Director of Services to the meeting.

#### Matters arising from the Minutes.

Cllr. Reilly raised the matter of Browns Field and requested Mr. Liam Gavin , Acting Town Manager to report back to the Council at the February meeting with an update on the current position. The request was supported by Cllr. Kitt who stated that during his term as Mayor he proposed that €5,000 would be allocated towards this project and he would like to know if this contribution would be forthcoming.

Cllr. Bane stated that the project should be progressed as it would benefit attracting people into the town. He also raised the matter of safety on the new inner relief Road .

Cllr. Reilly requested that the public lighting would be extended on the N.17. There is a 50kph speed limit in place at the location. He requested also in the interest of safety that a "no right turn" sign would be erected at the junction of the new Inner relief road and shop street as discussed at a previous meeting.

Cllr. Reilly requested that the Chairperson of Tuam Tidy Towns would be invited to the February meeting of the Council so that he could provide a programme of works which they intend to carry out. Cllr. Reilly proposed that a letter be sent to the OPW requesting that the river nanny would be cleaned from the Weir Road to Bishop Street. Mayor Kelly seconded the proposal. Mr. Gavin Acting Town Manager suggested that in lieu of writing a letter, that Mr. S. Langan Town Engineer would follow up the matter and liase with the OPW regarding these works, as Mr. Langan has been dealing with the OPW in relation to other Council matters. Mr. Langan stated that he has met with the OPW and while a dispensation has been given by the Fisheries Board to carry out these works they cannot commence until after 31<sup>st</sup> March 2014.

Cllr. Bane raised the matter of traffic backing up on the N.17 northbound and requested that funds be allocated as a matter of urgency to provide a filter lane for traffic turning right at Weir Road as this would allow traffic to flow more freely and reduce the back-up.

Cllr. Kitt suggested that if the traffic lights were upgraded and "intelligent" lighting installed it may help the situation. Cllr. Reilly referred to a previous request to have all the traffic lights synchronised.

#### **Adoption of the Minutes**

Cllr. Reilly proposed the adoption of the minutes of the December meeting and the Annual Budget meeting of Tuam Town Council.

Cllr.Kitt seconded the proposal and the minutes were adopted .

#### Capital Projects funded by Town Council Funds.

Mayor Kelly proposed the provision of new street lighting at Weir Road would be prioritised as one of the projects for capital funding and requested that the project be placed at the top of the list. Cllr. Kitt seconded the proposal and it was agreed by all.

Cllr. Bane proposed that the footpaths at Liam Mellows Street would be upgraded. Cllr. Reilly seconded the proposal and requested that footpaths at Abbeytrinity would also be upgraded.

Cllr. Flanagan requested that a new playground or refurbishment of the existing playground would be considered as one of the projects to be funded. Cllr.O'Hora suggested that consideration should be given to a number of playgrounds at different locations in the town as opposed to one larger one.

Cllr. O'Grady raised the matter of funding for re-generation of Gilmartin Road and stated that he did not agree with further funding of this scheme and suggested that the County Council reexamine the procedures for the allocation of Council houses.

Cllr. Reilly stated that a report should be prepared giving details of the amount of funding already provided in the area, and outlining the current situation relating to houses in the estates.

Mayor Kelly suggested that three or four projects from the list of Capital Projects presented should be prioritised on the basis of need and also on safety grounds. Mr. Gavin advised the Council to prioritise four projects and report back to the February meeting, with advice on how the projects could be delivered. A discussion took place and it was agreed that the following projects should be considered, -:

#### Dear Madam

The Town Council in all its existence has strived to do what was best for the town. In doing that, it has been the keenest supporter of Tidy Towns and has supported its every initiative in the past. The last three years under the stewardship of Pat Fahy and his able committee has seen a dynamic increase in the adjudicator's mark and an associated improvement in the town's appearance. Under a new chairman and new committee we will strive to stand on the shoulders of giants and go forward zealously.

This year Tuam Tidy Towns will embrace a bold plan of action. We will make a definite statement to mark the town out because we believe our town is unique and the centre of the universe. You have to believe and then act accordingly. Below are some of our plans to make Tuam even more unique.

We propose to enact a Hanging Basket Scheme for the <u>town of Tuam</u> in 2014. For the scheme to be a success, watering and maintenance of the baskets would be necessary from the first of May to the middle of October. Our committee and agents are committed to this endeavour and are most willing to carry out this watering and

maintenance over the six months of the coming summer and for summers to come.

However, in order to accomplish this we must acquire the following: a trailer, small generator, rainwater extraction pump, 100 litre water tank, lance and fittings, hose and rainwater tanks at locations with large roof areas. All of this will require about €1500 and a grant to cover this expense from Tuam Town Council would be an imperative. This scheme is a very worthy one. It should bring a fantastic benefit to the town over a number of years, for a relatively small outlay combined with voluntary input.

In conjunction with this project we plan to have summer plantings for planters in the centre of town. This is the most inexpensive and effective way to use them. Micro plants need to be planted in January/February to be ready come May. We are in the process of negotiating a contract for eight planters with extras for expected vandalism. We are very hopeful that you the Town Council could fund this project, as a parting gift to the town, which once started and with our voluntary assistance could sustain itself long into the future.

We hope to arrange that power washing will have effect at various locations, Curragh Park, Temple Jarlath High Street, the wall bounding St Mary's with High Street, and walls at the Weir Road junction. At Temple Jarlath we plan to insert all-weather profiles made by JFC onto the wall, so that variegated ivy can take root on the wall that would in time completely cover it. The "Woodcutter" could go and live somewhere else. We hope the County Council will install litter bins on this street in more effective positions. They may even be persuaded to repaint their old county building. With all these improvements High Street could recover some of its pride!

An agreement has been made with Inland Fisheries Ireland and the Office of Public Works for a reconfiguration of the Nanny River from just upstream of the Palace Grounds Bridge downstream to the Presentation Bridge, a distance of 200 metres. This project will go ahead pending permissions from the Presentation Board of Management and Galway County Council. It will be funded by Tuam Anglers Association.

TUS and Tuam Anglers have already been spraying Hogweed for a number of years and are beginning to bring it under control. Now they will have to tackle Japanese Knotweed, a different but probably an even more difficult problem.

A new cycling and walking route is being presently built taking in Dunmore Road Bobby Burke Road N17 and Tullinadaly Road. We intend to plant 46 trees on this route.

A new road was built last year leaving bare unfinished walls and rusty stanchions clearly visible. Pending permission we hope to cut away the stanchions and paint the walls. Similarly we plan paint or improve some derelict buildings pending permission of their owners.

The Shambles will be rebuilt. A new green created on the N17 approach from Milltown will bloom. Our town will be a better place.

We were very pleasantly surprised by the complimentary remarks of the Judges after our presentations and our walk about of the estate to them. As you will be aware Parkmore is the largest Housing estate in County Galway with 145 houses. We would dearly like to see the momentum that has grown in the estate in recent months being sustained.

Hence my letter: our initial efforts concentrated on getting people to paint their houses and most did, the Resident Association used what funds we could raise to paint common areas and walls etc. However some residents could not genuinely afford to paint their houses or were reluctant to commit what little spare cash they had to an amount of paint that would not be sufficient to complete the job.

Our Association would like to put together a proposal to ask you to assist us to further our work in the enhancement of the estate. We feel this would have a major benefit in terms of on both Maintenance and Morale. We were wondering if you could assist us with some of your Tuam town Council Funding to help us with this project.

This would insure that this estate would be kept to a high standard so that when houses become available that people looking for housing would be delighted to live on this estate. We are working hard to make sure that this estate does not fall like other estate in the town.

The estate is in five section and we are proposing work with people in each section to see what needs to be done to improve their area. We are looking for €5,000 with allocation 1,000 per section. We look forward to a positive response to our project DUINCH

### Proposal To Tuam Town Council – 3rd February, 2014

Firstly, we would like to thank the Tuam Town Council for giving us the opportunity to present this proposal

Use of the former Reserve Defence Forces Barracks, Old Road, Tuam

Proposed By:

The committee of the Marian Choral Society on behalf of the Marian Choral Society, Tuam

### Proposed Use:

We view the premises of the former Reserve Defence Forces Barracks as a potential base for our society.

We currently rehearse in various hotels, pubs and wherever space is freely available to us at the time. This usually results in the necessity to acquire multiple venues at once as various parts of the cast need to rehearse separately.

We currently store our costumes and props on the top floor of the Parish Centre (formerly the Mercy Convent) and while we are appreciative of the space we can only gain access through the administrators at times that are convenient to all parties. This sometimes results in us being unable to access items as required.

All the Society's administration activities are currently carried out in different committee members homes and/or places of work. This can prove difficult to carry out functions such as membership, insurance, ticketing, promotion, liaising with patrons, sponsors and members etc than if it were all run from one central location.

We also feel that this premises would give us the opportunity to expand and move our Society forward while still being cognitive of all past achievements, ie. a reception area which shows the history of the Society and recognizes all past, present and future members contributions to the Society, which could be viewed by the public at various events, festivals etc.

Also, as members of A.I.M.S. (The Association of Irish Musical Societies), we currently host the Western Region meetings in Tuam. These take place in the Rustic Vaults on Vicar Street. The A.I.M.S. Western Region incorporates 19 societies from Sligo to Clare and everywhere in between. We think that to hold such meetings in a facility provided by the town would demonstrate the councils commitment to the support of and dedication to the Arts in Tuam, for others to see.

This facility would allow us to bring all of our day to day activities under one roof and also provide us with the space to grow and realise all our ambitions.

Proposed Management of the Premises:

We propose that the committee of the Marian Choral Society take over all aspects of the management of this site.

We would take full responsibility for all upkeep and not allow it to fall into disrepair.

Our committee currently comprises of, a Chairperson, Treasurer, Secretary, P.R.O. and assistants for all roles. Each of these roles would take on their aspect with respect to the management of the premises. We would also propose that we given permission to make alterations to the building ie, installation of toilet facilities, removal of partitions, dance floor construction, external signage etc, while adhering to planning processes.

We understand that should we be successful in obtaining access to the premises, we will be responsible for ensuring full adherence to any and all legislative and regulatory requirements and/or any costs that may be incurred as a result of occupancy, including (but not exhaustive of) the payment of rates, service charges, utilities, health and safety standards and appropriate insurance.

We will hold our AGM on 13<sup>th</sup> February, 2014 where we will propose to amend our constitution to compel any future committee to take full responsibility for the premises.

### Funding:

We are a non-profit organization and raise our running costs through our shows and other charitable activities. As such, we are not in a position to offer any rental payment for the premises, however, the Society does possess a small surplus of

funding which will be used for the upkeep of the building and any alterations required. Further details can be provided on request by our Treasurer.

### About Us:

The Marian Choral Society has been part of our town for 40 years, putting on a musical production every year for the last 37 years. It has brought so much joy to many participants as well as literally thousands of patrons and audience members over this time.

This Society has given so much to the people of Tuam over the years and has always been very professionally run. We, the present committee, believe that although this proposal is a 'big ask', we are sure that for the Society to be in possession of a 'home' here in town, can only lead to another bright 40 years of musical entertaining and entertainment for young and old alike in Tuam.
