# 1 Miontuairiscí ó chruinniú an Choiste um Fhorbairt Pobail Áitiúil (LCDC) a tionóladh an 10ú Iúil 2018

Minutes of Local Community Development Committee (LCDC) held on 10<sup>th</sup> July 2018

T. Turley (Chairperson) welcomed all members to the meeting and noted the apologies received. He asked if there were any issues arising from the minutes of the LCDC meeting held on 10<sup>th</sup> July.

S. Ó Coistealbha requested that a copy of presentation from GRETB from previous meeting be circulated to the Members. No issues were raised by the Members.

On the **PROPOSAL** of M. Ward, **SECONDED** by D. Dowling, the Minutes of the Meeting of the Local Community Development Committee (LCDC) held on 10<sup>th</sup> July were agreed.



### 2 Tuarascáil ar deontais ceadaithe faoi Clár um Fheabhsú an Phobail 2018 Report on grant allocations for the Community Enhancement Programme 2018

K. A. Mortimer gave an overview of the LCDC subcommittee meeting for the Community Enhancement Programme that was held on 5<sup>th</sup> September to which she was Chairperson. Galway County LCDC was given an allocation of €143,401 for the Type A & Type B projects, with a recommendation of 30% to be ringfenced to Type A projects of €1000 or less. An extension of the CEP2018 was announced, specifically for Men's Sheds, with an allocation of €18,841 for Men's Shed that were affiliated with the Irish Men's Sheds association, giving an overall total of €162,242.

#### CEP Type A – capital expenditure of €1000 or less

The ethos of 1 grant approval per group was taken and all who applied under Type A received grant aid except for those who were eligible under Type B or the Men's Shed fund. The grants awarded either equalled the amount sought or was a max of €1000. 44 applications were approved grant aid totally €41,757 (29% of allocation)

#### CEP Type B – capital expenditure greater than €1000

The applications under this category were assessed and marked in line with the scoring matrix approved by the LCDC, with prioritisation given to projects targeting disadvantaged areas and/or disadvantaged groups. The total no. of applications under this category was 72 seeking €784,076 of grant aid. The remaining allocation available to Type B applicants was €101,644. It is proposed that 10 grants are approved under this category

#### **CEP Men's Sheds**

15 applications received under this scheme. Award criteria governed by the DRCD stated that only Men's Sheds that are affiliated with the Irish Men's Shed Association were eligible to apply. 14 of the applicants met the criteria and are being awarded grant aid. The one remaining applicant who didn't meet the criteria, it is proposed that funding will be provided from an alternative source of funding.

Four applications were referred to Galway City Council as the groups who applied were in the city jurisdiction. A list of the recommended grant awards was circulated to the Members.

- T. Turley welcomed the approach taken in the assessment of the grants and that a wide spread of groups is being grant aided.
- S. Ó Coistealbha, commended the work done and that he was fully satisfied that the requests of the LCDC was taken on board during the assessment, especially with the wide distribution of grant aid proposed. He also agreed with the movement of applications between the categories to maximise the benefit of the limited funding available to the LCDC and the redirection of some applications to alternative sources of funding, where feasible.

The Community Enhancement Programme grant allocations was approved on the **PROPOSAL** of E. Brown and **SECONDED** by D. Dowling.

- 3 Caiteachas i Gaillimh i rith 2017 agus maoiniú beartaithe chun tharraingt anuas do 2018/2019 Galway spend during 2017 and proposed funding drawdown for 2018/2019
- K. Coyne gave an overview of the various programmes underway; -

**CLÁR funding** - is a targeted investment programme for rural areas that aims to provide funding for small infrastructural projects in areas that experience disadvantage. There are two measures that are led by



the Local Authority, Measure 1 - Support for Schools/Community Safety Measures and Measure 2 - Play Areas. In 2017, 13 projects were approved for the two measures and are fully completed. In 2018, a total of 15 projects were approved, 10 under Measure 1 and 5 under Measure 2 with a total approved allocation of €603,615.

Outdoor Recreation Infrastructure Scheme - is part of the Government's Action Plan for Rural Development and provides funding for the development of new outdoor recreational infrastructure or the necessary maintenance, enhancement or promotion of existing outdoor recreational infrastructure in Ireland. The scheme seeks to support those sporting and recreational pursuits based on use of the resources of the countryside that contribute to healthy active lifestyles and the economic and tourism potential of the area for both local communities and tourist visitors alike. In 2018, a total of 5 projects was submitted, four under Measure 2 - Medium Scale Repair/Upgrade and New Trail/Amenity Development (€20k to €200k grants) and one under Measure 3 - Large Scale Repair/Upgrade and New Strategic Trail Development (€20k to €500k grants), amounting to over €1m.

Town & Village Renewal - is an initiative under the Government's Action Plan for Rural Development with a focus on improving the economic development of our rural towns and villages. In 2018 a submission was made to the Department for 12 projects for a variety or works - which range from enhancement of town & villages, to promotion or public lighting type projects - with an estimated cost of €1.3m. A decision is still pending from the Department.

A general discussion was had amongst the members with regard the various scheme. Cllr. J McClearn commended the various schemes, in particularly the Town & Village Scheme citing the example of the village of Woodford that had benefit of getting funding under this scheme for new footpath and it was a great incentive to the local community who came together to do additional works such as clean and paint the derelict properties etc. Cllr. D. Connolly stated welcomed the funding being provided and said that there should be a focus on areas of disadvantage. He stated that continued support from GCC officials to the various community groups is vital to give them confidence to apply under the various schemes.

Presentation - Unemployment rate figures (Eoin Brown)

E. Brown of the Department of Employment Affairs and Social Protection gave a presentation on 'Unemployment and Live Register in County Galway'.

There was a general questions and answers during the presentation relating to the information being provided and clarification on some of the statistics presented. The members had an in-depth discussion on CES, RSS & TUS and how such schemes can be a lifeline for some people. Especially those who live alone, there is a huge social aspect to these schemes, but it's becoming difficult to get a scheme to suit all, eligibility criteria can be very strict, there should be a special case made in exceptional circumstances. There are very little financial incentives for the individuals to participate and this should be reviewed. The concept of the schemes is great but the structure needs to be addressed.

T. Turley thanked E. Brown for his presentation and the members for their active discussions. *Presentation circulated to the Committee after the meeting.*
