To: The Cathaoirleach and each Member of Galway County Council

Re: Draft Budget for financial year ending 31st December 2018

Submitted in accordance with Section 103, Local Government Act 2001 (as amended)

Dear Member,

I enclose, for your consideration, the Draft Budget for 2018, together with a report detailing the main provisions outlined therein and a summary report from the Directors of Service in respect of activities in their respective functional areas which is submitted as an annual progress report in respect of the Corporate Plan.

In accordance with the statutory requirement issues relating to the preparation of the Draft Budget were considered at meetings of the Corporate Policy Group held on 12<sup>th</sup> September 2017 & 7<sup>th</sup> November 2017.

The financial and budgetary position of the Council was considered by the Finance Committee at meetings held on 7th March 2017, 3<sup>rd</sup> April 2017, 23<sup>rd</sup> May 2017, 7<sup>th</sup> June 2017, 26<sup>th</sup> July 2017, 12<sup>th</sup> September 2017 and 7<sup>th</sup> November 2017.

The Council considered and made its determination on the Local Property Tax adjustment at its meeting held on 29<sup>th</sup> September 2017 and each of the Municipal Districts considered the Budgetary Plan for each Municipal District at a series of meetings held between the 24th October 2017 and the 27th October 2017.

The Council may by resolution amend the Draft Budget but shall adopt the Draft Budget, with or without amendment, and determine, in accordance with the Budget so adopted, the annual rate on valuation to be levied and where appropriate have regard to the base year adjustment — determined in accordance with Section 29 of the Local Government Reform Act 2014.

The Council is required to complete the statutory process within a period of 14 days. This allows for adjournment, if necessary, of the Budget Meeting which is scheduled for 27th of November, provided the process is completed on December 10<sup>th</sup>.

#### General

The Members will be aware that much of the budget in any year is comprised of nondiscretionary costs such as loan charges, payroll, statutory demands, insurances, pensions etc or is comprised of expenditure that is assigned to the delivery of particular services

Given the funding available and the number of demands it is recognised that additional funding could be utilised effectively under almost every budget heading but the allocation of further resources has not been possible in almost all areas.

There are a number of aspects of budget 2018 which have been previously advised

- Reduction in income from Local Property Tax
- · Increased costs of insurance premia
- Reduced dividend from IPB
- Part funding (80%) of the increased costs arising from the National Pay Agreements
- Additional new ratable valuations
- Reduced funding from NPPR

In addition there are significant costs arising from new requirements in respect of housing maintenance.

Overall while the total gross expenditure budget shows an increase of €7m the net increase over the estimated outturn for 2017 as outlined in Table A is €89,000 (page 1 of the Statutory Tables). Additional expenditure in respect of roads and water services recorded in the 2018 budget is a contra item.

Keeping within budget in 2018 will require very careful monitoring by all units throughout the year and no contingencies have been provided for in the budget for 2018.

#### **Local Property Tax**

The funding previously derived from the Local Government Fund has been replaced by the proceeds from the Local Property Tax / Pension Related Deduction. The base funding from this source in 2018 is estimated to be largely the same as the amount received each year since 2014.

The decision of Council not to maintain the increase in the Local Property Tax reduced our income from this source by  $\leq 1.45$ m and this was partly reflected in the Municipal District budgets already considered by the Members.

The funding from the Local Property Tax/Pension Related Deduction has been estimated to produce income of €14.5m in 2018.

#### Financial position

The current financial position of the Council has been discussed in detail by the Finance Committee by the Corporate Policy Group and by the full Council and the revenue funding available to Galway County Council remains a critical issue. There is a requirement for additional funding in almost every area of activity of the Council including housing, property maintenance, road maintenance, fleet replacement, street cleaning, verge trimming, public lighting, economic and tourism development, ICT Development, the requirement for additional staffing in key areas and new programmes such as HAP. It is likely that future cost increases in many areas will be beyond our control giving rise to ongoing budgetary issues in the coming years.

#### **Commercial Rates**

As outlined previously the commercial rate for the County of Galway can only be increased once the rate for the former Ballinasloe Town Council area has achieved parity. As outlined to the Members the county rate could be increased if an administrative arrangement were introduced to limit the impact on the businesses in Ballinasloe. The budget has been formulated on the basis of bridging 33% of the difference between the Ballinasloe and the County rates. The County rate currently stands at €66.59 which is unchanged since 2009 and the proposed Ballinasloe rate is €61.00 which was increased for 2016 and 2017 but prior to that had been unchanged since 2008. The following table shows a comparison of the rate on valuation with the other counties in the region.

While the commercial rate has not increased since 2009 a general rate increase has not been included in the formulation of the draft budget. Our overall financial situation suggests that a commercial rate increase will be essential in respect of the budget for 2019. The issue of refunding 100% of commercial rates on vacant properties has been discussed as being a disincentive to the economic use of such properties. Section 31 of the Local Government Reform Act 2014 provides that a local authority may determine the proportion of a refund of commercial rates on vacant properties that would apply to each electoral area. No provision for income from this change has been made in respect of the draft budget for 2018 pending further consideration by the Members.

#### Work Programme

In addition to routine service delivery there are many projects that Galway County Council is currently leading will lead or is otherwise engaged in. These include the resolution of flooding problems in South Galway, Ballinasloe and elsewhere, the development of the harbour at Inis Oirr and similar projects, collaboration on the rollout of Broadband, implementing Government Policy and initiatives in respect of Housing delivery and maintenance, the delivery of the Galway City Ring Road, the commencement of the Ballinasloe Town Enhancement Scheme, the operation and remediation of the East Galway Landfill, the progression of a Food Hub in Athenry, the improvement of the N59, the advancement of Greenway proposals, the advancement of Masterplans for the former Galway Airport Site and the lands adjacent to the railway station at Garraun, the development of a Climate Change Strategy, the advancement of initiatives under the Tourism and Amenity Infrastructure Scheme, the development of a Digital Strategy, the delivery of European Region of Gastronomy 2018 and many other initiatives across the organisation. All of these and other projects will continue to advance in 2018.

#### Staffing

The Members will be aware that our staffing level is one of the lowest per head of population which impacts on our capacity to delivery services. Many positions have become vacant and remain unfilled due to financial necessity and I am in no doubt that the current staffing level is insufficient to deliver the quality of service that the Members and the public expect and demand. We have been as efficient as possible in filling posts and sourcing funds to defray the costs but further costs in respect of staffing are inevitable. As

outlined elsewhere some posts are part-funded at least in the short term including an officer to lead on our role in respect of the Broadband Strategy while other requirements such as our responsibilities under the General Data Protection Regulations must be funded from our budget. There are a number of positions that are the subject of acting arrangement due to posts not being filled permanently and in this regard administrative post competitions have been held in recent months. Therefore over the coming period there will be some filling of positions and a resultant movement of staff which together with consideration of the remit of each directorate is designed to give the organisation more certainty and stability for the period ahead. It is anticipated that there will be 23 retirements in 2018 which reflects the age of our workforce and such retirements incur additional costs in respect of pensions and gratuities.

#### Housing

Galway County Council has responded to the priority of housing delivery and is implementing the various initiatives of Government introduced to address this issue. In addition to delivering new housing units there are other initiatives and responsibilities including the introduction of minimum standards, electrical testing and planned maintenance programmes as well as earlier turnover of vacant units. The costs of delivering on these requirements are far beyond the financial capacity of our revenue budget and therefore the approach is to make part provision in our revenue budget in so far as we can afford and to consider the use of Internal Capital Receipts (ICR's) as a source of funding. However it is important to recognise that the level of ICR's is limited and there are a number of demands on same as a funding/co-funding mechanism with the approval of the Department also required.

#### **Economic and Community Development**

Notwithstanding the limited resources available in recent times the Council has continued to support communities and advance the economic development of the County. Two staff positions which are part funded by the Department have recently been filled in the Community and Enterprise Unit and the position of Public Participation Network Cocoordinator which is also part funded has been put in place. Galway County Councils involvement and support, financial and otherwise, is critical for many projects to progress with examples of the proposed Food Hub in Athenry and the Innovation / Enterprise space in Ballinasloe (both of which are the subject of El funding applications), the establishment of the Western Region Audiovisual Producers (WRAP) Fund and the Music Generation Partnership being some examples from 2017. The financial support element of some of these projects is more significant that others but it is essential that we are able to play the role envisaged for us in both economic and community development under the Local Government Reforms of 2014.

Galway County Council will continue to provide funding to various groups and bodies. This includes funding under the headings of Festivals, Economic Development, Community Facilities, Tidy Towns, Social Inclusion, Youth, Sport, Arts, Heritage and the Irish Language. This support by Galway County Council makes a significant contribution to the efforts of many communities and organisations to deliver initiatives and improvement in their areas. While it has been the practice to continually review this spend there will be careful consideration of how to target the funding available to achieve the best outcomes overall and to make any appropriate adjustments that may be identified. The Community & Enterprise Unit will continue to ensure optimum alignment with Galway County Councils objectives and complementarity to programmes such as ECOC and EROG.

#### E-Planning

There is a national project underway to introduce e-planning to all local authorities and I am currently Chair of the Project Board. The system development is scheduled for completion in the first Quarter of 2018 after which its rollout will commence on a phased basis most likely with pilot sites. While at one level this is simply the replacement of a manual system with an electronic version of same in practice it is a process of significant change. The main elements will be the ability to make planning applications and submissions on-line together with the making of on-line payment with electronic communication with applicants, prescribed bodies, An Bord Pleanala and the public. This transition will be a significant piece of work for the planning department in the year ahead.

#### **Capital Scheme for Tourism and Amenity:**

Given that Council is to support economic development including tourism the Members will recall that last year we introduced a scheme which would provide a funding opportunity for capital projects which are designed to support both our tourism industry and our communities themselves. The scheme to be funded from development contributions will focus on projects that would be of benefit to tourism while also enhancing the lives of our communities and the scheme sets out key criteria in regard to same. The closing date for submission of Expressions of Interest has recently passed and a total of 28 proposals were received with an estimated cost of €6m. This far exceeds the €1.5m that was signaled as the budget for the scheme, but I emphasise that no preliminary assessment has yet been completed including whether the applications made meet the terms of the scheme.

#### Town Centres.

The Members will be aware of initiatives which were designed to assist in the support of our town centres including development contribution exemptions and reduced rates for residential developments in our revised Development Contribution Scheme and the introduction of a rates incentive scheme for the setting up of new business in vacant properties. While the interest in the rates incentive scheme has been limited to date it is

intended to undertake some work to promote this scheme in 2018. We are all conscious of the need to support our Towns therefore we must consider further initiatives that might be of benefit including capital type projects whether delivered directly by Galway County Council or through working with Chambers of Commerce and/or Tidy Towns Committees. There may be opportunities to align any initiatives with increased Central Government grants schemes and the funding available under the Rural Development Programme and it is intended to bring forward further proposals in this regard.

#### Roads funding

The level of resources available for road maintenance and improvement has been consistent in recent years but falls short of that which would be desirable and necessary. Unfortunately it has been necessary to reduce our own contribution to roads in respect of 2019 but this can be revisited should further funds become available.

TII have by letter indicated that the level of funding for National Road Ordinary maintenance will be reduced by between 17% and 30% in 2018 but it is not anticipated that other grants will be affected.

#### Public Lighting.

The Members will be aware from previous discussion that the costs of public lighting are continuing to increase. Unfortunately I have been unable to make increased provision for public lighting in 2018. There are a number of issues in respect of public lighting that pertain to all Local Authorities relating to age and type of lighting, maintenance and energy efficiency and it is an area that will require significant investment in the forthcoming period.

The following table shows the budgetary trend for Galway County Council in recent years.

I wish to thank the Council's Directors of Service and their staff for their rigorous examination of budget items for 2018. In particular, I want to acknowledge the work of Mr. Ger Mullarkey, Mr. Michael McGovern, Ms Bernadette O'Connor, Ms. Caitriona Lusby and the staff in the Finance Unit and to thank all involved in delivering the draft budget.

The year 2018 will undoubtedly bring further challenges for Galway County Council, but I am confident that with the support of the Members, Management team, and colleagues we will provide valuable services in 2018 to meet the critical needs of the people of Galway.

I recommend the Draft Budget to you for adoption.

# Divisional Reports including Annual Progress Report on the Galway County Council Corporate Plan 2015 – 2019

#### **CORPORATE SERVICES & HOUSING UNIT**

#### 1. Library Development Programme

#### Indicative Activities in 2017:

- Library usage continued to increase in 2017. The Library Service of Galway County Council is one of the most heavily used services in Ireland and libraries are established EREF civic and cultural centres in their communities.
- Libraries remain the most visited public spaces in County Galway, with 500,000 visits in 2017.
- The Summer Reading Challenge took place throughout the county with 4,500 children registering for the challenge and 3,150 completing. Nearly 45,000 books were read by the children of Galway city and county during July/August 2017. Award ceremonies were held in most branch libraries. 548 new children's memberships were recorded during July/August.
- The National Distribution system has opened up the collections of all public libraries to the communities of rural Galway. To date since July 2017, 15,000 requests have been processed by library staff in Galway. Public reaction has been hugely positive to this service due to the accessibility of out of print titles, the availability of course books and access to new titles. The community library has now become an important educational aid to more isolated areas of the county and being able to order books online and collect them has increased the relevance of the library.
- Digital Literacy programmes continued including the continuance of IT classes in bigger branch libraries, facilitated by Age Action, Vodafone, and Rural Alliance. Initiatives included the extension of *Digitise the Nation* classes to An Cheathrú Rua, Dunmore, Loughrea, Portumna & Eyrecourt libraries. Customer training was also delivered on the range of online resources now available. To date Galway library members have downloaded 7500 e-book and e-audio titles.
- Customer led IT solutions included installing SurfBox in a number of libraries. SurfBox allows members of the public to send a print job to a printer in their local library. The print job can be sent from home, and it is released and collected at the library. Surfbox has been installed in Ballybane, Galway City, Westside, Tuam and Loughrea. Princh, which offers the same service, has been installed in the following three libraries. Clifden, Dunmore and Moylough.
- Libraries are vibrant creative hubs. Innovative events delivered in 2017 included
  - Strings Festival Ballinasloe Library and Church Gallery, 1350 people attended the two day festival, enjoying 13 performances featuring Strings as the common theme.

- The festival was funded by Europe Direct and the Creative Ireland programme. Planning is already underway for the Strings Festival 2018.
- Continued expansion of Galway's Great Read programme, funded by Creative Ireland. 2017 featured Padraic O'Conaire, his life, his works and his legacy. A new initiative of the 2017 Great Read is the introduction of a primary and secondary element into the programme. The aim is to work with teachers and students in various schools throughout the County to bring the life of O'Conaire and his writings, both in the Irish language and in translation, to a younger audience. A school in each municipal district was selected.
- Westside Public Library in conjunction with community partners held its first 'Family Day' to encourage community participation in library events. The day was to promote the 'Summer Stars' reading programme and encourage wider community engagement through the provision of workshops, music, face-painting, balloon crafting and storytelling. 2,500 people engaged with this 'Family Day' through attendance or social media engagement.
- Participation in the consultation process for the new National Spatial Planning
   Strategy
- One Book, One Island, Inishboifin, where a community endeavours to all read the same title.
- Event programme on the mobile library service at Castleblakeney Heritage Centre and Central Park Nursing Home, Clonberne.

#### Regular events include:

- Art exhibitions, book clubs, music performances, Culture Night, support for the various Arts Festivals throughout the county and city;
- Europe Direct centres in Galway continue to facilitate a number of annual events, both in branch and outreach.
- Children's Book Month was run in October 2017. New authors were invited this year and proved very successful. The month was launched in Clifden library and over 1,670 children enjoyed 55 events throughout the city and county for CBF.
- Seachtain Na Gaeilge was celebrated in An Spidéal, An Cheathrú Rua, Loughrea, Ballinasloe and Galway City.
- Bealtaine Festival in May was celebrated in e.g. Ballinasloe, Gort, Oranmore, Galway City, Tuam, Ballybane and Westside in conjunction with Age Action.
- Proposals in the Library Development Programme and in 'Opportunities for All' a
   National Public Library Strategy 2013-2017 were implemented including the adoption of
   a new National Book Tender, provision of online services, and the implementation of
   Right to Read strategy.
- Infrastructural improvements were carried out on a number of Branch Libraries including Oranmore and Gort.

- Work will continue, based on available funding, to maintain and improve, where
  possible, the Library Services in Galway as per the Galway Library Development
  Programme 2016-2021 and the new National Public Library Strategy, due to be launched
  in 2018.
- Work will continue on progressing the new Galway Community/Cultural Library.
- The Healthy Ireland, Work Matters and Right to Read campaigns will be rolled out across the library branch network, availing of national funding streams, with the aim of ensuring a range of service in both urban and rural branches.
- Efforts to enhance the use of technology will continue, including self-service technologies, while further promotion of the online resource package will be delivered.
- The computerization of branch libraries in the Galway service will continue, subject to staffing levels and financial resources.
- Galway Libraries will continue to develop our events programme, engaging with individuals and communities through our branches, availing of national funding opportunities where possible, including Creative Ireland, while operating within the constraints of local funding.

#### 2. Legal Advisory Services

#### Indicative Activities in 2017:

- The Department provided legal services for all programme areas, including the purchase and sale of properties, conduct of litigation including District Court Prosecutions, Circuit, High Court, Court of Appeal and Supreme Court Litigation, including Judicial Review. In particular, District Court Litigation (Rates, Planning Enforcement & Environmental prosecutions, Judicial Review and the completion of land acquisitions on inter-urban routes and acquisition of residential units, were substantial areas of work.
- The Case Management System, which facilitates the use of templates to create work flows for the efficient and cost effective delivery of legal services, is constantly being updated and applied to further work areas.
- Work has continued to update and complete our Register of Lands.

#### Proposals for 2018:

- Concentrate on and continue to provide efficient legal advisory services for all programme areas throughout the organisation.
- The continued completion of any residual work arising from Compulsory Acquisition on inter-urban routes.
- Workflows for the Case Management System will continue to be created, enhancing work delivery and capacity.

- Appropriate scanning of documentation and correspondence and Time recording to be implemented in full across the unit though our case management software package.
- Continue implementation of the Record Management Schedule and remove all noncurrent files from the office.

# 3. Recreation, Amenity & Play Facilities/ Outdoor Leisure Operations & Water Safety

#### Water Safety Programme - Indicative Activities in 2017:

- The Water Safety Programme involved the recruitment of a panel of 50 trained Lifeguards to provide services at 10 locations in the County [including five Blue Flag Beaches] and at six locations in the City as part of a Shared Service Agreement with Galway City Council.
- Induction Training was held on 25th May and 29th June, 2017.
- Upgrading of some equipment supplies was undertaken as well a Hut Preparation and Repairs-Maintenance Schedule agreed and delivered. The Service commenced on the 3rd June and continued until the 10th September, 2017.
- Following approval by Council, Funding of €6,150 was advanced to the Irish Water Safety Council.

#### Indicative Proposals for 2018:

- Implement Lifeguard Programme, subject to funding being available, on a Seasonal Basis
  including induction training. Any reduction in funding will impact on the service
  delivery i.e. duration of Water Safety Programme for the summer period 2018 and/or a
  reduction in lifeguard hours, with the potential to impact on Blue Flag accreditation.
- Promotion of the Lifeguard Programme using web-sites, social and local media.
- Commission further Risk Assessments with a target of having completed all 10 Risk Assessment for locations in the County. Progress works required under the ILSE (International Life Saving Federation of Europe) Risk Assessments in line with available resources.
- Continue, subject to funding and the approval of Council, provision of a financial contribution to Irish Water Safety.
- Roll-out next phase of the Ringbuoy Renewal Programme, subject to funding, including consideration of an inspection 'app' to build a record of sites within Council responsibility.

#### Parks, Pitches, Open Spaces and Playgrounds:

#### Indicative Activities in 2017:

- Rinville Park, Maree, Oranmore, managed by Galway County Council is owned jointly by Galway County Council and Galway City Council. It is a designated location on the 'Wild Atlantic Way'. It is used extensively by local residents, visitors and local organisations such as Scouting Groups.
- The Parks' Maintenance Programme continued to be delivered in partnership with local groups. In 2017, the Council commenced a programme of replacing & installing new concrete bases and marine grade stainless steel picnic benches in a number of areas across the park, with an emphasis on increasing accessibility to all users of this recreational amenity. The maintenance programme is co-funded by Galway City Council.
- A Concession for the provision of refreshments at Rinville Park during April to September was continued.
- Expressions of Interest were invited to cut and retrieve haylage on lands in and adjacent to Rinville Park – no expressions received
- Palace Grounds, Tuam Maintenance Programme for Palace Grounds Park, Tuam was implemented in association with a Council sponsored CE Scheme. Further upgrading of Paths was undertaken as part of a three year path upgrade programme.
- Ballinasloe Maintenance Programme was continued in Ballinasloe town for parks and open spaces in 2017.
- Applications were submitted under the Sports Capital 2017 scheme for funding for outdoor gym equipment for Dunlo Park Ballinasloe, Castle Avenue, Portumna and Palace Grounds, Tuam.
- The Unit provided administrative and advisory support to community groups to advance proposals for recreational facilities in their respective areas and to access available funding under several programmes such as CLÁR and the Outdoor Recreational Infrastructure Scheme 2017. Funding was awarded to several groups under these schemes with works required to be completed by the end of November.
- Accessibility enhancements including wheelchair swings were installed at playgrounds in the Palace Grounds, Tuam and Sarsfields Rd., Ballinasloe. Co-funded by the Department of Children and Youth Affairs (DCYA) Capital Grant Scheme for Play and Recreation 2017
- Refurbishment works were completed to the tennis courts in the Palace Grounds, Tuam and Portumna Playground.

#### Leisure Centres - Tuam and Ballinasloe

 A four year management, operating and maintenance licence was signed with Coral Leisure Ltd for Tuam and Ballinasloe Leisure Centres in January 2016. A Joint Liaison

- Committee is chaired by Corporate Services with Coral Leisure to review implementation of the Licence Agreement.
- Essential improvement and health & safety works have been overseen for both Leisure
  Centres receiving a significant investment in the infrastructure of the building and its
  equipment. These improvement works included an upgrade to the Fire Alarm System,
  Re-Tiling, an Upgrade to the Building Management System in Tuam and the
  Replacement of Pool Pumps, Steam Room Seating and Steam Room Equipment, Repairs
  to Disability Hoist in Ballinasloe Leisure Centre.
- Tuam and Ballinasloe Leisure Centres were successful in attracting significant funding in excess of €200,000 for energy efficiency improvement works in a joint project between ESB, SEAI and Coral Leisure. These works involved the installation of new LED energy efficient lighting, VSD controllers, new pool covers, new sand media filter and metering of utilities linked to the BMS. The works which were completed in October should lead to significant reductions in energy consumptions at both Leisure Centres.

#### Pitches / Running Track / Leisure Centres and Swimming Areas

- A Licence Agreement is in place with Tuam Celtic Football Club, to operate Galway County Council's All Weather Pitches in Tuam. A Liaison Committee is established to review operation of the facility.
- Dunlo Recreational Park, Ballinasloe Running Track was fully operational for most of the year, but was closed for approximately 6 weeks due to essential repairs being undertaken on the Track.
- A Schedule is made available on <u>www.galway.ie</u> indicating public times and bookings by local clubs.
- Concessions were continued in 2017 to permit applicants to sell ice creams and soft
  drinks at beach locations in the County for the summer season. One applicant was
  issued with a licence to operate at four beaches, while another applicant was issued
  with a licence to operate at one beach.
- In accordance with commitments previously given under the Play Policy, assistance was provided to playgrounds through direct funding and provision of insurance. To-date, a total of 65 playgrounds have been developed in the County, under this policy. The Smoke Free Playgrounds Policy launched in 2013 was ongoing in 2017. Information on all sites are available to download in the Council's Guide to Playgrounds 'Lets Play' available on www.galway.ie and an interactive map on the Mapzone section of the website.
- ROSPA Inspections of the 15 Council Owned playgrounds also took place in October.
- National Recreation Week was celebrated with a week long programme of activities in Tuam, in partnership with Tuam Schools Completion Programme and co-funding from the Department of Youth and Children. National Play Day and Recreation Week resources were combined to facilitate the participation Comhairle na nóg with support

from Youthwork Ireland. National Play days were held at Rinville Park and Gort Playground.

#### Proposals for 2018:

- Parks maintenance programmes, including grass cutting, will be developed and implemented in line with available resources for Rinville Park, Oranmore, the Palace Grounds, Tuam, Dunlo Park, Ballinasloe and other amenity and open spaces, with priority afforded, within available resources, to public parks and amenity areas.
- Continue maintenance required in Rinville Park under the Woodlands Plan to ensure newly planted Trees thrive.
- The maintenance of Council owned and operated Playgrounds, including the repair and/or replacement of play equipment, will be undertaken in line with resources.
   Annual ROSPA Inspections, required as a condition of insurance cover, will also be arranged for the 15 Council owned playgrounds.
- Endeavour to continue to provide administrative and advisory support to community groups wishing to advance proposals for recreation and to access available funding insofar as staff resources allow.

## 4. Council Facilities for Local Economic & Community Benefit / Heritage/Interpretative Facilities Operations

#### Indicative Activities in 2017:

- Funding was provided for the operation of Athenry Heritage Centre located in St. Mary's Church in Athenry Town Centre, which is the in ownership of Galway County Council and subleased to the Development Association who oversee the management of the Centre. The Centre employs a Centre Manager and staff through various schemes. The funding contributed to promotion, events and basic upkeep of this Historic Asset, which attracts over 3,000 visitors.
- The Battle of Aughrim Visitor Centre is owned and operated by Galway County Council. The Centre opened for the season from 29<sup>th</sup> May to 1<sup>st</sup> September, 2017.
  A Dutch Group of 36 people from Amergonen (which was the birthplace of Godard Von Ginkell) visited the Centre on the 2<sup>nd</sup> May, 2017 Heritage Week took place from the 20<sup>th</sup> to the 27<sup>th</sup> August where a variety of Heritage Events took place and were free to members of the public. Aughrim Remembered Weekend took place in July. Historic Assets: An application under the "Structures at Risk Fund 2017" was successful with a grant of €30,000 being made available to Galway County Council towards Phase 2 of the consolidation, stabilisation and safety remedial works project at St. Andrew's Church, Kilconly. The works which concentrated on the Bell Tower were successfully completed in November 2017.

Subject to funding financial support will continue to be provided to support the
operation of the Athenry Heritage Centre and Battle of Aughrim Visitor Centre to build
their number of visitors and promote these areas as part of overall Council investments
in tourism and support of the local economy.

#### 5. Community Warden Service

#### Indicative Activities in 2017:

- Corporate Services supports the co-ordination of the Warden Service which delivers a range of services on behalf of the Council. Monthly workplans are compiled based on service needs.
- Litter Pollution/Derelict Sites Surveys were carried out, whilst regular inspections of Playgrounds, Parks, Local Authority Estates, Halting Sites, Piers, Lifebuoys, Beaches, Bottle banks etc. continued to be undertaken by the Wardens.
- The Wardens continued to assist with the operation of pay parking and the implementation of traffic management plans in a number of towns across the County.
- Environmental Enforcement including the issuing of Litter fines and notices under the Waste Management and Water pollution Acts continued to be undertaken by the Warden Service.
- Dog Licensing inspection campaigns continued throughout the year.
- The Wardens continued to implement the provisions of the Roads Act 1993, in relation to abandoned vehicles, with vehicles identified, reported and removed as necessary throughout the year.

#### Proposals for 2018:

- This Unit will continue to co-ordinate the allocation of functions to the Community Warden Service and review the impact of functions based on agreed service indicators.
- Work will continue on assessing how the Service can best assist in meeting the objectives and business priorities of the organisation.
- Phased replacement of the Community Wardens vans will be implemented insofar as resources and may allow.

#### 6 Disability Action

#### Indicative Activities 2017:

Continued delivery of the Disability Action Plan.

- Supported the Accessible Ballinasloe initiative to develop Ballinasloe as an accessible, inclusive environment.
- Provision of two independent Track Systems to be installed in Nov 2017 in Ballinasloe Leisure Centre, to allow transfers, in the assisted changing room, from the wheelchair to the changing bed and, in the assisted wc/shower room, to allow transfers from the wheelchair to the wc/shower.
- Support improved Access for Persons with a Disability to Recreation and Amenity
   Facilities by the provision of Wheelchair Accessible Swings in Ballinasloe Playground
   (Double Wheelchair Swing) and in the Palace Grounds, Tuam (Single Wheelchair Swing),
   with additional minor accessibility groundworks to include the marking of a disabled
   parking bay and some footpath improvements in both areas.
- Accessible picnic table sets have been installed in both the Ballinasloe Park, adjacent to the Ballinasloe Playground, Sarsfield Road, the Palace Grounds, Tuam and a number of additional accessible picnic tables have also be installed in Rinville Park, Oranmore.

- Support implementation of the Customer Service Action Plan to continually improve access to services for persons with a disability.
- Support improved Access for Persons with a Disability to Recreation and Amenity Facilities, subject to finance being available.
- The Council is advancing plans for the provision of 2 no. Beach Wheelchairs on a pilot basis in two beaches commencing with An Trá Mór, Indreabhán beach and Trácht beach, Kinvara. The project is being led by the Corporate Section, working in consultation with the Water Safety Officer and the Galway Speeders Sports Group.

#### 7. Promoting the Irish Language

#### Indicative Activities in 2017:

- In March, a detailed programme for Seachtain na Gaeilge (1-17 March 2017) was implemented including engaging staff and members of the public with competitions, various events, musical showcases and more.
- Irish language classes (beginner and intermediate levels) were organized for staff and Members of the council.
- Website content approval procedure continues to be implemented in association with Customer Services and IS, to ensure bilingualism on <a href="www.gailway.ie/www.gaillimh.ie">www.gaillimh.ie</a>, in line with our language scheme and legislation.
- As part of the schedule of events for the Cruinniú na Cásca Easter Monday Creative Ireland National Day of Creativity, a seisiún comhrá as Gaeilge was included to help promote the Irish Language.

- Scoláireachtaí Gaeltachta Phádraig Mhic Phiarais 2017 / Pádraig Pearse Scholarships 2017 were provided again this year by Comhairle Chontae na Gaillimhe in collaboration with Summer Colleges in Conamara. 10 scholarships in total were provided to second level students in the County of Galway to attend Gaeltacht Summer Courses.
- The third annual Scoil Samhraidh an Phiarsaigh / Pádraig Pearse Summer School was held in Ros Muc over the course of three days, on the 27/28/29 July 2017.
- A promotional video of the Scoil Samhraidh an Phiarsaigh event was also recorded and produced.
- Community Support Grants The Irish language was specifically included as a category
  in the Community Support Scheme in 2017. Grants totaling €4,525.00 were approved
  for projects in Schools, Community & Voluntary Organisations to support the promotion
  and increased use of the Irish language.
- Comhairle Chontae na Gaillimhe continued to work in partnership with other
  organisations, inform them of our Language Scheme and ensure that the measures of
  the Scheme were implemented where such was within the Council's control. e.g Fáilte
  Ireland and their development of a series of interpretive panels for Conamara
  "Conamara Fiáin go smior / Wild at Heart", support and advice was provided, along
  with proofing services.
- Comhairle Chontae na Gaillimhe also continued its support of the promotion of Irish in communities throughout the County, by helping to promote events e.g Irish Hot Air Balloon Championships, National Heritage Week, etc through the Irish Language Media

   Radio and TV. Interviews were provided as Gaeilge on site.
- Mobile Simultaneous translation equipment continued to be used at Council meetings or other meetings at which translation may have been required.
- Drafting of the Third Language Scheme for Galway County Council has commenced and an internal review of the Second Language Scheme is underway.
- The Council continued to co-operate with An Coimisinéir Teanga, in dealing with issues raised by members of the public, regarding Irish language services and legislation.

- Continue to provide information to all staff of Comhairle Chontae na Gaillimhe regarding language duties, obligations and legislation.
- Continue to provide appropriate language awareness and language support material to staff of Comhairle Chontae na Gaillimhe, to enhance the provision of services through Irish.
- Continue to provide and build on the amount of Irish classes/courses provided throughout the year for staff and Members of Comhairle Chontae na Gaillimhe and council, focusing in particular on conversational Irish, based on available funding.
- Aim to continue Scoláireachtaí Gaeltachta Phádraig Mhic Phiarais / Pádraig Pearse Scholarships in partnership with Irish Colleges in the county.

- Promote the Irish language category for Gradaim an Chathaoirligh and community support grants, on a priority basis.
- Operate web-site approval process in partnership with Customer Services and Information Systems.
- Lead participation of Comhairle Chontae na Gaillimhe in activities and events for Seachtain na Gaeilge and where possible expand on these events for March 2018.
- Continue to organize and host the annual Scoil Samhraidh an Phiarsaigh event (or equivalent event) within the Gaeltacht Community as resources allow.

#### 8. Facilities Management – Council Properties / Health & Safety

#### Indicative Activities in 2017:

- Corporate Services continued to provide caretaking and facilities management services for the Council's network of offices, libraries and civic functions.
- The Unit continued to deliver on its requirements under the Safety Management
   Programme in areas such as PAT testing, periodic testing of electrical installations, VDU assessments.
- Energy efficiency monitoring and management continues to be a priority focus in the facilities unit. Display Energy Certificates were completed and put on display for 18 offices and libraries which are greater than 250 sqm.
- Further works at Gort Library were undertaken to improve Accessibility and Safety with the installation of a new ramp, new fire exit door and a new fire alarm system. New fire alarm and emergency lighting systems were installed at Eyrecourt Library.
- Tender processes were completed and new contracts put in place for fire alarms, emergency lighting, access control, CCTV for all offices & library accommodation.

#### Proposals for 2018:

- Maintenance contracts will continue to be the subject of ongoing review with the aim of
  maintaining costs reductions achieved in recent years and if feasible in limited areas
  achieve further cost reductions. New tender documents will be prepared in 2018 for
  contract implementation for Plumbers, Electricians, Lift Maintenance and Fire
  Extinguishers for all offices & library accommodation.
- In order to operate within available budgets it may be necessary to limit the
  maintenance of office and library facilities to focus on priority health and safety
  requirements and critical operating systems. In relation to County Hall, a significant
  number of management and maintenance systems are at or near end of life with an
  increased potential for systems failure and related response maintenance costs.

- The Unit will aim to further reducing energy consumption across its offices and libraries.
   Display Energy Certs will continue to be displayed to the public in all our offices and libraries.
- A Legionella Monitoring and reporting programme will be developed and commenced for office and library accommodation.

#### 9. Management of Records & Archives

The Archives Section works to ensure the care, preservation, management of and access to the Council's archives. Archives are valuable cultural assets which require specific care, and with growing interest in our past and in particular in family history and for The Decade of Commemorations, they are also important for cultural tourism. The Section also provides policy advice to the Council on the care and management of its records.

#### Indicative Activities in 2017:

- Continued to provide access to information on Galway County Council's archival holdings through its descriptive lists and also its on-line catalogue, and though various archival portals.
- Continued the programme of providing security backup and reference surrogates to collections and of processing several small archive collections.
- Provided on-going reader services, such as access to collections for research purposes, assistance with research queries, and the provision of research advice and guidance.
- Monitored the environmental conditions of the archives and endeavoured to ensure their continued protection, preservation and management, despite storage facilities not meeting internationally acceptable preservation standards.
- Conservation of Piers & Harbours public notices and other items.
- Outreach activities included production and launch of a new online exhibition on Piers and Harbours, Public Notices collections (GC/CSO2/)1; and the display of the exhibition From Colonial State to Free State, in Portumna Workouse Centre and Ballybane Library.
- Provided advice on records management best practice and assistance to Sections within Galway County Council as required.
- Continued the management of non-current record transfers to storage and record retrievals and returns: 518 recall requests were processed from January to-date (06/11/2017). There are now 110,833 entries on the ArcLink records management database.

- Concentrate on processing archive collections, whilst continuing to provide access and advice to researchers.
- Continue the programme of providing security backup and reference surrogates to collections. Galway County Council will continue to avail of commercial storage for its non-current records, and manage the retrieval and return of records held in off-site storage.
- Continue to liaise with Sections to develop and implement file classification & record retention schedules, and provide advice on records management best practice.

#### 10. Register of Electors

#### Indicative Activities in 2017:

- The Register of Electors for 2017/2018 was published on the 1st February, 2017 and came into force on 15<sup>th</sup> February, 2017.
- The Draft Register of Electors for 2018/2019 was published on 1<sup>st</sup> November 2017 and was made available for inspection by the public at Post Offices, Garda Stations, Public Libraries and the offices of Galway County Council and online at <a href="www.galway.ie">www.galway.ie</a> enabling any person whose name was not on the Draft Register to submit a claim on Form RFA1, to Galway County Council not later than 25<sup>th</sup> November, 2017. Claims are considered by the County Registrar at Revision Courts held in December each year.

#### Proposals for 2018:

- The Council will publish the Register of Electors for 2018/2019 by 1st February 2018.
- The approach to and extent of the field and awareness campaign to be undertaken in support of the Draft Register of Electors for 2019/2020 will be determined by available resources.
- The Draft Register of Electors for 2019/2020 will be published on 1<sup>st</sup> November 2018, and will be made available for public inspection, with Revision Courts to follow.
- A Supplementary Register of Electors will be compiled and published within the relevant timeframe in the event of a Referendum or Election.

#### 11. Corporate Planning & Support / Local Representation/ Civic Leadership

#### Indicative Activities 2017:

 Administrative services are provided for the Chief Executive, Cathaoirleach of the Council, Elected Members, Corporate Policy Group and Council Meetings.

#### Service Delivered for Plenary Council Meetings and Members

- Preparation of Agendas for Ordinary, Special, Annual and Budget Meetings of the Plenary Council, co-ordination of Agenda Items with all Sections, facilitating the Meetings and recording the Minutes.
- Publication of the Agendas, Minutes and Agenda documentation to the Extranet.
- Facilitating Meetings of the Corporate Policy Group.
- Facilitation of Expressions of Interest for attendance at Training Events and Conferences.
- Compilation of Reports to Council in accordance with the Local Government Act for Authorisation of Attendance by Members at Training Events & Conferences.
- Arranging in-house Training in line with the agreed Galway Co. Council Training & Development Plan for the Members.
- Processing Members Travel & Subsistence Claims for attendance at Training & Conferences.
- Facilitate the submission of Summaries of Conferences attended by the Members, preparation of Report for Agenda and publishing Summaries on the Website.
- Maintaining Database of Attendances of the Members at all Meetings of the Council, including Plenary, SPC, Municipal District, JPC, Local Traveller Accommodation Consultative Committee, Local Community Development Committee, Road Safety Together Committee.
- Facilitate the compilation of the Public Register of all Attendances and Payments of the Councillors.
- Maintenance of Ethics Register for Councillors.
- Facilitating the Members in the return of Donations Declarations
- Facilitation of Civic Receptions is supported by the Corporate Team in response to proposals of the Plenary Council –
  - A Civic Reception was held in Áras an Chontae on 24<sup>th</sup> April, 2017 to honour the following:

#### Facilitating the Joint Policing Committee and Meetings Administration Athenry-Oranmore MD

- Galway County Council operates a Joint Policing Committee (JPC) in conjunction with local Garda Síochána management and operation of this Committee is an assigned statutory function, in accordance with Section 35(4) and 36(1) of the Garda Síochána Act 2005 and in accordance with Revised JPC Guidelines issued in 2014.
- The function of a Joint Policing Committee is set out in section 36(2) of the Garda Síochána Act, which states: "The joint policing committee's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the local authority's administrative area".
- The JPC held its Annual Meeting on 18<sup>th</sup> September 2017 and its Public Meeting on 6<sup>th</sup> November 2018. Ordinary Meetings of the JPC were held on 6<sup>th</sup> February, 8<sup>th</sup> May, 18<sup>th</sup> September and a further Meeting is to be held on 11<sup>th</sup> December, 2017.
- Meeting Administration is provided by Corporate Services for the Athenry-Oranmore Municipal District. The AOMD has met monthly and held its AGM on June 13<sup>th</sup>.

#### Services provided by Corporate Services for the Organisation

- Maintenance of Ethics Register for Relevant Staff.
- Support provided by Corporate Services for Receiving, Registering and Opening of Tenders for the organization.
- Register of Chief Executive's Orders maintained, Orders Numbered by Corporate Services for each Section.
- Corporate Services continued to serve as liaison for the Office of the Ombudsman in relation to queries raised by the Office in relation to service delivery by Galway County Council. All correspondence is co-ordinated via Corporate Services, with a tracking system in place

#### Proposals for 2018:

- Corporate Services will continue to support the Cathaoirleach, elected members and the organisation of Plenary Council Meetings.
- The Council will maintain Staff & Members Ethics Register and facilitate the Members in the return of Donations Statements.
- The Unit will publish the Public Register of Attendance and Payments to Elected Members.
- The Unit will actively support the role of the Corporate Policy Group.
- Continue to facilitate the Joint Policing Committee.

The Council will continue to comply with our statutory requirements regarding Freedom
of Information and Access to Information on the Environment legislation and will
continue to facilitate the organisation in relation to Ombudsman queries.

#### Galway Commemorative Strategy for the Decade of Commemorations 2013 - 2023

A range of events and initiatives continued under the Galway Commemorative Strategy for the Decade of Commemorations 2013 – 2023.

- Decade of Commemoration Easter Monday event in Athenry A special ceremony, including flag raising with the Defence Forces, was held at the Athenry 1916 Commemorative Garden on Easter Monday. The Garden, which was developed and is a labour of love by the Athenry Tidy Towns Committee, is the exact site where Liam Mellow marshalled the Volunteers and organised them in the lead up to the 1916 Rising. A screening of the ten documentaries which Galway County Council in conjunction with the Galway Film Centre and the Heritage Council produced to commemorate the centenary of the 1916 Rising was screened in the Athenry Community Hall.
- Galway County 1916 Rising Heritage Trail (bi-lingual) Guide: A 350 page Guide was produced that allows the public to explore the historic sites and monuments in County Galway relating to 1916.
- Galway County 1916 Rising Heritage Trail (bi-lingual) Signage Project: To enhance one's
  journey on the 1916 Rising Heritage Trail, an interpretative signage has commenced
  which will see signage being put in place for 12 no. selected sites of Galway County
  Council's 1916 Heritage Trail Go Explore the Historic Sites and Monuments.
- "The Fenians, Colonel Kelly & The Manchester Martyrs" Conference was held in Holy Rosary College, Mountbellew on 11th November 2017. During the day, an exhibition was hosted by the Holy Rosary College Students and Mountbellew Heritage and Tourism Network on the Fenians, Colonel Kelly & The Manchester Martyrs and students from Coláiste An Chreagáin showcased an art exhibition on the same theme. Two original paintings were on display during the Conference relating to Colonel Kelly and the Smashing of the Van. Courtesy of Marie Cogavin.
- A Conference entitled "Galway 1917: Social Conditions and Political Change" to be held in Loughrea on 16th November 2017. During the day, there will be an exhibition on display relating to the Connaught Rangers who were killed in 1917 in France and Flanders.
- Galway County Council Archives digitised several small collections relating to the
  revolutionary period. These included three small files relating to the Munitions factory
  (GC/CSO/3/2,3 & 6) in the city, dating from 1916 to 1918, and also from the County
  Secretary's office it digitised a Dáil Éireann file, dating from 1919-1921
  (GC/CSO/3/1). The material will shortly be made available on the Archives' Digital
  Archive at www.galway.ie/digitalarchives \_.

 The Galway County Council Archives exhibition 'From Colonial State to Free State, what they said...' was hosted by the Portumna Workhouse Centre in April, and by Ballybane Library in June 2017.

#### Creative Ireland Programme / Clár Éire Ildánach 2017-2022

- Creative Ireland is the Government's Legacy Programme for Ireland 2016 and is a fiveyear initiative, from 2017 to 2022, which places creativity at the centre of public policy.
   It is a culture-based programme designed to promote individual, community and national wellbeing.
- The Corporate Services Section managed the inaugural *Cruinniú na Cásca*, which was a day-long national celebration of culture and creativity which took place around the country on Easter Monday. County Galway's *Cruinniú na Cásca* was held in the medieval town of Athenry, with the theme 'Draíocht Experience the Magic of Creativity'.
- Athenry Community Park was the venue for the creative, fun and learning day which was officially opened by the Cathaoirleach of the County of Galway, Cllr. Michael Connolly. Families gathered and participated in creative fun: by having a go at tagarchery, juggling, beating a drum, dancing with Kidisco, got involved in arts and crafts activities and workshops, and watched traditional crafts people at work. There was lots to see and do which included a treasure hunt, balloon modelling, face-painting, Irish Cómhra, with an animal display and a look into the wonderful world of beekeeping. Entertainment and dance was provided by 'The Wheel Barrow & the Accordion'. A giant pop—up audio visual sculpture The Gramophone also provided 1920's 1940's music.
- At Athenry library, children gathered to hear wonderful stories from Pat Speight who is one of Ireland's best known Storytellers, carrying on the timeless art and oral tradition of storytelling for young and old.
- Fun filled craft events were provided by Athenry Heritage Centre keeping children busy making Easter crafts throughout the day. Athenry Castle provided guided tours to allow people explore the castle experience
- The Cruinniú na Cásca event drew to a close with a spectacular concert in the Community Hall. 'Spraoi', showcased world class performances of song, music and dance and provided a perfect finale for this cultural event for all ages.
- Cruinniú na Cásca was organised by Galway County Council in co-operation with Athenry
  Community Council, Athenry Tidy Towns, Athenry Library, Athenry Heritage Centre,
  Athenry Castle/OPW, Athenry Historical Network, Galway & Athenry Film Clubs,
  Creative Ireland and working in collaboration with the local artists, craft persons and
  entertainers.

## Freedom of Information, Access to Information on the Environment,Ombudsman Queries

Freedom of Information Officer/Access to Information on the Environment Officer is assigned to Corporate Services and is the contact point for FOI and AIE Decision Makers & Appeals Officer in the organization and also the Local Government Management Agency and the Office of the Information Commissioner/Office of the Commissioner for Environmental Information. AII FOI & AIE Requests received are processed and tracked through Corporate Services and a Disclosure Log of FOI requests maintained.

#### Freedom of Information Indicative Activities in 2017:

133 requests received up to end October, 2017. Decisions were issued as follows:

- 43 granted, 38 part granted, 35 refused, 4 transferred/withdrawn, 13 remain to be decided.
- 6 Appeals for an Internal Review of FOI Decision received and decisions issued as follows:
- 4 decisions upheld, 2 decisions varied
- 4 Appeals to the Information Commissioner 2 Decisions of the Council have been affirmed by the Commissioner, 2 are pending.

#### Access to Information on the Environment Activities in 2017:

6 requests were received to end October 2017 Decisions were issued as follows

- 2 part granted, 3 refused, 1 pending decision
- 1 Appeal to the Commissioner for Environmental Information and decision is pending.

#### 13. Educational Support Services/Student Grants

#### Indicative Proposals 2017:

 A new single National Awarding Authority (Student Universal Support Ireland) was introduced by Government in 2012 and is operated by County of Dublin VEC. SUSI is responsible for all new applications. The Council remains responsible for 5 students for the 2017/2018 Academic Year.

#### Proposals for 2018:

 The Council will continue to administer the payments (Maintenance and Fees) and appeals procedure for existing students until their courses are completed. No new applications will be dealt with by the Council in 2018.

#### 14. Customer Service

#### Indicative Activities in 2017:

- The Customer Services Officers Group (CSOG) continued to meet over 2017. The CSOG is comprised of staff representatives from all the main service areas.
- The email address, customerservices@galwaycoco.ie remains a central point of access
  to information for Staff and Customers alike. Staff are asked to submit information on
  projects, campaigns, events, works etc. so that the Customer Services Team are aware
  what events are taking place across the Council and are better informed to handle
  queries. The general public can also email this address with general queries which are
  investigated and replied to appropriately.
- Customer Services continued to moderate and process Fix Your Street cases and follow
  up on outstanding cases with relevant sections. Fix Your Street is a national programme
  and is an on-line public forum where issues can be submitted by location to the relevant
  local authority.
- The centralised system for Public Notices continued in 2017 to enhance our Corporate
  Image in the Print Media, to generate savings through shared advertising space and also
  meet our requirements under National Procurement Framework. Advance copies of
  public notices prior to notices appearing in the various newspapers appear on Social
  Media and are sent to Elected Members with relevant contact details included.
- Customer Services continues to maintain the system of re-formatting new application forms and updating existing forms when requested. We now have 215 forms and memorandums in total on our register/coding system, available via our website.
- Door access system cards and car park fobs continue to be issued and maintained by Customer Services.
- A newly formatting poster version of the Customer Charter, Code of Conduct and Services through Irish was created and will be available at all Council public counters.

#### **Customer Services Desk and Communications Centre**

- The Customer Services Desk continues to be operated to provide efficient referral/query handling for customers as they enter Áras an Chontae. The phone service continues to be operated from the Customer Services Communications Centre on the second floor of Áras an Chontae.
- Corporate Services staff based in Customer Services are assigned to support the Mobile Phone Policy of the organisation and day to day administration of the account.

#### **Communications and Social Media**

 Further increased use of Social Media (Twitter, FB) with over 5,631 likes on Facebook and 10,890 followers on Twitter to date and this is continuing to grow on a daily basis. Social Media has been integrated with Advertising and other Promotional Campaigns of
the Council and specific attention given to the use of Social Media during severe
weather events. There has been an increase in the posting of events on behalf of staff
with a focus on Road Works, Water Disruptions and any other day to day events
happening throughout the County. The Customer Services team participated in 'Our
Council Day' twitter campaign nationally as coordinated by the LGMA.

#### Proposals for 2018:

- Co-ordinate implementation of the Customer Service Action Plan 2018 in line with agreed targets and goals in the Quality Customer Services Strategy.
- Continue to facilitate the Customer Services Officers Group meetings, information sharing and joint actions across all sections.
- Research Customer Service Models to apply to local needs and implement benchmarking process to further develop our standards as resources allow.
- Continue to implement 'Fix Your Street' to meet agreed targets.
- Facilitate updating of the Council Website in both languages and maintain a central deposit and coding system for all County Council Application Forms available via the website
- Continue to focus on the development of the County Council's use of Social Media as a source of information and an efficient communication channel for our customers.

#### 15. Operation of Coroner Expenses

#### Indicative Activities in 2017:

- Galway County Council retains three Coroners and provides services for the City and County Area.
- Corporate services provided administrative support under Agreed Scheme for Funeral
  Directors/Undertakers in accordance with available resources. Continued
  administration of payments for implementation of the Coroners Service including
  Pathology, Removal, Coroners Courts and other duties in line with Agreed Schemes and
  Statutory Instruments. Information on the Panel (Funeral Directors taking part in the
  Agreed Scheme for an agreed Fee) is circulated to An Garda Síochana, who are the first
  point of contact in an unexpected or unexplained death.
- In Oct 2017, an extensive review of the Agreed Scheme for Funeral
  Directors/Undertakers was undertaken and changes were proposed to include an
  increase to the rates paid. Implementation of these recommendations are contingent
  on the necessary funding being available.

- Continue administration of payments for implementation of the Coroners Service including Pathology, Removal, Coroners Courts and other duties in line with Agreed Schemes and Statutory Instruments, and subject to funding.
- In the event that additional funding is provided in 2018, the recommendations arising from the review of the Agreed Scheme for Funeral Directors/Undertakes may be implemented. A continuation of the existing Agreed Scheme, based on the current payment terms, may impact on service delivery and standards during 2018.

#### 16. Operation of Markets & Casual Trading and Requests for Filming in County

#### Indicative Activities 2017:

- Casual Trading Licenses were issued for a fee for a number of towns and villages throughout the County including Athenry (3), Ballinasloe (15), Clifden (8), Gort (11), Loughrea (2), Mountbellew (4), Dunmore (1), Headford (1), Tuam (8); in line with Casual Trading Bye-Laws.
- Continue to promote trading where bays are vacant by contacting those on the waiting lists and continued to monitor data on Casual Trading through Community Wardens Work Plans returns.
- In addition, special events licences were processed for the Ballygar Carnival, Dunmore & Loughrea Festivals and the Ballinasloe Horse Fair.
- 6 Requests from film makers etc. to use public property for filming were also processed.

#### Proposals for 2018:

- Continue to issue Casual Trading Licenses and consider reviewing existing Bye-Laws as staff resources allow.
- Progress on-line payment facilities for Licenses.
- Continue to facilitate queries and issue permissions as required to Media and Production Companies wishing to film in the County in support of the Film Galway Partnership.
- Co-ordination and operation of trading at the Ballinasloe Horse Fair in October in partnership with the Ballinasloe Municipal District Office.
- Review the funding model for the Ballinasloe Horse Fair with a view to maximizing available income in the context of the requirement for additional event management measures.

#### 17. Internal Audit Activity

Internal auditing is an independent, objective assurance and consulting activity designed to add value and improve the organizations operations. It helps an organization accomplish its objectives by bringing a systematic disciplined approach to evaluate and improve the effectiveness of risk management, control and governance process.

The Internal Audit Unit is responsible for providing assurance to the Chief Executive of the Council on the adequacy and effectiveness of the Council's internal control and risk management systems.

The internal audit work programme is driven by the annual Internal Audit plan which is drawn up in conjunction with the Executive Team and the Audit Committee.

#### Indicative Activities in 2017:

- A total of 8 audits were completed from the 2017 Audit Plan with 6 presented to the Audit Committee.
- As part of the quality assurance requirement of the Public Spending Code in depth reviews of the appraisal planning and implementation stages of both the N17 Carrownurlaur to Ballindine roads project and the Kilconnell landfill site were undertaken. The increase in expenditure, on the revenue service division, relating to rates administration was also examined.
- The 2016 Audit Report recommendations were reviewed and necessary follow up measures were taken.
- Policy compliance testing on the use of low value purchase cards and fuel cards was examined.
- Quarterly checking of the cash office, quarterly checking of revenue collector's receipts and lodgments, together with periodic checking in the motor tax headquarters office in County Hall. In addition, periodic checking and stock taking was undertaken in the motor tax sub offices in Ballinasloe and An Cheathrú Rua.

#### Proposals for 2018:

- The Internal Audit Unit will continue to facilitate the work of the Audit Committee.
- Reviews of recommendations made in the 2017 audit reports.
- Completion of audits as per the 2018 Audit Plan.
- Compliance with the Quality Assurance requirements of the Public Spending Code.
- Continued work on Policy compliance and value for money testing.
- Quarterly and periodic checks on the various income collection streams.

 Periodic checking and stock taking in the motor tax sub offices in Ballinasloe and An Cheathrú Rua.

## **Housing Construction**

#### Indicative Activities in 2017:

- Under the Social Housing Strategy 2020 Galway County Council has, to date, received approval for funding in the order of €24.5m to progress the design, planning, tendering and construction of 104 units.
- In addition, to date in 2017 project proposals for a further 58 units at an estimated cost
  of €13 million have been submitted to the Department of Housing, Planning & Local
  Government for approval.
- Projects at Weir Rd., Tuam; Garbally Drive & Esker Fields, Ballinasloe comprising a total of 42 units were progressed through various stage and statutory approvals during 2017.
- Most significantly, the Construction Contract for 40 units and the refurbishment of 21 units at Gilmartin Rd., Tuam, is to be awarded imminently, subject to the final stage approval of the Department of Housing, Planning & Local Government.
- In addition, 4no. single rural dwellings are under construction at present.

## Proposals for 2018:

- The construction programme will remain a key priority in 2018 with a clear focus on progressing all capital projects through design, planning, tendering & construction stages.
- Identifying further potential sites for development in line with the housing needs for various areas; including turnkey developments, will also remain a priority in order to provide a pipeline of projects to 2021.

## Strategic Development and Management Plan for Housing Lands

The active management of the housing land bank is part of a range of actions being taken under Rebuilding Ireland designed to accelerate and increase housing output.

- Strategic Development and Management Plans have been developed for lands in the Council's ownership, prioritising those sites that have the most potential to deliver housing in the short to medium term.
- A number of strategic sites have been identified for the development of master plans
  that will support the development of these sites to meet a range of housing needs on a
  phased basis, building high quality homes and sustainable communities.

- The Housing Unit will continue to review and update the Rebuilding Ireland Land Map on a quarterly basis.
- Continue to drive the implementation of the Strategic Development and Management Plans in order to advance sites to development stage at the earliest date possible
- The Council will invite Expressions of Interest from Approved Housing Bodies and Builders to build on selected sites within the land bank to maximize the delivery of units in the short-medium term, delivering sustainable communities.
- The Council is committed to maximizing the potential of the land bank to support
  housing need, including affordable housing and rental options, subject to the
  introduction of appropriate schemes and funding streams by the Department of
  Housing, Planning & Local Government.

Social Housing		

- The Council continued to meet the significant and increasing demand for social housing supports during 2017 through the provision of accommodation by various means including the Rental Accommodation Scheme, the Housing Assistance Payment, and nominations to Approved Housing Bodies and through the allocation of social housing.
- The Council completed the purchase of 21 units thus far in 2017, 4 of which were
  delivered under the Buy and Renew Scheme which was introduced in 2017 with the dual
  aim of improving the urban realm and making vacant derelict property available to meet
  housing need.
- Expressions of Interest were invited for the provision of turnkey developments. To date 5 submissions have been received and are currently being assessed.
- A Housing Needs Assessment was completed in 2017 and there are currently approximately 3,500 applicants on the record of qualified households.
- During the period January September 2017, a total of 157 offers were made to applicants on the record of qualified households for social housing. In addition, 50 nominations were made for voluntary housing provided by Approved Housing Bodies with the support of the Council.
- During 2017 the housing unit submitted a proposal to the SPC and Plenary Council to revise the existing areas of choice from over 50 to 15 for social housing applicants. This proposal was approved by both SPC and Plenary Council.

 A new Housing Allocation Scheme was adopted by Plenary Council in May 2017. The new Scheme incorporate provision for the operation of Choice Based Letting (CBL) to enable qualified households to exercise greater choice and involvement in selecting a new home.

#### Proposals for 2018:

- The Council will continue its' progress in the provision of social housing supports for persons on the record of qualified households.
- The Council will seek to increase the supply of housing units through all available channels. In particular the focus will shift towards delivery through construction including turnkey units in the coming year in accordance with national policy.
- As the focus of capital funding shifts from acquisitions to construction, the approach to acquisitions will be centred on delivery through Part V and the Buy and Renew Scheme.

#### Rental Accommodation Scheme (RAS) & Leasing

#### Indicative Activities in 2017:

- The Government has allocated funding for local authorities and approved housing bodies to lease or rent private residential properties for applicants on the housing list.
   RAS is aimed at persons who are in receipt of rent supplement for a period in excess of 18 months. Since the 1st April 2011, any housing applicants that are in RAS type accommodation are deemed to have their housing needs met.
- There are 256 households accommodated currently through the RAS Scheme.

## Proposals for 2018:

 The Council will continue to administer the RAS Scheme as well as working to progress supply options under the Social Housing Expenditure Programme Element of the Social Housing Strategy.

#### Housing Assistance Payment (HAP)

HAP has been in operation in Galway County Council for two years and there have been almost 750 tenancies created to date. HAP allows recipients to take up full-time employment and still retain their housing support.

Under HAP, local authorities will make the full rent payment on behalf of the HAP recipient directly to the landlord. The HAP recipient will then pay a rent contribution to the local authority.

## Indicative Activities in 2017:

750 applicants transferred to the HAP scheme by the end of October 2017.

- Lack of supply of available properties remains a significant issue for HAP applicants.
- Information sessions were held with Cope, Citizen's Information Centres, Mental Health and Family Support units working in the community, to increase awareness of HAP.
- Additional Information sessions were held with Estate Agents across the County.

- To continue transferring long term rent supplement recipients from the Department of Social Protection over to the HAP scheme, within the limits of available resources. 1,500 people are in receipt of long term rent supplement payments.
- Process all new housing applications for the HAP scheme.
- Continuation of inspection process for all properties under the HAP Scheme.

# Vacant Housing Repair and Leasing Scheme

#### Indicative Activities in 2017:

A key component of the Rebuilding Ireland Action Plan for Housing and Homelessness is a new scheme, the Vacant Housing Repair and Leasing Scheme, which targets the delivery of social housing and also ensures that existing housing stock is used to the maximum degree possible.

The basis of the scheme is that repair and improvement works to suitable vacant properties are funded to bring them up to the standard for rented accommodation and the cost of the works is then deducted from lease payments over an agreed lease term.

Galway County Council undertook an extensive campaign to attract property owners to the scheme

- Press releases on Social media
- Extensive adverting in local newspapers and local radio
- Two evening roadshows were held in Ballinasloe and Tuam
- Estate agents and solicitors were contacted directly throughout the county
- Notices published in community newsletters
- To date, 60 expressions of interest have been received from property owners with some files currently being progressed.

# Proposals for 2018:

Galway County Council will assist property owners to develop the scope of works and
also aid the property owner in the completion of the repair works. Property inspections
are carried out by Galway County Council staff that will identify the works required to
bring the dwelling to the required standard.

The Council will, subject to the appointment of a Vacant Homes Officer, proactively
engage with owners of suitable vacant properties in need of repair, with the aim of
making the property available under the Repair & Leasing Scheme to meeting housing
need.

## **Buy & Renew Scheme**

Under the Rebuilding Ireland Action plan a new scheme called the Buy and Renew Scheme was launched in July 2017. This new initiative provides funding to buy and renew vacant properties to meet housing needs while also addressing dereliction in towns and villages.

#### Indicative Activities in 2017:

• The Council has delivered 4 Units under the Buy and Renew Scheme which was introduced in 2017.

# Proposals for 2018:

- Galway County Council will continue to endeavour to acquire and renew Housing Units in need of remediation and make them available for social housing use in the areas of high demand.
- The Council will, subject to the appointment of a Vacant Homes Officer, develop a Vacant Homes Strategy and Action Plan, to maximising existing housing stock by returning suitable vacant properties to meet housing need.

## **Residential Tenancies Board - Registration of Rented Units**

#### Indicative Activities in 2017:

- The Residential Tenancies Act 2004 came into operation on 1st September, 2004. Part
  7 of this Act deals with the registration of tenancies with the Residential Tenancies
  Board. The published register is available on the Residential Tenancies Board website at
  www.rtb.ie
- A significant emphasis was placed on increasing the number of inspections of private rented houses in 2017, resulting in a total of 653 properties being inspected up to 31st October 2017.

#### Proposals for 2018:

 On-going inspection of Private Rented Properties to confirm compliance with current Standards for Private Rented Properties. It is intended that a further emphasis will be placed on increasing the number of inspections undertaken; however this will be dependent on the resources available.

#### **Voluntary Housing**

#### Indicative Activities in 2017:

• The Council is continuing to engage with the Voluntary sector so as to maximise the number of units being made available through the funding schemes CAS (Capital Assistance Scheme) and CALF (Capital Advance & Leasing Facility).

## Capital Assistance Scheme (CAS)

The Capital Assistance Scheme funding is provided by the Department through the Local Authority for the provision of housing.

 Ballinasloe (Tuath Housing Association)

  - The 2017 CAS Call remains open and the Council welcomes all applications from Approved Housing Bodies.

# Capital Advance and Leasing Facility (CALF) & Mortgage to Rent (MTR)

The Capital Advance and Leasing Facility and Mortgage to Rent Scheme provide social housing through off-balance sheet current expenditure.

- To date 88 units have been delivered at various locations around the County including Athenry, Tuam, Loughrea, Ballinasloe, Mountbellew, Clifden and Portumna. Galway County Council has 100% nomination rights on all units.
- Departmental approval received for 34 units in addition to the above.
- Proposals for a further 124 units across the County are currently being progressed.

- It is proposed that the Council will continue to engage pro-actively with the Approved Housing Bodies (AHB) in order to facilitate the sourcing of further units for the provision of social housing under this funding model.
- We will examine the potential for AHBs to deliver additional housing units on Council held lands.

#### Housing Strategy for People with a Disability

The main aim of this Strategy is to promote and mainstream equality of access for people with a disability to the full range of housing options available, suited to individual and households need.

#### Indicative Activities in 2017:

- The Housing Strategy for People with a Disability was adopted by Council in 2017 in compliance with National Strategy for Housing People with Disabilities 2017- 2020. The Strategy was devised with cooperation of the Disability Steering Group.
- Work continued throughout 2017 with de-congregating persons with a disability and moving them to standard housing.

#### Proposals for 2018:

- Continue to work with approved housing bodies and disability service providers to provide suitable accommodation in individual tenancies or in shared accommodation.
- A review of all housing applicants with a housing need on the basis of disability or medical grounds will be undertaken in 2018.

#### Homelessness

# Indicative Activities in 2017:

 There has been a marked and unprecedented increase in the demand for homeless services and in particular the number of families presenting as homeless during 2017.

- The Homeless Framework Action Plan was adopted by Council during 2017 and serves to guide the actions of the Council in responding to the many challenges of homelessness.
- The limited availability of private emergency accommodation presented many challenges in responding to homelessness and placed significant demands on the limited resources of the Housing Unit.
- The increased emphasis on care and case management and "move on options" for service users while proving useful was limited by the lack of move on options either in private rented sector or supported accommodation.

- It is anticipated that the increased demand for homeless services experienced in 2017 will continue in 2018 due to the limited supply of housing and in particular the limited availability of housing in the rented sector.
- The establishment of the Homeless Action Team, an action of the Homeless Framework Action Plan, will be a priority in 2018 to assist with a coordinated inter-agency approach to homelessness.
- Progress a Housing led approach with all forms of social housing including transition accommodation for families in cooperation with Approved Housing Bodies and with supports tailored to needs.
- Progress step down/ transition accommodation for single people needing some supports in cooperation with Approved Housing Bodies and with supports tailored to needs.
- Work with Voluntary & Statutory bodies to prevent Homelessness (e.g. Threshold, Tusla etc.) with a focus on tenancy protection and sustainment.
- Continue with case management with an emphasis on move on to appropriate accommodation.
- To continue to provide long term accommodation with all the necessary supports for both families and single homeless applicants.

# **Housing Grants**

- To date the number of applications for Housing Aid for Older People paid in 2017 is 150 with the number of Mobility Aids Grants & Housing Aid Grants totaling 124.
- Department funding was made available in the sum of €1,942,606 for 2017. Galway County Council must provide co-funding of 20%, €325,000 was sanctioned from the Councils own resources.

The Council will continue to administer the Housing Aid for Older People, Mobility Aids
Grants and Housing Aid Grants availing of grant funding from the Department of
Housing, Planning & Local Government to the extent that co-funding provided by the
Council and the staffing levels in 2018 allows.

# **Traveller Accommodation Programme**

#### Indicative Activities in 2017:

- The Council undertook a mid-term review of the Traveller Accommodation Programme 2014 2018 with the Plan updated to include capital projects, a focus on fire safety and increased targets for the provision of accommodation in 2017 and 2018.
- To date in 2017 the housing needs of 63 applicants have been met through the provision of standard housing, housing in Traveller specific group schemes and halting sites.
- Significant capital investment was secured for the provision, refurbishment and remedial works of traveller specific accommodation in Craughwell, Capira, Creggane and Tuam.
- Fire Safety and awareness was a key priority in 2017, with fire safety improvement works undertaken and awareness training delivered in Creggane, Tuam, Craughwell and Capira.
- The Traveller Accommodation Consultative Committee met on 3 occasions to date in 2017 with the Committee visiting Traveller specific accommodation in Craughwell, Capira and Tuam.

# Proposals for 2018:

- Progress the construction of 6 houses and 2 bays at Dunkellin Park Halting site,
   Craughwell
- Construction of 1 house at Creggane Group Housing Scheme, Ballinasloe.
- The Traveller Accommodation Consultative Committee will continue to play a lead role in overseeing the implementation of the Traveller Accommodation Programme 2014 – 2018.
- A further programme of fire safety awareness training will be delivered.

# **Local Authority Housing Stock Management**

## Indicative Activities in 2017:

 Funding was made available from the Department of Housing, Planning, Community and Local Government in 2017 to support Galway County Council in returning 30 vacant

- houses back to productive use. The housing unit are on target to complete the programme of works and have these houses available for letting in 2017.
- Over 95% of Local Authority housing have benefitted from cavity wall and attic insulation under Phase 1 of the Energy Efficiency Retrofitting Programme. This national programme was introduced in 2013 to ensure better energy efficiency for all our housing stock.
- Funding was made available from the Department for the refurbishment of 14 derelict houses at Tirboy, Tuam. The programme of works within the estate is ongoing.
- A proposal for funding has been submitted to the Department of Housing, Planning and Local Government for funding towards the costs of returning 25 derelict houses back to productive use.

- The ability of the Housing Unit to continue to return void housing unit for occupation
  will be dependent on the continuation of funding from the Department of Housing,
  Planning & Local Government under the Voids Programme. In the absence of the
  continuation of the Voids Programme, it may not be possible, within the resources of
  the Council, to continue to return void properties for occupation.
- Progress with Phase 2 of the Energy Efficiency Retrofitting Programme, where funding becomes available from the Department of Housing, Planning & Local Government, insofar as the Council is in a position to provide the necessary co-funding required.
- Progress the Radon Remediation Programme in risk areas within the limits of available resources.
- Deliver a Response Maintenance Programme on a priority basis within the constraints of available funding, with priority afforded to statutory requirements.

Local Authority Housing Stock Management - Minimum Standards and Preventative Maintenance

- Minimum standards for rented accommodation are applicable to local authority housing stock, subject to limited exemptions, with revised minimum standards implemented from July 2017.
- It is recognised and a source of significant concern that not all local authority housing stock currently complies with the minimum standards and proposals to address this were the subject of consideration during 2017.
- The need for a stock inventory to identify and quantify the work required to comply with statutory requirements, including minimum standards, and to support the introduction of a preventative maintenance programme was identified as a priority action, with additional staff resources assigned to this area.

- It is essential that all available revenue and capital resources are assigned to achieving compliance with statutory requirements relating to local authority housing stock, including minimum standards and electrical testing, at the earliest possible date.
- In the absence of the necessary funding required to achieve full compliance in 2018, it
  will be necessary to utilise all available funding to deliver a work programme on a
  priority basis, with an initial emphasis on the installation of fire detection
  systems/smoke alarms, carbon monoxide alarms, fire blankets and the installation of
  appropriate window restrictions on the first floor and above of all local authority
  housing stock.
- It will also be necessary to deliver a programme of electrical testing and for the servicing of boilers in order to achieve compliance with statutory requirements on a programme basis, given the constraints imposed by the current financial position of the Council.
- In order to deliver the priority elements of the work programme, as detailed above, it
  will be necessary, in addition to availing of the additional resources provided, to
  prioritise existing funding for this purpose. This may significantly reduce the level of
  funding available for response maintenance and impact on the ability of the Council to
  avail of funding streams for housing stock that may require an element of co-funding.
- A stock inventory will be undertaken during 2018 to identify the works, additional to the above, required to achieve compliance with statutory requirements, including minimum standards and electrical testing, and to inform the development and delivery of a Preventative Maintenance Programme. It is recognized that the delivery of a Preventative Maintenance Programme will delivery savings and efficiencies in the medium/long term and will allow for improved service delivery for our tenants.

## **Tenancy and Estate Management**

- The Housing Unit continued to work with vulnerable families in assisting them in sustaining their tenancies in accordance with the Tenancy Sustainment Strategy which was adopted by Council in March 2017.
- The Anti-Social Behaviour Officer continued to work intensively in a number of areas across the County, this is done in conjunction with the Gardai and relevant State stakeholders and other Council Departments.
- The Council's Tenancy and Estate Management Strategy involves active community engagement/participation at local level on an ongoing basis with an emphasis on the early identification of anti-social behaviour and breaches of tenancy agreement. The Council continued to engage with the Gardai and the unit meets regularly to discuss

problem areas and how both organizations can work together to address anti-social behaviour.

CCTV is in operation in seven sites at various locations across the County.

## Proposals for 2018:

- As part of the interdepartmental and inter-agency strategic approach, the Housing Unit
  has identified target housing estates which will be the focus of extensive estate
  management activity over the coming year.
- Estate management staff will continue to assist tenants with the sustainment of their tenancies as per the Tenancy Sustainment Strategy
- A revision of the Anti-Social Behaviour Strategy is required to take into consideration updates and changes.
- Planned upgrades to existing CCTV locations is planned for 2018 to better enhance the cameras ability to capture night time incidents subject to the availability of funding.

#### **Tenant Purchase Scheme**

The introduction of the Incremental Tenant Purchase Scheme in 2016 afforded eligible Local Authority Tenants the opportunity to purchase their Local Authority homes. This scheme has generated considerable interest throughout the county however a number of the conditions associated with the current scheme is limiting the number of eligible applicants.

## Indicative Activities in 2017:

To date in 2017 the Housing Unit have received 35 completed applications, 25
properties have been approved for purchase and sales for 7 properties have been
completed, total proceeds from sales amount to €319,420.

## Proposals for 2018:

 Galway County Council will continue to process all tenant purchase applications in a timely manner as they are received.

# House Purchase Loans (Private & Tenant Purchase Loans)

Galway County Council provide financial assistance to enable first time buyers to purchase a home either through the tenant purchase scheme or on the private market.

#### Indicative Activities in 2017:

 To date in 2017 the Housing Unit have approved and paid four tenant purchase home loans and one private home loan to the value of €268,150. Two further tenant purchase loan applications have been approved by the credit committee but have not yet been drawn down by the applicants, these amount to €105,105.

# Proposals for 2018:

 Galway County Council will continue to assess and process all housing loan applications in a timely manner as they are received.

#### **Housing Rents**

Whilst the collection of rents rests with the Finance unit, the assessment of rents and the setting of the Differential Rent Scheme is a function of the Housing Unit.

#### Indicative activities in 2017:

- The Differential Rent (DR) Scheme was revised and the following changes were implemented:
  - Max rent increased from €84 to €130
  - The Galway County Council DR Scheme was extended to include tenancies previously assessed under the former Ballinasloe Town Council DR Scheme. This required a review of 276 rent accounts with rent increased introduced on a phased basis for low income families.
  - The Rent review has been completed in Loughrea, Ballinasloe & Tuam Municipal Districts.
  - The rent review has commenced in the Athenry/Oranmore Municipal District.

## Proposals for 2018:

• The rent review will be finalized in Athenry/Oranmore and Connemara Municipal Districts in 2018.

# **Control of Horses**

- The Council continued to implement its protocol in conjunction with the Gardaí on the Control of Horses during 2017. The number of stray and abandoned horses continues to reduce significantly.
- The Council has undertaken a number of exercises to raise awareness and reduce the instances of keeping of animals on estates. Such exercises include public notices, letters to residents as well as Community Warden Inspections.
- Funding is provided by the Department of Agriculture, Food and the Marine at the rate of €375 per horse seized and euthanized or €200 (max) where a horse is seized and

rehomed. Whilst the Council makes every effort to operate within the fee limits set exceptional situations may arise resulting in greater costs.

## Proposals for 2018:

 Galway County Council will continue to work with the Gardaí in tackling the issue of stray and abandoned horses on public roads.

# Housing, Cultural & Recreation SPC


#### Indicative Activities in 2017:

The Housing & Emergency Services SPC met on 4 occasions to date in 2017. Areas covered included Social Housing Strategy, New Incremental Tenant Purchase Scheme, Tenancy Sustainment Strategy, Housing Construction/Supply, Traveller Accommodation Programme 2014-2018, Strategic Plan for Housing People with a Disability, Homelessness Action Plan 2017-2018, Anti-Social Behaviour Strategy, Review of Areas of Choice and Creative Ireland.

#### Proposals for 2018:

• In 2018, it is anticipated that the committee will examine, a range of additional policy areas relating to Housing, Culture and Recreation.

# ROADS, TRANSPORTATION, MARINE AND GENERAL SERVICES UNIT



The road grants for 2018 will be announced in February 2018. It is anticipated that there will be specific provision for bridges on non-national roads. Notification has been received from Transport Infrastructure Ireland advising that the level of funding for National road maintenance will be significantly reduced by at least 17% and possibly by as much as 30%.

#### **Road Condition Survey**

All Non-National roads were surveyed in 2017 by Galway County Council, a grading applied to them and they were mapped on the Pavement Management System. This was the first comprehensive survey carried out since the initial surveying and grading in 2012. The Pavement Management System assists with the management of the network and provides an updated inventory of the network. The road condition is graded from 1 to 10 with 10 being the best condition. The continuation of the local tertiary road repair programme which was commenced in 2014 is extremely beneficial and it is intended to continue the programme in 2018.

The results of the survey carried out in County Galway are used as a tool to assist in setting out priorities for the Road Restoration and Reconstruction Programme. This type of data is very valuable in determining areas of concern and in fine tuning programmes to maximize the effectiveness of scarce resources. Other factors outside the physical attributes of the road also contribute such as traffic volumes, accident history, regional importance etc.

# **National Roads**

#### Indicative activities in 2017:

 Funding was provided in 2017 to facilitate the continued advancement and delivery of the Major Inter Urban. The following major projects are managed by the National Roads Project Office and the costs associated with this programme are recouped in full from Transport Infrastructure Ireland.

- The M6 Galway/Ballinasloe and M18 Gort Crusheen Schemes have some minor landowner issues outstanding.
- The M17/M18 opened to traffic, ahead of schedule, at the end of September 2017.
- Consultants have been appointed for the Galway Ring Road and are based in the Project Office in Ballybrit. Publication of this scheme is programmed for the first quarter of 2018.
- Maam Cross to Oughterard has been granted Planning Approval and is the subject of ongoing discussions with NPWS.
- Contract Documents are being prepared for the N59 Moycullen ByPass. Land acquisition is ongoing.

• The annual resurfacing and maintenance programme for National routes was undertaken in accordance with the budget for maintenance works notified by Transport Infrastructure Ireland.

#### Proposals for 2018:

- N67 Ballindereen Kinvara permission was granted for this scheme in 2016.
   Construction is programmed to commence in 2018.
- N63 Annagh Hill to Abbeyknockmoy construction works are ongoing, with an expected completion date of the second quarter of 2018.
- The annual resurfacing and maintenance programme incorporating ordinary maintenance, annual resurfacing, winter maintenance, bridge maintenance and traffic route lighting maintenance will be undertaken within the limits of available funding from Transport Infrastructure Ireland.
- In addition, a full programme of Pavement Overlay works will be undertaken on the National Primary and National Secondary Road Network in the context of the 2018 grant allocations from Transport Infrastructure Ireland.

# Indicative Activities in 2017:

The sum provided from the Council's resources in 2017 is €6,340,350, to include provision for public lighting.

Funding of €2,823,360 was allocated for Surface Dressing within existing fence lines. It was allocated as follows:

# Proposals for 2018:

- The Unit will prepare the 2018 Roads Programme in the context of available funding from the Transport Infrastructure Ireland, Department of Transport and the Council's own resources. The Programme will be presented to the Council for their approval in February 2018.
- The distribution of the Local Roads Budget 2018 will be presented to Council for approval in the context of the 2018 Roads Programme. The level of discretion that will be available to the Council in the allocation of funding in 2018 for Regional and Local Roads will be restricted by the requirements of the Memorandum on Grants for Regional & Local Roads as issued by the Department of Transport.

#### **Marine Works**

#### Indicative Activities in 2017:

#### Fishery Harbours and Coastal Infrastructure Development Programme

Improvement works, by direct Council labour, costing €150,000, are being carried out on 1 pier – Bealcarra Pier - in the Municipal District of Conamara. There is a requirement for Galway County Council to provide €37,500 of funding towards this work, with the balance of €112,500 being provided by Dept of Marine. Safety improvement works are ongoing at Crumpán Pier which will continue in 2018.

#### Marine Maintenance

A marine maintenance programme is ongoing in relation to the 62 landing places in County Galway which have been identified as in the charge of Galway County Council. This involves varied works including the updating of access steps and rails and repairs to slipways, including the removal of algae growth on piers in County Galway.

# **Strategic Piers and Harbours:**

#### <u>Inis Oírr Harbour</u>

• Funding of €8million for the pier development on Inis Oírr was specified in the Infrastructure and Capital Investment Programme 2016 -2021 and an executive engineer has been appointed to progress and deliver the extension to the existing pier, with the support of An Roinn Cultúir, Oidhreachta agus Gaeltachta. Contract documents for the project will be prepared in 2018, with a possibility of tendering for the works, dependent on the funding available.

# Caladh Mór Pier, Inis Meáin

• Phase III Caladh Mór, Inis Meáin options are being evaluated.

#### Fishery Harbours and Coastal Infrastructure Development Programme:

 A dive survey has been carried out at Roundstone Pier. A detailed structural analysis is to be carried out to establish the required works and funding is to be sourced for same in 2018.

#### **Coastal Protection**

- The Council will continue to submit proposals to the Office of Public Works for funding to facilitate Coastal Protection Works.
- Options for coastal protection works at specific locations in the County are being considered.

# Arterial Drainage

#### Indicative Activities in 2017:

• The Council discharged its statutory responsibility for the maintenance of certain drainage works in the County through the Roads and Transportation Unit and the Council's Municipal District Offices. The Council has charge of twelve Drainage Districts and there are two Drainage Districts in County Galway which extend into Roscommon and Clare County Councils.

## Proposals for 2018:

- The Unit will undertake a programme of maintenance on the drainage works under the remit of the Council during 2018, the works carried out will be dependent on the funding available.
- All available sources of revenue will be utilised to undertake remedial and improvement works on the drainage districts under the remit of the Council.

# Flood Mitigation Works & Studies

#### Indicative Activities in 2017:

- Galway County Council continued working in partnership with the OPW during 2017 to identify and progress works aimed at reducing the risk of future flooding.
- In 2017 18 Minor Works Flood Alleviation Schemes were completed, at a cost of €816,000, with a further 10 ongoing, to be completed in 2018.
- A Joint Steering Group comprised of representatives of Galway County Council and the Office of Public Works continued to meet during 2017 to progress works on the Dunkellin River & Aggard Stream Flood Relief Scheme.
- The contract for the Kiltiernan to Ballinderreen Flood Relief Scheme has been awarded.
- Vegetation clearance and the construction of a Craughwell bypass channel was completed in 2017 on the Dunkellin River & Aggard Stream.
- An engineering consultant and an environmentalist will be appointed by the end of 2017 to progress the South Galway/Gort Lowlands flood relief scheme.
- Galway County Council has continued working in partnership with the OPW on the
   Western and Shannon Catchment Flood Risk Assessment and Management during 2017.

## Proposals for 2018:

- Outstanding works on all existing minor flood mitigation projects will be completed during 2017 and Galway County Council will liaise with the OPW with regard to minor works schemes that are under consideration with the aim of securing funding for these schemes.
- The Ballinderreen to Kiltiernan Flood Relief Scheme will continue to be progressed in partnership with the Office of Public Works and Transport Infrastructure Ireland.
- Works on the Dunkellin River & Aggard Stream, on the channel and bridges downstream of Craughwell will be completed in 2018.

- A scheme of works for the South Galway/Gort Lowlands Flood Relief Scheme will be developed in 2018, with the intention of going to contract in 2019, construction to commence in 2020.
- Applications for funding for any further schemes identified as offering appropriate
  potential to reduce the risk of future flooding will be advanced for submission to the
  OPW.
- Galway County Council will continue working in partnership with the OPW on the
  Western and Shannon Catchment Flood Risk Assessment and Management during 2018.
  Finalised flood risk management plans will be in published in 2018. The Office of Public
  Works will prepare a priority list in early 2018 which will be circulated to Local Authority
  members for their consideration.

# **Road Safety**

- The Road Safety Together Committee held meetings and continued its active role in the promotion of road safety.
- Road safety initiatives undertaken by the Council during 2017 included:
  - Promotion of the Drive for Life Programme for secondary schools.
  - In January and July 2017, the RSA 'Check it Fits' event whereby child car seats are checked to ensure they are safely and securely fitted took place at various Galway locations.
  - Support for the Cycling Safety Training Programme in national schools
  - The Council supported the Galway Rally in February 2017, and arranged for the distribution of road safety awareness material
  - Support for the Cycling Safety Training Programme in national schools
  - The Council supported 'Slow Down Day' in May and October 2017
  - Support for the operation of the Junior School Warden Scheme and competition held with 4 schools on 18<sup>th</sup> May 2017, in Mountbellew.
  - During the Bealtaine Festival in May 2017, a High Visibility Vests Campaign took place and vests were distributed, free of charge.
  - In June 2017, Galway and Mayo County Councils ran a joint campaign for the Connacht Semi-Final in Pearse Stadium where they were encouraged to drive safely to the event.
  - In June 2017, the Road Safety Plan for Galway City and County 2017-2020 was launched and circulated to the general public, libraries, Council offices, etc.

- In July 2017, Galway, Mayo and Roscommon Road Safety Officers ran a joint campaign for the All Ireland Football Quarter Finals in Croke Park where they were giving drink driving the 'red card'.
- In July 2017, Galway and Roscommon Co. Councils ran a joint campaign for the Connacht Final in Pearse Stadium, Galway, where they were encouraged to drive safely with the message 'Get There-No Regrets'.
- Support for the operation of the Junior School Warden Scheme and competition held with 4 schools on 18<sup>th</sup> May 2017, in Mountbellew.
- 'European Mobility Week' took place from 16<sup>th</sup> to 22<sup>nd</sup> September, 2017, and one of the initiatives undertaken that week was a 'Walk to School Day' where 3 local national schools took part in a walk from Kenny Park, Athenry, to their schools, wearing their high visibility vests.
- The 'European Day Without a Road Death' took place on 21<sup>st</sup> September 2017, and the Council promoted the 'Are You Daylighted' Campaign which encourages all road users to use their dipped headlights during daylight hours.
- 'Be Safe, Be Seen' initiative took place with Coláiste Chroí Mhuire, An Spidéal, on 28<sup>th</sup>
   September, 2017, whereby high visibility vests were distributed to the Transition Year.
- For the national Road Safety Week held from 2<sup>nd</sup> to 8<sup>th</sup> October, 2017, joint initiatives took place with NUIG and GMIT where high visibility vests were distributed to students; Advance Pitstop offered a free 5 Point Vehicle 'Health Check' to members of the public to ensure vehicles are in proper working order for the winter and Specsavers offered eye tests at reduced price to ensure the correct vision for driving.
- A Car Dismantling Demo took place on 3<sup>rd</sup> October 2017, in conjunction with Coláiste Cholmcille, Indreabhán and Coláiste Chroí Mhuire, An Spidéal. The Fire Service, Civil Defence and An Garda Síochána were present at this educational event
- Social Inclusion Week took place from 16<sup>th</sup> to 22<sup>nd</sup> October, 2017, and high visibility material and leaflets was distributed.
- During 2017, road safety awareness messages appeared on the Council's social media in order to continue raising road safety awareness to its staff members and also messages were sent to local press aimed at the general public.
- During 2017, high visibility vests, armbands and road safety awareness leaflets were distributed, free of charge, to schools, community groups and the general public.

- The Road Safety Together Committee is to meet regularly and continue its active role in the promotion of road safety.
- Road safety initiatives proposed by the Council during 2017 include:
  - Promotion of the Drive for Life Programme for secondary schools.
  - Support for the Cycling Safety Training Programme in national schools

- Continue to raise awareness of road safety to the general public by regular radio messages and through social media
- Support for the operation of the Junior School Warden Scheme in 4 schools
- Various initiatives to raise awareness to the general public
- Continue the distribution of high visibility vests, armbands and road safety awareness leaflets, free of charge, to schools, community groups and the general public.

# **Speed Limits**

#### Indicative Activities in 2017:

- A 4 year programme of the installation of SLOW ZONE speed limit signage in housing estates continued for the second year in 2017. Funding provided in 2017 for this programme of works was €34,450.
- The Unit continued to implement Road Works Speed Limits; in consultation with the Gardaí and Transport Infrastructure Ireland, as deemed necessary to facilitate the delivery of the Council's various work programmes.

## Proposals for 2018:

- The programme of the installation of SLOW ZONE speed limit signage in housing estates is expected to continue in 2018, depending on funding being made available by the Department of Transport.
- A review of County-wide speed limit bye-laws is continuing in 2017, which will result in a
  programme of work installing and updating signage as per bye-laws, which are to be
  adopted at plenary Council.
- The Unit will continue to implement Road Works Speed Limits; in consultation with the Gardaí and Transport Infrastructure Ireland, as deemed necessary to facilitate the delivery of the Council's various work programmes.

# **Public Lighting**

#### Indicative Activities in 2017:

 A sum of €1,122,000 was provided in the 2017 Budget to fund the cost of the public lighting programme including the maintenance, energy and upgrade costs.

## Proposals for 2018:

• The Council will continue to maintain and upgrade the public lighting in County Galway. The budget provided covers the maintenance and energy costs associated with the existing public lighting network.

#### Community Involvement Schemes

## **Community Involvement in Roadworks Scheme**

The Council continued to actively promote the Community Involvement in Roadworks Scheme as a means of harnessing community support for road works on suitable local roads. A total of €346,822 was provided for 24 schemes by the Department of Transport, Tourism and Sport.

## Proposals for 2018:

• The 2018 Draft Roads Programme will include provision of funding to facilitate the operation of the Community Involvement in Roadworks Scheme, dependent on the funding made available.

# **Local Improvement Schemes**

#### Indicative Activities in 2017:

 Notification of the recommencement of the Local Improvement Schemes was received in late August 2017. An allocation of €942,000 was notified in October 2017 and this has facilitated the commencement of works on 42 schemes. These works are ongoing.

## Proposals for 2018:

• An allocation, similar to that received in 2017, is anticipated for 2018. It is intended to advertise the scheme, seeking submissions, in early 2018, with a view to carrying out works at further locations.

#### Greenways

#### Indicative Activities in 2017:

- Galway County Council continued to progress the proposed walking and cycling
   Greenway from Galway to Oughterard with support from the Department of Transport.
- Galway County Council continued to progress the development of the walking and cycling Greenway from Clifden to Oughterard, with support from Fáilte Ireland.

# Proposals for 2018:

• The Council will continue to progress all Greenway projects in the County, offering increased sustainable transport options to both residents and tourists.

#### **Customer Service**

#### Indicative Activities in 2017:

• The Unit made information available to the general public, in 2017, on our Winter Service Plan for 2017/2018 at <a href="www.galway.ie">www.galway.ie</a>. The information sets out how the Winter Service for ice and snow conditions will be provided for in County Galway.

- The Unit is making increased use of Twitter and Facebook as the appropriate instant social media to advise the public of temporary roadworks, including ongoing updates on timeframes for the works. This method of communication was also used during the severe weather event Storm Ophelia.
- The Unit continues to publish public notices on <u>www.galway.ie</u> regarding planned, longer-term roadworks.
- The Unit continues to operate an On-Line Payment Facility to allow for the payment of Fixed Charge Notices (Parking Fines).
- Notices advising the general public on issues relating to the Roads Act, which affect them, such as hedge cutting, unauthorised advertising etc were made available on <a href="https://www.galway.ie">www.galway.ie</a> and have been advertised in the local newspaper.
- A nominated person within the Unit deals with all Customer Service queries from whichever source they are received, such as Fix Your Street, Customer Comments system, e-mail, Twitter etc. to ensure response are issued in a timely manner.

- The Unit shall continue to make use of <a href="www.galway.ie">www.galway.ie</a> and other social media to advise and inform the public of Roads issues which affect them.
- The Unit will continue to train frontline staff on-the-job. This will ensure sufficient knowledge within the Unit, to enable it to continue to operate efficiently and effectively despite the reduction in staffing numbers.
- The option of extending the on-line payments facility for other services will be considered.

## **Corporate Support**

#### *Indicative Activities in 2017:*

- The Unit continued to be responsible for the efficient operation and administration associated with the Municipal District of Tuam.
- The Unit continues to provide support for the Roads and Transportation Strategic Policy Committee with policy formation. Matters considered in 2017 included the allocation of roads funding,

#### Proposals for 2018:

- The Unit will continue to actively support the role of the Roads & Transportation
   Strategic Policy Committee in policy formation, with a view to furthering policies
   previously considered in 2017 and also completing policies on advertising on public
   roads and traffic calming in built up areas.
- The Unit will continue to work with the Members to ensure that the Municipal District system is an efficient and effective model for addressing operational issues.

# **FINANCE UNIT**

## Value for Money, Shared Services and Public Procurement:

#### Indicative Activities in 2017:

- SupplyGov have established and are operational in Galway County Council:
  - A new DPS (Dynamic Purchasing System) for Road Marking Supplies and Services January 2017.
  - A new DPS for plant hire came into operation April 2017
  - A New Electrical and Plumbers Framework September 2017.

All information was circulated to relevant staff regarding these new procedures. During 2017 Galway County Council engaged with the LGOPC on the following frameworks/DPS: Plant Hire Services, Road Making Materials – Supply Only, Road Making Materials – Supply & Placement, Footway & Road Pavement Restoration, Ready-Mix & Concrete Additives (Supply only).

- 17 Requests for Tender (RFT) and 63 Requests for Quotation (RFQ) were raised on SupplyGov (LA Quotes) during 2017 YTD. There were also 44 Tenders processed through eTenders.
- Galway County Council is also engaged with the OGP on the following National Contracts and Frameworks: Bulk Fuel, Electricity, Natural Gas, Fuel Cards, Envelopes, Copying Paper, Manage Print Services, Print Panel, Stationery, Personal Protective Equipment, and Janitorial supplies.
- Purchase Cards: During 2017 we continued to use the Lighthouse BCS Portal to process transactions to Agresso. We currently have 174 Active Cards with 2017 YTD Spend of €807,000 and have processed 6361 transactions YTD.
- Fuel Debit Cards: We currently have 238 active fuel cards with an YTD spend of €529,000 made up of 8,141 transactions across 66 Filling Stations.
- High level training was rolled out for engineers and administration staff on eTenders in March 2017.
- Data Returns: All data returns required by the LGER and the OGP were completed and returned on time.
- Public Spending Code: The public Spending code was issued to NOAC at the end of May 2017.
- Circular Fin 07/2012: Under the Public Service Reform Plan GCC have published a quarterly listing of Purchase Orders greater than €20k.

## Proposals for 2018:

• SuppyGov.ie – organise additional training for all buyers and administration staff on the new DPS – *Dynamic Purchasing System* 

- To review the Corporate Procurement Plan and the Corporate Procurement Policy.

- Policy notes developed for Accounts Payable including supplier statements /fraud prevention.

## Proposals for 2018:

- Investigation of alternative automated methods to achieve BUDGET cycle (use of Prevero). Enhancement review of CCAS Budgetary Modules & full implementation of functionality.

#### **Revenue Collection**

#### Indicative Activities in 2017:

- Continued review of the Revenue collection function to ensure best practice is achieved and any new income stream is incorporated efficiently.
- Continued utilisation of the ASCENDAS system in regard to the management of income streams such as rates, rents & development levies.
- Continued utilisation of the MARPS process in regard to housing loans.
- Liaison with the Law Agent in regard to the Implementation of the Tenancy Warning system in regard to rent arrears and Section 12 Applications for Possession under the terms of the Housing (Miscellaneous Provisions) Act 2014.
- Continued implementation of electronic payment methods e.g Billpay, Household Budget, EFT, online payment facility etc to facilitate customers.

#### Proposals for 2018:

- Monitor and update the Revenue collection function as regards best practice
- Continue to review debt collection procedures including legal enforcement measures with the Law Agent.
- The unit will continue to offer the Bill Pay option to Rents, Loans, RAS and Rates customers.
- Provide appropriate training to staff on debt collection procedures.

# **Motor Tax and Driver Licensing Systems**

#### Indicative Activities in 2017:

- A special report on the Administration and Collection of Motor Tax was carried out on a joint basis by the Office of the Comptroller and Auditor General and Local Government Audit Service and published in early 2017. One of the recommendations contained in the report was that the factors influencing the decision of customers to tax online or at Motor Tax Offices should be established, and evaluation of these factors and the costs of collection should inform the future development of motor tax collection, and of other related services currently provided only in motor tax offices. Customer Survey forms were received from the Department of Housing, Planning, Community & Local Government in September 2017 these were given to all customers and completed responses were returned to the Department.
- 91,617 transactions were processed by Galway Motor Tax Offices up to the end of October 2017 at a value of €15.4m.
- 68% of total motor tax activity for the Galway area was carried out online in the year to date an increase from 65% for 2016.
- 3,647 declarations of non-use for vehicles were recorded at the Galway Motor Tax Offices up to the end of October 2017.
- A review of vehicles taxed at island rate was commenced during the year, in consultation with Community Wardens and An Garda Síochána.
- The criteria for converting a vehicle to a goods vehicle (with 2 rows of seats) was clarified at national level, and Motor Tax Offices are required to refuse applications which do not meet the national requirements.

#### Proposals for 2018:

- Work will continue on retrieving and digitizing motor tax records in long-term storage with a view to creating an accessible index of all vintage vehicle registration records.
- The Motor Tax Offices in An Cheathru Rua, Ballinasloe, and Galway, will continue to implement all motor tax policies and procedures, and provide support and advice to members of the public, including customers of the motor tax online service.

## Indicative Activities for 2017:

 Completed rollout of Office 365 suite of products to allow for greater productivity and remote working capabilities.

- Replacement and improvement of Firewall infrastructure for higher security and reporting capability.

- Geological Heritage Audit Phase 1: There are currently an estimated 135 County
  Geological Sites (CGS) in County Galway that have been provisionally listed by the
  Geological Survey of Ireland. Co Galway will be audited in a phased approach, the
  priority for 2017 was to cover around 40 CGS sites in the north-western part of County
  Galway, including the 25 sites within the Joyce Country Aspiring Geopark area and any
  additional site/s of significance (following approval by the relevant Expert Panel).
- An ecclesiastical heritage audit will be undertaken for the Oranmore Electoral Area documenting and creating a database of the rich artwork that is contained in the churches.
- The community archaeologist worked with various groups, schools and individuals in the
  county to increase awareness, knowledge and appreciation of the archaeological
  heritage of the county. He also provided guidance and assistance on undertaking
  archaeological heritage based projects to best heritage practice. In addition to this a
  number of conferences and events were held throughout the county.
- 'Stories from the landscape'. Galway County Council, Clare County Council and Tipperary County Council worked with Galway Film Centre and each county produced 3 high quality films on various aspects of heritage. This initiative received funding from the Heritage Council.
- 'Go Wild' Summer Camps. Developed two children's biodiversity 2 day summer camps with BirdWatch Ireland, Oughterard Heritage, Irish Workhouse Centre, Portumna and the Heritage Council. These successful courses were delivered in Portumna and Oughterard.
- A six week course took place in Tuam Library in May and June 2017 entitled 'An
  Introduction to Publishing and Archival Best Practices'. The course was delivered by
  various lecturers and was developed in partnership with the Old Tuam Society and Tuam
  Library. 25 people attended this course.
- The Biodiversity Project operates as a partnership Project between the County Council through the Heritage Office and the Applied Ecology Unit, NUI, Galway in conjunction with Galway Rural Development and Galway County Heritage Forum supported by the

Heritage Council and Galway County Council. Funding was sought from the Heritage Council for the payment of the salary and overheads for the Project Manager and to undertake projects such as producing further biodiversity Action Plans for towns and villages in the county, the development of an invasive species strategy, graveyard management conservation plan for a select number of graveyards and the provision of an education and awareness programme for the communities in the county

- Athenry Walled Towns Day Funding will be sought from the Walled Towns Funds of the Heritage Council and Athenry Walled Town Day took place in Sunday 20th August 2017. An estimated 3000 people attended this family fun day.
- Athenry & Loughrea Walled Towns Educational Project Funding was sought from the Heritage Council to develop z-cards for both towns. The z-cards are in the final stages of production.
- Loughrea Medieval Festival This 3 day event was held in Loughrea 25<sup>th</sup> 27th August 2017 in partnership with Loughrea Medieval Festival Committee. In the region of 15,000 people attended this very successful event.
- Decade of Commemoration Further development and updating of the bi-lingual website for the Decade of Commemoration. Launch of 'Voice of the Rising', Galway County 1916-2016 Memorial in Renville Park, launch of Éamonn Ceannt Memorial in Ballymoe on 30<sup>th</sup> May 2017. A bi-lingual heritage 1916 Heritage Trail was developed in partnership with GMIT and will be launched in Gort on 14 December 2017.'The Fenians, Colonel Kelly and the Manchester Martyrs' conference will be held in Mountbellew on 11<sup>th</sup> November 2017. The Loughrea Remember Conference will be held on 16th November 2017.
- ICAN Community Heritage website. The Heritage Office continued to work in partnership with the Museum of County Life Castlebar and community groups around the county to further develop this website.
- Féile na gClogh, Inis Oírr took place from 14<sup>th</sup> 17<sup>th</sup> September 2017. In the region of 100 people attended the stonewall workshop, lettering and carving workshops and the sketch outs around the island. In addition to this a large number of other people stayed on the island who connected to workshop participants.
- Heritage Week Events August 2017. A very successful bus tour relating to the food and heritage of south Connemara took place during heritage week. This linked in with Galway West of Ireland Region of Gastronomy initiatives. Promoted and assisted local communities in the delivery of their heritage week events around the county.
- Community Events, Conferences and Workshops Assistance, advice, and support was also be given to numerous Town and Community events in 2017including heritage training and relevant local heritage conferences and seminars.
- Diaspora and Emigration: Tuke Emigration Scheme Project –Work continued with the Clifden 2012 Committee and Oughterard Heritage Group on this project. This project

- and other emigration and diaspora Projects were launched in Cloonacauneen Castle on 6 November 2017.
- Digital Mapping of Graveyards in the County –this continued with several graveyards being mapped and memorial inscriptions being recorded and up loaded to www.galway.ie
- The Beo Schools Project with Insight, NUIG and Galway Education Centre ongoing.
- Participated on Committees such as the Placenames Committee, Loughrea Heritage and Development Company and the Aran Life Project.
- Roll out of the Heritage Grant Scheme as part of Community Grants.
- The Golden Mile Calendar to be produced and launched in December 2017.
- Development of a new Galway County Heritage and Biodiversity Plan 2017-2022 took
  place during the year. This included public consultation sessions, review of submissions
  to the new plan, meetings with Galway County Heritage and Biodiversity Forum and
  presentation to SPC.
- Galway Gastronomy Heritage Project: The heritage office has engaged with several
  groups through the county collecting and showcasing their work on
  www.heritae.galwaycommunityheritage.org To date over 800 individual items have
  been digitised and made available on the website. The project was officially launched in
  Claregalway Castle on 6 September. The project is being delivered in partnership with
  the Social Inclusion Unit and Creative Ireland.
- Worked with colleagues in other Departments of Galway County Council including Corporate Services (eg. Battle of Aughrim Visitor Centre, Rinville Park and 1916 Signage Project); Roads (eg. Connemara Greenway, general heritage advice); Environment Section (eg. graveyards); Housing (eg. naming of estates); Planning (eg. inputs to plans and development management as required). Part of Creative Ireland team and Galway County Council – Region of Gastronomy team.
- Seafest- Devised and delivered a programme of events relating to the sea and out boating heritage tradition.
- Assisted communities in Creggs, Monivea, Moylough, Tuam, Killimor, Cornamona,
   Oranmore and Gort to develop heritage trails (both digital and paper based).

- Undertake Phase 2 of a Geological Heritage Audit of County Galway in partnership with the Geological Survey of Ireland and the Heritage Council.
- Galway West of Ireland Region of Gastronomy Heritage Projects 2018 continue to
  work with local communities and organisations gathering information relating to the
  gastronomical heritage of the county and produce written, audio and video outputs for

- Participate in a new Community Physical Activity research programme with a number of other Sports Partnership and Waterford Institute of Technology.


Staff Training and Development:



The Training and Development Section provides a wide range of training programmes to enable staff and management carry out their duties in a confident and competent manner and in a safe working environment. Staff investment in training benefits the organisation through the upskilling of employees and it also facilitates continuous personal development. There have been approximately 1948 training days provided from January to November in 2017.

Health & Safety training formed a considerable part of the 2017 Training Plan which included the following courses: Driver Certificate of Professional Competence Training, Signing, Lighting and Guarding Training, Safe Pass and Chainsaw training; Manual Handling Training; Confined Spaces Emergency and Rescue Training; Occupational First Aid and CSCS Health & Safety @ Roadworks Training. 28 Fire Wardens renewed their training and all indoor staff received Fire Evacuation Training in 2017.



# Staff Welfare:

Galway County Council has a number of Family Friendly Schemes in place including:

 Employee Assistance Programme: A confidential counselling service, the "Employee Assistance Programme" or EAP is available to all Galway County Council employees.
 Health Assured Ltd was renewed as our service provider on behalf of Galway County Council.

- Shorter Working Year Scheme: 30 staff members availed of unpaid leave under the Shorter Working Year Scheme in 2017.
- Parental Leave Scheme: 59 staff members availed of parental leave in 2017.
- Work Sharing Scheme: 57 staff members availed of work sharing arrangements in 2017.
- Career Breaks: 10 staff members availed of career breaks in 2017.
- Parent Leave Scheme: 13 staff members availed of the new parent leave scheme in 2017.
- Cycle to work scheme: Under this scheme an employer may provide an employee with a
  bicycle and/or associated safety equipment up to a maximum value of €1000 without
  the employee being liable for benefit –in-kind taxation. 18 applications for participation
  in the Cycle to Work Scheme have been processed to date in 2017 for Council
  employees.
- Travel Pass Scheme: There are currently 17 staff members availing of the Tax Saver Travel Pass Scheme.
- According to service records, 23 full-time staff members and 2 part-time fire personnel are due to retire in 2018.

# HR Payroll Shared Services Program:

The Superannuation Data Readiness Project was completed in 2017 and the Migration to MyPay, Local Government Shared Service Centre took place. MyPay Shared Services Centre now administer Superannuation/Pensions for Galway County Council with effect from the 14th August, 2017.

- Recruit and deploy staff in an efficient and professional manner, and in accordance with Government policy.
- Continue within the available resources to deliver training and development programmes. The 2018 Training Plan will focus on the delivery of mandatory health & safety training and certification requirements taking into account individual and organisational requirements.
- Develop, implement and communicate appropriate human resource policies in line with existing and new legislation, and in keeping with best practice.
- Support and advise Line Managers on the implementation of workplace policies.
- Promote dignity at work, diversity and equality for all employees of the Council.
- Continue to promote a climate of good industrial relations and strengthen the partnership approach to joint problem-solving in the interest of employee and customer relations.

# **ENVIRONMENT, WATER and EMERGENCY SERVICES UNIT**

# **Capital Investment Programme**

### Indicative Activities in 2017:

• Since 1<sup>st</sup> January 2014 the Council continues to implement the Capital programme as an agent of Irish Water. The investment decisions and timing of investment are decided by Irish Water based on business case and need the approval of the Commission for Energy Regulation. The Water Services Investment Programme as we knew it has been replaced by Irish Water's Capital Investment Programme. In 2017 the main schemes which made significant progress were water rehabilitation schemes, Kinvara Sewerage Scheme, Leenane Water Scheme, Oughterard Sewerage Scheme, and Athenry Sewerage Scheme. Some of these schemes will continue into 2018.

## Proposals for 2018:

• Throughout 2018 it is planned to commence works in at Athenry WWTP and continue the planning for the network upgrade also. Progress is expected to be made on the planning of a wastewater solution for Glenamaddy and the completion of the long awaited plant in Oughterard. Long term planning has also started for the expansion of the area served by the Tuam RWSS and the provision of water also from the Lough Mask scheme into north east Galway.

# Management and maintenance of Water and Wastewater Schemes

### Indicative Activities in 2017:

• The Council continues to operate the water and wastewater schemes as agent of Irish Water under the terms set out in the Service Level Agreement and the annual service plan. The Council as agent of Irish Water is now operating within a regulated environment and the practical effect of this has been a much greater emphasis on reporting of activities and measurement of performance. This has resulted in the adoption of new practices and new technology while at the same time having to absorb reductions in staff numbers driven by the Commission for Energy Regulation. Emphasis continues to be placed on Health and Safety and quality compliance.

### **Indicative Activities in 2018:**

• The Council will continue to operate the Service Level Agreement and perform within the parameters set out in the Annual Service Plan. New performance indicators are proposed for 2018 and it is expected that further transformation initiatives will be rolled out as well as progress in relation to the Water Industry Operating Framework (WIOF) which should clarify the road ahead for the industry as a whole.

### Water Conservation

### Indicative Activities in 2017:

Active leak detection and repair works have continued throughout 2017. Extensive upgrade and maintenance works has been carried out on meters associated with District Metering Areas (DMAs), allowing for complete and accurate data to be gathered on the network. Works on the Rehabilitation Programme (Carraroe, Inishmore, and Loughrea & Spiddal) were completed in 2017 and further phases will be rolled out under the Capital Investment Programme.

# Proposals for 2018:

To further reduce Unaccounted for Water in the county during 2018, IW will be
increasing the available resources through a Find & Fix programme, with additional
resources being made available for both leak detection and leak repair works. These
resources will include contractors being retained to carry out all aspects of water
conservation works.

# **Waste Management Infrastructure**

- Galway County Council is continuing to operate the landfill at Kilconnell for the acceptance of waste for a defined period of time in the 2 remaining cells and in parallel, commence the capital works for the permanent capping of the existing cells 1 to 7.
- Civic Amenity Sites continue to operate under contract at Ballinasloe, Clifden and Tuam.
- Tier 2 Site Investigations and Tier 3 GQRA were carried out at Historic Landfill sites at Glenamaddy and Ballygar, funded directly by Department of Communications, Climate Action and Environment (DCCAE).
- Rehab Glasco continue to provide a collection service for glass and beverage cans at the County's 92 bring bank centres, while the Council has a partnership arrangement with Athchursáil Arainn Teo. (Now Athchursáil Arainn Cuideachta Gniomhailchta Ainmnithe) to operate an integrated waste management scheme for the Aran Islands. On Inishboffin a landfill and recycling service is provided for, fully funded by Galway County Council.
- The Local Authority Prevention Network (formerly the Local Authority Prevention Demonstration Programme) is ongoing. The Network is involved in identifying actions for prevention and capacity building within community, business and public sectors in relation to resource use efficiencies and areas covered include waste prevention, energy conservation, water conservation and capacity building, training and awareness

- The final capping works on cells 1-7 at the Kilconnell landfill which commenced in 2017 will continue during 2018.
- Monitor the operation of leased recycling facilities countywide.
- Provide mobile hazardous waste & WEEE collections at targeted locations
- Implement waste collection bye-laws in targeted areas.
- Provide an education campaign in support of separate organic waste collection upon Implementation of separate collection by private collectors.

# **Environmental Monitoring & Enforcement Measures**

- Details of enforcement notices, warning letters issued and initiated prosecutions under Environmental legislation in 2017 will be set out in the 2017 RMCEI (Recommended Minimum Criteria for Environmental Inspections) returns which are due for issue by January 31st 2018.
- The 2017 RMCEI returns detail planned pro-active inspections carried out on regulated facilities and unplanned reactive inspections in relation to complaints received and incidents of environmental pollution. Inspections are carried out in relation to complaints, permitted waste facilities, permitted collectors, quarries, garages, various waste producer categories, discharge licences, sewage sludge facilities, farms, private wastewater treatment systems, air pollution licences, deco paints facilities and solvent registered sites.
- Joint Producer Responsibility Inspections were carried out by wardens and enforcement officers, focusing on food waste disposal and commercial brown bins in agglomerations of >500.
- Joint inspections were carried out with REPAK on non-compliant businesses, under the CU WERLA pilot packaging programme.
- 8 litter 'black spots' were cleaned up, barriers and signage erected and CCTV installed
  with funding provided by DCCAE under the Anti-Dumping Initiative 2017. Over 100
  tonnes of waste was removed during the Initiative which was publicised locally on
  Council's social media and in local newspapers.
- Approx. 70,000 waste tyres were removed from illegal dump sites with funding provided by DCCAE, prior to introduction of new Waste Tyre Regulations on 1<sup>st</sup> October.
- Warning letters were issued to all businesses who had not registered with REPAK ELT under amended Waste Tyres Regulations.
- Multi-agency inspections were carried out at 2 unauthorised ELV sites which had been identified in 2016. Aerial photography of sites was provided by CU WERLA prior to inspections.

- Monitoring was carried out in relation to drinking water, bathing water, rivers, lakes and landfills in accordance with legislative requirements both directly and via contracts with external laboratories. Follow-up actions were taken in response to non-compliances.
- Enforcement actions included the enforcement of 126 discharge licenses for large scale private wastewater treatment systems and the inspection of 35 farms and 91 domestic wastewater treatment systems.
- Public notices were issued and investigative monitoring was carried out as required in response to drinking water and bathing water non-compliances. Six Blue Flags and Six Green Coast plaques were awarded to bathing areas in County Galway.
- Portumna Bathing Area achieved the Blue Flag Award for the first time in 2017 bring the total number of Blue Flags to six and Six Green Coast plaques were awarded to bathing areas in County Galway.
- Activities which have the potential to cause air pollution such as dry cleaning and vehicle refinishing were regulated.

- The Council will set out all planned pro-active inspections of authorised facilities under various Environmental Legislation in the 2018 RMCEI Plan which is due for issue by January 31st 2018. The scale of Enforcement activity in 2018 will reflect the resources available for inspections and will be on a prioritised basis taking consideration of Departmental, EPA and WERLA guidance.
- The Council will continue to carry out investigations and monitoring under environmental legislation, in accordance with government policy and EPA directions, and take enforcement measures as required for non-compliance with environmental legislation.
- CU WERLA pilot packaging programme will be rolled out to all local authorities in 2018 and joint inspection campaign with REPAK to take place on all unregistered businesses in County. Follow up enforcement action to be taken, as advised by WERLA.
- Covert CCTV cameras will be sourced and purchased for temporary deployment at locations where persistent dumping occurs.
- Further enforcement action including warning letters and prosecutions to be taken for all tyres retailers who have not registered with REPAK ELT by 31st December 2017.
- Introduction of fixed penalty notices under Producer Responsibility Initiatives, for example, failure to register with relevant compliance scheme, failure to display appropriate signage and/or certification of registration.
- Introduction of fixed penalty notices under the Air Pollution Act 1987 in relation to vehicle refinishing and organic solvents.
- The Council will work with the public and other agencies, including the WFD Office, on the improvement of water quality in identified priority catchments, through public awareness and through a concentrated programme of inspections of potentially

polluting sources including large scale private wastewater treatment systems, farms and domestic wastewater treatment systems.

# **Derelict Sites and Dangerous Structures**

### Indicative Activities in 2017:

• The Council continued to exercise its powers under the Derelict Sites Act 1990, in order to compel the owners of neglected, ruinous and unsightly buildings and land to take remedial action. While there are currently no sites on the Derelict Sites Register, enforcement action continued to take place where required.

# Proposals for 2018:

Sites in the county will continue to be reviewed in accordance with the Derelict Sites
policy and the Dangerous Structures policy.

## **Burial Grounds**

### Indicative Activities in 2017:

- There are currently 233 burial grounds listed on The Council's burial ground register. The Council, with the participation of the many local burial ground committees, carries out works of maintenance and improvements as resources permit.
- A burial ground extension programme continued throughout 2017 with priority given to extensions at Annaghdown, Quansboro, Claregalway, Leenane etc.
- Extensions were completed at Killursa, while Part 8 approval was received in respect of extensions at Leenane, Bealadangan, Clarenbridge, Creagh and Killimordaly.
- Improvement works were supported at a number of burial grounds resulting in increased plots available.
- An annual grant is provided to committees who maintain the burial grounds in their area. A 3 tier grant was awarded to Committees in 2017 - €600, €450 or €300 with grants made to over 160 committees in 2017.

## Proposals for 2018:

 The Council will continue to progress extensions in conjunction with the local communities. Works will commence to extensions at Leenane, Bealadangan, Clarenbridge, Creagh and Killimordaly in partnership with local communities and as resources permit while extensions will be advanced at Abbey, Abbeyknockmoy, Annaghdown, Claregalway, Kilkieran, Kilmeen, Knock, and Quansboro again as resources permit.

## **Environmental Awareness & Education**

#### Indicative Activities in 2017:

- Awareness officers are involved in promoting environmental awareness through ongoing engagement with the domestic and commercial sectors
- Community awareness events have taken place focusing on waste management, waste prevention, food waste, home composting, household hazardous waste, energy conservation and water conservation
- Ongoing development and dissemination of information through local media, social media, libraries, schools, voluntary groups etc.
- Ongoing involvement with Tidy Towns groups
- Ongoing involvement in the Green Schools programme with over 90% of county schools involved
- Participating with and funding community based Anti-Litter initiatives
- Delivery of WEEE and National Spring Clean initiatives
- Cleaner Greener Galway in conjunction with Gardai Siochana.
- Links with Regional Officer.
- Liaising with Community and Enterprise Unit, Heritage Officer, Biodiversity Officer on various environmental projects
- Ongoing implementation of the LAPN / Waste Prevention Programme.

### Proposals for 2018:

- The Awareness campaign will continue with particular emphasis on further enhancing partnerships with community and voluntary groups and the continued dissemination of information to all sectors using all suitable methods.
- Ongoing implementation of the Waste Prevention Programme.
- Continuation of Cleaner Greener Galway initiative in conjunction with Garda Siochana
- Liaising with European Region of Gastronomy campaign

# **Energy Efficiency**

- Galway County Council achieved certification to the international standard ISO 50001
   Energy Management Systems in 2017.
- Energy efficiency information was supplied to all Chambers of Commerce in the County.
- Energy efficiency information was provided at Meet West, Local Enterprise days and environmental sessions with local communities.

- Continue the energy efficiency fabric upgrade and deeper retrofit programme for local authority housing.
- Provide real time metering software for Galway County Councils significant energy users to identify energy saving opportunities.
- Continue with provision of information at local community and business events and explore further funding opportunities.

# Animal Control & Welfare

#### Indicative Activities in 2017:

- Animal welfare cases involving dogs, cattle, sheep and horses were investigated where appropriate in conjunction with Gardaí, Dept. of Agriculture and welfare groups.
- The Council continued to be active in providing pound facilities for impounding of horses, sheep, cattle and goats. Structural improvements were made to Ballinasloe Pound. The Council veterinary service liaises with Housing in the implementation of the Control of Horses Act including the tendering processes.
- The Council continued to implement the Dog Breeding Establishment Act 2010 which requires the registration, and compliance with standards, of all premises coming under the definition of a 'dog breeding establishment'.
- Under the Control of Dogs Act, increased compliance with dog licensing was achieved by targeting resources.
- The Microchipping of Dogs Regulations 2015 came into force for all dogs on 31 March 2016. An ongoing information campaign using leaflets and the website continued throughout 2017.

- The Council will continue to provide pound services and are carrying out further improvement works to Ballinasloe Pound.
- Ongoing improvements to the efficiency of the Dog Control service will be implemented during the year to include continuing targeting of resources with a view to increased compliance with dog licensing.
- The Council will continue to investigate cases of animal welfare breaches in conjunction with Dept of Agriculture, Gardai and welfare groups.
- The Council will implement and enforce the micro-chipping law.
- Dog Breeding Establishments on the register will be inspected and all reports of unregistered breeding establishments will be followed up. It is a legal requirement that all establishments apply for registration.

# **Food Safety**

### Indicative Activities in 2017:

- The Council provided a Veterinary Public Health Inspection Service for both City and Galway County Councils under the terms of its service contract with the Food Safety Authority of Ireland.
- There are 11 local abattoirs in the county which are approved by the Council under Irish and EC legislation. These premises slaughter cattle, sheep, goats, pigs and poultry under Council supervision. One abattoir processes wild game.
- The Council also supervised 9 EC Approved meat processing premises in both the city and county.
- Specific EC required welfare training at time of slaughter was organised for staff of Galway abattoirs.

# Proposals for 2018:

- The Council will provide a Veterinary Public Health Inspection Service for both City and Galway County Councils under the terms of a 2.5 year Service Contract with the Food Safety Authority of Ireland. The present contract commenced on the 1<sup>st</sup> January 2017 and expires on the 30<sup>th</sup> June 2019
- Resources for this service have been included in the budget for 2018
- There are 11 local abattoirs in the county which are approved by the Council under Irish and EC legislation. These premises slaughter cattle, sheep, goats, pigs and poultry under Council supervision. One abattoir processes wild game. Inspections on these premises will continue under the FSAI contract.
- The Council continues to supervise 9 EC Approved meat processing premises in both the city and county.
- 3 new Premises are presently engaging with our Veterinary Officers in order to achieve approval
- Training for Food Business Operators and veterinary inspectors will continue during 2018.
- Continued operation of Food Safety compliance activities to standardised procedures.

# MAJOR EMERGENCY MANAGEMENT (MEM)

# Indicative Activities in 2017:

 The Major Emergency Development Committee (MEDC) which was established by the Council as part of the New National Framework for MEM is ongoing and is chaired by Mr. Jim Cullen (Director of Services). Work is continuing by the committee in preparation of the Severe Weather & Flood Response Operational Plan.

- The MEM West Regional Steering Group (RSG) under chair of an Garda Siochana continues to meet in its role of co-ordinating Major Emergency Management between the eight Principal Response agencies (PRA's) -i.e. 3 Local Garda divisions, 4 Local Authorities and HSE West in the Galway, Mayo and Roscommon areas.
- The MEM West Regional Working Group (RWG) involving members of the Principal Emergency Services (PES's) in the West Region, i.e. Local Authority Fire Services, Local Garda Divisions and HSE West Ambulance Service, continues to operate, under the auspices of MEM West Regional Steering Group.
- Galway Co. Co. Headquarters continues as the location of the Local Co-Ordination
   Centre (LCC) for the three Principal Response Agencies (PRA's) Galway County Council,
   HSE West and Galway Garda Division for Major Emergencies in the Galway County
   area. The information management (IM) facilities at LCC in County hall are been
   upgraded currently in late 2017
   It should be noted that the City Council LCC is located at City Hall and was used during
   Flood Ophelia in 2017
- The County/City MEM integration group, was established between the PRA's in Galway City and County under the chair of Mr. Joe O' Neill Director of Services Galway City Council to deal with issues in the City/County area and in particular large crowd events, and continues to operate.
- Regional training is ongoing for relevant personnel in the eight PRA'S in the west region
- Galway County Council procured an Onsite Coordination Centre (OSCC) Vehicle for MEM on behalf of the 8 PRA's in the West, MEM region in 2016 The outfitting of vehicle with financial support from MEM RSG was completed in 2017
- Galway County council will procure a two tempoary mobile body storage units for the 7
   Local Authorities in the West & North West MEM regions to increase capacity in these regions respectively see capital 2017-2020 report

- Both local and regional personnel will receive further training and testing in their various new roles as allocated in their PRA Major Emergency Plans.
- The Major Emergency Development Committee (MEDC) which was established by the Council as part of the New National Framework for MEM is ongoing will be chaired by Mr. Jim Cullen (Director of Services) from 2017 onwards as GFRS is now part of Council's Water Services and Environment Directorate
- Validation and updating of the existing County Council Major Emergency plan is envisaged to continue in 2018.
- Work on the Major Emergency Regional co-ordination plan is ongoing.

- Council personnel and Galway fire service personnel will continue to support Regional Steering Group and Regional Working Groups and local MEDC and the Galway County/City integration group.
- The upgrading of OSSC Vehicle, which was finished in 2017 and OSCC vehicle -which is been managed by GFRS,- will be used in future exercises as an ON Site Co-Ordination Centre OSSC
- A Major Emergency exercise involving the 3 Local Competent Authorities (LCA's,) -i.e.
   Galway County Council –including GFRS as PES to County Council-, Galway Garda

### Indicative Activities in 2017:

- The Schools Fire Safety Program was rolled out again in primary schools in County Station Areas.
- Self-contained smoke alarms with long life batteries are been procured by GFRS for 300 households and continue to be issued to households in Galway City and County for installation by community groups as in previous years. This project was completed with the assistance of the Community and Enterprise Units in both Galway City and Galway County Councils as part of the ongoing National Directorate for Fire and Emergency Management (NDFEM) Programme.

- It is hoped to have the Schools Fire Safety Programme restarted in 2018 involving local fire officers visiting 4<sup>th</sup> class in a number of national schools in Galway City Brigade Area. This program delivers a national fire safety message but is subject to the availability of financial resources.
- Self-contained smoke alarms will be issued in 2018 in both city and county from allocations received in 2017.

CHES: FIRE OPERATIONS

## **KEEPING COMMUNITIES SAFE (KCS)**

### A FRAMEWORK FOR FIRE SAFETY IN IRELAND

The Fire Service is subject to the same financial constraints and consequent scrutiny of expenditure as are all Local Authority services. Additional investment in Fire Services beyond that already programmed will be challenging, given the impairment of public and local government finances.

The challenge – as reflected in the document title – "Keeping Communities Safe" – is to manage the available resources to achieve an optimal outcome for the public in terms of their individual safety, and to minimize loss and disruption to society.


Achieving the successful implementation of the main provisions in KCS by the end of 2018 will require ongoing commitment from the Fire Service, the City and County Management Teams along with the City and County Elected Representatives. It will be necessary to prepare a Service Development Plan/ Action Plan which will be reflected in the form of a new Draft Section 26 Plan prepared by the Fire Service Management. The Draft Section 26 Plan had been presented for consideration to the County Council housing & Emergency Services Strategic Policy Committee in May 2014 outlining the background and content of the document and the associated proposed changes in the Fire Authority Policy as a consequence.

All the work on KCS had been put on hold subsequently, until discussions between NDFEM and unions at national level are concluded, which is ongoing with the establishment of FSNOIG nationally. SIPTU withdrew its objection to the approval of Section 26 plan by Local Councils in April 2016 as it is a statutory duty of local authorities.

The updated Draft Section 26 Plan will be presented to a full meeting of the Council in late 2017 or early 2018 for approval after it has been presented at Water, Environmental & Emergency Services SPC.

### Indicative Activities in 2017:

 There are 11 Fire Stations in the City and County located at Athenry, Ballinasloe, Clifden, Galway City, Gort, Loughrea, Mountbellew, Portumna, Tuam, Inis Mór and Cheathru Rua. All stations are resourced with retained personnel except Galway City, which is a mix of full-time personnel on shift and retained personnel.



note indicative trend of reduction in emergency calls attended from peak in 2010 with flatlining in last three years

- The Council employs approximately **154** fire-fighting personnel at full complement directly in the Galway Fire Service including full time and retained fire-fighters in the City and County. There are also **11** supervisory and fire prevention senior fire officers, including Chief Fire Officer( CFO), 4 civilian support personnel, a Brigade Mechanic and Civil Defence Officer (CDO) working in the Galway City Fire station.
- During 2016, the fire service responded to a total of 1,538 emergency incidents, 925 by the County Brigades and 613 by the Galway City Brigade in its City and County fire ground. This represented a tiny decrease in overall emergency calls when compared to 2015-see FIG 1a for Emergency calls attended by GFRS 2009-2016. It should also be noted that there was a 7.3% decrease in calls attended in city brigade area and a 5% increase in calls attended in county brigade areas from 2015-2016
- The Fire Brigade continue to attend at emergency incidents in the City and County, as in previous years. The total number of emergency calls attended –approximately-in Galway City and County attended by all 11 brigades to 1st September 2017 was 1210-1, 1927 in same period in 2016-, of which 488 were in Galway City Brigade Area.
- The percentage increase in fire and emergency calls attended for first 3 quarters this year 2017 is marginal at about 1.5% when compared to same period last year, again the same trend reduction in calls in city brigade area now reduced with new Fire station in a Cheathru Rua and increase in calls attended in retained County station areas.

- The Council endeavored to ensure that all of its Fire and Emergency Services personnel received training as in previous years at local level. Senior and Junior Fire officer training with the National Directorate for Fire & Emergency Management (NDFEM) also progressed. Training was carried out as per annual training program for 2015 as per previous years.
- All county retained operational personnel are operating under the National Incident Command System since 2009 as per Fire Services Change Program under the Health and Safety remit. The roll-out of the GICS for the fire station personnel both f-t and retained in Galway City was implemented in October 2014.
- The Council intend to continue to prepare pre-fire plans for City and County risks, which is a statutory duty under the Fire Services Act 1981 & 2003.
- The Fire Service's Health & Safety Steering Group continued to meet in 2016 with monthly meetings to manage and drive the Health & Safety Management Plan throughout the fire services and obtained OSHAS 18001 Accreditation in December 2017.
- National Standard Operating Guidelines (SOGs) that underpin generic risk assessments in the fire service Ancillary Safety Statement (ASS) will form the backbone for our training plans throughout the City and County for all fire personnel to the end of 2016.
- The preliminary initial risk categorization of all 10 Galway Fire station grounds was
  prepared for initial consideration by management team as per KCS procedure. The
  output of the preliminary Risk categorization has been presented to both housing &
  Emergency Services SPC and Connemara area committee in 2014 with one of the key
  outputs being the need for a new retained Fire station in An Cheathru Rua.
- Unfortunately there has been one death due to accidental fire in Galway City and county in 2017 to date. There were no accidental fire deaths in 2016

## Operational

- The revised Draft Fire and Operations Plan, which was approved by the Housing & Emergency Services SPC in 2014 will be revised in light of KCS. The new draft will be put before Council -both SPC & full council -for formal approval in late 2017 or early 2018, and will take cognizance of the outcome of the city and west review and risk categorization process.
- The Council will endeavour to ensure that all of its Fire and Emergency Services personnel continue to receive training as in previous years, at local level. Fire Officer training with the National Directorate for Fire and Emergency Planning Training will be

- carried out with as per annual training program for 2016 subject to budgetary provisions.
- National SOGs will continue to form the backbone of our training plans throughout the City and County for all fire personnel in 2017. The next set of SOGs will be rolled out in 2018 and Galway Fire Brigade continues to role-out with the national program as SoG's are issued
- The National Framework 2010-2015 and Keeping Communities Safe", by National Directorate will inform the service of other work to be carried by Galway Fire Brigade in 2018.
- The new retained Fire Service in An Cheathru Rua will be continue to be imbedded into our operational response




Fig existing 11 FIRE STATION GROUNDS INCLUDING An Cheathru Rua GY22

## **CAMP WEST**

• The Fire Authorities of Connacht and Donegal and the HSE West are involved with this Central call-out and communications project, which is run by Mayo County Council as Contracting Authority from the Western Regional Communications Centre (WRCC) in Castlebar. HSE West Ambulance Service have withdrawn from the WRCC by end of December 2014. All Local Authority partners' contributions will increase accordingly in 2017-2018 to make up for the HSE contribution shortfall. All three regional Camp Projects are currently being reviewed by NDFEM as a part a new CTRI project. GFRS - along with all other LA Fire Services is migrating to a new national digital Private Mobile Radio (PMR) and mobilizing platform known as TETRA, similar to partner PES's e.g. Gardai and National Ambulance Service (NAS), who have changed already. Out station communications equipment have been changed over in Galway Fire stations in 2016 and 2017, as part of the CTRI Project. The change over to the Tetra digital radio system will have financial implications for all Local Authority Fire services in the future as there will be an annual fee for each Tetra device in use, to be paid to Tetra Ireland, who have won the national digital communications project for all Emergency services in Ireland

 It is understood that as Camp migrates from a regional to a national model a new national funding model will be established. This might have benign implications for Council budgets from 2018/2019 onwards.

# Regional Critical Incident Stress Management (CISM) Project

- Galway County Council is the Contracting Authority to roll out the CISM system to the 6 No. Fire Authorities of Connacht and Donegal. Provision is being made in 2018 budgets to continue this project, with Galway County Council acting as the contracting authority. A contract for 2013-2016 was issued by Galway County Council as contracting authority for the West to VHI as CISM service provider to Fire authorities in the WEST and Donegal after a tender competition in e -tenders in 2012-2013
- There was a national review of CISM systems used LA Fire services in Ireland, which reported in 2016.
- The existing contract was extended for a 12 months to Sept 2017
- A new tender was issued in 2017 for provision of CISM Services for period 2017-2020 in West region and a new contractor Inspire workplaces from Northern Ireland won the tender for next 3 years from 1st October 2017

CHES: FIRE SAFETY CERTIFICATES AND FSA 1981 INSPECTIONS

## Indicative Activities in 2017 (based on 2016 data):

 In 2017, the Fire Service fire prevention staff carried out 260 inspections of premises as part of its Fire Prevention Function, under the Fire Services Act (FSA) 1981 & 2003, Licensing Acts, Planning Acts, Dangerous Substances Act and also carried out inspections for the issue of Fire Safety Certificates (FSC's) under Building Control Act 1990 (as amended) respectively. The Fire Prevention Department processed **246** public licence applications in 2016 and issued **152** public licence applications to the courts in 2016

- The Fire service have received **270** licence applications all types to date in 2017
  The Fire Prevention Department dealt with **111** planning applications in 2016 and dealt with **92** planning applications to date in 2017 -all from Galway City Council -
- The Fire Prevention Department dealt with **251** Fire Safety Certificate (FSC) Applications —all types- in 2016 under Building Control Regulations, **133** in the County area and **118** in the City.
- The Fire Prevention Department have received the following number of FSC Applications all types; 94 for the City and 115 in the County from January to November 2017.
- Fire officers processed 81 Disability Access Certificate Applications (DAC's) on behalf of the County in 2016 with 66 applications received to date in 2017.
  - There has been less inspection of premises under Fire Services act 1981& 2003 as there has been a vacant AFO position for first half of 2017.

# Proposals for 2018:

- Fire prevention staff will continue to process all FSC type applications on behalf of County and City and DAC certificates on behalf of County.
- Process licence applications and planning applications as received in 2018.
- Continue the program of inspection of retail petroleum stores in the city and county.
- Continue to process DSA licences of retail petroleum stores in the city and county as received.
- Continue to inspect nursing homes in the City and County.
- Commence an inspection program of hostels and hotels in the city and county.
- Carry out inspections in city and county on foot of complaints on a prioritized basis.

### **GALWAY CIVIL DEFENCE**

# **Indicative Activities in 2017**

- Galway Civil Defence, through their 5 training centres, Galway City, Oranmore, Loughrea, Ballinasloe and Clonberne have had an intensive year with duty activities and training, locally and centrally, through the Civil Defence College, Roscrea.
- A programme of training in Cardiac First Response, Occupational first Aid, Emergency First Response is currently ongoing through 2016 and again in 2017. 17 student EMT's are currently in training and will be qualified in 2017.

- Search Management training in 2017 was conducted in the Garda Training College in Templemore.
- SUA (Drones) teams and ground search teams were extensively involved in the search for the missing crew members of the Irish Coastguard Helicopter R116.
- SUA teams have now received and continue to train in the use of Infa-red Cameras supplied by the Civil Defence Branch and continue to operate as a regional response tram.
- A 4x4 vehicle was supplied by the Civil Defence Branch Technical Dept. for the purpose of SUA Operations.
- All units will again be responding to their community's requests for assistance at local community events, providing first aid cover and other assistance that may be requested.

#### Proposals for 2018:

- Focus on training for 2018 will centre in developing the Search Management capability and Swift Water Rescue training with members partaking in courses rolled out by the Civil Defence College, Roscrea.
- Instructors who qualified in 2017 and training will commence with unit members from thereon.
- An additional unit to be established in the West of the County in Clifden in 2018 to expand the scope of operations and to provide a Civil Defence presence to the Connemara area.
- To partake in Re-certification training in line with the Civil Defence College programme for 2018.
- EMT's and EFR's to be up-skilled to the new Clinical Practice Guidelines (CPG's) in early 2018.
- Continuous liaison with the PRA's to develop and promote Civil Defence as a support organisation.
- New members are always welcome from their community and training will be provided to all members of the highest standard by our instructor core.

# Galway Fire & Rescue Service

- G.F.R.S is the Principal emergency service (P.ES.) for Galway City And County Councils respectively The followings sets out the indicative Capital programme for G.F.R.S. for 2018-2020.
- Please note all projects are subject to Department Of Housing, Planning, Community &
   Local Government Funding and specific approval by project.

## Fire Appliances

- There is a very limited national capital budget for FS appliances/equipment.
   Galway County Council has submitted a request to Department Of Housing planning & Local Government for capital funding/support the following items in late 2017:
  - IS Unit for County
  - 3 Pre Owned Class b appliances
  - 4by4 vehicle
- The DHPCLG had approved the procurement a new Class B appliance for Galway County Council Fire Authority, as part of Regional Tender for the West & North West Regions for 5 number Class B appliances in 2015. This Project is being led by Roscommon County Council, who issued tender documentation in the summer of 2015. Expected delivery of new Class B appliance is November 2017.
- The DHPCLG allocated a new class B Appliance to Galway County Council as part of a national Procurement plan from 2018 -2020. This class B appliance will be procured centrally as part of a national procurement process by OGP.

#### **Fire Stations**

I refer to DECLG capital announcement 2016-2020 for new Fire station projects in early 2016

Subject to Department of Housing Planning and Local Government, approval & funding as outlined above, Galway County Council intend to:

- Progress new 4 bay retained Fire station Project in Tuam, Co. Galway:
   Galway County Council have received approval from Department of Housing Planning,
   Community and Local Government to proceed to construction stage. Construction is expected to start before end of November 2017. It will be a 9-12 month contract, hence opening of new Fire station in Tuam, expected in autumn 2018
  - Progress Galway City Project new HQ station i.e. site selection and progress planning - following outcome of the review of the Fire Services and external consultant's report.

- Identify and procure a new Site for a new fire station in Athenry as approval in principle was given by the Declg in 2008, & then make a case to Department of Housing Planning And Local Government to procure & appoint Design consultants for a new fire station in Athenry.
- Make a case to Department of Housing Planning And Local Government for approval for a site for a new Fire station in Loughrea. A possible potential site in Council ownership had been previously identified in the locality.
- Ballinasloe Fire Station Extension Project —application lodged with DECLG in 2008.
   Approval was given by the Department of Housing Planning Community and Local Government for an interim project for Ballinasloe Fire Station, in existing location. It is intended to procure design team for this project and bring the project to planning stage and submit cost plan to DHPCLG for approval in 2018
- Mountbellew Fire Station Project continue to make case to the Department to advance the project. An application for approval in principle was lodged with DECLG in 2009.

Galway Fire and rescue service attained OHSAS 18001 Health & Safety accreditation in late 2017 on foot of some of above works

### Other- Small Projects Capital

- We are procuring smoke alarms for 2018, as part of National Community Smoke Alarm Scheme as per previous years. A submission has been made to DECLG to procure about 600 smoke alarms in 2017 and continue distribution via Galway County and City Council's Community Smoke Alarms' Schemes in 2017/2018 to vulnerable households.
- We are seeking partial funding from national Major Emergency Management (MEM)
   Budget for upgrading information management (IM) system digitally at Local Co-Ordination Centre (LCC) in County Buildings for Galway city and County
- Similarly GFRS procured a mass fatality unit portable refrigerated temporary body storage facilities – a Local Authority Function under MEM Framework -, on behalf of 11 Local Authorities in West, North West and Midlands Regions at a cost of €35,000 in 2014.

The DECLG have recouped up to 50% of above funding in 2015 to Galway County Council.

Galway County Council are currently procuring two refrigerated body holding systems for West and North West MEM Regions to be partly funded by DHPCLG. The Local Authorities in West and North West region will make up remainder of funding. This will bring number of units in west and north west to about 45 -50.

# Roads, Transportation, Marine and General Services

Capital projects relating, to Roads, Piers and Harbours, Flood Mitigation schemes, Plant Acquisition and Smarter Travel (Greenway) are detailed below.

The completion of the following projects is subject to the appropriate departmental sanctions, the availability of the necessary funding and compliance with all appropriate legislative and regulatory provisions.

## **NATIONAL ROADS (including Major Inter Urbans):**

In addition to works on Major Inter Urban routes, a full programme of Pavement and Minor Improvements Works, Safety Measures and Bridge Improvement Works shall continue to be undertaken on the National Primary & National Secondary Road Network. This Programme is dependent on annual allocations from Transport Infrastructure Ireland and as such the programme of works shall be presented to the Council on an annual basis in the context of the Annual Roads Programme.

The Council remains committed to utilising all available capital funding streams to maximise the delivery of housing including construction, acquisitions, turnkey developments, Part V and Buy & Renew. The Council will also actively support Approved Housing Bodies in availing of the Capital Assistance Scheme to deliver housing. A number of capital projects will also be delivered under the Traveller Accommodation Programme.

The Council has a number of applications under the Capital Assistance Scheme (CAS) which funds delivery of social housing by Approved Housing Bodies (AHBs). In total 81 units are currently being progressed at a cost of €11,363667m, 32 of which are acquisitions and 49 units are to be constructed. The 2017 call for proposals under the Capital Assistance Scheme remains open and the Council continues to actively engage with Approved Housing Bodies.

### **House Purchase Loans:**

Loans up to the approved limit of the Department of Housing, Planning and Local Government will be issued to eligible purchasers under the various loan schemes operated by the Council. Funding is sourced by way of borrowing, the debt servicing of which is met by repayments from loanees.

A significant capital investment programme is required for existing local authority housing stock to achieve compliance with minimum standards, co-fund energy efficiency works and the return of voids housing units, to undertake a stock inventory and to deliver a preventative maintenance programme.

Provision has been made for works under the Energy Efficiency Retrofit Programme (EERP) to be carried out on our occupied stock. The Council is working towards the completion of Phase I, cavity wall and attic insulation upgrade of its entire occupied stock. To date approximately 95% of our stock has been upgraded. We will seek to expand the programme to achieve deeper retrofitting of our stock in the future, subject to the availability of co-funding.

It is intended to avail of housing internal capital receipts, to fund an improvement programme in

existing stock to achieve compliance with statutory requirements, including minimum standards, and to commence a preventative maintenance programme. These programmes will be afforded priority in the allocation of available capital funding during the period 2018 – 2020.

In addition, project proposals for the rebuilding/refurbishment of derelict housing stock will be advanced subject to approval and funding from the Department of Housing, Planning & Local Government.

Please note all project proposals are subject to Department of Housing, Planning & Local
Government funding and specific stage and statutory approvals by project and are dependent
on the availability of co-funding where required.

### CORPORATE SERVICES

Progress on all projects is subject to continued availability of internal and external funding together with necessary statutory and legislative approval as appropriate on a project by project basis.

### Libraries Development

The following projects are proposed for capital investment to ensure the sustainability and growth of Library Services. Galway County Council manages the Library Service for both the City and County Local Authorities.

- A flagship capital project is to advance the development of a new Galway Community Library, to include modern educational, cultural, event and archive facilities.
- Continued investment to enhance the use of technology, including RFID and Open Libraries, providing the match funding necessary to avail of national funding streams.
- A programme of minor improvements to address health and safety and access issues across the branch network, in line with conservation best practice and regulations associated with this Protected Structure where applicable.

## **Recreation and Amenity Development**

Capital investments over the next three years will focus on completion of projects which have been given previous commitments under the Recreation and Amenity Framework and Playground Policy.

Implementation of the Strategy relies on external sources of co-funding and working with community groups to lead on re-generation of buildings and Historic Assets in Corporate ownership.
