Ta Comhairle Chontae na Gaillimhe ag lorg léirithe spéise ó dhaoine agus/nó eagraíochtaí inniúla a bhfuil taithí acu chun saoráid slán Dídine do Mhadraí a chur ar fáil do Chomhairle Chontae na Gaillimhe le seirbhís bhreise coimeádaithe dídine nó gan í sin.

Chun críocha oibríochta ní mór go mbeadh an tsaoráid dídine laistigh d'achar réasúnta, laistigh de 50 km ar bhóthar go hidéalach, ó Cheanncheathrú Chomhairle Chontae na Gaillimhe ag Áras an Chontae, Cnoc na Radharc, Gaillimh, H91 H6KX. Déanfar freastal ar oirthear chontae na Gaillimhe go príomha leis an gcró seo, go háirithe na ceantair seo thíos, gan a bheith teoranta chucu:

Baile Locha Riach

Tuaim

Baile Átha an Rí

Galway County Council is seeking expressions of interest from competent and experienced persons and/or organisations to supply a secure Dog Shelter facility to Galway County Council with or without the additional service of a shelter keeper.

For operational purposes the shelter facility must be located within a reasonable distance, ideally within 50 km by road, from Galway County Council Headquarters at Aras an Chontae, Prospect Hill, Galway, H91 H6KX. The pound will primarily serve the east of Galway county with the areas of the county below of particular interest but not limited to the following:

**Loughrea**

**Tuam**

**Oranmore**

**Athenry**

**Ballinasloe**

Déanfar na gnéithe seo a leanas a mheas agus oiriúnacht na saoráide á mheasúnú:

- Cuirfear cóiríocht oiriúnach, shábháilte, shlán agus ghlan ar fáil chun madraí a gabhadh, atá ar fán nó nach bhfuil éileamh orthu a choinneáil ar feadh tréimhsí gearra go dtí gur féidir úinéir nua a fháil dóibh. Ní mór go mbeadh saoráidí comhlíontach, ar a laghad, le caighdeán ghinearálta maidir le Bunachais Pórúcháin Madraí, mar a leagtar amach sna Treoirínte um Bunachas Pórúcháin Madraí 2018 arna chur ar fáil ag an Roinn Forbartha

The following factors will be considered when assessing suitability for the facility:

- The premises shall provide suitable, secure, safe and clean accommodation for the detention of seized, stray or unwanted dogs for short periods until rehoming can be facilitated. Facilities must, at a minimum be compliant with the general standards for Dog Breeding Establishments, as outlined in the Dog Breeding Establishment Guidelines 2018 provided by the Department of Rural Community Development,

Tuaithe agus Pobail, nó mar mhalairt air sin a bheith ar chaighdeán sách ard le go mbeadh sé éasca aistriú chuig na caighdeáin sin a dhéanamh.

- Ní mór foirgneamh nó limistéar atá sainithe go soiléir a bheith leithdháilte le haghaidh úsáid eisiach Chomhairle Chontae na Gaillimhe dá dídean do mhadraí.
- Chun críocha oibríochta ní mór don tSaoráid Dídine a bheith inrochtana do mhaor madraí agus do phearsanra tréidliachta i gContae na Gaillimhe agus a bheith suite laistigh d'achar réasúnta, laistigh de 50 km ar bhóthar go hidéalach, ó Cheanncheathrú Chomhairle Chontae na Gaillimhe ag Áras an Chontae, Cnoc na Radharc, Gaillimh, H91 H6KX agus déanfar freastal leis ar oirthear Chontae na Gaillimhe go príomha.
- Beidh an áitreabh sách mór agus beidh dóthain cróite ann chun déileáil le tréachur ionchais 100-150 madra in aghaidh na bliana, nó suas le 10 madra ag aon am amháin.
- Déanfar áitreabh ar bith a úsáidfídh Comhairle Chontae na Gaillimhe chun críocha an Achta a choinneáil ar chaighdeán a éileoidh Comhairle Chontae na Gaillimhe.
- Cuirfear limistéar oiriúnach oibre ar fáil ar an áitreabh do mhaor/mhaoir madraí agus cigirí tréidliachta agus cuirfear rochtain slán 24 uair an chloig ar fáil dóibh ar an dídean.
- Na saoráidí a chuirfear ar fáil (stóras dramhaíola, leictreachas, doirteal, reoiteoir, uisce te, draenáil oiriúnach, córas cuí chun monatóireacht a dhéanamh ar an teocht)
- Ní mór torann ó mhadraí ag tafann a bhainistiú lena chinntiú nach mbeadh an áitreabh ina crá croí ó thaobh torainn de agus lena chinntiú nach mbeadh an torann ag cur isteach ar na madraí eile
- Seirbhísí Coimeádaí Dídine (i gcás go mbeadh siad de dhíth)

or be of a sufficient standard that conversion to these standards may easily be carried out.

- A clearly defined building or area must be allocated for the exclusive use of Galway County Council dog shelter.
- For operational purposes the Shelter Facility must be accessible to Galway County dog wardens and veterinary personnel and located within a reasonable distance, ideally within 50 km by road, from Galway County Council head office, Aras an Chontae, Prospect Hill, Galway H91 and will primarily serve the east of Galway County.
- The premises shall be of adequate size and contain sufficient kennels to cope with expected throughput of 100-150 dogs per annum or up to 10 dogs at any one time.
- Any premises used by Galway County Council for the purpose of the Act shall be maintained to a standard required by Galway County Council.
- The premises shall provide a suitable working area for dog warden/s veterinary inspectors and provide them with 24-hour secure access to the shelter.
- Provision of facilities (waste storage, electricity, sink, freezer, hot water, suitable drainage, an appropriate system for monitoring of temperature).
- Noise from barking dogs must be managed to ensure that the premises is not a source of noise nuisance and to ensure that the noise does not adversely affect the dogs.
- Services of Shelter Keeper (should they be required)
  - General care, feeding, cleaning, disinfection and maintenance of hygiene standards at the facility.
  - Provide assistance where necessary to the dog wardens and veterinary inspectors in examination, vaccination, and microchipping of dogs.
