**1. Baineann an t-eolas sa mheabhrán mínithe seo le grúpa de bheirt sealbhóirí tí nó níos mó ag teacht le chéile chun soláthar uisce a chur ar fáil dóibh féin sa chás nach bhfuil soláthar ar bith (nó soláthar atá go mór neamhdhóthanach) ar fáil cheana féin.**

**2. Is iomaí bhuntáiste agus bharainneachta a bhaineann le grúpa comharsan uisce a phíopáil ó fhoinsí amháin go dtí a dtithe agus feirmeacha bainteach leo:-**

Cuireann Comhairle Chontae na Gaillimhe deontas ar fáil de 85% den chostas faoi réir ag uasteorainn de €6,475 in aghaidh an tí.

D'fhonn cáiliú do dheontas tí, ní mór don iarratasóir, ar thabhairt chun críche na scéime, doirteal agus sconna a shuiteáil sa teach agus ní mór dóibh a bheith ceangailte leis an ngrúp-sholáthar uisce.

**3. De ghnáth, cinníonn na deontais a bhíonn ar fáil go gcoimeádtar ranníocaíochtaí ag leibhéal réasúnach agus d'fhéadfadh méid beag d'obair dheonach a bheith i gceist i roinnt cásanna. Tugann táistálacha a dhéantar roimh thosú ar an obair eolas maidir le hiontaofacht na foinse ó thaobh táirgeachta agus sláinte de. Déanann foireann theicniúil Chomhairle Chontae na Gaillimhe scrúdú ar phleananna agus leagan amach gach scéime lena chinntiú go mbainfear amach an caighdeán ceart ó thaobh tógála agus feidhmíochta, agus bíonn Cigirí ar fáil le comhairle a chur ar ghrúpaí, le linn dul chun cinn na hoibre, nó ar aon deacrachtaí a d'fhéadfadh a eascairt as.**

1. The information contained in this explanatory memorandum relates to a group of two or more householders getting together to provide themselves with a water supply where no such supply (or a seriously deficient supply) already exists

2. The piping of water from a single source by a group of neighbours to their homes and associated farms offers many advantages and economies:-

Galway County Council provides a grant of 85% of the cost subject to a limit of €6,475 per house.

In order to qualify for a domestic grant, the applicant must, on completion of the scheme, have a sink and tap installed inside his/her house and it must be connected to the group water supply.

3. The grants available generally ensure that contributions are kept at a reasonable level and in some cases, may include a small element of voluntary labour. Tests carried out before work goes ahead establish the reliability of the source from a health and yield viewpoint. The plans and design of each scheme are examined by the technical staff of Galway County Council to ensure that the proper standard of construction and performance is reached, and Inspectors are available to advise groups, during progress of the work, on any difficulties that may arise

Tá sé tábhachtach cúrsaí airgid a shocrú ag an tús. How to plan a group water scheme:</b>  Group schemes may be carried out, subject to the approval of the Local Authority:-</p> <p>(a) in areas where the local authority do not propose to carry out a public scheme</p> <p>(b) in areas which can be served by extensions of existing local authority water mains.</p> <p>(c) in areas where the local authority intend at a later stage to provide a public water supply. In such cases schemes should be designed as to be capable of being integrated with the public scheme in due course.</p> <p><u>If you and your neighbours are interested in a scheme you should proceed as follows:-</u></p> <p>(a) The starting point is the selection of a committee comprising not more than six people and headed by an energetic group organiser who will conduct all necessary business with the group, and Galway County Council.</p> <p>(b) The Organiser should write in the first instance to the Secretary, Galway County Council, Water Services Department, County Hall, Prospect Hill, Galway giving notice of the intention to formulate a group scheme.</p> <p><b>5. Financing</b>  The balance of the cost of a scheme net of state grants is met by participants by way of cash contribution and/or voluntary labour and must be at least 15% of the cost of the scheme. It is important to arrange money matters at the outset. The organiser will want working capital to meet the expense involved in the preliminary stages of investigation and he/she would be well advised to collect a sum of money from each participant when it is decided to go ahead with the scheme. It is suggested that a practical way to apportion the individual cash contributions from participants would be (a) on a valuation basis or (b) at a flat rate per house - due regard being made to the varying financial circumstances of the members of the group, and to the extent to which their voluntary labour will be made available in each case.</p> <p><b>6. ## **7. Tógáil**

**Nuair a eiseofar teastas na Comhairle ar an ngrúpa, a léireoidh méid ionlán deontas an Údarás Áitiúil, is**

to find a suitable source. When a possible source is located, it must be subjected to quantity and quality tests to make sure that it will produce a satisfactory supply of potable water which will be adequate to meet the domestic and agricultural requirements of all the participants. The larger the number of participants involved consistent with the amount of water available at source, the more economical will be the scheme. The grant is based on the cost per house, which is generally obtained by dividing the all-in cost by the number of houses in the scheme. The aim of the group should be to secure, at the outset, 100% connections from the householders in the area to be served by the group scheme. In this way, the cost of the scheme will be kept at a minimum.

When the source has been tested and approved, the group collects an initial contribution from each house so that an engineer may be engaged to prepare a design for the scheme. The design must be approved by Galway County Council. This procedure ensures that designs are in line with the local authority's own water supply proposals for the area. In some instances, changes have to be made in the designs so that schemes can be integrated at a later stage with regional developments in, or planned for, the area.

On the basis of the approved design, quotations must be sought and selected for the work and the costs of the scheme estimated. At this stage, the collection of the necessary cash contributions to be made by the participants must be completed by the group organiser before the appropriate grants may be allocated. The group must open an account in a local Bank in the names of the Trustees appointed by the members, lodging the cash collections to start the account. Subsequently, all Local Authority grants are paid direct into this account

## **7. Construction**

When the Council's certificate indicating the total amount of the Local Authority grant is issued to the

**Íocfar na deontais dheiridh nuair a dhearbhóidh Cigire Chomhairle Chontae na Gaillimhe go bhfuil soláthar uisce suiteáilte i ngach teach agus go bhfuil an scéim ag obair go sásúil.**

#### **8. Scéimeanna críochnaithe a chothabháil**

**Moltar do ghrúpaí rialacha a chur ar bun maidir le cothabháil agus oibriú a gcuid scéimeanna chomh luath agus is féidir tar éis don obair a bheith tosaithe, le cur amú agus mí-úsáid uisce a sheachaint.**

group, work can then start provided the group have obtained the necessary road-opening licence from the County Council, and the necessary insurances have been taken out.

The Branch Bank nominated by the group is informed by the Council of the number and amount of the grants being allocated. Grants are paid in instalments when materials are delivered on the site and pro-rata with the rate of progress on the scheme. The bank account is, therefore, the working fund from which the group makes payments to cover the cost of design, purchase the materials, and other related requirements.

The final grants will be paid when the Galway County Council's Inspector confirms that a water supply is installed in each house and the scheme is working satisfactorily.

#### **8. Maintenance of completed schemes**

It is advisable for groups to adopt rules for the maintenance and operation of their schemes as soon as possible after work has commenced - so as to prevent wastage, misuses of water, etc.

**Guide to tax related requirements from 1st March  
1988 for payment of group water and sewerage  
scheme grants**

**Section A**

**Re: The Contractor**

For grant applications received on or after 1st March, 1988 it is necessary that a current C2 certificate or a tax clearance certificate from the Revenue Commissioners be submitted to the Department in respect of a group's contractor/(s) engaged to perform the construction work. The position in relation to such certificates should accordingly be confirmed prior to tender/contractor stage of the work. Where a contractor is not engaged and the group undertake the work themselves, a tax clearance certificate will be required for each of the individual group members.

**Section B**

**Re: The Group**

Where grants up to €10,000 apply: In the case of all relevant sewerage schemes, and group water schemes (in non-disadvantaged areas), it will be necessary for the trustees to insert on the application form the group scheme's tax district and reference number (this information may be obtained from the local inspector of taxes), and to state on the form whether to the best of their knowledge, the group scheme's tax affairs are in order.

Where grants exceeding €10,000 apply: Where grants for group water schemes other than schemes in disadvantaged areas exceed €10,000, and for all relevant group sewerage schemes, it will be necessary for a current tax clearance certificate from the Revenue Commissioners to be provided in respect of the group scheme.
