### **BIA INNOVATOR CAMPUS**

Mr Liam Conneally, Chief Executive visited the Teagasc Offices and the BIA Innovator Campus to have a meeting with Mr Frank O'Meara, Director/Head of Teagasc and representatives of the BIA Innovator Campus.

The primary purpose of the meeting was to formally introduce the heads of both organisations and to get an update on the project including the official opening, as well a providing the forum for a discussion around the commitment of both organisations to the campus.

Following the presentation and discussions, Mr O'Meara and Mr Conneally commended the project stating that it is an invaluable project that has unique offering and that it will make a significant contribution to the ecosystem to grow the food sector and add value.

The BIA Innovator Campus representative confirmed their commitment to the founders in terms of delivering on the original objectives of the project, and to continued collaborative working to deliver on the relevant elements of the corporate plans and strategies of both Galway County Council and Teagasc.

It is expected that the project will open in September and all the elected Members as well as a broad range of stakeholders will be invited. Mr Conneally and Mr O'Meara agreed that the strategic collaboration between both their organisations was extremely beneficial and that the BIA Innovator Campus demonstrated how cross agencies and cross government working can deliver excellent outcomes.

### GALWAY COUNTY DRAFT TOURISM STRATEGY 2023 - 2030

On Tuesday 18<sup>th</sup> July, a briefing on the Draft Tourism Strategy was arranged for the for the Elected Members in the Raheen Woods Athenry. The event, which was opened by the Cathaoirleach, Cllr Liam Carroll was attended by 24 Councillors in total and provided an opportunity to give a detailed insight into the development of the strategy and how it sits in the context of Failte Ireland's regional strategies and other key Council plans/policies.

As part of the briefing Liam Conneally, Chief Executive and Alan Farrell, Director of Services were joined by a panel of tourism representatives from Failte Ireland including Daithi Gallagher from the Wild Atlantic Way, and Fiona Dunne & Tony Dawson from the Ireland's Hidden Heartland team, with presentations that gave an insight into the key priorities for the recently launched regional plans for the Wild Atlantic Way and Ireland's Hidden Heartlands.

Ali Curran from CHL consultants gave an in-depth presentation in relation to the background to the strategy, the process including the extensive consultation, the development of the strategic priorities and key concepts from the strategy including the development of the zones to assist with the implementation of the strategy.

Ruairi Lehmann, Galway City Council presented on the Galway Tourism brand that has been prepared jointly by the City & County Tourism Officers in association with Failte Ireland and industry representative. He outlined that the brand would provide a consistent identity for the sector, highlighting that success of the brand will be heavily dependent on the quality of the implementation campaigns and use.

As part of the presentations and panel discussion a number of key items were evident. These included the importance of the linkages between the regional strategies and the Council's strategy; the development and implementation of Destination & Experience Development Plans (DEDPs) by Failte Ireland which will be informed by the County Tourism Strategy and will entail detailed plans for implementation of key actions; the need for collaboration among the agencies, and the importance of engagement/capacity building at industry and community level.

The questions and answers to the panel provided an opportunity for the Members to clarify a number of matters. It was evident that the consultation process and research had culminated in a draft strategy that facilitated tourism development across the whole county and that the matters raised by the Members could be aligned with the strategic priorities and action plan contained in the draft strategy.

The CE and DOS outlined that the intention is to complete the environmental process which will take at least six weeks and advised the Members that there was a firm target of bringing it to the September Plenary meeting for the consideration and approval of the Members, stating that the purpose of the briefing was to facilitate a more in-depth briefing followed by questions and panel discussion. The Members were advised that CHL and the executive would review all the issues raised prior to completing the draft for issuing. The CE confirmed that it was his intention to build the tourism team and resources available to drive the implementation of the strategy, saying that Galway has all the vital tourism assets, and he wants to ensure there is adequate investment to enable delivery and add



value to the local economy. He said that the strategy would also strengthen the Council's ability to secure funding from other sources including Failte Ireland, Government Departments and Brussels.

The Draft Tourism Strategy was also brought to the Economic Development and Enterprise SPC on the 19<sup>th</sup> July and the SPC approved the Draft to move to the next phase of the process and agreed the target of getting it approved by Council at the September Plenary meeting.















Other notable pieces of work since the last report to the June plenary council meeting was the commissioning of a discover Galway promotion document including a calendar of events around the county and the development of a map for tourism focused map for Kinvara that was included in the June/July edition of 'This is Galway' magazine. Other areas were included previously and it is anticipated Gort will be included in an Autumn edition of the magazine.

Preparations are underway for the visit to Milwaukee in August with some tourism promotional material being lined up for display.

#### JOYCES COUNTRY AND WESTERN LAKES GEOPARK

In a significant step for local development in Connacht, Joyce Country and Western Lakes Geopark has just undergone an assessment mission by UNESCO, which it is hoped will lead to achieving UNESCO Global Geopark status in the near future.

Over a three-day period, two UNESCO assessors were guided through a kaleidoscope of fascinating heritage features, local businesses and communities in the beautiful Joyce Country and Western Lakes area of north County Galway and south County Mayo. Mountains, lakes, fjord, rivers, woodlands, geological sites, local business and start-ups, community development groups, stand-out visitor attractions – they were all in the mix.

The itinerary includes an event for Key Stakeholders (funders/other partners, communities, politicians) at Kylemore Abbey (co-hosted by University of Notre Dame campus). This was attended by the Cathaoirleach, Cllr Liam Carroll and Alan Farrell, Director of Services. Earlier in the day Mr Liam Conneally, Chief Executive and Mr Farrell met with the international judges to confirm the support of the Council for the project and engage with them as part of the judging regarding the UNESCO designation.

The territory of this aspiring UNESCO Global Geopark has outstanding beauty, derived from a fascinating 700 million years of geological heritage and the way the land has been inhabited and farmed since the last ice age about 12,000 years ago. It also includes three great western lakes – Loughs Carra, Mask and the top half of the Corrib.

This would be the first UNESCO Global Geopark in Connacht and the first on the island of Ireland to include a Gaeltacht, called Dúiche Sheoigheach agus Tuar Mhi Éadaigh (Joyce Country and Tourmakeady).

## SICAP (SOCIAL INCLUSION AND COMMUNITY ACTIVATION PROGRAMME)

The Mid-Year review of the SICAP Annual Plan for 2023 is due for decision by end July 2023 and a meeting of the SICAP Sub-Committee will be held on 18<sup>th</sup> July to examine the financial and non-financial updates in detail and make recommendations to the full LCDC at its meeting on 25<sup>th</sup> July. Following a number of meetings to determine details to feed into the procurement process for SICAP 2024-2028, it is expected that the RFT (Request for Tender) will be published on E-Tenders in July, with an indicative publication date of 17<sup>th</sup> July which will remain open until early September.

### COMMUNITY ENHANCEMENT PROGRAMME

All Community Enhancement Programme (Community Support Fund) grants must be drawn down by 31<sup>st</sup> August. Most grants for running costs have been drawn down to date, however, most small-scale grants for capital projects or equipment remain outstanding. ## Healthy Ireland Conference:


As part of this Conference on 7<sup>th</sup> July 2023, the HSE's Healthy Ireland Implementation Plan 2023 – 2027 was launched. This Plan aims to build the role of the HSE in enabling individuals to live longer, healthier lives by supporting them to adopt healthy behaviours; supporting people to self-manage and live well with their chronic health conditions; supporting the development of healthy environments that help people and staff to adopt healthy behaviours. ### Playground Stencils:

Healthy County Galway is rolling-out Playground Stencils for Schools in County Galway, and to date, 11 Schools have availed of the stencils at their ground. The Playground Markings Stencils Pack was developed by Capiche for the HSE back in 2006 as part of an initiative to counteract obesity and enhance the health and wellbeing of our school going population. The Playground Markings programme was designed with several key factors in mind, ease of use, durability, and cost effectiveness. The stencil packs are made up of a variety of stencils such as hopscotch, circuit trail, snail, and a maze. Healthy Galway provide the stencil packs free of charge on a loan scheme and the schools / community organisations are responsible for funding the paint and installation of the stencils. This initiative is primarily aimed at Primary Schools, but the stencils can also be utilized in other settings.

A link to this survey will be circulated to all Elected Members and the PPN in the near future, and we would be very grateful if the survey could be circulated as widely as possible to ensure that all activities for older people are captured in the Directory.


# PUBLIC PARTICIPATION NETWORK (PPN)

### ACTING AS AN INFORMATION HUB:

The PPN sent out 1 Monthly Newsletter along with 9 mass emails to all 1,242 Member Groups in addition to regular updates on our social media accounts. The PPN Website was updated regularly with funding announcements, news from Government Departments, resources for groups and local/ national events.

### **BUILDING CAPACITY:**

The PPN hosted an information webinar to discuss Climate Change & Biodiversity efforts and opportunities in the County. The council has recently announced the Appointment of First-Ever Biodiversity Officer for the County, Rosina Joyce and Community Climate Action Officer, Denise Feeney — to mark this and to welcome them to their new roles the PPN organised an event to celebrate biodiversity projects and efforts being made within the County to tackle Climate Change.





### PROMOTING REPRESENTATION:

The PPN is reviving the Green Recovery Linkage Group which acts as a linkage group made up of PPN members and individuals with an interest in addressing environmental concerns in County Galway. A public meeting will be held on the 25th June. The Disability Forum began planning its next meeting which will be held in August. Guest speakers were identified and contacted. Date for next meeting to be confirmed.

# RURAL DEVELOPMENT

### OUTDOOR RECREATION AND INFRASTRUCTURE SCHEME

### The Outdoor Recreation Infrastructure Scheme was launched 1st June 2023.

Details of the Scheme circulated to Elected Members, Public Participation Network, Notice in Newspapers, and social media.

 Projects must be shovel ready with all permissions in place, except for the Project Development Measure outlined below.

## ORIS 2023 provides funding as follows:

# Project Development Measure – <u>Deadline to Galway County Council</u>, 10<sup>th</sup> July 2023

Timeline for completion of Project 18 Months.

- Detailed development of projects which would enable them to reach a standard for application under Measure 2 or Measure 3 of ORIS such as detailed design, preparation for Planning and/or Procurement, appropriate assessment etc.,
- Funding of up to €50,000 at a 90% rate of aid
- Local authorities and State bodies can each submit two applications under this Measure
- Local authorities with inhabited off-shore islands may submit one additional application under this Measure (max. 3 applications) which relates directly to a project on one of the inhabited off-shore islands

## Measure 1 – Deadline to Galway County Council - 31st July 2023

Timeline for completion of project 18 months

- Small scale repair/development/promotion and marketing
- Funding of up to €30,000 at a 90% rate of aid
- Maximum of 7 applications can be submitted by each Local Authority
- Maximum of 3 applications can be submitted by each Local Development Company
- Maximum of 2 applications per State body

Measure 2 – <u>Deadline to Galway County Council – 1<sup>st</sup> September 2023</u> Projects must be ready to go!

Timeline for completion of Project – 24 months



- Medium scale repair/upgrade and new trail/amenity development
- Funding of up to €200,000 at a 90% rate of aid
- Maximum of 3 applications can be submitted by each local authority
- Maximum of 1 application may be submitted per State body

# Measure 3 – <u>Deadline to Galway County Council – 1<sup>st</sup> September 2023</u> Projects must be ready to go!

Timeline for completion of Project – 24 Months

- Large scale repair/upgrade and new strategic trail/amenity development
- Funding of up to €500,000 at a 90% rate of aid
- Local authorities and State bodies can <u>submit 1 application</u> each under this Measure

## The following types of projects and activities, will not be supported by the scheme:

- Greenways in excess of 20km
- Infrastructure for commercial activities
- Purchase/lease of land
- Legal fees
- Standalone outdoor gym/calisthenics workout area projects
- Sports grounds, traditional playgrounds and Multi-Use Gaming Areas (MUGAs)
- Works within Town Parks, marked street trails, walkways and cycleways within towns and villages except as outlined in Project Location above
- Surfacing works to public roads
- Refurbishment and construction of buildings (except in very exceptional and limited circumstances for projects where this would substantially improve access to, and the utilisation of, recreational resources by the wider public)
- Walking or running tracks located in a confined space, e.g. around sports pitches or playgrounds, or within other sports grounds
- Maintenance works on elements of trails which form a normal part of the work undertaken as part of the Walks Scheme
- Works covered under the agreed work plans of the Walks Scheme
- Activities which do not comply with the definition of countryside/outdoor recreation as set out above and as defined in Embracing Ireland's Outdoors3.
- Capacity building or training
- Ongoing operational costs
- Costs not directly related to the project
- Indirect costs of the project e.g. community organisation staff time spent working on the project in an administrative capacity
- Organisation core costs, including overheads
- Retrospective costs activity that has already been undertaken or costs incurred prior to date of project approval
- VAT where applicants are registered for VAT
- Charges such as bank interest costs, fines, financial penalties, and legal dispute costs
- Sponsorship and charitable donations
- Depreciation
- Notional costs e.g., lost opportunity



## 'Contribution in Kind' & 'Voluntary Labour Contributions in Kind'

Up to a maximum of 5% of project cost, can be provided in various forms including the provision of plant and equipment and/or voluntary labour etc. Grantee costs are excluded from this contribution.

# The following are ineligible for 'Contributions in Kind':

- Project administration e.g., attendance at meetings, preparation of grant application forms.
- Funding drawdown claims and management costs.
- Contributions which cannot be verified such as routine litter picking, ongoing maintenance, cleaning, security and undertaking research.
- Labour provided by a participant on a Rural Social Scheme/TÚS/other exchequer funded scheme.
- Donated Materials *e.g., aggregate, cement.* The value of materials contributed must be verifiable and vouched (*e.g., by an invoice or statement from the body donating the material certifying both volume/quantity and market value of donation*). For example, flowers donated to a project are not reckonable for in-kind contribution.
- Donated Plant *e.g., tractor, trailer, concrete mixer etc.* The completed voluntary timesheet captures the labour value attributable to donated plant. No contribution is attributable to donated plant.

# The following list of activities were deemed ineligible as 'Voluntary Labour' recently by the Department of Rural & Community Development:

- Meeting with stakeholders such as Coillte/Forest Managers
- Meetings to discuss the project, visiting the site
- Seeking advice from stakeholders
- Linking in with various committees/ seeking advice and feedback from users of the trails,
- Managing Budgets,
- Researching Products for the Project
- Meetings regarding decision making e.g. in relation to location of seating, types of trails etc., contacting suppliers
- Litter picking.

Galway Trail Running Club are to host a "Connaught Championship Event" in Kilcornan. The "Backyard Ultra", will be held on September 22<sup>nd</sup> and will see the top 15 runners going to the All-Ireland Championship and the winner going on to represent Ireland at the World Championship

The runners start a 6.7km looped course on the hour, every hour. A last person standing event, where the event keeps going until there is only one person left.

The event is capped to 100 runners and will start just before sunset on September 22nd (8pm), runners will complete a loop every hour, with the winner expected to complete approx. 30-34 hours.

In 2018, The Partners, Galway County Council, The Brothers of Charity and Coillte worked together to progress an application for funding through the Outdoor Recreation Infrastructure scheme, to develop a network of trails through the Clarinbridge Cowpark, Kilcornan Wood and Kilcornan Estate in order to maximise the benefits of these recreational areas.

A Grant of €200,000 was approved by the Department of Rural & Community through the Outdoor Recreation Infrastructure Scheme in partnership with Galway County Council, Brothers of Charity Services, Kilcornan and Coillte.

The Scheme is funded under "Our Rural Future" which specifically prioritises the growing outdoor activity tourism sector as part of a long-term vision for a vibrant and sustainable rural Ireland.

## GALWAY SPORTS PARTNERSHIP

# SAFEGAURDING (CHILD PROTECTION)

Galway Sports Partnership continues to deliver Safeguarding courses online across the 3 different levels, Basic Awareness (SG1), Club Children's Officer (SG2) and Designated Liaison Person (SG3).

### **BIKE WEEK**

Galway Sports Partnership lead Bike Week 2023 with 19 events taking place across Galway. From Ballinasloe to Clifden. There were events for all levels and ages of cyclists. The highlights include the Gort Mini Greenway Cycle, Couch to 25k in Lawrencetown, Family Cycle in Ballinasloe and a beautiful family cycle for all ages through Carrabane Forest.

## OLYMPIC HANDBALL - TEACHER TRAINING

Galway has the highest number of primary schools taking part in Olympic Handball competitions in the country. The sport is very popular across Galway. To support the sport of Olympic Handball, GSP



linked with the Irish Olympic Handball Association to deliver two teacher training courses in Renmore Community Center in early Summer. The courses were aimed at primary and secondary school teachers as part of a plan to develop the sport from primary school to adults with the aim of having a Galway club in the coming years.

#### **PICKLEBALL**

GSP has been working with a number of groups including Pickleball Ireland to help develop the sport in Galway. Pickleball is similar to Tennis but played on a smaller court and is suitable for all ages and abilities. The focus of our programme is older adults (Over 50 years) and aims at increasing activity in a fun and social way for this age group. The work culminated in an event in Maree Community Centre in June.

# INIS MEÁIN PARKRUN

Ireland's most westerly ParkRun was launched with great fanfare on Inis Meáin in early June. ParkRun is a 5km course that people can walk, run or jog every Saturday morning. Participation is free and people can take part in any of the ParkRuns across the globe.

#### AUTISM IN SPORT

Training for volunteers to cater for people with disabilities has taken place on 13<sup>th</sup> and 17<sup>th</sup> June online. The courses, Autism in Sport and Disability Inclusion covered the main aspects of catering for people in across many sports.

# SPORT ENERGY SUPPORT SCHEME (SESS) FOR COMMUNITY BASED FACILITIES

Sport Ireland have launched a second phase of the Sports Energy Scheme. Through LSPs, this phase will now also target community owned sports facilities which do not currently qualify for TBESS or other Government support schemes through DRCD, Local Authorities etc. Clubs or facilities affiliated to Sport Ireland recognised NGBs should access support directly through their NGB. General cost of living increases such as rising costs in accommodation, rent, rates or labour costs are not eligible. Fuel costs associated with machinery, vehicles, travel or transport do not qualify. Registration for this initiative was closed in early June.

# ARTS OFFICE

#### CULTURE UP ARTIST IN RESIDENCE ON THE EDGE

The Arts Office successfully spearheaded an application for €50K to Arts Council's International Residency Initiatives Scheme in collaboration with Áras Éanna as lead applicant. From 12<sup>th</sup> July artists are invited to apply for one of ten <u>AIR on the Edge</u> residencies in Ireland, The Netherlands, Serbia, Denmark and Finland. Artist studio space, self-catering accommodation, artists fees and travel expenses will be provided for successful artists. Two artists from Galway County will be selected.

### CULTURE NIGHT LATE - ATHENRY

The Arts Office successfully applied for an additional €16K from Arts Council to partner with Macnas and Athenry Heritage Centre to co-produce a processional performance through the streets of Athenry on Friday 22 September as part of Culture Night Late (after 9 p.m.). We're working with the partners and all stakeholders on the development and production elements of this late Culture Night spectacle. 


# ARDÁN - MISLEÓR SHORT DOCUMENTARY GRANT

### KINVARA COMMUNITY ORCHESTRA PRESENTS BIDDY EARLY A FOLK OPERA

Kinvara Community Orchestra will produce a new work, written by Kinvara-based composer, Stephen Johnston, and conducted by Garry O'Briain and staged in Kinvara over two nights in December 2023. The subject of the Folk Opera is the life and times of the traditional herbalist and clairvoyant, Biddy Early. The story of Biddy Early is part of the cultural heritage of the West of Ireland. The Opera will be performed by 50 musicians and local singers. 

## SUMMARY OF SOCIAL HOUSING ASSESSMENTS 2023

The Summary of Social Housing Assessments 2023 brings together information provided by local authorities on households in their functional area that are qualified for social housing support but whose social housing need is not currently being met. It is a point-in-time assessment of the identified need for social housing support across the country.

This is a statutory assessment to count the total number of households qualified for social housing support across the country on 1st November 2023, in order to better inform policy and plan for the delivery of the right types of housing support. 'Net need' or the total number of households qualified: This is the total number of households qualifying for social housing support whose social housing need is not being met. All the figures in this report are based on net need. Households must be qualified for social housing support. Households currently living in local authority rented accommodation, approved housing body accommodation, accommodation provided under the Housing Assistance



Payment (HAP) scheme, accommodation provided under the Rental Accommodation Scheme (RAS), accommodation provided under the Social Housing Capital Expenditure Programme (SHCEP) schemes or any household on a transfer list are not included in the total number.

### ASSESSMENT OF HOUSING NEED 2023

In Accordance with Section 21 of the Housing (Miscellaneous Provisions) Act 2009 and Section 6 of the Housing (Traveller Accommodation) Act 1998, Galway County Council has been instructed by the Department of Housing Planning & Local Government to carry out a Housing Needs Assessment for 2023.

The Council will be contacting certain applicants currently on the housing waiting list to reassess their eligibility for housing support. All applicants who receive this correspondence must reply in full to it.

Completed returns with all necessary documentation enclosed, should be completed online in the case of the online SSHA form or submitted to the Housing Section, Galway County Council not later than the 11th of August 2023.

Persons who do not return the forms / requested documentation for re-assessment before 11th August 2023, will be removed from the social housing waiting list. In the event of being removed from the waiting list, they will be required to re-apply and if approved, they will not be re-instated at your original date of application. This may also affect rent supplement.

## OFFER A HOME - UKRAINE RESPONSE

Galway County Council continues to work on the Ukraine response with the administration of <a href="https://www.offerahome.ie">www.offerahome.ie</a> programme. Under the 'Offer a Home' programme, local authorities are appealing for offers of houses, apartments, or holiday homes for use as temporary accommodation for those arriving from Ukraine. Ideally, properties would be available for at least six months. Property owners can offer homes at <a href="https://www.offerahome.ie">www.offerahome.ie</a> or by contacting the local authority in which the property is located – dedicated contact details for each local authority are available at offerahome.ie. The local authority in which the property is located will be the point of contact for owners throughout the offer and assessment process. Owners can expect to be contacted by always County Council and an assessment of the property is carried out shortly after.

The owner of the property is informed throughout the process and anybody who offers a property through the website can check the status of their offer at any stage through the site. Suitable properties are matched with Ukrainian beneficiaries with by our implementing partner IOM (International Organization for Migration) and provide support in agreeing licence agreement and other arrangements.

## **CROI CONAITHE**

### REVISED VACANT PROPERTY REFURBISHMENT GRANT SCHEME

With effect from 1 July 2023 additional funding is available under the Vacant Property Grant Scheme to support the refurbishment of vacant and derelict properties located on the islands.

The maximum rate of the Vacant Property Refurbishment Grant payable is up to 20% higher for eligible vacant and derelict properties on qualifying islands.

This brings the maximum grant rates for refurbishing properties on islands up to €60,000 for the refurbishment of vacant properties and up to €84,000 where the property is confirmed to be derelict. The maximum cost limits for the individual works categories are also increased by 20%.

#### HOME ENERGY RETROFIT CLINIC AT GLINSK

The housing Unit presented at a Home Energy Retrofit Clinic on Thursday 13<sup>th</sup> July in Glinsk Community Centre (near Creggs). The topics covered included the

The event was run as part of Glinsk Sustainable Energy Community initiative and other Speakers covered topics including an overview of SEAI Grants, an introduction to the Glinsk Sustainable Energy Community and a summary on the Home Energy Assessments that have been carried out. There was a large attendance on the night and the event was very successful.



### PROPOSED SALE OF DERELICT SOCIAL HOUSING STOCK

There are a number of ex social houses in the ownership of GCC that are deemed to be derelict and because of issues such as access, services, extremely rural location and lack of demand, it is considered that these are not viable to return to social housing. A batch of twelve properties have been identified initially and these have been placed with REMAX Auctioneers for sale. It is expected that for sale signs will be erected shortly and the properties will be advertised. Subject to the identification of a potential buyer, these properties will be brought before the Council under the Section 183 process for approval, in due course. ### **ENERGY RETROFITS**

The Energy Efficiency Retrofit Programme continues to carry out significant work across the county. The aim of the programme is to improve the fabric of the existing council dwellings and to provide an



energy-efficient heating system. The minimum BER rating required following the works is a B2. However, to date under this programme, Galway County Council has surpassed this in all our retrofits, achieving an A rating in many houses. Since 2021 under the current programme Galway County Council has retrofitted 178 dwellings throughout the county at an average cost of €41,600. Galway County Council are proposing to retrofit additional houses in the following locations in 2023.

## CARAVAN LOAN SCHEME

Galway County Council has 14 halting site bays, each of which includes a welfare unit, under its remit, with 10 in Tuam Halting Site and 4 in Capira Halting Site in Tuam. The licencees of these bays provide their own caravan or mobile home, with the Council responsible only for the maintenance of the bay.

We received notification in early July from the Traveller Accommodation Unit of the Department of Housing Local Government and Heritge of the continuation of the Pilot Caravan Loan Scheme – Traveller Specific Accommodation, which supports the provision of Traveller Specific accommodation through preferential loans to Travellers to purchase their own caravan/mobile home for use on halting sites as their residence.

The amount of a loan advanced is subject to a maximum of 40,000 euro, with the loan repayable for a specified period of time. The Council is required to satisfy itself that the applicant can make the loan repayments and loan repayments received must be ring fenced to be used for site maintenance works. The Council recoups each the amount of each loan issued from the Traveller Accommodation Unit of the Department of Housing, Local Government and Heritage

Galway County Council has been approved to allocate 1 Caravan Loan at this time, with a requirement to confirm with the Department its intention to draw its allocation by 31<sup>st</sup> August 2023. This allocation will be reviewed by the Department of Housing later in the year.

We have received limited enquiries regarding the scheme, which has been publicised by the Councils Traveller Liaison Officer and through the local Traveller Representative Groups. Two expressions of interest have been received with no completed applications received to date.



## LA 01/23 - CAISLÉAN RAITHIN, ARDRAHAN


A Part 8 planning application, in accordance with the Planning and Development Regulations 2001, as amended, was lodged on 3<sup>rd</sup> March 2023 for a 10-unit housing development on a greenfield site to the rear of the existing 'Caisléan Raithin' housing estate approx. 0.6 Km from Ardrahan village.

The proposal comprises 3 no. single storey 2 bed houses, 1 no. 2 storey 3 bed house, 6 no. 2 storey 2 bed houses, car parking, connection to existing services and all ancillary site development works.

No submissions/observations were received by the closing date of 20th April 2023.

A Chief Executive's Report was presented to the Loughrea MD Meeting on Monday 10<sup>th</sup> July 2023 with the recommendation that the planning permission proceed subject to 19 conditions.

The Elected Members voted in favour of the proposed development to be carried out as recommended in the Report.

# LA 03/23 - ST. JOSEPH'S PLACE, BALLINASLOE

A Part 8 planning application, in accordance with the Planning and Development Regulations 2001, as amended, was lodged on 11th April 2023 for a 8-unit housing development on a greenfield infill site at St. Joseph's Place, Ballinasloe.

The proposal will include 2 specialist (bungalow type) houses for older persons/those with reduced mobility and six 2 storey terrace houses, car parking, connection to existing services and ancillary site works.

No submissions/observations were received by the closing date of 24th May 2023.

A Chief Executive's Report is currently being repaired and is due to be presented for consideration at the Ballinasloe MD Meeting on 26th July 2023.



## LA 04/23 - DUNLO HILL, BALLINASLOE

A Part 8 planning application, in accordance with the Planning and Development Regulations 2001, as amended, was lodged on 19th May 2023 for a proposal to renovate and extend the existing terraced buildings at Dunlo Hill, including "Dooley's Pub" (protected structure RPS ref 2730) to create a residential housing development comprising of; 10 no. duplex one bed apartments, 1 no. single-storey one-bed apartment, 2 no. duplex two-bed apartments (13 no apartments in total), as well as the conversion of "Dooley's Pub" from a public house to a community use.

The proposal includes for partial demolitions (outbuildings and sheds to the rear courtyard areas) and alterations. It also includes for construction of 2 no. new 2 bed duplexes in lieu of the existing sheds on the northern boundary and a new single storey extension to the townhouses.

The development includes for connections to existing services, delineation of on-street carparking, provision of street trees, set down area and all associated ancillary site development works.

No submissions/observations were received by the closing date of 3rd July 2023.

A Chief Executive's Report is currently being repaired and is due to be presented for consideration at the Ballinasloe MD Meeting on 26th July 2023.

# PART 10 - DROIM NA GAOITHE, BAILE CHLÁIR

A Part 10 planning application, in accordance with the Planning and Development Regulations 2001, as amended, is currently being prepared for a proposed residential development at a site in Droim Na Gaoithe, in Baile Chláir.

The site is approx. 2.7 Hectares with road frontage to the West onto the R381 main Baile Chláir to Oranmore Rd. and frontage to the South-East onto the Local L7110 'Lakeview' Road.



The proposal is for an 88-unit housing development with a mix of 1-4 bedroom units comprising apartments, duplexes and houses. The proposal also provides for a creche and community playground with connections to existing services and associated ancillary site works.

An overview of the proposals was presented to the Athenry-Oranmore MD Meeting on 11th July 2023.

It is intended that the planning application will be lodged to An Bord Pleanála by the end of July 2023.

# Circular RW 10/2023 Galway County Additional Restoration Improvement Allocations 2023

In recognition of the fact that cost inflation is having a significant impact on the cost of delivering regional and local road annual work programmes, the Minister for Transport is making additional funding of €22.5 million available to local authorities this year through Restoration Improvement (RI) Grants. This additional funding is intended to assist local authorities in delivering their annual road strengthening work programmes.

In late June 2023, in response to a query from the Department of Transport, Galway County Council indicated that the Road Operations Section had capacity to complete additional road resurfacing works, were funds to become available. A substantial set of proposals was submitted, focusing primarily on regional roads, roads damaged during the past winter, and the three-year roads programme.

On 3rd July, the Council was pleased to receive notification from the Department of Transport of additional funding under the Roads Improvement Grant scheme in the amount of €1,544,435. This brings the total amount awarded to Galway County Council in 2023 under the RI Grant to €21,999,435.

We propose to continue with our existing contractors in respect of completion of the works. The additional funding will accommodate 2 no. significant roads resurfacing projects in each MD, including a significant extension of the R446 works (former National Road – N6) in the Loughrea MD.

Thanks to the efforts of our MD teams, we have been able to position ourselves for best advantage in achieving these funds.

Furthermore, we have indicated our willingness and capacity to complete further additional works, should the opportunity arise.

The additional roads to be completed are outlined in the table below.

# Kilrickle (Kilreekill) - Kilcooley Group Water Scheme GY841 - Update

The project includes for the installation of 41.5 km of water mains in the project area which comprises an unserved rural area in Kilrickle and the replacement of the existing Kilcooley GWS network. The newly installed network will be supplied by Cappataggle GWS and on completion will be amalgamated with Cappataggle.

The completed project will provide mains water to the Kilrickle area which experiences consistently poor groundwater quality and yield. It will also provide the existing Kilcooley GWS with compliant drinking water. This GWS has been on a boil water notice since December 2009 and is on the Department's Remedial Action List RAL.

The completed project will supply 262 houses, 2 National Schools and several businesses with clean and wholesome drinking water.

The project budget is € 3.57 M made up of contributions from a DHLGH Grant of €3.24 M and Local Contribution of € 0.333 M.

To date, approx. 52% of the Pipeline is installed and 67% of valves installed. approximately 80% of the mains are being installed using directional drilling which reduces the need for open cut trench which in turn saves on road restoration works.

## Spiddal Wastewater Treatment Plant - Commissioning Update

The photo above shows the secondary settlement tank in the foreground, sludge pumps on the left. In the background, welfare facilities and HMIs housed in the structures to the left (HMI means 'human-machine interface' and these interfaces are intended to streamline the use of industrial machinery by connecting a person to a machine, system, or device. Their purpose is to provide insight into mechanical performance and progress), wash water storage in centre background and concrete sludge storage tank in the right.

Changeover of flows in Spiddal is now scheduled for the week commencing July 31<sup>st</sup>. This will be followed by a 28-day process proving period which will conclude at the end of August when full commissioning is expected.

## Community Involvement Schemes

As the Members will be aware, the Department continued the Community Involvement Scheme (CIS) in 2022 and 2023 and local authorities were invited to apply to the Department for CIS funding for those years. The CIS is based on a minimum community contribution of either 10% or 20% based on the criteria below. It is no longer permissible to carry out a CIS funded scheme where the local community contribution is a combination of monetary and works. Please see the following terms below:

Where the local community contribution is monetary a minimum contribution rate of 10% will apply; and where the local community contribution comprises works the minimum contribution rate will be 20%.



No other grants allocated under Department of Transport grant programmes can be used for the community contribution.

The legislative provisions for members of a community carrying out works under the Community Involvement Scheme are outlined in Section 13(6) of the Roads Act, 1993 which provides that, a person or a group of persons may, with the consent of a road authority, carry out maintenance works on a local road. A road authority may provide materials, plant, equipment, and the services of its staff to a person or group carrying out such works. The person or group (and each member thereof) carrying out works with the consent of a road authority will be indemnified by the road authority against all actions and claims howsoever arising in respect of the works, and the carrying out of works, provided that the works are carried out in a bona fide manner and in accordance with any conditions, restrictions or requirements specified by the road authority.







# **FIRE & EMERGENCY SERVICES REPORT**

## RETAINED FIRE SERVICE INDUSTRIAL ACTION

Since earlier this year SIPTU were in discussions with the LGMA re the implementation of the 13 recommendations of the *Retained Fire Services in Ireland - A Review of Recruitment and Retention and the Future Sustainability of Service Delivery Report*. On the 10 May, SIPTU withdrew from the negotiations and having previously balloted its members regarding industrial action, Notice was served on all Local Authorities that Industrial Action (in 3 phases) on the part of all retained fire fighters nationally would commence on 6th June.

On the 19 June, the Labour Court met with both parties and decided that it may be in a position to assist with the discussions/negotiations and until such time as the Labour Court could have a full hearing (26th June) and issue a recommendation. SIPTU agreed not to progress the industrial action any further.

The Labour Court issued its recommendation on the 10 June 2023. SIPTU is putting the recommendation to its members for ballot to either accept/reject. The ballot is taking place electronically from Monday 17 July 2023 to Wednesday 19 July. SIPTU have recommended to its members not to accept the Labour Court Recommendation. In anticipation of the recommendation being rejected by SIPTU members, SIPTU issued notification of strike action to all Chief Executives on the 12 July, with the action due to commence 12:01am on Wednesday the 26 July.

SIPTU have indicated that they will comply with the Voluntary Code of Practice "S.I. No. 1/1992 - Industrial Relations Act, 1990, Code of Practice on Dispute Procedures (Declaration) Order, 1992", which will see a fire service response to "life at risk" calls. Galway Fire and Rescue Service in conjunction with the National Directorate for Fire and Emergency Management (NDFEM) in the DHLGH have developed contingency plans for the event that such a strike goes ahead.

# NEW FIRE APPLIANCE

Earlier in July, Galway Fire and Rescue Service took delivery of a new Fire Appliance (Fire Engine). This appliance will be located in Galway City Fire Station with the appliance its replacing going to Athenry Fire Stati

#### REGENERATION SCHEMES

#### **URDF CALL 3**

The Government have announced details of a €150 million fund to end long-term vacancy and dereliction in towns and cities under the URDF Call 3. Galway County Council have been awarded €2,000,000 to tackle problems of vacancy and dereliction within its URDF settlements of Tuam, Ballinasloe and Oranmore. The fund can transform locations across the county and promote vibrant communities in our urban centres. The third round of URDF funding will act as a dedicated revolving fund within each local authority so as to address the financial barrier and risk faced by local authorities in seeking to tackle long term vacant and derelict buildings and sites across URDF towns. Galway County Council have been allocated target by the DHLGH of 300 vacant and derelict properties to enter the Programme and 27 CPOs / Compulsory Acquisitions to commence in 2023 and this URDF allocated funding can be utilised to meet this target.

This third round of funding support under the URDF programme is not seeking to replicate or replace the various social housing programmes available to local authorities to tackle vacant and derelict buildings and sites. The URDF revolving fund should not therefore be seen as another social/affordable housing programme. The funding will be available to cover the acquisition costs of a property or site and also any civil or design works which may be required to de-risk or improve the site/building to make it more attractive for reuse, development by others or onward sale. The intention is that the fund would be replenished from the proceeds received from the end use/user, thereby allowing the local authority to put in place a rolling programme to tackle long term vacancy and dereliction without recourse to significant borrowing and the associated financial risk. This programme and funding allocation will enable Galway County Council to have a real and lasting impact activating the regeneration of our town centres.

## ATHENRY:

Public Realm design: The Cross Street and Market Square enhancement design package which is being incorporated into the wider public realm is currently being finalised for the Part VIII package. 

## BARN OWLS BREEDING SUCCESS

Barn Owl Nest Boxes which were installed in January 2023, thanks to the support of Galway County Council and the Local Biodiversity Action Fund from the NPWS, were visited on the 20<sup>th</sup> June by the Biodiversity Officer and John Lusby, BirdWatch Ireland. Four healthy Barn Owl chicks were ringed on this visit and it was noted that this was one of the quickest uptakes of a Barn Owl nest box on record. Barn Owl populations for County Galway are displaying a positive trend and the provision of suitable nesting locations is providing positive outcomes for the success of the broods.

The Community Wardens are mapping Invasive Species across the county in response to the complaints relating to public land and this is coordinated through the Invasive Species Working Group of Patricia Delaney (Infrastructure & Operations Unit), Ita Gordon (Planning Section) and Rosina Joyce (Biodiversity Officer). Training will be provided to new Community Wardens in the coming weeks on Invasive Species identification and mapping.

#### MEDIA AND PUBLIC ENGAGEMENT

The Biodiversity Officer was interviewed for Galway Bay FM news on her recent appointment and on the awarding of over €100,000 to Galway County Council for Biodiversity Projects through the Local Biodiversity Action Fund from the NPWS. The item ran on the main news bulletins throughout the day and was also featured on the Galway Bay FM News website.

The Biodiversity Officer was also interviewed for a feature on the *Great Outdoors* with Breandan O'Scanaill on Connemara Community Radio on the 13<sup>th</sup> July and discussed Galway County Council's biodiversity projects in Connemara and around the county.

Social media engagement was strong over the last month for the County Galway Biodiversity Office accounts.

The Biodiversity Officer presented at the PPN's Biodiversity and Climate Info Webinar on the 27<sup>th</sup> June, and outlined the remit of the role to Community Groups throughout the county and gave an update on various projects along with opportunities for members of the public to engage with conservation and citizen science projects.

BirdWatch Ireland's Junior Members magazine *Bird Detectives* featured a two-page spread on the recent winning artwork from the Golden Wings Competition that was run by Galway County Council and the bird conservation group. BirdWatch Ireland has a membership of over 15,000 and this feature has highlighted the role that Galway County Council play in nature conservation on a national stage.









# GALWAY AIRPORT

The Facilities Section engaged with National Parks and Wildlife Services in relation to the significant number of Feral Pigeons that were occupying the two hangars at the old Galway Airport site. A Section 42 licence under the Wildlife Act 1976 – 2018 was granted to Galway County Council. The Feral Pigeon culling was completed in June 2023. Rectification works are underway to ensure safe operations of the 6no. Mega doors at these two Hangars.





The Facilities Section continue to inspect and maintain all the emergency lighting, fire alarm systems, electrical inspections, legionella monitoring, radon testing, PA Testing, VDU Assessments, fire extinguisher inspections, roof access systems, BMS heating systems to ensure a safe and workable environment for staff and members of the public.

Galway County Council's Instagram page has a similar audience base to the Council's Facebook page.



Westside Library delivered another successful programme in conjunction with community partners. Since the establishment of the festival, the programme has increased in size and scope and has become a key strategic partner for the delivery of the city council's Arts strategy.



The Westside Arts Festival is a community-based event which aims to promote and celebrate the spirit and people of Westside through the arts and this year the central theme was 'Sunbeams and Stellar Dreams'. This festival has won the Pride of Place Award and the Mayoral Award for Galway City for two years.



Working with supporting organisations such as Westside Resource Centre, Youth Work Galway, TUSLA, Foróige, Age Action, Galway City Partnership, the Bridge Project and the Westside Community Organic Garden, the festival programme offered opportunities for young and old to explore and experience the different art mediums including a performance from the Brothers of Charity BUKA drama group and a musical performance from the Ukrainian community's choir 'Harmony' which showcased the fusion of Ukrainian and Irish culture. Audiences were invited to dance and join in the singing throughout the performance with the aim to build links between the old and new communities.

Confidence building workshops for Traveller Pride Week were facilitated by youth workers to encourage participants to showcase their culture and heritage and a newly formed Women's Club launched their first exhibition of photography after their recent completion of the GRETB smart phone photography course.

Saturday the 8<sup>th</sup> of July is the Family Day at the Library and footfall through the doors exceeded 1,400 people. Events included a storytelling session from Patricia Forde, Laurate na nÓg; graphic designer Alan Nolan's workshop explored the world of superheroes and the use of illustration to tell the story; Yoga sessions, LEGO club, intergenerational bingo, flower arranging and badge making utilized the MakerSpace to full capacity. The day also included performances from Irish Youth Music Award participants Grace McQuaid; an upcoming band with Liam, Cian and Maya who played in the RDS on May 20<sup>th</sup>and concluded with Jazz artist John Conneely Inc. who is headlining the Galway International Arts Festival this year.


# LAUNCH OF THE FAI BOOKLET



# PRE-TENANCY PRESENTATION IN RELATION TO WATE MANAGEMENT AND LITTER MANAGEMENT



In partnership with the Housing Section a presentation was given to tenants at a pre-tenancy meeting in Clifden. Waste Management obligations were outlined, along with advice on waste services available and litter management in the new estate.

#### WASTE MANAGEMENT AND ENFORCEMENT

Following on from inspections under the Waste Presentation Bye Laws, enforcement by way of Warning letters were sent to almost 30 householders in Tuam and Gort during June mainly regarding provision of brown bins and segregating appropriately.

Inspections were carried out by enforcement officers at a number of premises to check compliance with the PRI regulations including Plastic Bag Levy, WEEE, Batteries and Farm Plastics.

During the month of June 88 waste complaints were logged and 72 waste complaints were closed off by Community Wardens and Technical Staff.

#### WASTE MANAGEMENT NOTICES ISSUED

Three Warning letters, and 6 notices were issued during June under the Waste Management Act 1996.

During June six warning letters were issued under PRI legislation while 4 warning letters were issued under Food Waste Regulations to Commercial premises and one warning letter was sent to a garage regarding hazardous waste. 2 Summonses were also issued in June.

### CLIMATE CHANGE

#### CLIMATE ACTION UNIT

The new Climate Unit has now been established within the Environment Section, dedicated to supporting and implementing climate action within Galway County Council and throughout the county.

Tina Ryan, Climate Action Coordinator, manages the Unit focusing on the priorities for 2023
including the development of the Climate Action Plan, internal energy, ongoing projects and set
up of the Community Climate Action Fund,



- David O'Loughlin, Energy Officer, is focused on optimising our internal energy consumption and efficiency. He works closely with the council-wide Energy Team to identify decarbonisation and energy efficiency opportunities and monitor progress towards our energy reduction goals.
- Rebecca Mooney, Climate Action Officer, started with GCC in late May. She is focused on developing our new Climate Action Plan and implementing actions. She will work with both internal and external stakeholders to implement climate action and sustainability initiatives.
- Denise Feeney, Community Climate Action Officer, started in the role in June. She has extensive
  experience working with communities in the county and will focus on supporting communities
  and businesses to identify climate actions and avail of funding.

#### CLIMATE ACTION PLAN

The Consultation Plan for the predraft stakeholder engagement and the draft Baseline Risk Assessment (KPMG) and Greenhouse Gas Emissions Assessment (Bable Gmbh) were presented to the Climate and Biodiversity SPCE and to the Senior Management Team.

A meeting was held with KPMG to discuss issues raised at the SPC in



relation to the draft Baseline Risk Assessment (KPMG) and they are including additional text within their document to highlight the issues raised.

As part of the pre-draft stakeholder engagement, a presentation was given to the Green Recovery Group of the SPC introducing the new unit and the plan. We also gave a presentation with the SAUTI Youth Group at the Mary Robinson Climate Conference entitled "Meaningful Youth Engagement with Galway County Council on Climate Policy". Regional workshops were held to develop draft actions for the Climate Action Plan including one concentrating on the Decarbonisation Zones. A Summary Document and Questionnaire have been developed and are currently being translated with a view to launching the stakeholder engagement questionnaire in late July.



# LAW AGENTS UPDATE

On Thursday the 13<sup>th of</sup> July, the council were successful in securing vacant possession of a local authority dwellinghouse which had been the subject of illegal occupation and protracted legal proceedings over a significant period of time. The matter had initially come before the District Court by way of application pursuant to the Housing (Miscellaneous Provisions) Act, 2014.

Although the council had been successful in securing an Order for Possession, the said Order was subsequently appealed to the Circuit Court by the illegal occupier. Again, the council were successful and ensured that the District Court Order was affirmed at Circuit. Efforts were then focussed on liaising with the Sheriff's Office of the Court Services, and subsequently an Garda Siochana to exercise the Warrant for Possession. The illegal occupier continued to refuse to vacate the property.

With the assistance of various stakeholders and agencies, including representatives from the Housing Section, the Court Services, the Court Messenger and an Garda Siochana, the council was finally able to secure vacant possession in a safe and incident-free manner.

This technical and logistical exercise also involved the strategic planning for the immediate demolition of the now derelict property and its adjoining dwelling, a vacant derelict local authority house, to ensure that further unlawful occupation would not take place. This will now pave the way for the redevelopment of the site, finalising the regeneration of the immediate area of the estate in question.

The first stage of the redevelopment has been completed with the two derelict properties having been demolished and the site has been secured.



# CONAMARA MUNICIPAL DISTRICT UPDATE

The July meeting of the Conamara Municipal District was held on Friday 14<sup>th</sup> July 2023 in Áras an Chontae. The Municipal District approved the Litter Management Plan 2023 – 2025 and received updates on a number of projects including the N59 Projects at (i) Claremont, (ii) Clifden to Maam Cross. (iii) Moycullen Bypass and (iv) Oughterard Bridge. The Municipal District Members were also briefed on the Galway to Clifden Greenway, the Verge Trimming Programme, Scoil Samhraidh an Phiarsaigh 2023 / Pádraig Pearse Summer School 2023 and changes to the Vacant Homes Refurbishment Grant relating to the islands. The Water Safety Awareness and Development Officer also provided a briefing and presentation on water safety awareness.

Following a request at the June Meeting of the Municipal District, an inter-agency meeting including Galway County Council, the Galway Fire and Rescue Service and An Garda Síochána was convened at County Hall on Tuesday, 18<sup>th</sup> July 2023. The meeting was to facilitate inter-agency cooperation in relation to the Summer Ready Programme for the Conamara Municipal District with a particular focus on arrangements for the August Bank Holiday weekend. A number of joint actions were agreed both for 2023 and 2024.



#### UPDATE ON ACTIVITIES - JULY 2023:

- The Restoration Improvement Works and Restoration Maintenance Works have been tendered and a Most Economically Advantageous Tender identified. Work commenced in May and is ongoing, hopefully to be complete approx. end of August.
- The road works on the islands (DRCD funding) was tendered in February but due to higher-than-expected tenders the DRCD has asked the Council to proceed in a different manner the works were retendered and have now been sanctioned to proceed by the DRCD. Works are due to commence in mid-August with a completion date target of mid-September 2023.
- The Strategic Infrastructure Scheme at the Causeways is progressing through design.
- An application has been made to the Department of Transport for a Strategic Infrastructure Scheme at Cuan na Loinge to address flooding of the main road into this area.
- Safety Improvement Works €115,000 (3 projects) have gone out for Tender.
- Climate Change Projects €150,000 (3 projects) have gone out for tender.
- Local Improvement Schemes (1 on Inis Bofin complete, 4 in Connemara North area mainland have been tendered and awarded to the contractor for completion shortly & 3 on Aran islands carried out by direct labour in August 2023)
- Main activities at moment for outdoor staff include road maintenance, town and village maintenance, preparation works for roads programme, ongoing roads programme works (surface dressing) & drainage works.
- Community Wardens 3 positions, 1 vacant(advertised) dealing with illegal dumping, parking enforcement, ring buoy inspections.
- Town and Village Maintenance substantially done by direct staff.
- Piers & Harbours- Direct labour projects ongoing under Marine Infrastructure Scheme 2023 5



The Department of Transport has recently allocated additional funding through the Road Improvement grants and the Tuam MD has received funding for 2 schemes – R347 Athenry Road and Frank Stockwell Road in Tuam town.

# LOW COST SAFETY MEASURES AT DALGIN NEAR MILLTOWN

Safety improvement works carried out by the Dunmore Roads crew setting back the fence and verge to improve the sightlines for motorists. One of three schemes funded this year in the Tuam MD by the Department of Transport.

# PEDESTRIAN FACILITY SCHEME CAHERLISTRANE

Upgrade of infrastructure in Caherlistrane village which was funded partially from Councillors Notice of Motion. Works included extension of public lighting to GAA pitch, infill to paths, upgrade of parking bays and a pedestrian crossing. Works carried out by our Headford roads crew.















Funding has also been received this month by the Tuam MD for the Palace Grounds project under the Community Recognition Fund, which has received €68,000 funding, of which €38,800 must be drawn down by mid-October 2023, and the remaining €29,200 by mid-October 2024.

The funding allocated to the various elements of the project are.

- Upgrading and widening Walkways, boundary fencing with native hedging to be completed in Year 1
- Sensory Garden area to be completed in Year 2, and other elements such as biodiversity signage, Fit Sticks Signage will be progressed also next year.

### SIG KILBANNON

Tuam MD have reached agreement with the last of the landowners in respect of the Kilbannon realignment Scheme with more signed agreements expected next week. Further final documents have also been received from the design consultants. It is envisaged that all landowners will be signed by October with the scheme to be put to tender in Quarter 4. The scheme will involve the realignment of the R332 road north of Tuam in Kilbannon village and will incorporate a new carriageway, cycle and footways and traffic calming measures.

#### **NEW APPOINTMENTS**

Tuam MD welcomes the appointment of 3 new Community Wardens to the MD. The Community Wardens duties are broad ranging, covering environmental, housing and planning complaints, parking permits, parking as covered under any applicable bye-laws, Pay and Display cash collections, littering, Illegal dumping, illegal burning, dog fouling, playground inspections, Signage, Scaffolding and Hoarding Licences.

There was also the appointment of 1 General Operative to the Headford area roads crew.

### TII SCHEMES UPDATE.

Additional funding allocated from TII since the commencement of the Defects programme, HD28 programme, VRS programme, Retrofitting of fencing and the Capital Pavement schemes. Since it was rolled out in 2013 funding of over €16.6m has been sanctioned over this period. There has been a steady decrease in the number of defects on the National routes since the programme has commenced. This is due to the funding allocated and also the significant amount of overlays carried out by the NRPO across the network during this period.

Funding for 2023 is an additional €943,000 which is managed by the SEE and EE based in the Tuam office.
