DEXCOM'S INVESTMENT IN ATHENRY

Galway County Council has welcomed the announcement by the IDA that med-tech firm Dexcom is to create 1,000 permanent jobs at its proposed new global manufacturing facility in Athenry, County Galway. Subject to the planning and development process, the new facility will see an investment of up to €300 million over 5 years, creating up to 1,000 high skilled jobs over the period with up to 500 jobs created during the construction phase

Dexcom is a leading developer, manufacturer and distributor of continuous glucose monitoring systems for diabetes management. The new facility will be Dexcom's first production plant in Europe and the proposal to locate it on the IDA Ireland owned land in Athenry and has been hailed as a "game changer" for the County and the Region. The lands in question are part of the Strategic Economic Corridor contained in the Galway County Development Plan 2022 –2028 and zoned for development as part of the Athenry Local Area Plan. The decision by Dexcom to invest in Athenry is testament to the work of this Council through the forward planning process and confirms the potential of the Strategic Economic Corridor in delivering significant numbers of high-quality jobs for Galway. The circa 30-hectare site was earmarked by IDA Ireland to accommodate exactly this type of investment and it is wonderful to have secure the investment for Ireland and the West in what is a highly competitive global market.

Galway County Council, in conjunction with the IDA, played a central role in attracting the investment by working closely with the IDA and company representatives over the last 18+ months to attract Dexcom to choose the site as their preferred location. CO-WORKING SPACE

The development of the facility contributes to the regeneration of Athenry town centre, while meeting the immediate need for office space for Dexcom's leadership team in Ireland. The space has been designed so that is suitable for use by the community and so that it can meet future tenants of the hub with own door offices and co-working space available as well as meeting rooms.

JUST TRANSITION FUND

To facilitate a just transition toward a low-carbon economy in the midlands the EU has awarded Fáilte Ireland €68 milllion for a Regenerative Tourism Scheme to invest in the sustainable development of tourism in the midlands with the aim of creating job and sustaining communities.

Fáilte Ireland hosted an in-person Industry Networking Event for tourism partners in Galway, and Islands on Thursday 4th May 2023.





Gráinne Mullins - an award-winning pastry chef when she launched Grá Chocolates from her parents' shed in 2020 and supported by LEO Galway. The chocolate business, which features local Irish ingredients and hand-painted designs, has since won her six more awards and stockists including Brown Thomas and members of the Leading Hotels of the World group. Revenue last year (2022) was \$1 million.

SHARED ISLAND:

Galway County Council through the Economic, Rural & Community Development Unit is the lead partner and this project is a unique collaboration with a shared commitment of Galway and Leitrim County Councils partnered with Armagh City, Banbridge and Craigavon Borough Council to develop Excellence Centres in Food Innovation and Agritech. Each of the Local Authorities is leading out on one of the three strands with signature events organised around this. ABC Borough Council have some key events on June 7th/8th, Leitrim County Council have June 22nd in the scheduled diary while Galway County Council are considering late early July to organise a climate conference subject to availability of appropriate speakers. The BIA Innovator Campus are central to the project and the potential for Ag Tech is coordinated with BIA in terms of scoping the potential to build out on the existing/planned services through the facility.

REGENERATION SCHEMES

ATHENRY:

The Cross Street and Market Square enhancement design package which is being incorporated into the wider public realm is currently being finalised for the Part VIII package. This will form part of Phase 1 of the Athenry Public Realm Enhancement Scheme. The work is being coordinated to ensure alignment the imminent Draft Local Area Plan and Local Transport Plan.



LOUGHREA TOWN HALL:

The Council have received approval from the Department of Rural & Community Development to proceed to tender for the renovation and development of Loughrea Town Hall. This is an important milestone in the revitalisation of this iconic building in Loughrea and follows on from the revised costing proposals and business case submitted to the Department. The funding uplift to support proposed works will be considered on presentation of the Tender Assessment Report, which will be submitted on completion of the procurement process. Instructions have issued to Aughey O Flaherty Architects who are the lead on the design team to re-mobilise with a view to entering Procurement phase as soon as is reasonable.

CLIFDEN:

Presentations made to Municipal District and Chamber of Commerce as part of the second phase of public consultation on the developing conceptual design for Clifden Town Centre. In general, the proposed designs are gaining in support which will allow the design to be progressed with a view to developing a Part 10 planning application. PORTUMNA COURTHOUSE

The Regeneration Team are currently reviewing the Draft Tender Documents for Portumna Courthouse. An updated ecological survey including Bat surveys is scheduled for the coming weeks.

PORTUMNA

RPS Consultants are progressing the Portumna public realm design with feedback on draft issued by Regen Team following the first phase of public consultation. It is anticipated that final draft will be submitted to the Council in the coming weeks and that the next phase of public consultation will take place in June. As part of the consideration of the public realm enhancements potential car parking sites have been identified, with negotiations continuing following the engagement of a valuer by the Council

The acquisition of the opportunity corner site on Abbey Street is nearing closure.

As part of the Portumna Streetscape Scheme two information events were held in Portumna and applications were invited in accordance with the scheme. The extended closing date was Monday 15th May and it is expected that assessments will be completed by the end of May.

GORT:

The second phase of the Public Consultation on the conceptual design for Gort was held in Gort on April 27th, 2023 and was attended by BDP Consultants and staff from the Council. While the feedback was mainly very positive, some local businesses have raised issues regarding elements of the proposals which will be considered by the team progressing the project. Further consultations with elected representatives and the business community will be scheduled and formal submissions from all concerned will be requested to inform assessment. In tandem with the public realm, the Gort Town Centre First Plan is being progressed. LOCAL COMMUNITY DEVELOPMENT COMMITTEE (LCDC)

- Following a submission by the LCDC in March, the Department announced allocations for County Galway under the Community Support Fund (Community Enhancement Fund) https://www.gov.ie/en/press-release/a3c39-our-rural-future-ministers-humphreys-and-joe-obrien-announce-300432-for-193-local-projects-in-county-galway-under-the-community-support-fund-2022/ This Fund provided vital small-scale funding towards energy/running costs and small capital projects for 193 grassroots groups the grants towards energy costs have been paid to all relevant groups in May to ensure they receive this much-needed support towards rising electricity and heating costs as quickly as possible.
- The Department of Rural and Community Development has advised that funding announcements under the Community Recognition Fund will be made on 18th May. This once-off fund will provide €1.2m in funding for vital community amenities and facilities in communities hosting Ukrainian Nationals.

COMMUNITY DEVELOPMENT

- The Cathaoirleach Awards for 2023 were launched by the Cllr Michael 'Moegie' Maher, Cathaoirleach of the County, and were publicised through the PPN and local newspapers and media. There has been great interest in the nomination process across the 10 award categories and nominations will close on 12th May 2023.
- The closing date for the National Tidy Towns Competition for 2023 was 10th May, and staff from
 the Community Section assisted Corofin to enter the competition for the first time this year
 through grant assistance, a site visit, and funding towards a Biodiversity/Planting Plan. In 2022,
 45 groups from the County entered the national competition which is among the highest number
 of entrants from any county nationally.
- The Community Section liaised with other Units to identify 2 towns/villages/groups/estates to represent County Galway in the Annual IPB All-Island Pride of Place Award, and the following have been nominated: Creggs Rural Development in the 'Climate Action and Biodiversity' category for their work in habitat mapping and raising awareness at local level, and Gort River Walk Group for their work to revitalise this important local amenity and make it accessible and usable by the wider community. A panel of judges will visit these 2 areas during the summer to review their work and Elected Members and Staff will be notified of the dates in due course. This follows on from a very successful Pride of Place for County Galway in 2022 with Lawrencetown winning the Best Village category and Woodford runner-up in the Creative Place category, and both groups will be recognised at a civic reception following the May Plenary Meeting.



SOCIAL INCLUSION

- To celebrate the Bealtaine Festival, a series of events on the theme "Movies in May" will take place across the county, to encourage older people to attend theatres to view movies combined with a social occasion.
- A meeting of the Older People's Council (OPC) Executive Committee took place on Monday 8th
 May and members of the Committee will attend an OPC National Convention in Tralee
- The Community Section has nominated staff to attend Cultural Competency Training on 19th May which has been organised through the Traveller Interagency Group.


CREATIVE PLACES TUAM

With over 150 performances in 52 venues across 12 countries, she is known nationally for her work with Irish Modern Dance Theatre-John Scott (Dublin) and by touring internationally with Compagnie Nacera Belaza (Paris).

ARTS COUNCIL FESTIVAL MAKERS CONFERENCE 2023 - GALWAY

The Arts Office attended the national Arts Council Festival Conference in Galway alongside representatives from our local festivals including Clifden Arts Festival, Shorelines Arts Festival and

North East Galway Fit up Festival.





The Arts Council in partnership with Drama and Theatre Studies at the University of Galway and Creative Europe Desk Ireland presented the Festival Makers Conference (formerly Change Makers) on Thursday 11 and Friday 12 May 2023 in Galway City. The two-day conference provided opportunities for festival makers, festival stakeholders and artists making work in a festival context to exchange ideas, share, map sector developments and discuss practices relevant to festivals in Ireland. Many of the Galway County based performances and funded festivals showcased their work and acknowledged the support of Galway County Council Arts Office.

PUBLIC ART PROGRAMME 2023:

Tuam OPW Mural: Galway County Arts Office in collaboration with OPW and Department of Social Protection have issued an Artist brief to two mural artists for the creation of an original mural inspired by reflections with local Youthreach teenagers in Tuam. This work was facililated by local artists Joanna McGlynn. The total budget for this commission is €12,000. Selection will take place in June 2023.

Craughwell Public Art: Led by Public Art Curator Rina Whyte in collaboration with Galway County Arts Officer, an artist's brief has been prepared for the commission of public art. Craughwell has been awarded a Per Cent for Art grant of €41,000 and a Public Art Working Group has been established as guardians and community representatives of this process.





The Public Art Working Group has selected a working title of 'The River Runs through it' for this commission based on the Dunkellin River which runs through Craughwell. Not every village has a river running through it and the Dunkellin has been a symbol of life, the basis for settlements from the Celtic era through to Norman, Christian and now modern multi national and denominational settlements. It flows into the Rahasane Turlough, the largest remaining wetland in Europe which is also of immense importance ecologically, economically and nostalgically that with the Dunkellin river has provided economies of blacksmithing, milling, fishing, farming, sport, horse racing and entertainment. The selection process will take the form of a Two Stage Open Competition. It is open to all interested professional artists or collaboratives at any stage of their career or experience who are interested in working on a commission that can reflect the considerations of the Public Art Working Group.

CREATIVE IRELAND

GALWAY COUNTY CREATIVE IRELAND BURSARIES

The closing date for the Galway County Creative Ireland Bursaries was Friday 12th May. We received a total of *46* applications and assessments will take place week of 22nd May. Total fund available: €50,000 with potential grants being awarded from €2,000 to €10,000.

CRUINNIÚ NA NÓG

Galway County will celebrate Cruinniú na nÓg, a National Day of Creativity for children and young people, with a host of FREE events and workshops on Saturday 10th June. The day is all about giving children and young people the opportunity to express themselves through cultural and creative activities while having fun! Events will take place throughout the county from Ballinasloe to Connemara and everywhere in between. Cruinniú na nÓg 2023 is a collaboration between the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media, the Creative Ireland Programme, local authorities and RTÉ. Galway County Council is delighted to once again partner with Creative



Ireland for Cruinniú na nÓg in presenting in-person diverse activities throughout the county for a wide range of ages.

There are many free, fun events including: *The Shape Shifting Slua* - a street performance created by Jojo Hynes & Midie Corcoran with the Creative Youth Committee in Tuam. Large-scale creatures will take to the streets of Tuam from 1:30pm. *Patterns of Invisible Life* is a visual art workshop with Madeleine Shinnick; children will create a large mandala and make lanterns from patterns and colours of the plant kingdom in Mountbellew Community Hall. Muintearas presents Slógadh na nÓg, a day of creativity in Rosmuc with a series of music and dance workshops aimed at teenagers culminating in a performance in Tír an Fhia, Leitir Móir & Pairc Péile Rosmuc. Drumadore will host a drop-in drumming session in Oughterard Community Centre for all ages.

Along with artists, community groups, schools and organisations offering creative acitivities to young people, Galway County Council is also curating a variety of events for the children and young people of the Ukrainian community in Galway county. CROI CONAITHE

From 1 May 2023, the grant is being further expanded to provide for applications for one property which will be made available for rent, in addition to one property which will be a principal private residence of the owner.



(above image of a Galway property that has received Croi Conaithe grant aid)

A grant of up to a maximum of €50,0002 is available for: - the refurbishment of vacant properties for occupation as a principal private residence, and - for properties which will be made available for rent, including the conversion of properties which have not been used as residential heretofore, subject to appropriate planning permission being in place.

This is subject to upper limits for the types of work, specified below, having regard to a reasonable cost assessment by the local authority. The grant is inclusive of the VAT cost of the works. Where the refurbishment costs are expected to exceed the standard grant of up to €50,000, a maximum top-up grant amount of up to €20,000 is available where the property is confirmed by the applicant to be derelict (i.e. structurally unsound and dangerous) or if the property is already on the local authority's Derelict Sites Register, bringing the total grant available for a derelict property up to a maximum of €70,000.

In the case of a top-up grant in respect of a derelict property not on the Derelict Sites Register, an independent report prepared by an appropriately qualified professional is required to be submitted along with the application, confirming, to the satisfaction of the local authority, that the property is derelict.

Those applying for the grant are required to indicate on the application form if they are applying in respect of a property that will become their principal private residence or a property that will be made available for rent. This must be indicated at the outset as different conditions apply depending on the application type. Those applying for the grant are also required to indicate on the application form if they are applying for the Vacant Property Refurbishment Grant alone or the Vacant Property Refurbishment Grant including the Derelict Property top-up Grant. The level of grant payable is contingent on the works approved by the local authority and is paid on completion of the works and



based on vouched expenditure following a final inspection by the local authority. An SEAI Better Energy Home Scheme Grant3 may be available in combination with this grant. However, works covered by SEAI Better Energy Homes Scheme will not also be provided for under the Vacant Property Refurbishment Grant. The local authority must satisfy themselves that proposed works are not claimed for under any other grant. In respect of rental properties, all landlords are required by law to comply with the standards for rental housing and ensure that their properties are fully compliant with fire safety and minimum standards regulations for rental properties



CÉIBH INIS OÍRR IMPROVEMENT AND EXTENSION PROJECT

The project to extend Inis Oírr pier is progressing towards a contractor tender competition inside the next 6 weeks. The proposal to redevelop the pier came about in response to significant issues with the existing infrastructure. The primary concerns being frequent overtopping of the existing storm wall, congestion on the pier deck during tourist season, and berthing capacity for increasing cargo and passenger requirements.

The acquisition by Compulsory Purchase Order (CPO) of all lands, terrestrial and foreshore, required for the project has been completed. The operative date for the CPO was the 28th April 2023.

The formal approval of the approving authority, The Department of Rural and Community Development (DRCD), is required in advance of publishing the tender documents for the proposed works. This is in accordance with the requirements of the Public Spending Code, engagement is ongoing, and approval is anticipated before the end of May 2023.

The Design & Build tender period will run from June to October 2023 with an appointment thereafter. It is aimed to have a contract award by the end of the year.

The works will take two years to complete, and the redeveloped pier will be available for use from the beginning of 2025 based on the current project programme.



The Roads and Infrastructure MD teams throughout the County are actively working to complete Active Travel Footpath and Infrastructure Construction Projects in multiple Towns and Villages throughout the MDs.

INSTALLATION OF LIGHT SEGREGATION MEASURES IN ORANMORE VILLAGE

Light segregation measures were installed on one of the busy routes for Walking and Cycling to one of the 4 schools in the immediate area. This "Pop Up Infrastructure" installation will be monitored and assessed in the coming months and will ultimately be extended under the upcoming Safe Routes To School programme for Oranmore Schools.

Works included the planning, design, procurement and implementation of multiple upgrades and installations of Pedestrian Crossing at 11 locations throughout Clifden Town.

This Active Travel project included the installation of new Belisha Lights, Tactile Paving and Line Marking works. The project was initially started in 2022 but was paused during the Summer months to facilitate the busy tourist season in Clifden. TEMPORARY TIME-LIMITED WAIVER IN RESPECT OF DEVELOPMENT CONTRIBUTIONS



CONDITIONS AND OPERATIONAL ARRANGEMENTS:

The temporary development contribution waiver arrangements will apply for 1 year to all permitted residential development –

- that commences on site between **25 April 2023** (the date of the Government Decision approving the measure) and **24 April 2024**, and
- is completed not later than **31 December 2025**.

This end date is to facilitate large schemes to be speedily brought forward and progressed, while also incentivising their completion as quickly as possible within a reasonable timeframe.

The waiver arrangements are being applied irrespective of the date of planning permission for residential development availing of the scheme. In addition, in recognition of the fact that developers are required to submit "commencement notices" or "7 day notices" to the local authority in accordance with the Building Control Regulations prior to the commencement of works, the waiver arrangements will also apply to developments in respect of which —

- (i) "commencement notices" were submitted to the local authority within the 28 day period prior to 25 April 2023 i.e. on or after 28 March 2023; or
- (ii) "7 day notices" were submitted to the local authority on or after 4 April 2023.

In terms of the practical operation and administration of the new measure, it is proposed that instead of developers/ project promoters having to pay the relevant development contributions to the local



authority in the normal manner (usually on commencement of construction or in accordance with an agreed phased payment plan with the local authority), the Department will, further to the submission

of commencement notices from developers to local planning authorities and verification by the planning authority that development has actually commenced on site, pay the relevant charges due to the local authority on behalf of the person liable for the contribution.

In this regard, the Minister is cognisant that the waiver scheme should not impact on local authorities ability to fund the ongoing provision of necessary infrastructure to support development in their functional areas or require the taking out of interim borrowing to prevent delays to infrastructure development works. In light of this, it will be necessary for efficient administrative arrangements to be put in place to ensure that local authorities are promptly compensated by the Department for development contributions that would normally be paid at commencement stage by developers. To facilitate this, local authorities will be required to invoice the Department on a monthly in arrears basis in respect of development contributions payable further to the receipt of commencement notices from developers. The Department will notify local authorities in relation to the detailed operation of the waiver arrangements – including how they will be administered, claimed and paid - as early as possible.

For information and clarification, it should also be noted that the **Uisce Eireann water and waste water connection charges** referenced in the new Government support package will still have to be paid upfront by developers in the normal manner, with the monies being subsequently refunded by Uisce Eireann on notification of the commencement of works i.e. in effect a rebate rather than a waiver arrangement.

FINANCIAL SAFEGUARDS

A number of financial safeguards are in place to prevent profiteering by the sector and ensuring that the measures will benefit purchasers and help boost supply. Developers are already subject to compliance with specified regional price caps in relation to the First Home scheme and a €500,000 cap under the Help to Buy scheme. In addition, the Department applies unit cost recommendations on proposed social and affordable housing developments to ensure value for money. These requirements will remain in place as a price control mechanism under the new waiver arrangements.

Further conditions and requirements of the waiver scheme In order to ensure that the measure operates as intended, it will be important that appropriate arrangements are put in place to ensure compliance with the terms of the scheme, including that developers availing of the scheme sign an undertaking confirming that they agree to comply with the said conditions of the scheme. This will include the application of clawback/ refund arrangements in relation to development contributions paid to local authorities by the Department on behalf of the person liable for the contribution where the conditions of the scheme have not been met i.e. safeguarding against situations where — (i) reported commencements have not actually been started, and (ii) units have not been completed prior to the end date of the scheme. Verification arrangements will be required in both such instances.



These and other relevant requirements in relation to the practical operation of the scheme are currently being developed and will be notified to local authorities as early as possible.

The Tuam LAP 2023-2029 was placed on public display for 6 weeks, from Friday the Wednesday 8th of February 2023 until Thursday 23rd March 2023 (inclusive). A public consultation drop-in session was held in Tuam on Monday 6th March 2023. A Webinar Event was also held on Thursday 9th of March 2023. All events were well attended. A total of 62 submissions were received within the public consultation period.

The Chief Executive's Report on the submissions received on the Draft Tuam LAP including the Draft Tuam Local Transport Plan issued on the 4th May 2023 to the Municipal District of Tuam and will be the subject of consideration by the Municipal District at a meeting to be held on Tuesday, 6th June 2023.





GALWAY'S FORGED GATES PROJECT



A crowd of over 280 people from aged 9 to 90 attended "The Galway County Forged Gates Project" which was officially launched by Cllr. Eileen Mannion, Leas Chathaoirleach, Galway County Council, on Friday 5th May at Mountbellew Agricultural College/ATU Campus, Mountbellew, Co. Galway.

This project had very simple beginnings, when the Heritage Office of Galway County Council and the Skehana & District Heritage had independently embarked on separate initiatives relating to collecting and collating information, oral heritage and images of forged gates, the craft of the blacksmith and the forge. It was only when the two groups crossed paths, that the project blossomed and resulted in the start of the Galway Forged Gates Project.

Cllr Eileen Mannion, Leas Chathaoirleach of the County of Galway said "that the project captures and preserves the significance of the blacksmith and the forge as told by blacksmiths themselves and their descendants as they recall and relay their recollections from childhood memories and stories from their ancestors." She also said "Thanks to this new Creative Ireland and Galway County Council funded initiative and the voluntary contribution of Skehana and District Heritage Group and Holy Rosary College, Mountbellew, all this very valuable information is captured on short films, audio interviews and recordings, photographs, pull-up banners and postcards which were produced with the assistance and contributions of local volunteers and media professionals and is now available free of charge for all to appreciate and use."







Jimmy Laffey, PRO, Skehana and District Heritage Group said "In Ireland, the blacksmith traditionally played an important role in the community and while they primarily shod farm horses, ponies and donkeys as farriers, they also repaired and manufactured agricultural implements, shod wheels and made gates and railings amongst many other tasks to include making their own tools of the trade. It used to be that every town and village in Ireland had at the very least, one forge and a blacksmith. Another key service which their premises provided was that of a community gathering point as a social outlet where locals exchanged ideas, advice, stories, news and without doubt some gossip as well."

Speaking at the launch Emma Laffey, as principal project co-ordinator with the Skehana & District Heritage Group, recalls "for me it started in a very simple way really as I began to notice the huge number of wrought iron gates on the roadsides as I drove to work and around the Skehana area. I started to take pictures of the more local ones, just on my phone, getting permissions from the landowners and householders as well as any story or history associated with the gates from them. It was amazing the local communities response and information they had. So I decided to put all the



information I had gathered into an online hardback book as a keepsake for the Skehana & District Heritage Group. I printed a couple of copies and with Jimmy Laffey's suggestion I sent a copy to our Galway Heritage Officer Marie Mannion, that I realised she already had the skeleton of a larger project on forges and blacksmiths in the melting pot. The rest is history and has culminated in the final product that we, as a team, now have. I found it to be a most rewarding journey along which I met and worked with so many wonderful people and learned so much from them. I am so grateful to each and everyone of them. I also learned that it is so important to capture what you can before it is too late as we have lost two brilliant participants and reservoirs of information for the project, John Mannion and John Joe Ward, just in the last few months."

According to Marie Mannion, Heritage Officer, Galway County Council "The vernacular forged wrought iron field gate is a very valuable, but often neglected, aspect of the cultural heritage of our rural landscape in county Galway. These field gates were for the most part forged in the local blacksmith's forge.

They are practical and functional while at the same time are an artistic expression of the blacksmith who made them. During the twentieth century cast-iron, tubular steel and other mass produced gates became more common while at the same time the forged wrought iron gates went into decline as did the blacksmiths forge. In addition to this changing farming practices has led to many of these gates being abandoned in hedges and fields throughout the county, as the older forged wrought iron field gates became too small to accommodate new big machines entering fields. However, to the careful observer there are still many beautifully crafted wrought iron field gate to be found around the county.

Therefore, the aim of this project was to identify, record, raise awareness and knowledge of the wealth of wrought iron field gates that are to be found in the county of Galway. It sought to identify the names of the local blacksmiths and their forges. As this project shows the best way to capture this information is to work with our local communities and Skehana & District Heritage Group who have a great understanding and knowledge of their local heritage. Working with Holy Rosary College, Mountbellew we have now uncovered a wealth of our rich hidden local heritage."







Following the launch proper a presentation, of a beautiful fully functional, swinging and latching, replica gate complete with pillars was made to participants involved in audio recordings, film making and publications as well as the steering committee members. In addition, a special presentation was made to John Feeney, a retired blacksmith from Ballyedmond, who made a great comeback last year to make four wonderful films for the archives. This was a beautiful true to life painting of John working at his forge fire, as he made a sheep crook, with the reflection of the red glow on his face and glasses being most striking features. This was done by Eve Murray from Skehana who is a second year art student in Limerick and is a credit to her undoubted talents.

Ever and Always The Marvellous Story of Aleen Cust 'Britain And Ireland's First Female Vet' (a Bilingual Primary School workbook)







Niamh Ní Chróinín, TG4's newly appointed ambassador for children and presenter of the dedicated children's channel Cula4 and Cllr Michael Maher, Cathaoirleach of the County of Galway launched a bilingual workbook on Aleen Cust; the first female veterinary surgeon to work in Ireland, or indeed the world, in 1900 in Mountbellew Agricultural College ATU on April 21st.


In the region of 150 students from Mountbellew National School, Moylough National School, Holy Rosary College, Coláiste an Chreagáin and members of the public attended the launch. In attendance was Martin Blake, Chief Veterinary Officer, Department of Agriculture, Cllr Roger Kennedy, Tipperary County Council, Cllr. Joe Murphy, Chairperson of County Roscommon Heritage Forum, Cllr Dr Evelyn Parsons, Cathaoirleach of Ballinasloe Municipal District and Senator Victor Boyhan.





Eithne O'Halloran of Kylemore Abbey wrote the text and designed the layout aided by superb illustrations of Sara Nylund. The workbook is in a bilingual format and will appeal to a wide audience of younger readers, has added educational value, each section having an exercise to provoke searching minds, quizzes, word games and artistic challenges. Feedback to date suggests that the book will entertain both young and indeed older readers.

Aleen Cust was Irish born at Cordangan Manor, close to Tipperary town in 1868 to Leopold and Lady Cust, a land agent for the Smith-Barry estate. After Leopold's untimely death in 1878 at forty-six years of age, the family moved back to England and Aleen became a ward of the Widdrington family of Newton Hall, Northumberland, close to the Scottish border. Aleen always wanted to be a vet and despite being disowned by her family she went to the New Veterinary College in Edinburgh and graduated with merit in 1900. The Royal College in London refused her permission to sit their final examinations because she was a woman. Undeterred Aleen returned to Ireland and took a position assisting a well-known veterinary surgeon in Athleague, Co. Roscommon, William Augustine Byrne. Aleen was an excellent practitioner and a very fine horse woman; accepted by the community and kind and compassionate to her clientele. In 1905 Aleen obtained a controversial position as a Local Authority Veterinary Inspector for the Mountbellew district (described by the Western People as 'disgusting, if not absolutely indecent'), which she held until 1915 when she drove her own car to France to assist the treatment of injured horses during World War 1.



'Miss Cust' or 'Vet Cust' as she was known rode a white Arabian stallion in her earlier years at work and is remembered in Galway and Roscommon for her integrity, intelligence, wit, charm, determination. The women who followed in her footsteps found employment difficult as societal prejudices and economic depression were formidable barriers in the earlier years. In the present time the intake of females far surpasses that of male applicants to veterinary schools around the world. The feminisation of the veterinary profession is well and truly complete.



Cllr Michael 'Moegie Maher, Cathaoirleach of the County of Galway speaking at the launch said "Well thankfully things have changed and one hundred year's later the majority of the 3000 plus registered vets in Ireland today are female. I am delighted that this bi-lingual workbook which tells Aleen's story will be available for all schools in Galway, Roscommon and Tipperary." Addressing the students present he added "I hope that Aleen's story inspires you and that by believing in yourself anything is possible".







Veterinarians Brendan Gardiner, Donal Connolly and Ascinta Kilroy of the Aleen Cust Memorial Society, Marie Mannion, Heritage Officer of the Galway County Council, Nollaig Feeney, Heritage Officer, Roscommon County Council and Róisín O'Grady, Heritage Officer, Tipperary County Council managed and directed the project.



Edna Curley, Principal of Mountbellew Agricultural College (ATU) said she was "delighted to be hosting the launch in the college given Aleen's work with the farming community in Mountbellew".



Brendan Gardiner of the The Aleen Cust Society said that the Society "regard this bi-lingual schools workbook as an eternal legacy to the memory of this trailblazing, courageous woman"

GALWAY COMMUNITY HERITAGE – ICAN (IRISH COMMUNITY ARCHIVE NETWORK) MEETING IN SKEHANA



A meeting of the members of Galway Community Heritage – ICAN took place on Wednesday 10th May in Screens of Guilkagh. Members from Oughterard Heritage Group, Moycullen Heritage Group, Claregalway Heritage Group, Killererin Heritage Group, Moylough Heritage Group, Skehana Heritage Group, Abbey Heritage Group, Galway Community Archaeology and Woodlawn Heritage Group attended as well as Lorna Elms and Hassan Dabbagh from the National Museum of County Life. It was the first in-person meeting since February 2020. Meetings were held online for the intervening 3 years.

Each group gave a presentation on their work and projects as well as issues and opportunities that they faced. Oughterard Heritage Group had a magnificent display and exhibition with regards to the archaeological heritage and Skehana Heritage had an exhibition of their Midwife Project and book. In addition to this Abbey Heritage gave each member copies of their bi-linugal publication "South East Galway: Aspects of its heritage: CINEÁL FHÉICHÍN AGUS SÍOL ANMCHA".

DECADE OF COMMEMORATION FUNDING 2023

A total of € 69,000 was sanctioning to Galway County Council from the Commemorations Unit of the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media to deliver the following projects in 2023:

HISTORIAN IN RESIDENCE

The events of the decade between 1913 and 1923 were momentous and defining ones. It was the decade that influenced relationships for a generation and was a period which saw the achievement of Irish independence and the foundation of our State.

It was also a period of transformation and cultural renewal in Irish society, following on electoral reform, land reform, education reform and migration. The demand for constitutional change was in parallel with the assertion of workers' rights and women's rights.



The decade was one of the most momentous of modern Irish history and justifies a comprehensive commemorative programme that recognises its importance, acknowledges the achievements of its generation and enhances the understanding today of the events that shaped our society.

While the events that occurred between 1913 and 1923 had a huge impact nationally they had a particular relevance in the County of Galway.

Therefore, Galway County Council in the context of its role in providing civic leadership recognises the importance of playing a positive and proactive role in leading commemorative celebrations and activities during the course of the decade and had decided to contract a Historian in Residence for 2023; this is following on for very successful projects in 2021 and 2022.

RESPOND REFLECT REJOICE: 1923 THROUGH THE LENS OF OUR LITERARY AND ARTISTIC CREATIVES

Respond Reflect Rejoice: 1923 Through the Lens of our Literary and Artistic Creatives is a series of talks, commissions, residencies exploring and remembering our writers, artists and musicians and their contribution to events that occurred during a significant period of time in Irish History. The approach is creative, collaborative, and participative in nature - artists, creatives, community groups, academics and writers will come together to create a platform to encourage reflection and creative responses. The purpose – a deeper understanding and appreciation of the role and influence of the creative arts in Ireland in 1923. The outcome – a programme of engaging and informative talks; artistic residencies/commissions which will be embedded in communities in Galway County municipal Districts. The programme of public talks led by experts will reflect on writers such as Elizabeth Bowen, Sean O'Casey & Liam O' Flaherty respond to artists such as Mainie Jellet's and her abstract paintings rejoice on WB Yeats' winning the Nobel Prize in Literature. Our commissions/residencies will be informed and inspired by events that happened both locally and nationally during this significant period of time in Irish History

BI-LINGUAL BOOK: A HISTORY OF AN GARDA SÍOCHÁNA IN COUNTY GALWAY: A CENTURY OF SERVICE

This will be a 250 page full colour bi-lingual publication. It will deal with the formation of An Garda Síochána, the coming of the force to Galway on 25 September 1922. It will also give how An Garda Síochána has contributed to building a safe and peaceful society in particular as it relates to County Galway and how members of An Garda Síochána contribute to the local areas in which they work and live. It also aims to show the changing roles of An Garda Síochána over the past 100 years. This publication will also compliment the exhibition entitled Gardaí in *Galway 1922 – 2022.* The publication will be distributed to libraries, schools and the wider community free of charge.



STORYMAP OF MEMORIAL SITES IN COUNTY GALWAY RELATING TO THE DECADE OF COMMEMORATIONS 1916 – 1923

Galway County Council's Heritage Office intends to record Memorial Sites in County Galway relating to the Decade of Commemorations 1916-1923 and to create a number of StoryMaps to help create an awareness of these very important memorials and to will seek to tell the stories about these memorials. Built on leading edge geospatial technology it is hoped that these custom storymaps will inform and inspire people to explore the memorials relating to 1916-1923 that is available right on their doorstep.

These StoryMaps bring together the latest mapping technology with text, images and multimedia content to tell powerful location based stories accessible from any internet enabled device with a Web Browser including Tablets and Phones. They are therefore an ideal tool to communicate the story of the memorials and the events, people and locations that they commemorate.

WORKBOOK ON AN GARDA SÍOCHÁNA IN COUNTY GALWAY: A CENTURY OF SERVICE FOR PRIMARY SCHOOLS

This bi-lingual workbook is aimed at 5th and 6th class students will be integrated into the primary school curriculum and will focus in on creating an awareness, knowledge and interpretation of life in 1920s Ireland and the role of An Garda Síochána over the past 100 years. It is proposed to embed videos and podcast into the workbook and this will assist in brining history to life in the classroom.

FORGETTING & REMEMBERING IN THE WEST OF IRELAND: GALWAY COUNTY COUNCIL AND THE DECADE OF CENTENARIES, 1913-23

It is proposed to hold this closing event for the Decade of Commemorations in October 2023 in Galway County Council, Áras an Chontae, Prospect Hill, Galway. It will be an evening of reflection on the events that took place in County Galway commemorating the period of 1913 – 2023. This will be delivered by a series of lectures, music, song and dance.

The seminal events that shaped modern Ireland during the revolutionary decade from 1913 to 1923, saw an unprecedented public engagement with Ireland's revolutionary past during Ireland's Decade of Centenaries. Galway County Council was at the forefront of a widespread and unprecedented series of public events that engaged and re-discovered our communal past, with over a decade of community based acts of remembrance and historical discovery, public debate, commemoration and education. The recovery of communal and familial memory, the unforgetting of the painful events of the past, and the re-assessment of the impact of national and internal conflict on small communities across Galway has left an indelible educational and historical legacy. Dr Conor McNamara, Historian-in-Residence for Galway County Council, will provide an overview of the Decade of Centenaries in Galway and explored what was achieved by Galway County Council, in terms of remembrance, research, publications, commemoration and communal engagement. It is proposed to film this event and to make it available on www.galwaydecadeofcommemorations.com website.





LOCAL AUTHORITY CORPORATE PLAN 2024-2029 AND THE PUBLIC SECTOR EQUALITY AND HUMAN RIGHTS DUTY



The Irish Human Rights and Equality Commission wrote to the Chief Executive in April 2023 to note that Local Elections and subsequent new corporate planning cycle for

local authorities will take place in 2024 and take the opportunity to highlight Galway County Council's statutory obligations under Section 42 of the Irish Human Rights and Equality Commission Act 2014 ("the Duty") which is to promote equality of opportunity, eliminate discrimination and protect human rights; of all service users, policy beneficiaries and employees, across all function areas.

The correspondence advises that the Commission will develop and implement a strategic programme of work applicable to the local government sector during 2023/24 to support local authorities in meeting their obligations under the duty.



Section 42(2) (a) of the Irish Human Rights and Equality Commission Act 2014 requires an organisation to set out in its strategic plan "an assessment of the human rights and equality issues it believes to be relevant to the functions and purpose of the body and the policies, plans and actions in place or proposed to be put in place to address those issues."

In advance of the forthcoming corporate planning cycle Galway County Council is progressing an initiative to implement the Public Sector Equality and Human Rights

Duty (the Duty). A cross-organisational working group has been established to create the conditions necessary for effectively and efficiently implementing the Duty. The core task for the working group is to create the conditions for implementation of the Duty. This will involve working with an external consultant to develop key foundations of:

- An equality and human rights values statement to provide a frame and benchmarks for implementing the Duty;
- Assessment of equality and human rights issues relevant to the functions of Galway County Council, the first step required under the Duty; and
- Implementation Plan for the Duty in Galway County Council.

The initiative will ensure inclusive policies and practices continue while informing the implementation of the Duty in this new corporate planning cycle.



Galway County Council will publish, its human rights and equality assessment, and the policies, plans and actions in place or proposed to be put in place to address the issues identified in the assessment, in a manner that is accessible to the public in our strategic plan. In addition, we will report, in a manner that is accessible to

the public, on developments and achievements – in respect of the policies, plans and actions in place or proposed to be put in place to address issues identified in our assessment - in our annual report.



AMBASSADOR OF MEXICO TO IRELAND VISITS GALWAY COUNTY COUNCIL.

The Ambassador of Mexico, Ms Carolina Zaragoza visited Áras an Chontae on 11th May 2023 to meet with the Cathaoirleach of the County of Galway Cllr. A Twinning Agreement between Clifden and the Borough of Coyocan, Mexico City was signed in 2012. The visit marked an important milestone to further strengthen the close friendship ties and the continued economic co-operation and support between the two communities.















COMHAR CHUIGÉAL, LEITIR MEALLAIN

Glór na nGael was founded in 1961 as a language development tool through competition between community groups.



In 2014 Glór na nGael was appointed as the lead organisation for the Irish language, one of the six lead organisations funded by Foras na Gaeilge. Glór na nGael has a particular responsibility in three areas of work, the development of Irish in the family, the development of Irish among community groups and the development of Irish among enterprise and business groups

The Glór na nGael national competition is open to committees, community groups, Irish language sub-committees of larger groups whose main aim is to promote Irish in their local community. The competition is open to groups on the island of Ireland regardless of population, location or on whether the group has paid employees or is wholly voluntary. There were eight categories in the competition including Youth, The Family, Education, Mental and Physical Health, The State and Business Projects, Protecting the Environment, Heritage and Spirituality Events and opportunities to speak Irish An Ghaeltacht as well as Special Prizes for the Competition.

Each year Galway County Council presents a prize of €1,500 to an award winner in the county of Galway in the Special Prizes for the Competition.

This year's awards presentation of the Glór na nGael National Competition took place in the Armagh City Hotel on the night of Saturday 15th April 2023. The Galway County Council's Prize was presented to Comhar Chuigéal, Leitir Meallain, Co. na Gaillimhe

Comhar Chuigéil is a community based co-operative organisation providing facilities for public events, Day Care Centre for the elderly, Family activities, Outdoor recreational events, Kayaking club, Heritage centre and Seaweed centre.



As part of the competition process Comhar Chuigéal were assessed on the overall services they provide to the community in general and received the special recognition award sponsored by Galway County Council.

BATTLE OF AUGHRIM VISITOR CENTRE

The Battle of Aughrim Visitor Centre re-opened on the 16th May 2023 where visitors can learn about how three rival European Kings took hold of Ireland in their struggle for power with over 45,000 soldiers gathering in Aughrim in 1691.

The centre is located in the heart of Aughrim Village just 7km from Ballinasloe and 22km from Loughrea.

The centre offers visitors:

- Interpretative and artefacts display
- New Educational/Learning zone
- Children's worksheets, costume dress-up
- Self-guided driving, cycling or walking trail of the battlefield (full trail route approx. 10km)
- Free car parking & baby changing facilities
- Fully accessible
- Children's playground and park adjacent to Centre
- Guided tours of battlefield on request

Seasonal opening of the Centre is from May –September with opening times from Tuesday – Saturday, 10.30am - 4.30pm and Sunday 2.00pm – 5.00pm

A Delegation from Washington County, Wisconsin visited Galway County Council in honour of the 20-year Sister Partnership between Washington County, State of Wisconsin, USA, and the County of Galway. The members of the delegation from Washington County, Wisconsin included County Board Chairman Jeffrey Schleif and his wife Pam, County Board Vice-Chair Carroll Merry and his spouse Jean, County Board Supervisor Lois Krueger-Gundrum, State Representative Rick Gundrum, County Board Supervisor John Schodron and his wife Dawn, County Board Supervisor Pam Konrath and County Board Supervisor Tony Thoma and his spouse Susan.

At the Plenary meeting on April 24th 2023 The Cathaoirleach along with the Chairman of the Washington County Board Mr Jeffrey Schleif signed a Charter to further strengthen the friendship ties and cooperation that join the County of Galway and Washington County. The Cathaoirleach presented Washington County with a wall hanging 'Contours' a replica of the wall hanging outside the Council Chamber that reflects the design and inspiration for the bespoke carpet that forms the central design element for the Council Chamber. Aras an Chontae was opened in 1998 and the lighting system in the atrium has become outdated and inefficient. The original lighting was still in place, but the efficiency of the lighting has diminished due to this now outdated technology. This coupled with the age of the fittings and the location of the fittings at a very high level the maintenance costs are escalating year on year. Several of the fittings failed and needed some maintenance works. The location of the lighting results in expensive and time-consuming maintenance.

These lights were up graded to new fittings and the projected savings are outlined below.

ATRIUM AREA IN COUNTY HALL



CONSUMPTION COMPARISON

A range of IP54 recessed downlights designed with quality materials, components & SMD LED lightsource. These high efficiency energy saving luminaires are available in a range of sizes, wattages and colour renderings, making them the perfect solution for modernisation to energy saving where the aesthetics are vital without the need

to compromise on results. They are suitable for all retail and commercial lighting installations with an emphasis on corridors, reception, restrooms and retail space.





- Projected reduction of 5,062 kWh per annum.
- The new LED luminaires do not require scheduled re-lamping and have lifespan of 30,000 hours
- Estimating electricity costing 40 cent per kWh ex vat
- Estimated saving on electricity cost per year €2,024 ex vat
- With expect life span to be 30,000 hours the projected lifetime is 20 years
- Based on today's electricity prices versus the cost of running today's technology there is a projected cost saving of €40,480 ex vat over the lifetime of these lamps.

MAINTENANCE

With the new lamps the maintenance cost will be reduced as the life of the new lights are a projected 20 years.

REPLACEMENT PARTS - FUTUREPROOFING

Warranty on these luminaires is 5-years.

CONCLUSION

The Facilities Section undertook a review of the energy usage of County Hall and highlighted that significant energy costs savings could be achieved by replacing the 150 Watt recessed downlighting in the Atrium with 30 Watt LED lighting having similar illumination at Ground floor level. This energy saving project will yield an estimated saving on electricity cost per year €2,024 ex vat or €40,480 ex vat over the lifetime of these lamps.

BALLINASLOE LIBRARY - EUROPE DAY

As part of Europe Day 2023 the Europe Direct Centre based in Ballinasloe organised a number of exciting activities. First up was a visit to the Centre by students from Scoil Mhuire, Ballygar who met Blue Wise Marine / SmartBay community liaison coordinator Sinéad Ní Fhátharta, who talked to them about alternative energies and showed them a live feed of the facility. The students then took a trip to Galway Atlantaquaria to meet Dr. Noirin Burke, an ocean literacy marine education specialist who hosted an interactive workshop on ocean energy focusing on wave / tidal and offshore wind.

COMMUNITY EVENTS

Clarinbridge Cáirde Club

A presentation on waste prevention, food waste prevention and littering were delivered to Clarinbridge Cáirde club as part of their weekly events programme.

Northampton National School

As part of their Climate Ambassador programme, a presentation was given to senior classes of Northampton National school on food waste prevention and various types of composting options.

Galway County Council is replacing its existing Litter Management Plan in accordance with Section 10 of the Litter Pollution Act, 1997 which requires local authorities to review its Litter Management Plan every 3 years.

CATCHMENT MANAGEMENT

- 2 water pollution complaints were investigated during April.
- Follow-up with previous Section 12 Notices issued continued.
- 10 river monitoring sites were sampled as part of the Water Framework Directive monitoring programme.
- 4 septic tanks were inspected as part of the EPAs National Inspection Plan.
- 27 inspections of Discharge Licenced sites, issued under Section 4 of the Water Pollution Act, were carried out.
- 1 inspection was carried out at Craughwell National School as part of issuing of a new <u>discharge</u> licence.

OIL POLLUTION.

On the 23rd of April Galway County Council received a call re the presence of oil in the Owenriff River in Oughterard. Galway County Council mobolised the Fire Service and staff from the Environment section to assess the site and take immediate measures as necessary on the 23rd. Verde Remediation Specialists were then contracted by Deloitte (the owners of the site) on the 26th to carry out investigations and remediation at the site.

Investigations and remediation are still on going at this site.

ENFORCEMENT

- Enforcement included issuing four Section 12 Notices under the Water Pollution Act.
- 3 warning letters were issued.

DRINKING WATER

- Boil Water Notice lifted on the part of Spiddal PWS served by the Rossaveel Reservoir.
- BWN for part of Loughrea Town was lifted. 520 customers remain on the BWN.



SOLVENTS AND DECO PAINTS REGULATIONS

A Deco Paint Certificate of Compliance was issued in April.

PLANNING

21 planning files were assessed, and reports were provided to the planners. One member of staff attended a pre-planning meeting in relation to a large development.

BATHING WATERS

Preparation continued for 2023 season with meetings with the EPA and the Water Safety Officer. A number of alterations to the Bathing Water posters are required and this is being arranged.

BLUE FLAG BEACH ART COMPETITION FOR SCHOOLS

Galway County Council invited all primary schools in County Galway to participate in a Blue Flag Beach Art Competition. The students have been requested to design and paint a picture. The closing date is 31st May 2023.

Each winning poster will receive a voucher and their poster will be displayed on the Notice board at the relevant beach over the summer months and on the Council website www.galway.ie

WASTE MANAGEMENT AND ENFORCEMENT

Inspection of households for compliance with the Waste Presentation Bye Laws began in April with approximately 120 households in Tuam town being visited. As a result of these inspections a number of Warning Letters and



Section Notices under the Waste Management Act will be issued for non-compliance with the bye laws.

Five commercial food premises were inspected for compliance with the Food Waste regulations during April.

Inspections in relation to WEEE, Batteries and the Plastic Bag Levy were started in April.

During the month of April 70 waste complaints were submitted to the Environment Section for investigation by Community Wardens and Technical Staff.



WASTE MANAGEMENT NOTICES ISSUED

A number of Warning letters, Section 18 Notices and Section 55 Notices under the Waste Management Act 96 were issued in April.

One court case for prosecution in the District Court in April was adjourned.

TYRE REMEDIATION SITE

Over 4000 tonnes of tyres have been removed from the site at Lurgan, Killimor. It is envisaged that the site will be cleared completely by the end of May

SOLID FUEL REGULATIONS

Meetings were held in April between the Environment Section, Roscommon County Council and Mayo County Council in relation to completing a joint application for funding under the Solid Fuel Regulations. The scope of the project was agreed on and an application was made in early May. A separate application for funding to carry out awareness of the regulations and to create a register of solid fuel producers was also submitted solely by the Environment Section of GCC.

BURIAL GROUNDS

BURIAL GROUND MAINTENANCE GRANTS

The Council will be advertising the annual Burial Ground Maintenance Grants to assist voluntary groups in the upkeep of the burial grounds, in May 2023 with a closing date of Friday 18th August 2023. It is requested that groups keep all receipts in relation to work undertaken at the burial ground.

LANDFILL DEVELOPMENTS

EAST GALWAY ECO PARK

Galway County Council hosted a well-attended Public Information Day on Thursday 11th May at Kilconnell Hall, Ballinasloe for the proposed East Galway Eco Park on the site of the former landfill in Kilconnell.

School children from St Gabriel's National School, Cappataggle National School and New Inn National School attended the event with much energy and enthusiasm for the proposal and offered valuable inputs. Members of the local communities and businesses in the area were equally enthused by the vision Galway County Council have for this development and provided valuable input into this consultation process.





The consultation period to allow the local community to "Have Your Say" remains open until 1st June. Our design team of Brady Shipman Martin and Fehily Timoney will then embark on finalising a design for a planning submission later this year. CLIMATE CHANGE



We were delighted to have been involved in organising the Galway County Youth Climate Assembly on the 19th of April in conjunction with SAUTI Youth Project and Youth Work Ireland Galway. The event was hosted by the BIA Innovator Campus, and they were very helpful in embracing the low-carbon food concept as part of the event.

The Youth Climate Assembly was one of the first assemblies of its type to happen at a local level in Ireland. The event provided a space for 57 young people from 13 of our secondary schools and youth organisations to gather to discuss climate action in the county. The participants were introduced to policies, projects and research being undertaken in County Galway to tackle the Climate and



Biodiversity Crises and were encouraged to initiate positive change through their school and/or youth/community group. The feedback from the event is currently being gathered into a report to be presented to Galway County Council and their ideas will be incorporated into our Climate Action Plan 2024-2029. In this way, young people are being supported to influence and shape local government policies.

There were presentations and contributions from Cathaoirleach Michael Maher, Director of Service Eileen Ruane, Tina Ryan, Rosina Joyce, Marie Mannion and Mark Molloy from Galway County Council, Dr Gordon Bromley and Dr Kathy Reilly from the University of Galway, Michelle Chiperi Aivazova from the SAUTI Youth Project, Colm Foley from the BIA Innovator Campus, and Breda Larkin from the Talamh Beo Project.

Feedback from the young attendees included:

"I really enjoyed the Q&A and the way we could express how we feel about climate change, and we learned what we could do to help change Galway for the better".

"I enjoyed Breda talking about farming and how she is planning on going organic, I think she inspired all the young farmers with her speech".

"There is a bigger community concerned about climate change than I previously thought. You can combat climate change in any career and there's a lot of opportunity to get involved".

"I would love to regularly participate in events like these with like-minded young people".

NEW BIODIVERSITY OFFICER

The Galway County Council Biodiversity Officer Position was officially filled on the 2nd May 2023 by Rosina Joyce. This role falls under the remit of the Planning and Sustainable Development Section with collaboration already underway on projects and plans with other sections in the organisation. The post is 100% funded by the Heritage Council in year one, reducing to 75% in year two and 25% in year three.

CLIMATE YOUTH ASSEMBLY: BIODIVERSITY PRESENTATION

A presentation on how Galway County Council are addressing the issues facing Biodiversity in the county was given at the Climate Youth Assembly, in Athenry on 19th April. The presentation explored the pressure climate change places on ecosystems and how young people can direct and bring about change. A display stand outside the main hall allowed for direct engagement and interaction with the students and provided them with Biodiversity resources on everything from pollinators to hedgehogs.



SCHOOL TALKS

School talks were given to all the children at Scoil Náisiúnta, An Fháirce and Scoil Náisiúnta Naomh Padraig, An Chloch Bhreac on how the students can protect biodiversity in their local community. These talks were given in association with the Clonbur/Cloghbrack Pride of Place Group.

THE GALWAY BUZZ CELEBRATING NATIONAL BIODIVERSITY WEEK 2023 (19- 28 MAY)

A Social Media Campaign promoting events as part of the Galway Buzz celebrating National Biodiversity Week 2023 (19- 28 May) is currently underway. The Sustainable Gardening workshop in Loughrea is already booked out with 50 attendees and a waiting list in operation and the Wildflower Workshop in Brigit's Garden only has a few places remaining. A workshop on Orchard Management will take place in Headford Community Orchard and will be delivered by Irish Seed Savers will also take place during the week.



LAW AGENTS UPDATE

- Galway County Council has recently succeeded in prosecuting a property owner in Connemara for unauthorised construction of a dwellinghouse in circumstances where planning permission had been granted for a shed. The conviction and Court Order arising includes an Order for compliance with the Enforcement Notice issued and removal of the unauthorised structure within a period of 4 months. The council have also recovered all expenses incurred in the investigation and prosecution of this offence by way of Court Order for costs.
- Galway County Council has assisted the various Directorates of the council and the parties
 involved in securing the initial base in Ireland for Dexcom and its enterprise at Athenry, Co.
 Galway. The Law Agent Dept. will play a crucial role in laying out the legal footprint for this future
 development whilst assisting in putting in place the necessary formal agreements between the
 various stakeholders involved.
- Galway County Council. recently succeeded in re-entering before the courts the matter of a
 failure to comply with a Court Order previously obtained for removal of an unauthorised
 structure. It is hoped to bring this matter to a successful conclusion by way of enforcement of
 this Court Order.



CONAMARA MUNICIPAL DISTRICT UPDATE

The Restoration Improvement Works and Restoration Maintenance Works have been tendered and a Most Economically Advantageous Tender Identified. It is expected that work will commence at the end of May

The road works on the islands (DRCD funding) was tendered in February but due to higher than expected tenders the DRCD has requested to proceed in a different manner and the works will be retendered later in the year.



Total funding of €1,225,975 across 2022 And 2023 has been received for works to Piers and Harbours in the Galway County Council functional area from the Brexit Adjustment Local Authority Marine Infrastructure Scheme (BALAMI). Matched funding at 5% of the works value is provided from Galway County Council's own budget to bring the total provision to €1,290,500.

The majority of this spend is in the Conamara Municipal District area, comprising works at 16 locations with a combined allocation of €1,125,500. Most of the works have been completed and the remainder are on track for completion ahead of the funding drawdown deadline of November 2023.

The largest of the projects include the construction of a storm wall at Bealcarra Pier and the installation of pontoons at Kilronan, Inis Mór. The pontoon installation contract has been awarded and the pontoons are scheduled to be in place by the end of September 2023.






FIG. 1. BEFORE IMAGES






FIG. 1. CONSTRUCTION WORKS ON-GOING

TUAM MUNICIPAL DISTRICT UPDATE

TUAM EAST:

 Roadworks Programme underway in Tuam East with Road Improvement and Road Maintenance works being carried out by Direct Crews and various subcontractors (HCQ for Overlays & Colas for SD works). Works have been completed for numerous roads which include the following; Ballyroe, Clooncun, Laughill, Ballinlass and Kilavogeher



- Our Direct MD Crew has completed a number of drainage projects recently including the Climate Adaption Scheme in Pollacorragune and several Drainage Improvement Projects on the N17. This week our MD Crew has also commenced works on the LIS in Rosmearan.
- Upgrade works of existing signage has been completed at a number of locations in Tuam East over the past month (R328, R362 & R332)













PEDESTRIAN CROSSING CAHERLISTRANE

We are working currently on Stage 3 of the Caherlistrane project, which involves the construction of a Pedestrian Crossing near the GAA pitch, with a short section of additional footpaths. We have also included ducting for a future upgrade of the public lighting to LED. Reduction in ground staff numbers has resulted in this project being delayed, we hope to have the Civils part completed by the end of next week and all works will be done this summer.

STREETSCAPE SCHEMES

The investment in the visual upgrading of our towns and villages is ongoing in 2023 based on the success of Schemes in eight locations to date.

Over thirty premises in Tuam Town Centre have been offered funding to improve their facades and works are due to commence in Summer 2023.
