Réamhrá

Aithníonn Comhairle Chontae na Gaillimhe ról agus iarrachtaí gníomhaireachtaí, comhlacthaí agus grúpaí pobail áitiúla maidir leis an obair a dhéantar chun slacht a chur ar an gcontae ina ndéanann Comhairle Chontae na Gaillimhe freastal. Cuirtear fáilte roimh an obair sin agus tá ardmheas uirthi. Leagtar amach sa cháipéis seo ceanglais Chomhairle Chontae na Gaillimhe nach mór do gach grúpa, gníomhaireacht agus comhlacht cloí leo lena chinntíú go dtugtar faoi na gníomhaíochtaí sin ar bhealach iomchuí ar mhaithe le sábháilteach agus tairbhe gach duine.

Obair agus Seirbhísí Beartaithe

Caithfear an obair nó na seirbhísí atá beartaithe a chomhaontú leis an innealtóir ceantair iomchuí sula ndéantar iad a cheadú ag an Innealtóir Ceantair Bhardasaigh sa cheantar ina mbeidh an obair le déanamh nó na seirbhísí le cur ar fáil. Ní mór an obair a dhéanamh ar bhealach a ligfidh do Chomhairle Chontae na Gaillimhe obair chríochnaithe a ghlacadh faoina cúram i ndiaidh tréimhse iomchuí gan costas ceartúcháin nó deisiúcháin a thabhú ina leith.

Cialláinn sin, go héifeachtach, go gcaithfidh togróirí na dtograí tuairisc i scríbhinn ar na tograí a chur faoi bhráid na Comhairle. Ba chóir don tuairisc seo an obair nó na seirbhísí a bheidh i gceist a lua go soiléir, lena n-áirítear na suíomhanna, an clár ama agus an lón daoine a bheidh i gceist. Ní mór a rá cibé an Pobail nó TÚS, nó an oibrithe deonacha as pobal áitiúil iad.

Tabharfaidh an innealtóir Ceantair Bhardasaigh deimhniú i scríbhinn ar chomhaontú maidir leis na tograí beartaithe sa tuairisc.

Beidh an obair agus na seirbhísí a cheadófar de réir na dtograí comhaontaithe agus ní chuirfear túis leo go mbeidh an deimhniú i scríbhinn faigthe.

Ní mór don Ghrúpa Deonach/Pobail deimhniú a thabhairt i scríbhinn go bhfuil árachas dliteanais phoiblí aige go leibhéal €6.5m i gcás aon teagmhas amháin, chomh maith le hárachas

Preface

Galway County Council recognises, welcomes and greatly values the efforts and role of local community groups, bodies and voluntary agencies in carrying out works to improve the overall appearance of the county in which Galway County Council serves. This document sets out the requirements of Galway County Council to which all such groups, agencies and bodies must comply to ensure that these activities are carried out in an appropriate fashion for the safety and benefit of all.

Proposed Works & Services

The works or services which are proposed must be agreed with the relevant area engineer prior to approval by the Municipal District Engineer of the area in which works or services are to be carried out or provided. These works must be that Galway County Council can take completed works in its charge after an appropriate period without incurring rectification or repair cost prior to same.

This effectively means that the proposers must submit a written outline of these proposals. This outline should clearly state the works or services involved, the locations, the time schedule and the number of persons involved with details as to whether the participants are part of a formal scheme such as a Community Employment Scheme, TUS or simply volunteers of a local community.

The Municipal District Engineer shall confirm in writing, agreement in regard to the proposals outlined.

The works and services permitted shall be strictly within the agreed proposals and shall not proceed until this written confirmation is in place.

Insurance Requirements

The Community/Voluntary Group must provide written confirmation that it has Public Liability insurance to a level of €6.5million for one single incident and Employers Liability

The Community/Voluntary Group must also indemnify Galway County Council in regards to works and services provided.</p> <p>The period of the insurance cover must extend until the works have been taken in charge or until the service provision is completed.</p> <p>Health & Safety Legislation Compliance</p> <p>The Community/Voluntary Group must provide written confirmation that all its proposed works and services shall be carried out provided in compliance with appropriate safety and health legislation. This effectively means that all involved must have appropriate training (e.g. this can range from SLG training for high risk construction projects on a road to a toolbox talk/induction for a low risk job), signage where required, equipment, PPE and properly developed and appropriate safety documentation relative to the risk. Depending on the activity some documentation may need to be submitted to Galway County Council – see the Process Flow Chart of application requirements overleaf.</p> <p>Galway County Council will not take on any role or responsibility in regards to compliance with Health & Safety Legislation for these works or services.</p>

Works have been assessed and divided into 2 categories based on risk and competencies required. with a speed limit greater than 80km/hr and traffic volumes greater than 1000 vehicles per day. Works on all other types of roads will be assessed on a case by case basis.

Maoiniú:

Ní féidir le Comhairle Chontae na Gaillimhe maoiniú óna Clár Bóithre a chur ar fáil go díreach d'aon Ghrúpa Deonach/Pobail le haghaidh an chineál seo gníomhaíochta. Funding:

Galway County Council cannot provide funding directly from its Roads Programme to any Community/Voluntary Group for these types of activities. Galway County Council may within existing resources provide materials and/or equipment to assist in these activities if appropriate. Whilst Galway County Council will make every effort to assist these projects failure to comply or to ensure ongoing compliance with the requirements of the above will prevent a project commencing or cause it to be stopped without notice.

Process Flow for Voluntary & Community Groups Applications

Construction:

If the proposed works are deemed to be construction related, the following submission will be required. Examples of such works include but are not limited:

Painting, drainage, wall building, footpaths, erecting signage and other activities as defined by the HAS.

Submission

- GCC Application form
- Group Safety Statement
- Insurances
- Method statement/risk assessments
- Traffic Management plan (where appropriate)

These activities are only permitted on single carriageway roads with a maximum speed limit of 80km and a maximum traffic volume of 1000 vehicles per day.

No works are permitted on major roads with a speed limit greater than 80km/hr and traffic volumes greater than 1000 vehicles per day. If guidance is required on traffic volumes contact the local area engineer.

Non-Construction:

If the proposed works are deemed to be non-construction related the following submission will be required.

Examples of such works include but are not limited: *Litter picking, grasscutting, strimming, spraying, watering plants, emptying litterbins, street sweeping, cleaning recycling centres, hedge trimming (by hand), and maintenance of flowerbeds etc...*

Submission

- GCC Application form/self-declaration
- Insurances

These activities are only permitted on single carriageway roads with a maximum speed limit of 80km and a maximum traffic volume of 1000 vehicles per day. No works are permitted on major roads with a speed limit greater than
