Notice of the proposal to make the Headford Draft Local Area Plan 2015-2021

Notice is hereby given that Galway County Council pursuant to Section 20 of the Planning and Development Act 2000 (as amended), Article 14 A of the Planning & Development (Strategic Environmental Assessment) Regulations, 2004 (as amended), Article 6 of the EU Habitats Directive (92/43/EEC) and the Birds Directive (79/409/EEC) as amended, has prepared a Draft Local Area Plan (LAP), a Strategic Environmental Assessment (SEA) Screening Report, an Appropriate Assessment (AA) Screening Report and also a Strategic Flood Risk Assessment (SFRA) for Headford.
